CONGRESS APPROVAL OF 'MARIJUANA' USE 'ALMOST DONE'

of medical cannabis or marijuana as its approval in Congress to legalize its use, "is almost done," according to experts.

This was disclosed by Dr. Richard Nixon Gomez and his colleagues at Monday's Media Health Forum of Bauertek Corporation, a research, development and medical manufacturing company in Guiguinto, Bulacan.

On the other hand, Dr. Gem Marq Mutia, adult medicine specialist and founder of Philippine Society for Cannabinoid Medicine, said that many people are now enlightened as to the benefits of medical cannabis as medicines to various ailments such as Parkinson's disease, Alzheimer's disease. chronic pain, chemotherapy associated with nausea and vomiting, multiple sclerosis and intractable epilepsy.

Mutia said that pushing for the legalization on the use of medical cannabis as medicine has begun in 2014. In the 19th Congress, it is now with the technical working group and soon to be deliberated in the plenary and then the final step is the signing of the bill by the President.

It is also a record high with nine bills in Congress and one bill in the Senate. Mutia said that it's no longer a subject of debate whether marijuana can cure or not but only the time of its approval and how to regulate its use.

Dr. John Ortiz Teope, a researcher, critic, political analyst, media practitioner and the secretary general of TIMPUYOG Philippines, said that though many people are now enlightened on the benefits of the medical cannabis, he sees the resistance to be coming from the pharmaceutical industries. He called on everyone to be vigilant and people to be educated about marijuana benefits.

He said that Filipinos should bear in mind that it

> Gomez, a scientist, inventor and the general manager of Bauertek Corporation, explained that unlike other countries, the Philippines can sustain the supply of the medical cannabis, once its manufacturing is legally allowed.

> He further disclosed that in a survey conducted by his company, respondents were "almost unanimous" in favor of using medical cannabis as a medicine. include Respondents doctors, students, OFWs, government teachers, workers, among others. Another nationwide survey was conducted by a refutable survey firm, results of which will be disclosed in due time.

> The RA 9165 or the ComprehensiveDangerous Drugs Act of 2002 may delist marijuana as one of illegal drugs, once its use as medicine is legalized.

> Since research, clinical trials and 60 countries have legalized marijuana use as medicine, there is no reason for Filipinos not to accept it, Gomez said.

> Theimplicationsoflegalizing the use of marijuana include prolonging life, decreasing the number of sick people as well as those who died, lesser medical expenses. "Health security should be given importance by the government," Dr. Teope, stressed. (Nelson Santos-

SC announces amendments to BSK poll protest rules

MANILA – The Supreme Court on Wednesday announced amendments to the rules covering the BarangayandSangguniang Kabataan (BSK) election protests before the lower courts.

In a statement, the tribunal said the amendments were approved during the SC's en banc deliberations on August 29.

Among the amendments include a provision for an initial recount of ballots of a sampling of "pilot protested clustered precincts".

"This initial recount is intended to determine whether the protest is meritorious upon showing by the protestant of at least 20 percent substantial recovery from the overall vote lead of the protestee,"

The rule shall apply prospectively to all BSK election protests and is seen to "provide for expeditious, inexpensive and just determination and disposition of such election contests."

The new amendments also incorporate revisions made in the court rules on civil procedure in 2019 such as the judicial affidavit rule, which reduces into writing in a question-and-answer format the direct testimony of a witness.

The 2023 Amended Rules shalltake effect 15 days after publication in a newspaper of general circulation or in the Supreme Court Official Website, but its effectivity shall in no case be later than October 15, 2023. (PNA)

SC asks Cagayan guv, counsel to explain acts in withdrawn suit

MANILA – The Supreme Court has directed embattled Cagayan Gov. Manuel Mamba and his lawyers to explain why they should not be cited in contempt regarding the suits they filed in connection with a House inquiry.

In a statement on Thursday, the Tribunal said during its en banc deliberations on August 29, it has ruled to require Mamba and his counsels to explain why they should not be held in contempt for failing to disclose to the court supervening events in his case, including the fact that he had surrendered to the Congress committee investigating him.

A legislative inquiry is being conducted by the House of Representatives Committees on Public Accounts and Suffrage and Electoral reforms over allegations of illegal campaign spending raised in resolutions filed by Cagayan Rep. Joseph Lara, whose spouse ran and lost to Mamba in the gubernatorial race in the 2022 polls.

The House ruled to detain Mamba for contempt following reports that he refused to authorize the travel of his employees to attend the House hearing earlier this month.

Mamba filed a petition before the SC and subsequently obtained a temporary restraining order.

temporary restraining order (TRO) from the Tribunal to stop his detention by the House body.

However, the High Court noted that "based on various news reports, petitioner voluntarily surrendered to respondents (Congress) without promptly informing the Court of such supervening development" and that "the foregoing effectively rendered nugatory" the TRO it issued.

"The Court, before acting on the manifestation and motion to withdraw (the) petition (filed by Mamba), resolvedtorequirepetitioner Manuel M. Mamba and his counsels, i.e., Macalintal Law Office, to show cause why they should not be disciplinarily dealt with or held in contempt for acts that constitute "abuse of or any unlawful interference with the processes or proceedings of a court not constituting direct contempt" and/or "improper conduct tending, directly or indirectly, to impede. obstruct, or degrade the administration of justice' within ten (10) days from notice," it said. DepEd Calabarzon expects to log bigger enrollment for SY 2023-2024

CALAMBA CITY (PIA)-The Department of
Education (DepEd) in
Calabarzon expects to log
more enrollees this year
higher than its previous
record of 4.05 million last
year.

The Education department said around 4,102,945 enrollees are expected in Calabarzon for the incoming school year, including those registered under the Alternative Learning System (ALS).

In its August 22 update, enrollment in Calabarzon has already reached 2,915,796, which is the highest in the country. Region IV-A also posted the highest number of enrollees in the country last year with 4,052,158 students.

DepEd IV-A Regional Director Atty. Alberto Escobarte expects the enrollment rate to surpass the record last school year, as the resumption of classes draws near.

"For the coming school year, sa enrollment update namin, we have so far enrolled almost 2.9 million students that is equivalent to 72% of the total official enrollment count comparing[sic] to last school year."

Escobarte adds, "The momentum is increasing and we expect that our total enrollment last year would be breached by 4 million plus and we expect about 50,000 new enrollees to be added this school year."

The DepEd Calabarzon assured that it has enough teaching personnel to ensure the continuous delivery of education despite the high enrollment turn out.

"Bago pa matapos ang School Year 2022-2023 ay pinag-uusapan na sa Regional Office [at] sa National rin po, pinaguusapan ng ma fill-up na dapat ang lahat ng vacant teaching positions dahil inaasahan na ang pagdagsa ng malaking numero ng mga magaaral sa pasukan. Mas maraming guro rin ang kakailanganin para tugunan ang pangangailangan ng ating mga mag-aaral," said Regional Information Officer Ariel Azuelo.

Meanwhile, Wilbert Ulpindo, Project Development Officer II, said the six-day school maintenance week beginning August 14 was enough time to refurbish classrooms and other school facilities.

Department of Environment and Natural (DENR) Resources CALABARZON signed a MemorandumofAgreement with the Department of Labor and Employment (DOLE) Region No. IV-A for the implementation of "Tulong Panghanapbuhay Ating Displaced/ Disadvantage Workers (TUPAD) Program" last June 27 at the DENR CALABARZON Regional Office, Brgy. Mayapa, Calamba City, Laguna.

Through the TUPAD program, 450 "displaced, underemployed, and seasonal workers" in CALABARZON will be hired and mobilized for 90 days starting July 2023 to November 2023 to aid the implementation of forest protection program of DENR.


