SC TO UPHOLD NATIONAL JAIL DECONGESTION SUMMIT

QUEZON CITY, (PIA) — The Supreme Court (SC) of the Philippines will spearhead a National Jail Decongestion Summit aimed at addressing the overcrowded prison conditions facing the persons deprived of liberty (PDLs) in the country.

The summit will be jointly organized by the Department of the Interior and Local Government (DILG) together with the Bureau of Jail Management and Penology (BJMP) as the lead agencies at the forefront of securing an efficient justice system.

"Here, the Supreme Court, the Department of Justice, and the Department of the Interior and Local Government shall collaborate to identify the root causes of prolonged detention in jails, which contribute to prison overcrowding," said Chief Justice (CJ) Alexander Gesmundo.

"We aim to establish new policies and initiatives that shall expedite the processing of criminal cases and alleviate jail congestion," he further emphasized.

with line the celebration of the 28th Correctional National Consciousness Week (NACOCOW), CJ Gesmundo personally conducted visit to City Jail to the Pasay determine the actual conditions of PDLs as well as the detention facilities towards the development effective program interventions.

DILG Secretary Benjamin "Benhur" Abalos Jr. stressed the importance of the said initiative in formulating equitable sentencing and jail management practices to enable a more humane safekeeping of PDLs.

"Our department sincerely appreciates the Supreme Court's commitment to help us address and reform the conditions of persons deprived of liberty. It is a significant move towards achieving a fair and just criminal justice system. The DILG stands ready to collaborate and contribute

QUEZON CITY, (PIA) – to this important initiative," The Supreme Court (SC) said Abalos.

BJMP Director Ruel Rivera meanwhile reported the significant leap in resolving congestion in the country from a rate of 600% in 2018 to 351% in 2023. Other initiatives of the BJMP to cater to the welfare of PDLs include the continuous enhancement of the Jail Paralegal Programs which provide assistance to inmates for the speedy disposition of their cases.

The BJMP also seeks to establish more jail facilities alongside the enhancement of the PDL Welfare and Development Program.

On the other hand, the SC is strongly advocating for the imposition of lower bail amounts to indigent accused individuals towards expediting the release of qualified PDLs and their reintegration to community.

In addition, the SC gave an immediate directive to trial courts to prioritize the disposition of criminal cases which will also aid the integrity of the justice system. (SC/DILG/PIANCR)

PBBM LAUNCHES"HANDA PILIPINAS" VISAYAS LEG IN TACLOBAN

PRESIDENT Ferdinand "Bongbong" R. Marcos Jr. graced the "Handa Pilipinas" Visayas Leg – a celebration commemorating the 10th anniversary of the catastrophic super typhoon "Yolanda" on Nov. 8, 2013 in Tacloban City.

The exposition led by the Dept. of Science and Technology (DOST) held in Summit Hotel, from Nov. 8-10 tackled "Innovations in Disaster Risk Reduction and Management Exposition."

The president said what happened 10 years ago "underscores the importance of disaster risk reduction and management." The Filipinos' spirit is incredible, he added. "Our ability to come together to support one another, to rebuild during such adversity is always an inspiration."

The event is an annual exposition of innovations in Disaster Risk Reduction and Management (DRRM).

This year's theme is "STY Yolanda remembered: understanding Risks and Preventing Future Disasters."

Marcos further said that the government is always committed to advancing the country's disaster resilience. He mentioned the importance of the role of DOST in the undertaking. "The DOST has been instrumental in developing cutting-edge technology for disaster risk prevention, mitigation preparedness, response and recovery."

Collaboration among government agencies, local government and the private sectors and communities "is a key to effective and successful in disaster risk and management."

"The difference between victims of disasters and victors over disasters is how they handle adversities. The first one suffers from the same repeated story. The latter moves forward and builds resilience,"

said DOST secretary, Dr. Renato Solidum Jr., for his part. He explained that investing in resilience is a legacy opportunity. "As we build Philippine resilience, we are making Filipino communities more prosperous and secure than before."

Solidum delivered the opening remarks while Tacloban City Mayor Alfred Romualdez welcomed the guests to the event.

Dept. of the Interior and Local Government (DILG) Secretary Benhur Abalos Jr. said: "We at the DILG stand together with the DOST in our commitment in enhancing the capacities of our LGUs in the disaster risk management," adding that his department has initiated several initiatives like the activation of the DILG operation centers and others. Abalos assured the DOST of its "all-out support."

Leyte Governor Carlos Jericho Petilla said that "we can't really prepare enough" referring to the forthcoming disasters, but preparation should be tp the maximum. "We have to see disaster as a science and a solution as a science," the governor told the even attendees. "I wish we can eliminate disasters but we can only do reduction."

In the afternoon, during the presentation of the Disaster Preparedness Technologies forum, DOST presented projects such as abaca-fiber reinforced composites for transport; collapsible toilet bowls; upgraded emergency disinfection rainwater collection system; and food reserve.

The three-day event showcases a series of technology fora, where scientists, experts and resource speakers discuss the DOST-developed, supported and funded DRRM technologies. (Nelson S. Santos)

JOEY AYALA: 'MARIJUANA IS A GREAT MUSCLE RELAXANT'

SONGWRITER/SINGER Joey Ayala, a medical cannabis or marijuana use advocate said that the hemp is a great muscle relaxant.

His father was sort of "supportive" of Ayala's use of the plant in the 70's when he was in high school. "Kung gagamit ka niyan, dito ka lang sa bahay. Kung sa labas, baka antukin ka, baka mahilo ka at masagasaan ka," Ayala quoted his father as telling him. Because of his father's "openness," to accept the plant's use, there was no more mystery, so he did not become an addict as a common notion now.

Regarding the present law's avoidance of the use of medical cannabis, Ayala said the more they try to stop people from using it, the more it becomes a mystery to them or curious about it.

been over a It has decade when advocates and medical cannabis supporters have been pushing for the legalization of its use as medicines. "It is more important to demystify and allow people to form their own opinions, to make their own control rather than to make external controls," Ayala explained in support of the move to legalize marijuana use as medicines for epilepsy, chronic pain, nausea and vomiting and multiple sclerosis, age wasting syndrome, among other ailments.

Ayala was one of the panelists in this week's Media Health Forum of Bauertek Corporation with Dr. Richard Nixon Gomez as its general manager. Other regular panelist was Dr. Gem Marq Mutia, a specialist in adult medicine and founder of Philippine Cannabinoid Medicine, who said that the use of marijuana as medicine started centuries ago. "Wala ng mas tradisyonal pa sa marijuana" he said and when it comes to mainstream medicines or western conventional medicines, the plant has also undergone clinical trials and proven to be effective.

It is disheartening to note however, that only one patient was granted a compassionate special permit to buy the imported marijuana oil but nobody has availed yet because of additional processes to purchase the medicine.

Mutia mentioned national hero Dr. Jose Rizal who was able to buy marijuana medicine from a pharmacy in 1879.

Ayala said he prefers to use marijuana if he's looking for "something relaxing." Its use is not as bad as soft drinks, alcohol, coffee, he said.

Gomez said that anxiety and depression can also be cured by marijuana medicine. "Medical cannabis immediately matutulungan ka sa anxiety, depression," he said rather than waiting for doctors for appointment and who charged exorbitant fees.

Mutia meanwhile explained that our body has endo cannabinoid system and known as stress-management professionals.

Ayala on the other hand, explained that he doesn't use marijuana for his performance but as muscle relaxant. He is well known for his style of music that combines the sounds of Filipino ethnic instruments with modern pop music.

These products include RIMO Curls, a rice-mongo curls snack, RIMO Blends. instant baby cereals, Momsie, a rich-nutty chocolate food. brown rice bar, enhanced Nutribun, and Go and Grow, a micronutrient powder

With their nutritional benefits, some of these food products are currently used in the Department of **Education and Department** of Social Welfare and Development's (DSWD) supplementary feeding programs.

Nutridense also significant steps in addressing anemia among Filipinos in 2016. The promotion consumption of iron-fortified rice in La Union is one of Nutridense's answers to the said problem.

Doctor said Iron-Fortified Rice (IFR) is a well-milled rice mixed with mineral iron in rice kernel form. It is like ordinary rice but contains more iron which prevents Iron Deficiency Anemia among the people.

To this day, Nutridense to produce continues these goods. The mission to realize their advocacies continues to roll on.

Starting a new business is challenging. Even if Doctor had a prior business with LLP, buying the equipment needed to produce food products was quite a handful. Then the DOST-FNRI and SETUP supported him in acquiring the technologies and equipment needed to operate the business.

Some of the FNRItechnologies developed are the IFR and RIMO blends. The FNRI was instrumental in the early development of the firm, as it assisted in the supervision of equipment test runs and trial productions.

In 2015, SETUP provided the equipment like twoscrew kernel extruders and blending machine, to commercialize the technologies.

SETUP's intervention and FNRI's food formulas were vital in the significant increase of gross sales and volume production of Nutridense.

The former attendee of a forum is now an established entrepreneur, who received recognitions and spoke on different forums and events for his advocacy-driven enterprise.

His previous awards include FNRI-DOST's Scaling-up Rice Fortification and Kabalikat Award. Doctor also served as a speaker on nutrition emergencies, durina malnutrition reduction and complementary feeding, among others.

He was also one of the Science, Technology, and Innovation (STI) Ambassadors of year's Regional Science, Technology, and Innovation Week (RSTW) in Laoag City, Ilocos Norte from October 16 to 18. With Nutridense's accomplishments effective adoption of technological DOST's intervention, the DOST-1 also recognized him as the Regional Winner of the 2023 Most Industry 4.0-Ready (I-Ready) Award in the Pinna-ScIGLAT Awards of the recently concluded RSTW. "Your continuous assistance in mentoring us and our co-MSMEs, through your programs, has elevated a lot of lives, families, and communities. This I-Ready award ignites another opportunity for Nutridense and a reminder to be always better in serving our customers," Karl Doctor, the elder Doctor's son, said in his acceptance speech.

Today, the businessman serves as an inspiration to every aspiring entrepreneur in founding a company with a cause. While there are risks in establishing enterprises, DOST's programs, like SETUP and research institutions, such as FNRI, are more than willing to lend a hand for the betterment of Filipinos'

In the case of Nutridense, Doctor successfully grew the business by fusing flavors towards the cause of alleviating nutrition problems among Filipino children with the help of DOST. (Patrick R. Balanon)

BTr fully awards reissued T-bond

MANILA - The Bureau of the Treasury (BTr) on Tuesday fully awarded the reissued seven-year Treasury bonds (T-bonds). With a remaining term of six years and eight months, the reissued bond fetched an average rate of 6.807 percent.

The auction was two times oversubscribed with total tenders reaching PHP60.9 billion.

The BTr raised the full of PHP30 program billion, bringing the total outstanding volume for the series to PHP94.7 billion.

"The 7-vear Treasury bond average auction yield stood at 6.807 percent, higher

versus the 6.675 percent in the previous 7-year T-bond auction on October 17, 2023 but lower [than] the comparable 7-year PHP BVAL (Bloomberg Valuation Service) yield of 6.88 percent as of November 6, 2023," Rizal Commercial Corporation (RCBC) chief economist Michael Ricafort

Ricafort said this was also in view of the recent downward correction in the comparable seven-year US Treasury yield which is now at 4.63 percent, down from a high of 5.03 percent posted in Oct. 19, 2023.
