## BUKIDNON PINEAPPLE JAM PRODUCER EARNS FDA CERTIFICATION WITH DOST CONSULTANCY

Mama Nene Homemade Delights locally known as Paula's Bukidnon Delight earns its Certificate of Product Registration (CPR) for its Pineapple Jam, through the consultancy and training services of the Department of Science and Technology.

The Certificate of Product Registration (CPR) is a requirement of the Food and Drug Administration for food products (beverages, water, canned goods, etc.), food supplements, medicines, and others if such products will be exported. It is also a requirement of institutional buyers such as malls and supermarkets. With the newly acquired CPR, this woman-led enterprise can now expand its market reach and offer its delicious and high-quality pineapple jam throughout the country through various malls, pasalubong centers, and others.

Ms. Paula Chiong, the owner, considers this achievement a significant milestone since pineapple jam is the very first product of the business. "I thought na imposible para sa isa ka micro na negosyante na maka kuha og FDALTO and CPR but with the help and guide of DOST napa sayon and napa dali and I have proven na walay imposible basta naay pasencya, pag kugi, perseverance and determination. Karon challenges nasad ang atubangon which is to conquer the Philippine market". She relayed how DOST has assisted her firm to acquire FDA License to Operate, and now her CPR. She also said that with this new milestone, she is ready to face a new challenge: conquering the Philippine market.

The firm first acquired the SETUP program. Aside from the technology upgrading they have acquired, they are also a licensee of the Food and Nutrition Research Institute (FNRI)'s Enhanced Nutribun Technology. The firm is also a beneficiary

of the Manufacturing Productivity Extension (MPEX) Program through the consultancy services of DOST. These programs have helped the company improve its plant layout, food safety, and halal training, which can help boost the firm's competitiveness and productivity. The firm was also assisted in its laboratory analysis through the DOST 10 Regional Standards and Testing Laboratories.

Ms. Paula is currently producing 1,000 kilograms of pineapple jam every month—an increase of 66% after DOST intervention and has produced seven additional products such as Pineapple muffin, pineapple ensaymada, Paula's Mango Jam, Paula's Langka, Paula's vinegar, Paula's vinaigrette and Paula's Chili Sauce. Paula's Bukidnon Delights products are now becoming among the most sought-after pasalubong products from the province. ## Patuloy ang 'No Face Mask' Policy

**MAG-UUSAP** ulit ang mga kasapi sa Metro Manila Council (MMC) at ng Department of Health (DOH) kung kinakailangan na ba i-angat o hindi pa ang public health emergency status ng bansa dahil sa nabatid ng Metro Manila mayors mula sa Department of Health (DOH), na kung pagbabatayan ngayon ang hospital utilization rate dito sa National Capital Region (NCR) ay nasa 29% pa lamang ng buong populasyon dito sa Metro Manila ang naitatalang bilang ng mga pasyente na nag-positibo umano sa COVID-19.

Sinasabi ng mga kinauukulan na nasa 25% pa lamang ang positivity rate ng mga COVID cases dito sa Metro Manila.

Gayunman, nilinaw ni San Juan City Mayor Francis Zamora, chairman ng MMC na maaari pa ring magpatupad ang mga lokal na pamahalaan ng face mask policy sa pamamagitan ng isang Executive Order o di kaya ay ordinansa, kung talagang kakailanganin. Sa kasalukuyan ay nananatiling opsiyonal ang pagsusuot ng face mask dito sa NCR.

Ayon kay Zamora, hindi pa aniya kinakailangan ang mandatory na face mask use sa NCR dahil ito'y nananatiling nasa low-risk category sa COVID-19, sa kabila nang pagtaas ng mga naitatalang bilang ng mga tao na mayroong sakit.

Kaugnay nito, sa kabila ng bahagyang pagtaas

ng kaso ng Covid-19 sa NCR tiniyak naman ni Dr. Jose Rene de Grano, ang pangulo ng Private Hospitals Association of the Philippines, Inc. (PHAP) na ang mga pribadong ospital ay may kakayahang tumanggap ng mga pasyente ng Covid-19.

Sinabi pa ni de Grano na ilang mga pribadong ospital ang nag-ulat ng 20 hanggang 50 porsiyentong pagtaas ng mga na-admit na pasyente ng Covid-19 nitong nakalipas na dalawa hanggang tatlong araw.

Gayunman, ipinaliwanag ni De Grano, na karamihan sa mga naturang pasyente ay hindi unang na-ospital dahil sa Covid-19 ngunit dahil sa iba pang mga sakit, napag-alaman lamang na nagpositibo lamang ang mga ito sa virus matapos isagawa ang routine testing bilang bahagi ng safety protocols sa mga ospital.

Bagama't karamihan sa mga na-admit na kaso ay "incidental", sinabi ni de Grano na binabantayan nila ang mga pasyente at inoobserbahan lalo na ang mga mayroong comorbidities at kung sino ang immune-compromised sa mga ito.

Sa aking punto mga kaibigan, maganda na rin na ibalik ang mandatory na pagsusuot ng face mask lalo na kung tayo ay pumupunta sa mga high-risk areas hindi lamang dito sa Metro Manila kundi maging sa mga probinsiya.

## MECO: FILIPINOS ARE SAFE IN TAIWAN

Manila Economic and Cultural Office (MECO) Chairman and Resident Representative Silvestre Bello III on Saturday allayed concerns about the safety of Filipinos in Taiwan amid brewing tensions with neighboring China. Bello said the Philippine government, through MECO, is looking out for the welfare and well-being of the Filipinos there. "So we would like to assure you, everyone. I'll take this opportunity to inform you... in Taiwan everything is normal and, if in the remote possibility na magkaroon ng emergency situation, like for example earthquake, mga lindol o even war, preparado po ang Taiwan government not only in protecting their own people but even the Filipinos, especially our workers," Bello said in a media forum in Quezon City. According to Bello, the National Police Agency of Taiwan has assured him the protection and security of the Filipinos in the self-ruled island nation.

"I met with the Director General together with the head of the Home Civilian Defense of Taiwan and they assured us na iyong ating mga kababayan ay protektado nila," Bello said. Bello said he was told by security officials that Taiwan has 89,000 shelters that can accommodate more than the total population of Taiwan. "Ganoon kapreparado iyong ating mga kasama sa Taiwan and they really treasure our OFWs kasi sila, according to them, are the best in their manufacturing industry," he said. The MECO official noted that 90 percent of the factories in Taiwan are serviced by Filipino workers. He said roughly 160,000 OFWs are in factories and all the rest are highly skilled teachers, farmers, and workers in the hospitality industry. "So, huwag po kayong mag-alala... everything is normal, our OFWs there are safe and there is no

**Joint Operational Guidelines for first time jobseekers signed**

**QUEZON CITY, (PIA)** –The Joint Operational Guidelines that will institutionalize the procedures for all implementers and the issuance of pre-employment documents for the first time jobseekers as provided under the Republic Act No. 11261 or the First Time Jobseekers Assistance Act has been signed.

The Department of Labor and Employment (DOLE), with fifteen other signatory-agencies of the First Time Jobseekers Assistance Act Inter-Agency Monitoring Committee (FTJAA IAMC), formally signed the FTJAA Joint Operational Guidelines (JOG) in a ceremony held on 12 May 2023 at the Kingsford Hotel Manila, Parañaque City. DOLE Secretary Bienvenido E. Laguesma, in his keynote address during the signing event, underscored the prime importance of the FTJAA JOG, to ease the financial burden of the first time jobseekers.

**Application for CSE-PPT set on August 20**

**QUEZON CITY (PIA)** – The Civil Service Commission (CSC) has announced that applications for the Career Service Examination-Pen and Paper Test (CSE-PPT) for Professional and Subprofessional Levels on 20 August 2023 will be open from 22 May to 21 June 2023.

CSC Chairperson Karlo Nograles stated that the Commission has prepared 97 testing centers across 16 regions nationwide to accommodate a large number of applicants interested in serving the country's civil service.

Interested applicants must be Filipino citizens, at least 18 years old on the date of application, and possess good moral character.

They should not have been convicted of any offense or crime involving moral turpitude, have been dishonorably discharged from military service, or dismissed from any civilian position in the government. Applicants who have taken the same level of Career Service Examination within three months from the exam date are not eligible to apply.

Educational attainment is not a requirement for applicants who meet the qualifications. Applicants must submit a fully accomplished application form, four passport-sized photos, a valid ID,

a Certificate of Consent/Release/Waiver relating to the Corona Virus Disease, and an examination fee of P500 to the CSC offices.

The application form is available at the National Capital Region CSC office, located at No. 25 Kaliraya St., Brgy. Doña Josefa, Quezon City and other CSC Regional or Field Offices, or it can be downloaded from the CSC website and printed on a legal-size bond paper.

The CSC website has detailed information on the requirements, I.D. specifications, and list of testing centers by region. The CSC emphasizes that it does not hold review classes, publish or distribute review materials, or endorse any entity offering review sessions to prospective civil service examinees.

Passing the Career Service examinations grants Career Service Professional Eligibility or Career Service Subprofessional Eligibility, which, together with education, experience, training, and other competency requirements, is necessary for a permanent appointment to corresponding positions in the government career service that do not involve the practice of profession and are not covered by the Bar, board, and other special laws. (*CSC / PIA-NCR*)
