# ADB OKs \$2.1-B financing for Bataan-Cavite Interlink bridge

Development Bank (ADB) has approved a USD2.1billion financing for the construction of a 32.15kilometer bridge that will connect Bataan and Cavite. In a statement on Tuesday, the ADB said the Bataan-Interlink Bridge (BCIB) Project will complete the transport loop around the Manila Bay and better link Metro Manila to central Luzon and Cavite, Laguna, Batangas, Rizal and Quezon provinces.

The BCIB project will be financed under a multi-tranche financing facility, with

the first tranche amounting to USD650 million.

The project is expected to reduce the travel time between Bataan and Cavite to an hour and a half from five hours, and to about two hours from four hours between Bataan and Metro Manila.

The traffic decongestion in Metro Manila and the reduced travel time will help lower annual greenhouse gas emissions in the country by an estimated 79,000 tons of carbon dioxide equivalent.

It is expected to help boost economic activity in these

areas, which together account for about 60 percent of the country's gross domestic product.

"This project will transform the economic landscape of central Luzon, unlock the full potential of Bataan and Cavite for trade, manufacturing, and industrial output, and boost their tourism," said ADB Vice-President for East and Southeast Asia and the Pacific Scott Morris.

"Once completed, BCIB will offer a platform for reimagining a more vibrant, resilient, and dynamic greater Manila Bay area," he said.

The ADB said the project will see the construction of one of the world's longest

marine bridges, including two cable-stayed bridges, 24 kilometers of marine viaducts, and a total of 8 km. of approach roads in the two provinces.

'The BCIB represents the latest installment in ADB's broader agenda of support towards strengthening and transport networks in and greater Manila. around This includes the South Commuter Railway, Malolos Clark Railway, and two other projects currently being prepared for financing — the Metro Manila Rail Transit Line 4 and the Laguna Lakeshore Road Network," Morris said.

"These projects will expand and transform the transport network in the metropolis, improve regional connectivity, and offer Filipinos access to more job opportunities," he added. (PNA)

# DOH Biyaheng Kalusugan affirms fight against HIV, AIDS stigma

LUCENA CITY (PIA)
-- The Department of
Health (DOH) Center
for Health Development
- CALABARZON
emphasized the importance
of collective effort to combat
HIV/AIDS stigma with the
launch of the Biyaheng
Kalusugan campaign on
World AIDS Day.

DOH Assistant Secretary Maylene Beltran said Kalusugan Biyaheng is anchored upon the 'Health is Life' campaign of the department which directly involves various sectors and stakeholders in the fight against Human Immunodeficiency Viruses (HIV) and Acquired Immunodeficiency Virus (AIDS) by promoting healthy sexual behaviors thru various fora and discussions.

"We will diagnose 95 percent of HIV-positive individuals, provide antiretroviral therapy for 95 percent of those who were diagnosed, and achieve viral suppression for 95 percent of those treated—that is the end goal of ending AIDS by 2030," Beltran said.

According to the DOH Epidemiology Bureau - National HIV/AIDS & STI Surveillance and Strategic Information Unit, new HIV infections in the Philippines rose to an average of 418 percent every year from 2010 to 2022.

In Calabarzon, the Health department logged 1,574 HIV cases and has killed 49 patients.

With the rising number of reported HIV cases, DOH Calabarzon Local Health Support Division chief, Dr. Ma. Elena Castillo-Gonzales highlighted the importance of properly diagnosing individuals considered most at risk of infection.

join the "l et US conversations promoting safe sexual behaviors in this fight against HIV and AIDS. Let us work together in educating our communities about risky sexual behaviors, and how we can protect ourselves against HIV and AIDS," she said.

The health department has also committed

in strengthening its information campaigns to emphasize the importance of getting tested and treated for the life-threatening disease

Castillo-Gonzales continues, "We have the collective responsibility to ensure our community's sexual and reproductive health to end the HIV epidemic. We need to take care of our sexual health because each life is important."

N o n - g o v e r n m e n t organization EpiC Philippines Project Director Teresita Marie Bagasao, believes cooperation among countries to warrant the significant gains in HIV/ AIDS prevention.

"For us, this is important because we feel that this [World AIDS Day] is a day to re-commit ourselves to the continuous effort to end AIDS [and] to provide inclusive services to our kababayans." Bagasao said.

At the center of the campaign is the LGBTQ+community who have experienced the stigma and risks of HIV/AIDS.

Quezon Pioneer Pride Group Vice President Florencio dela Rosa, said that although the disease presents a disproportionate impact in their community, WorldAIDS Day is important in creating conversations on HIV/AIDS as a public health concern.

"We know that HIV/AIDS has a disproportionate impact on the LGBTQ+community because there is a higher risk of infection. That is why we as a community is grateful for the acknowledgment of World AIDS Day which helps increase awareness of the effective health services for the LGBTQ+community."

Aside supporting from World AIDS Day, the Provincial Government of Quezon also supports NGOs and civic groups whose main agenda is spreading HIV awareness and, building inclusive and safe spaces. (PB/PIA-4A; with reports from Provincial Government of Quezon)

# DOST disaster food passes palate of kids

Department of Science and Technology's disaster food passed the palate of kids in Quirino. This was confirmed thru consumer survey of DOST through the Industrial Technology Development Institute in collaboration with the Provincial Science and Technology Office Quirino and Municipal Social Welfare Development Office of LGU-Diffun on Ready-to-Eat (RTE) foods to 20 senior citizens and 20 elementary school children in the Province of Quirino on December 6, 2023.

This activity aims to evaluate the acceptability of RTE retort foods – Ginisang Monggo and

Chicken Corn Soup as an aid for disaster relief efforts in the country.

During the taste testing, participants tried each pack of RTEs and provided useful feedback to determine the acceptability of the products for all ages. This is to ensure and determine when the preferences of each age group are attained without compromising its nutritional value.

Mr. Ermin S. Orendain, Senior SRS of DOST ITDI led his team and Engr. Rocela Angelica B. Gorospe, PSTO Director with Mr. Jonathan A. De Jesus, PSTO Staff assisted in the conduct of the activity.

# Severe drought possible in 65 PH provinces by May 2024 - DOST chief

QUEZON CITY, (PIA)

– At least 65 provinces, representing approximately 77 percent of the Philippines, are expected to experience drought by May 2024 due to a "strong" El Niño phenomenon, according to Science and Technology Secretary Renato Solidum Jr.

Solidum made announcement on Tuesday, December 12, during a briefing at Malacañang Palace following a sectoral meeting with President Ferdinand R. Marcos. Jr. He explained that "moderate to severe drought conditions" are anticipated from February to May 2024, impacting the majority of the country.

He further elaborated that approximately six provinces (7 percent) are facing the potential for "dry spell" conditions, which are less severe than droughts. Solidum warned Northern Luzon could scorching experience temperatures reaching 41 degrees Celsius (105.8 degrees Fahrenheit) in April or May, with the heat index potentially rising by an additional 5 to 15 dearees.

He also shared temperature forecasts for other regions: Metro Manila (38.3 degrees Celsius), lowland Luzon (39.9 degrees Celsius), and Mindanao (39.5 degrees Celsius) in April.

PH El Niño team ready for severe drought

Solidum acknowledged the strong El Niño prediction for next year and emphasized the need for preparedness across various sectors.

"We need to further intensify our efforts to ensure we are ready for this, especially in areas like health, water, agriculture, sanitation, and peace and order," said Solidum.

"We also need everyone's involvement in this effort," he added.

President Marcos, responding to the El Niño forecast, instructed government agencies to coordinate plans to mitigate potential impacts. He specifically highlighted addressing possible issues related to water, agriculture, energy, health, security, and education, according to Solidum.

Inlinewith this, the president has ordered the creation of 'Task Force El Niño' to be led by the National Disaster Risk Reduction and Management Council (NDRRMC).

The establishment of the said coordinating body is necessitated by the importance of tapping a whole-of-government approach to mitigate the impacts of the phenomenon on the environment, economic security, and public safety.

"We'll have to organize first the task force. This is the time to put every condition together," said Marcos, urging everyone to take part in the active efforts of the government to enhance the climate resilience of the country.

To ensure minimal disruption across the country, the Philippine government is proactively preparing for the anticipated El Niño phenomenon and encouraging public awareness and collaboration.

Following this initiative, the development of a holistic information campaign that will intensify the promotion of ecological responsibility in communities has been projected especially in areas of efficient resource consumption and conservation. (JMP/PIA-

# SC clarifies need to prove criminal intent in cases

MANILA – The prosecution must still prove that an accused intentionally committed a prohibited act even if the offenses involved do not require criminal intent as an element.

The Supreme Court (SC) stressed this in reversing a Court of Appeals (CA) decision and acquitting a man convicted for violation of the law protecting buyers of subdivision and condominiums.

In a statement Thursday, the court said "dispensing with proof of criminal intent for crimes mala prohibita, where criminal intent is not an element, does not discharge the prosecution's burden of proving, beyond reasonable doubt, that the prohibited act was done by the accused intentionally." The SC ruling granted the petition for review filed by FelixValenzonachallenging the CA which had affirmed the Regional Trial Court's conviction for violation of Presidential Decree (PD) No. 957 or the Subdivision and Condominium Buyers' Protective Decree 957).

Valenzona was the president of ALSGRO Industrial and Development Corporation, a real estate company.

In 2003, ALSGRO entered into two contracts to sell with Ricardo Porteo two lots in ALSGRO's Bayfair of Margana Subdivision (subject contracts) in Laguna.

However, upon verification with the Registry of Deeds of Muntinlupa City in 2006, Porteo discovered that the subject contracts were not registered in accordance with Section 17 of PD 957. In reversing the conviction of the accused, the Court distinguished between "intent to commit the crime" and "intent to perpetrate the act."

"To hold Valenzona criminally liable, it must also be established that he had the volition or intent to not register or [to] cause the non-registration of the subject contracts, which the prosecution failed to do." the SC ruled.

The SC added that it cannot simply rely on the bare findings of a violation

of PD 957 committed by ALSGRO, and that Valenzona was the corporation's president.

"The Court must be satisfied that the nexus between Valenzona's position in the corporation, and the commission of the offense with which he was charged, has been shown. If such nexus is not required for purposes of conviction, and the mere pretext that a violation of PD 957 is malum prohibitum is deemed sufficient, then the President (or Manager or Administrator) of every corporation engaged in the realestatebusinesscovered by the law automatically becomes criminally liable for every violation of PD 957 committed by such corporation," the Court ruled, stressing that such is an absurd interpretation of the law. The greenhouse effect was explained, distinguishing between the natural human-enhanced Emphasizing processes. the impact of fossil fuel combustion, she revealed the heightened humanenhanced greenhouse effect contributing to global warming. The discussion delved into the extensive ramifications of climate change, including water scarcity, disruptions in food production, threats to health and well-being, impacts on urban infrastructure, and effects on biodiversity and ecosystems.

Estrebillo presented alarming trends in the Philippine climate, noting an increase in hot days and a decrease in cold nights. Variations in rainfall patterns were highlighted, impacting different regions of the country. While there was a slight decrease in the number of tropical cyclones entering the Philippine Area of Responsibility, an increase in their intensity was noted. The discussion also touched upon the contribution of warming conditions to rising sea levels, particularly affecting islands in Mindanao and the western coasts of Central and Western Visayas.
