## Researchers urge exploration of PH hot springs and volcanic microorganisms for biotech and pharma applications

The researchers suggest further microbial and natural product (NP) exploration of volcanoes and hot springs - underexplored habitats that will undoubtedly yield a huge repertoire of novel and biologically active compounds.

Microbial natural products (NPs) have been prominent sources of drugs for a long history, especially for cancer and infectious diseases and hot springs and volcanic environments represent valuable sources of novel natural products (NPs), yet largely untapped and understudied.

Given this, a study on "Bioactive Compounds from Hot Spring

and Volcanic Microorganisms," was conducted by a research team from the University of the Philippines Cebu and Adamson University.

There are almost 400 volcanoes located all over the country according to the Philippine Institute Volcanology of and about Seismology, 25 of which are considered active, and the Philippines is also endowed with many natural hot springs.

The study by the team of Dr. Fleurdeliz Maglangit surveyed the bioactive NPs from hot springs and volcanic microbes from 2006–2022, highlighting their chemical structures and biological potential.

"Microbial pathogens or microorganisms that are capable of producing diseases, quickly evolve new ways to combat drug therapy, more rapidly than theintroductionofnewdrugs and drug candidates to the clinical pipeline, that's why new sources of biologically active compounds effective against drug resistant cells are urgently needed," Dr. Maglangit said, one of the researchers.

The threat of antimicrobial resistance (AMR) and superbugs, which are microbial strains that have become resistant to the drugs used to treat them, have continued to rise rendering relentlessly. antibiotics the current and drugs ineffective for common infections.

AMR is considered the next silent pandemic.

According to the World Health Organization, AMR is one of the top 10 biggest threats of the century, causing nearly five million deaths annually and over 1.2 million deaths directly attributed to AMR.

"Hot springs and volcanic environments have been shown to harbor high microbial biodiversity with unique metabolic profiles, yet they remained untapped and understudied for their production of novel druggable chemical entities," Dr. Maglangit said.

The NPs isolated from hot springs and volcanic microbes represent diversity and structural novelty in comparison to the NPs isolated from terrestrial or marine habitats. The hot spring water temperatures provide favorable conditions for thermophilic microbes to generate a wide array of bioactive metabolites.

Hot springs, also called thermal springs, are springs with water temperatures above their surroundings. They are produced by geothermally heated groundwater which is warmed either by shallow intrusions of molten rock in volcanic areas or by circulation through faults to hot rock deep in the Earth's crust.

Hot springs are inhabited by heat-lovingmicroorganisms or thermophiles that can thrive at high temperatures. The diversity of these organisms has been mainly attributed to temperature. Other factors include pH, dissolved hydrogen sulfide levels, biogeography, and geological history.

Thermophiles have attracted significant interest in recent years for their production of heat-stable enzymes for biotechnological applications including industrial, agriculture, and medical processes.

Maglangit's team recommended the conduct of more extensive experiments, whether in animal models or human subjects since some of the compounds that have been identified from hot springs and volcanic microbes have only been tested in

vitro. springs have Hot shown to host a been variety of heatwide tolerating or thermophilic, microorganisms, and among these are the hot springs in Mt. Makiling, Los Baños, Laguna, as well as the Wonder Lake hot springs, also in Laguna, and the two hot springs in Benguet - Badekbek and

Dalupirip. Incidentally, the same research team is currently involved in a research project with Mainit Hot Springs located in Brgy. Montañeza, Malabuyoc, Cebu as the area of interest. Project ISAAC (Isolation. Screening, and Antimicrobial Activity Compounds from of Actinobacteria) aims to isolate, screen, and characterize thermophilic Actinobacteria the for production of bioactive compounds with the potential for drug development. To date, several thermophilic strains were isolated from Mainit HotSpringswithremarkable bioactivities against Gram-positive pathogens including Staphylococus aureus and Bacillus subtilis compared with gentamicin or oxytetracycline antibiotic control. Isolation and characterization of the bioactive compounds are currently underway in their laboratories.

The microbial species and chemical diversity in hot springs and volcanic habitats are indeed indicative of future exploration. These novel microorganisms will also produce likely novel druggable molecules.

The research is funded by the Department of Science and Technology-National Research Council of the Philippines (DOST-NRCP). The full report on this research will appear in the Philippine Journal of Science (PJS), the oldest science journal in the on June 2023 country issue. # PBBM WELCOMES MORE INVESTMENTS, ADVANCED AGRI-TECHNOLOGIES FROM BANGKOK-BASED BUSINESS CONGLOMERATE

President Ferdinand R. Marcos Jr. on Tuesday hailed the Bangkok-based business conglomerate which is planning to invest some US\$2.5 billion in agricultural technology development in the country.

Officials of Charoen Pokphand Group (C.P. Group) led by its chairman Chearavanont Soopakij paid a courtesy call Malacanang telling in President Marcos of the company's use of new technologies that it has incorporating been to boost the value of the agricultural sector.

For its expansion plans and business integration in the Philippines, the C.P. Group plans to invest US\$2.5 billion from 2023 to 2027, covering swine (US\$1.3 billion), poultry (US\$280 million), shrimp (US\$800 million), and food (US\$120 million).

"We're very impressed with the new technologies that you use. I remember you told me that each plant farm you build is different from the last one because you immediately incorporate and adopt techniques new in technology," Marcos told the C.P. Group executives, saying that it is the type of progression that he wants to be replicated in the Philippines.

In November 2022, C.P. Group officials met with President Marcos during his visit to Thailand, during which the company pledged to make additional investments in the Philippines.

The C.P. Group officials offered to bring in the stateof-the-art technology to fulfill the whole upstream and downstream raw materials up to the finished product for the market and for future exports.

Marcos said they would have to discuss with other stakeholders the viability of putting together a project that would also boost the production and resiliency

of the agriculture sector in the country.

"We will discuss amongst ourselves with all the others, those who will be helping put together the project. We will certainly see what is the most ideal way," the President said. Marcos also pointed out that the government has a vital part to play in implementing the

in implementing the project and keeping the momentum his administration has made in agriculture "moving forward."

"We know that the government has a part to play. It's not only the private sector partner. The government has a part to play to support the program and that's something that we have to decide," he added.

"Learning new things and applying new things, that's the only way I think to compete as well. C.P. Group has done so well... to be a state-of-the-art company."

The President also pointed out the country has the raw materials and a good labor force to complement available technology to boost the value chain in the agriculture sector

"Even in terms of the ecosystem of agronomists and agriculturists, experts in fisheries, experts in rice, in broiler production... we have many people who are very, very good. It's the system that we need," Marcos said.

"They're not working independently as if the other parts of the system don't exist. That's more or less where we find ourselves. Now...I suppose we could start from where we are and try to just keep improving," he added.

Marcos also recalled a time the Philippines was exporting rice to other countries. "That's why now we're trying to catch up. So yes, we, I'm sure we can. I'm sure that there has to be a way... to get all the lessons that have been learned by not only you, but everyone around the world," he said.

"I keep explaining to everybody that agriculture is not about planting and putting seeds into the ground. That's just a small, small, small part of it. It's a system. It's the research and development; iť s the mechanization," the President said, saying that non-mechanization is the reason the country has not been able to continue the process of consolidation to improve systems.

The C.P. Group is now a leading holding company in Thailand. It holds investments in 21 countries and economies worldwide, operating through more than 200 subsidiaries, and employing over 300,000 people.

It operates across eight business lines: agroindustry and food; retail and distribution; media and telecommunications; e-commerce and digital; development: property automotive and industrial products: pharmaceuticals; and. finance and investment.

During the meeting, the company officials requested government assistance in locating suitable land covering 400 hectares for aquaculture (shrimp) and 300 hectares for swine and poultry, including eggs.

Among the officials who attended the meeting with C.P. Group executives were Speaker Martin Romualdez, DeputyHouse Speaker and Pampanga Rep. Gloria Macapagal-Arroyo, and Frederick D. Go, Presidential Adviser on Investment and Economic Affairs.

A verified complaint was filed in this Court which aver that:

SPOUSSES JASMIN MOSADA and REGENALD MOSADA as represented by GEMMA DIGNOS & JOSEPH DIGNOS ("Spouses Dignos" and/or "Plaintiffs"), who are Filipino citizens, of legal ages, with residence address at Phase 3 Block 3 Lot 24, ACM Subdivision Alapan 1-A, Imus, Cavite, by counsel, and by way of this Complaint ("Complaint"), respectfully state:

#### FACTUAL ANTECEDENTS

1.1. Spouses Jasmin Mosada & Regenald Mosada constituted GEMMA DIGNOS and/or JOSEPH DIGNOS as their lawful attorneys-in-fact in relation to the construction of a two-storey house (the "Project"). Specifically, they were authorized to do all acts, matters and things whatsoever with respect to the Project.

1.1.1.The Special Power of Attorney granted to Ms. Gemma Dignos and/or Mr. Joseph Dignos by Spouses Regenald M. Mosada & Jasmin F. Mosada, notarized 26 December 2019, is marked and attached herein as Plaintiff's Annex "A".

1.2. Spouses Jasmin Mosada & Regenald Mosada likewise constituted GEMMA DIGNOS and/or JOSEPH DIGNOS as their lawful attorneys-in-fact in relation to the above-captioned case, with full power and authority to appear in all proceedings, meetings, hearings, conferences and negotiations involving this case, to appear at any and all mediation proceedings, pre-trial or preliminary conference or any meeting before the court and/or a court-appointed commissioner, to sign, verify, deliver and receive any and all agreements, instruments, pleadings, motions, notices, affidavits, and other documents and papers, execute the verification and certification of non-forum shopping, and other documents in relation to the matter at hand, and perform any and all acts incidental and necessary to accomplish the foregoing.

1.2.1. The Special Power of Attorney granted to Ms. Gemma Dignos and/or Mr. Joseph Dignos by Ms. Jasmin Mosada, as apostilled on 3 February 2022 by Hon. Roussel R. Reyes, Consul-General of the Republic of the Philippines to Qatar, is marked and attached herein as Plaintiffs Annex "B".

1.2.2. The Apostilled Special Power of Attorney granted to Ms. Gemma Dignos and/or Mr. Joseph Dignos by Mr. Regenald Mosada, as apostilled on 3 February 2022 by Hon. Roussel R. Reyes, Consul-General of the Republic of the Philippines to Qatar, is marked and attached herein as Plaintiffs Annex "C".

1.3. On 5 December 2019, Spouses Mosada and JP Llamoso Home Builders ("JP Llamoso Builders"), as represented by its owner and herein defendant Mr. Jean Paul Llamoso entered

#### into a Construction Contract.

1.3.1. A copy of the said Construction Contract dated 5 December 2019 is attached herein as Plaintiffs' Annex "D".

1.4. Under the aforementioned Construction Contract, JP Llamoso Builders is obliged to construct, build, and complete a two-storey house (the "Project").1 JP Llamoso Builders was given thirty two (32) weeks or one hundred ninety two (192) working days from the execution of the Construction Contract and acquisition of the Building Permit.2

1.4.1. The Building Permit was issued by the Bacoor City Office of the Building Official on 15 January 2020. A copy of the said Building Permit is attached herein as Plaintiffs Annex "E".

1.5. Also pursuant to the Construction Contract, Spouses Mosada were obliged to pay to JP Llamoso Builders the amount of Two Million Seven Hundred Seventy Thousand Pesos (Php2,770,000.00) (the "Contract Price") in different tranches.3

1.6. Of the Contract Price, Spouses Dignos, on behalf of Spouses Mosada, has as of even date paid Two Million Five Hundred Fourteen Thousand Five Hundred Pesos (Php2,514,500.00), detailed as follows:

1.6.1. On 28 November 2019, a payment was made in the amount of Six Hundred Ninety Two Thousand Five Hundred Pesos (Php692,500.00), for the payment of the downpayment as stated in the Construction Contract. A copy of the Acknowledgment Receipt issued by Jean Paul Llamoso pertaining to the foregoing is attached herein and marked as Plaintiffs' Annex "F".

1.6.2. Subsequently, a payment was made in the amount of Thirty Thousand Pesos (Php30,000.00), for the full payment of the Building Plan. A copy of the Acknowledgment Receipt issued by Jean Paul Llamoso pertaining to the foregoing is attached herein and marked as Plaintiffs' Annex "G".

1.6.3. A payment was likewise made in the amount of Eight Hundred Thirty One Thousand Pesos (Php831,000.00), for the full payment of the first billing. A copy of the Acknowledgment Receipt issued by Jean Paul Llamoso pertaining to the foregoing is attached herein and marked as Plaintiffs' Annex "H".

1.6.4. Also, a payment was made in the amount of One Hundred Thirty Thousand Pesos (Php130,000.00), for the partial payment for the gate and fence. A copy of the Acknowledgment Receipt issued by Jean Paul Llamoso pertaining to the foregoing is attached herein and marked as Plaintiffs' Annex "I".

1.6.5. Moreover, a payment was made in the amount of One Hundred Thirty Thousand Pesos (Php130,000.00), for the advanced payment for the second billing. A copy of the Acknowledgment Receipt issued by Jean Paul Llamoso pertaining to the foregoing is attached herein and marked as Plaintiffs' Annex "J".

1.6.6. Lastly, a payment was made in the amount of Seven Hundred One Thousand Pesos (Php701,000.00), for the full payment of the second billing. A copy of the Acknowledgment Receipt issued by Jean Paul Uamoso pertaining to the foregoing is attached herein and marked as Plaintiffs' Annex "K".

1.7. Despite the faithful and consistent payment by the Plaintiffs of the Contract Price, the work constructed by the Defendants in relation to the Project remained bare and unsatisfactory, not to mention that the Defendants failed to observe the period of construction agreed upon, as discussed in Paragraph 1.4 and its sub-paragraph of this Complaint.

1.8. Pursuant to such non-compliance, the Plaintiffs sent an Official Demand Letter dated 12 May 2021 to demand the return of the sums of money they paid in relation to the failure of the Defendants to construct the Project. A copy of the said demand letter is attached herein and marked as Plaintiffs' Annex "L".

1.9. The Plaintiffs also sent a Final Demand Letter dated 23 October 2021, again reiterating the refund of the sums of money they paid. Notably at this juncture, the Defendants already refunded Seventy Thousand Pesos (Php70,000.00) sometime in March 2021 to the Plaintiffs. A copy of the said final demand letter is attached herein and marked as Plaintiffs' Annex "M'.

1.10. Failure to heed the said demands, the Plaintiffs were given no choice but to institute this instant action.

1.11. It is of note that the promise of the Defendants to refund is contained in their Facebook Messenger message addressed to Spouses Mosada which they share to the Spouses Dignos as their attorneys-in-fact. In the said Facebook message, the Defendant Llamoso mentioned that the Spouses Mosada had the option to either continue with the project but there will be a delay of an additional three (3) months, or stop the same and seek refund. A printout of this Facebook Messenger message is attached herein and marked as Plaintiffs' Annex "N".

1.12. In another Facebook Messenger message, Defendant Llamoso mentioned that he will issue post-dated checks for the refund. However, no such

checks were remitted. A printout of this Facebook Messenger message is attached herein and marked as Plaintiffs' Annex •o•.

#### II. RESCISSION

2.1. As held by the Supreme Court in the case of George C. Fong vs. Jose V. Duenas4, "as a contractual remedy, rescission is available when one of the parties substantially fails to do what he has obligated himself to perform. It aims to address the breach of faith and the violation of reciprocity between two parties in a contract.• Moreover, the Court had the occasion to state that "the power to rescind obligations is implied in reciprocal ones, in case one of the obligors

should not comply with what is incumbent upon him."

2.2. As applied in the instant Complaint, the Defendants are already in substantial breach of its obligations under the Construction Contract dated 5 December 2019 for-failing to construct the Project within the specified period and for failing to make substantial and satisfactory construction works for the Project. It must be noted that it has almost been three (3) years since the execution of the Building Permit. The construction is now far beyond the period contained in the Construction Contract, as discussed in Paragraph 1.4 of this Complaint.

2.3. Under Article 1191(2) of the Civil Code of the Philippines,5 "the injured party may choose between the fulfillment and the rescission of the obligation, with the payment of damages in either case. He may also seek rescission, even after he has chosen fulfillment, if the latter should become impossible.•

2.4. In this instant case, the relief sought by the aggrieved Plaintiffs is that of rescission, instead of fulfillment, as the Defendants made themselves scarce when being confronted about the matter.

#### III. DAMAGES

3.1. It is likewise provided in the provision of law cited that rescission may be coupled with damages.6

3.2. Likewise as held by the Supreme Court in the case of Spouses Luigi

M. Guanio and Anna Hernandez-Guanio vs. Makati Shangri-la Hotel and Resort, Inc.,7 • the mere proof of the existence of the contract and the failure of its compliance justify, prima facie, a corresponding right of relief."

3.3. Also as discussed in the aforementioned case, "a breach upon the contract confers upon the injured party a valid cause for recovering that which may have been lost or suffered" (emphasis supplied). The remedy serves to preserve the interests of the promissee that may include his "expectation interest- the interest in having the benefit of his bargain by being put in as good a position as he would have been in the contract been performed; his "reliance interest" - which is his interest in being put in as good a position as he would have been had the contract by being put in as good a position as he would have been had the contract in the end at the contract by being put in as good a position as he would have been had the contract in the performed; or his "restitution interest" - which is his interest in having restored to him any benefit that he has conferred to the other party.

3.4. In this case, it is not hard to see that all the three interests mentioned above need preservation. The Plaintiffs expected that their dream two storey house when they return home from working abroad will come to fruition when they entered into the

Construction Contract with the Defendants. Their reliance on the Defendants on the construction of the same is also apparent and hard to deny, as they were the ones in possession and control of the property all this time. Lastly, the Plaintiffs deserve restitution on the sums of money they paid since the Defendants fail to deliver on their promises under the Construction Contract.

#### IV. WITNESSES

(i) Ordering the Defendants for the refund of Two Million Five Hundred Fourteen Thousand Five Hundred Pesos (Php2,514,500.00), as actual damages;

(ii) Ordering the Defendants for the payment of One Million Pesos (Php1,000,000.00) as actual damages for the preservation of the expectation interest, reliance interest, and restitution interest of the Plaintiffs;

(iii) Ordering the Defendants to pay the Defendants attorney's fees amounting to not less than Two Hundred Fifty Thousand Pesos (Php250,000.00), and litigation expenses and cost of suit.

The Defendants likewise pray for such other relief as the Honorable Court may deem just or equitable.

# Gov't urges increased budget disbursement as utilization rate reaches 90%

QUEZON CITY (PIA) --The Department of Budget and Management (DBM) has called on government agencies to accelerate their budget disbursement spending following and the announcement that utilization rate of the government agencies reached 90% between January and April 2023.

The DBM recently published a report on the utilization of Notices of Cash Allocations (NCAs) for national government agencies, as well as budgetary support to Government-Owned or -Controlled Corporations and (GOCCs) Local Government Units (LGUs). The report, available on the

The SLP continues to be Department's lead the livelihood capabilitybuilding program for vulnerable, poor, and marginalized households and communities. that helps improve their socioeconomic conditions through accessing and acquiring necessary assets to engage in and maintain thriving livelihoods. DBM website, reflects the latest data on the utilization rate as of the end of April 2023.

During the aforementioned period. government agencies utilized a total of P1.175 trillion in NCAs, representing a utilization rate of 90%. NCAs serve as cash authority documents issued by the DBM to agencies or operating units through authorized government servicina banks, ensuring sufficient cash allocation for their respective programs and projects.

DBM Secretary Amenah Pangandamanemphasized the critical role of the national budget in funding government initiatives, stating, "We all know that our national budget is the lifeblood of all government programs and projects. The faster we disburse and utilize our funds, the faster we can procure and implement our projects."

Secretary Pangandaman urged agencies to avoid underspending, citina the limited fiscal space available. Moreover, she emphasized the importance of discipline within national government agencies, warning that funds may be reallocated to agencies capable of effectively implementing them. Secretary Pangandaman reiterated the previous announcement made at the beginning of the year, stating that only implementationready proposals would be considered for inclusion in the 2024 Budget.

As of April 30, 2023, the DBM has disbursed P2.982 trillion, which accounts for 94.8% of the total agencyspecific budget allocated to national government agencies. Overall, the DBM has released P4.518 trillion, equivalent to 85.8% of the P5.268 trillion national budget, as of the same date.

TheDBM'scallforincreased budget disbursement aims to ensure efficient utilization of funds and prompt project implementation, contributing to the successful execution of government programs and initiatives. (dbm/pia-ncr)

### Court convicts former Cainta execs, orders arrest of former mayor

MANILA The Sandiganbayan Sixth Division has ordered the arrest of the former mayor of Cainta, Rizal to face graft charges after the tribunal convicted three other municipal officials charged with him over transactions dating back to 2000.

The anti-graft court, in its decision dated May 30, ordered the issuance of warrants of arrest against Nicanor Felix and his co-accused municipal Herminia treasurer Mendoza Cruz, municipal accountant Ophelia Cruz De Guzman and private individual Ariel Bautista to stand trial.

The court in its ruling also found Felix's coaccused municipal budget officer Privada Gonzales, municipal bidding committee member Marciano Doroteo, and budget officer Glady Formales guilty on three charges of graft and sentenced them to up to 26 years imprisonment as well as fines.

The charges arose from alleged irregularities in transactions entered by the localgovernmentunit(LGU) without competitive bidding with suppliers, particularly the procurement of a Contex scanner from Joriel Trading worth PHP1.4 million and the procurement of miscellaneous supplies from Tueance Alera Gentrade Industries worth PHP448.607 in 2000. The records of the case against Felix and the coaccused was ordered archived subject to revival upon their arrest or

voluntary surrender. "In the meantime, let alias warrants of arrest be issued against (the) accused," the court ordered. (PNA)

# Tax court affirms previous ruling clearing Ressa on tax raps

MANILA – The Court of Tax Appeals (CTA) has affirmed its earlier ruling clearing online news publication Rappler Holdings Corp.(RHC) and its publisher Maria Ressa on tax evasion charges.

In its 11-page decision dated May 18 and written Associate Justice bv Catherine T. Manahan, the tax court First Division "denied for lack of merit" the motion for reconsideration filed by the government and said it "finds no compelling reason to reverse or

modify" its earlier decision acquitting Ressa.

The government claims income tax deficiencies on the part of RHC arising from trading income from the issuance of Philippine Depositary Receipts (PDRs) to foreign entities on various occasions and willfully failed to pay income tax and value added tax for 2015 as a dealer in derived securities that income from the purchase and sale of securities covered by the PDRs. ruled The tax court

# BI warns anew vs. call center job scams in Myanmar, Thailand

MANILA – The Bureau Immigration (BI) on of Wednesday reiterated anew its warning against a call center job scam that recruits Filipinos, mostly professionals, to work abroad.

This came following the BI's repatriation of nine Filipinos trafficked in Thailand and Myanmar.

statement, BI In а Commissioner Norman Tansingco said the victims have good background in the Philippines before being recruited in these countries.

"These latest batch of victims show that traffickers are using the same modus to recruit young professionals to seemingly-good call center jobs abroad ... Only to find out that it is a scam," he said.

Three of them -- two males and a female -- were brought home from Myanmar last May 30; while the remaining six, aged 20s to early 30s, were rescued from Bangkok last May 29.

"The new face of victims now are really professionals with good jobs here in the country but seek adventure abroad, Tansingco said.

Like other illegal recruitment victims tend to schemes, different disclose travel purposes.

"Some of them are even traveling with their partners or claimed they will be visiting family, and have previous travels," Tansingco said.

The victims left the country in 2022 and earlier this year. (PNA)

### BSP eyes May inflation at 5.8% to 6.6%

MANILA - Upticks in the prices of rice, vegetables and several other key food items are projected to drive the country's inflation rate for May 2023 to between 5.8 percent to 6.6 percent.
