NEW MEGA HEALTH CENTER SEEN TO DECONGEST HOSPITALS IN CAVITE

CAVITE CITY (PIA) – Anew 100-bed 3-storey mega health center in Cavite that will cater to the needs of a growing population in Cavite's 1st district aims to ease overcrowding in hospitals.

The Cavite City Medcare Mega Health Center, located in Barangay 28, Sea Breeze, Cavite City will provide free, accessible, and quality public health care services to Caviteños through its medical surgical, outpatient, diagnostic, birthing, emergency, and pharmacy services.

Health Secretary Teodoro Herbosa together DOH Assistant with Secretary Dr. Ariel Valencia, led the turnover ceremony, which was graced by Cavite City 1st District Rep. Ramon Jolo B. Revilla III, Cavite City mayor Denver Reyes-Chua, Cavite board member Ram Revilla-Bautista, and other city officials.

Cavite's 1st district is composed of Cavite City and the towns of Noveleta, Kawit, and Rosario.

Sec. Herbosa assured the public that the DOH will continue its commitment to improving the quality of health services in the country, and will support the efforts of local government units and its leaders to alleviate poverty through the 8-point action agenda of the department.

"The establishment of mega health centers like this is a way for us to finally achieve and strengthen universal health care. [We believe] that every life is valuable in Bagong Pilipinas," Herbosa said in his keynote message.

Herbosa also pledged to work on the immediate provision of additional health equipment to ensure the efficiency of the new facility.

Meanwhile, Revilla said that the health facility is a priority project of him and his father, Senator Ramon Bong Revilla Jr., and has committed to the continuous development of the health center.

"The opening to the public of this Mega Health Center fulfills our promise during the campaign period to establish a new public hospital in our district that will enhance the quality of public service and address the medical needs of our fellow citizens. What used to be just a dream for us is now a reality. We will further improve and enhance the services of this facility for every Caviteño," he stated. Chua expressed gratitude to the DOH and the Revillas their commitment to making the project a reality, which he expects will provide further urgent care to his constituents and fellow Caviteños.

The mega health center is expected to be fully operational this April. (RF/ PIA-Cavite)

'Child-friendly' LGUs recognized for effective child welfare, protection initiatives

CARMONA CITY, Cavite (PIA) – Local government units should remain vigilant in ensuring the safety of children and creating a community that will protect them from all kinds of abuse, a town mayor stressed during a recognition ceremony for the Seal of Child-Friendly Local Governance (SCFLG).

The Council for the Welfare of Children (CWC), along with the Department of the Interior and Local Government (DILG) IV-A and the Department of Social Welfare and Employment (DSWD) IV-A, recognized 63 LGUs in Calabarzon during the

2022 SCFLG awarding ceremony on April 4, for their exemplary performance in enacting programs and policies aimed at protecting children from abuse.

The 2022 SCFLG assessed all 142 local government units in the Calabarzon region through the following indicators categorized under the four categories of children's rights: survival, development, protection and participation, and governance.

In a message of support, Agoncillo, Batangas Mayor Cinderella Valenton Reyes said local government units must protect the rights of children and not make compromises on cases of child abuse.

"The law dictates that we cannot make compromises in cases of child abuse. We, as elected officials, have to take a stand. We cannot make compromises on cases like these," Reyes said.

The local chief executive believes that local leaders have a moral obligation to be an instrument for the welfare and development of children.

"We are all tasked by our Lord and the law to be vigilant and protect our youth. When the time comes, it is very difficult for a victim to find their voice and ultimately speak out against the abuse inflicted upon them," Reyes added. Agoncillo is one of the 11 cities and municipalities in Batangas Province that received the 2022 SCFLG. They are joined by 13 LGUs in Laguna, 10 in Rizal Province, and 15 in Quezon Province.

Meanwhile, Carmona stands with the 14 LGUs in Cavite province to receive the award, having achieved a perfect score of 100 points in the 2022 audit.

DOH raises alert on pertussis in Calabarzon

CALAMBA CITY (PIA) – The Department of Health (DOH) in CALABARZON has activated its Incident Management Team (IMT) to augment the needs of local health offices following the declaration of a code blue alert in the region against pertussis.

In a Code Blue Alert, LGUs and health facilities are expected to provide surveillance reports on pertussis cases to the Incident Command Systems to facilitate timely updates and data analysis.

Regional Disaster Risk Reduction and Management in Health (RDRRM-H) officer-in-charge, Joehl Francisco, urged local health offices to actively report suspected and confirmed cases of pertussis within 24 hours to prevent the virus from further spreading.

"We highly encourage local health personnel to co-locate because one of our findings upon institutionalizing local government units in terms of DRRM-H (disaster risk reduction and management in health) is that they are located within the operations center," Francisco said.

He further explained: "We want reporting to be on time, and as much as possible, instances where individuals experience symptoms should be reported within 24 hours to prevent the disease from spreading."

Citing the country's experience during the COVID-19 pandemic, the DOH Calabarzon and its local counterparts will adopt the 'Prevent-Detect-Isolate-Test-

of their own lives, make informed decisions, and be engaged in the processes that affect them," the lawmaker declared.

Mylah Gatchalian, assistant regional director for operations of DSWD IV-A, emphasized that towns and cities that are considered "child-friendly" always include children in their programs, legislation, and services.

"Great leaders create vibrant tirelessly emphasizing spaces inclusivity and ensuring children of all abilities can participate. Leaders who are champions of childfriendly local governance, giving priority to children in planning, budgeting, legislation, and delivery of services to assure that the rights of a child are realized," Gatchalian said. (PB/PIA-4A)

Reintegrate' (PDITR) strategy on top of other infection prevention control measures.

The health department also reminded health facilities to implement infection prevention control protocols, such as proper disposal of infectious wastes.

"Infection prevention and control, as well as physical distancing inside health facilities are very important. The public is also encouraged to wear face masks to prevent infection, especially in large gatherings," the health officer said.

Other precautions to observe include proper and regular handwashing, keeping infants and children away from individuals with suspected symptoms, and having their children vaccinated.

The DOH Calabarzon assured the public of their readiness to accommodate the possible influx of outpatient consultations and admissions in health facilities, with their sufficient human resources, supplies, and equipment in rural health units and hospitals. (PB/PIA-4A)

DOST, LGU Mambajao upskill Incident Management Team

To enhance resilience, the Department of Science and Technology, in collaboration with the Local Government Unit of Mambajao, conducts Basic Incident Command System at the new Operation Center building in Lakas, Mambajao. The training was participated in by 40 members of the Incident Management Team of the MDRRMO.

The technical experts from the Office of the Civil Defense, Provincial Government of Lanao Del Norte and Bukidnon, and Local Government Unit of Tagoloan shared their expertise for the Basic Incident Command System Training. The event was participated by various representatives from LGU Mambajao, Philippine National Police, Bureau of Fire Protection, Philippine Coast Guard, DOST, and

The three-day workshop conducted on February 7-9, 2024 was composed of a series of lectures, brainstorming, and simulations that explained to the attendees the basics, the organization, and the facilities of the ICS.

In her opening message, Ms. Raquel Ranara of MDRRMO - Mambajao, emphasizedtheimportance of preparedness before a disaster occurs. "It is always better to be prepared in any event or case of any incident," she said.

The activity focused on training participants in handling unforeseen events, applying management by objectives principle, and mastering essential resource management within an Incident Command System (ICS). Additionally, it aimed to enhance participants' comprehension considerations in incident and event planning, emphasizing significance of transfer of

command, demobilization, and close-out processes. "An Incident Action Plan is very important in the execution of the rescue operations", said Mr. Patrick Callanta, speaker from the Office of the Civil Defense.

This event highlighted the commitment of the government to achieve disaster resilience by incorporating Incident Command Systems in the effective management of potential and actual disaster consequences in the Municipality Mambajao.

DOST and LGU Mambajao has also recently conducted the Incident Command System (ICS) Executive Course also as part of the implementation of the MOCCOV project.

Upcoming training includes Emergency Operations Center Training, Integrated Planning on Incident Command System Training, Incident Command System Position Course, and All-Hazards Incident Management Team Training. (Engr. George Pio G. Aclan/DOST 10)

AAPCU now has 11 nominees, extends deadline to April 21

The awards was initiated by former President Gloria Macapagal-Arroyo and Chinese Foreign Minister Wang Yi in 2021.

Previous winners include former First Lady Imelda Marcos whose pioneering visit to China in 1974 led to the establishment of diplomatic relations between the two nations on June 9, 1975.

Lavina said APPCU has become a major national project with its awarding ceremony now a main event in the celebration of the establishment of diplomatic ties during the week of June 9.

This year's award rites will be held on June 7 at the Manila Hotel.

MANILA – A further cut in banks' reserve requirement ratio (RRR) is still possible, the Bangko Sentral ng Pilipinas (BSP) said.

"Wewanttoeventually reduce the reserve requirement, but we're trying to figure out the right timing. We will raise it at the Monetary Board meeting at some point soon and that is another thing," BSP Governor Eli Remolona Jr. told reporters in a briefing late Monday.

In June last year, the RRR of universal and commercial banks and non-bank financial institutions with quasi-banking functions were slashed by 250 basis points to 9.5 percent.

However, Remolona said the 9.5 percent is not low enough, adding the said RRR puts the Philippines as the highest in Asia.

"So, when to do it, and how much would be reduced to the requirement, that's one of the things we want to look forward to," he said.

Sought to comment on whether a cut in RRR is possible within the third quarter of this year, Remolona

said "it is unlikely."
Meanwhile, Rizal Commercial
Banking Corporation chief
economist Michael Ricafort
said on Tuesday that the
BSP could cut RRR this year
or in 2025 if the economic
and monetary environment
are already conducive to do
so.

"Reserve requirements cuts, if already allowed by well anchored inflation and would not lead to higher inflation at some point in the future, would increase banks' loanable funds," he said.

Ricafort said this will help reduce intermediation costs with lower cost of reserve requirements that will help stimulate more demand for loans, increase investments and other business activities which will lead to faster overall economic growth.

"Every 1 percentage point cut in large banks' RRR is equivalent to about PHP142 billion infused into the banking system that can be used for more loans, investments, expansion, among other uses of funds," he added. (PNA)

Marcos turns over Balanga housing units to 216 relocated families

President Ferdinand R. Marcos Jr. on Tuesday turned over housing units to 216 informal settler families in Balanga, Bataan affected by the cleanup and relocation operations in hazard-prone areas.

The relocated settlers used to live along the Talisay River.

The Balanga City Low-Rise Housing Project of the National Housing Authority (NHA), located in Barangay Tenejero, features six condominiumstyle buildings.

Each unit, measuring 27 square meters, is equipped with two bedrooms, a kitchen, toilet, bath, and fully operational water and power supplies.

In his message, Marcos said the project is part of the government's Pambansang Pabahay para sa Pilipino Housing (4PH) program, which aims to address the six million housing backlog by 2028.

"Sa loob ng maraming taon, humarap kayo sa peligrong dala ng pagtira sa tabi ng ilog. Kaya narito tayo upang bigyan ng lunas kanilang suliranin ang (For years, you faced the dangers of living by the river. So, we are here to give a solution to their problem)," Marcos said in his speech.

"Kavo ngayon maninirahan sa sariling bahay ligtas, dena kalidad, at komportable. lamang po Ngayon pa ay binabati ko na ang ating mga benepisyaryo congratulation pagsisimula ng panibagong yugto ng inyong buhay (You can now live in your own house that is safe and comfortable. As early as now, I am extending my congratulations to our beneficiaries for starting this new phase of your life)!" he added.

The President also assured government the remains committed building more safe, quality, and comfortable housing units.

The NHA also plans to build basic facilities in the housing community, such as a fourstory school building with 20 classrooms, a multipurpose building, and a

covered basketball court. Acommunity center building has also been constructed within the housing project to ensure that beneficiaries will have access to basic commodities, educational facilities and community needs.

It houses a health center, daycare center, barangay learning hub, offices of the homeowners' association and a local government unit housing satellite office. (PNA)

Ferdinand R. Marcos Jr. on Wednesday announced that the April 30 deadline for the franchise consolidation of public utility vehicles (PUVs) will no longer be extended.

During the Bagong Pilipinas Town Hall Meeting on Traffic Concerns, Marcos was asked by a representative of the transport sector about the nearing deadline consolidation franchises PUVs.

"Wala na pong extension, kailangan na kailangan na natin 'yan (No more extensions, we really need that already)," Marcos responded.

"Titiyakin lang natin na hindi mapabigat ang babayaran at iuutang ng driver at operator kaya ginagawa nating maayos at ginagawa nating well organized 'yung sistema (We just have to make sure that the drivers and operators will not be burdened with the

payment and loan, so we are making the system well organized)," he added.

The consolidation requires PUV operators to form cooperatives or corporations to access business financing in acquiring modern jeepney units.

It is part of the government's PUV modernization program that started in 2017.

Failure meet the to consolidation deadline will result in the revocation of franchises of noncompliant operators. barring them essentially from operating.

deadline consolidation application was originally set for 31, 2023, but the President approved the recommendation of the Department of Transportation to extend the deadline to April 30, 2024. (PNA)

Malacañang exec explains PH Journalist's Code of Ethics

DAVAO DEL NORTE (PIA) -- Top officials of Presidential Task Force on Media Security (PTFoMS) recently oriented Information Officers Network (ION) e as well as media practitioners in Davao del Norte on the Journalist's Philippine Code of Ethics and on the working definition of "media workers.'

PTFoMS Executive Undersecretary Director. Paul M. Gutierrez, explained that the Journalist's Code of Ethics was drafted by the Philippine Press Institute (PPI) and discussed and finalized in a multilateral workshop conference held during the National Press Week in 1988.

added that workshop was attended by representatives from the PPI, National Press Club, Philippine Movement for Press Freedom (PMPF), NationalUnionofJournalists (provisional committee), Kapisanan ng mga Manggagawa sa Media sa Pilipinas, Press Freedom Foundation of Asia, and the Photojournalists Guild of the Philippines.

Gutierrez discussed the 11 points of the Journalist's Code of Ethics, explaining the relevance of each point to government information officers and to private media practitioners.

"Don't feel na irrelevant po ang ating mga PIOs (public information officers) sa ganitong mga pagtitipon. Kayo po ay kabahagi sa mas malawak na pamilya ng media sa atin pong bansa," he said during the forum.

(Don't feel that our PIOs (public information officers) are irrelevant in such gatherings. You are part of the broader family of media in our country.)

Attended by information officers of local government units national and government agencies and private media practitioners, the forum served as the learning session of the monthly meeting of ION in Davao del Norte

During the session, lawyer Hue Jyro U. Go, the PTFoMS chief of staff, discussed Administrative Order No. 01 (AO 1), which created the Presidential

Task Force on Violations of the Right to Life, Liberty, and Security of the Members of the Media" and highlighted the definition of "media worker."

He said that the operational basis of the basic mandate of PTFoMS is contained under Section 2 of AO1, Series of 2016, which created thePresidential Task Force on Violence Against Media Workers "shall have the and mandate of ensuring a safe environment for media workers '

Led by an Executive Director, PTFoMS chaired by the Department of Justice (DOJ) and cochaired by the Presidential Office, Communications the Department of Interior and Local Government. Department National Defense, of Solicitor General, Armed Forces of the Philippines, Philippine National Police, National Bureau Investigation, of and Presidential Human Rights Committee as member agencies

Meanwhile, Go defined media worker based on Section 1 of AO 1 as those who are engaged, whether as a principal occupation or not, in media practice, print, including internet, radio broadcasts commentaries, and or television

He added that media workers are to be understood as those who are legitimately engaged in media practice, directly or indirectly, whether as a principal occupation or not, including but not limited to reporters, anchorpersons commentators, columnists, cameramen, photographers in print, on the internet, radio, and on television."

the other hand, Gutierrez made it clear that based on the legal and operational definition of the media workers, he found no distinction whether they are government information officers or private media practitioners.

During the forum, ION Davao del Norte former vice president Joan Lanciola said that the determination who should be recognized as legitimate

Matters regarding the guidelines and rules of conduct for the 2024 Bar Examinations will be announced in subsequent Bar bulletins.

Housing chief vows support to LGUs, coordination with gov't agencies

MANILA - Department of Human Settlements and Urban Development (DHSUD) Secretary Jose Rizalino Acuzar promised the Department's firmer support to local government units (LGUs) and bolster coordination with other national agencies aovernment (NGAs).

Acuzar made this remark as he expressed enthusiasm in the signing of the Joint Memorandum Circular (JMC) on Public Financial Management with LGUs and NGAs on April 3.

"This [signing] marks a significant step forward in our collective effort to empower LGUs and achieve stronger public financial management,' Acuzar said in a news release on Sunday.

He said JMC "ushers in several significant changes to our existing policy guidelines."

This is another solid proof of the administration's pursuit to Bagong Pilipinas brand of governance," he added.

He guaranteed DHSUD's commitment to "foster the improved coordination among oversight agencies, strengthen LGU support to equip them with the necessary tools and knowledge for local land development use and planning."

Acuzar also pledged to "ensure an efficient process for reviewing and approving plans while facilitating their alignment with regional and national priorities."

The formulation of the JMC was spearheaded by the Department of the Interior and Local Government (DILG) headed Secretary Benhur Abalos Jr.

The JMC was primarily designed to enable better coordination among government national agencies led bv DILG, DHSUD, the National Economic and Authority Development (NEDA), Department of **Budget and Management** (DBM) and the Department Finance's Bureau

Since the DOT will be one of the data sources for the project, RD Castro mentioned that this endeavour is a good step towards the improvement of the system and coverage of data collection of the agency to answer the need for more tourism data.

FDI net inflows up in Feb 2024

MANILA - Foreign direct investments (FDI) net inflow went up by 89.9 percent in February this year.

Data released by the Bangko Sentral ng Pilipinas (BSP) on Wednesday showed that FDI net inflows during the month amounted to USD907 million, up from the USD478 million recorded in January 2023. FDIs include investment

by a non-resident direct investor in a resident enterprise, whose equity capital in the latter is at least 10 percent, and investment made by a non-resident subsidiary or associate in its resident direct investor. The BSP said an FDI can be in the form of equity capital, reinvestment of

earnings, and borrowings. "The increase in FDI was supported mainly by the 173.2 percent expansion non-residents' investments in debt instruments to USD820 million from USD300 million in January 2023," said the BSP.

Reinvestment of earnings also increased by 16.4 percent to USD99 million from USD85 million.

The BSP said top sources of FDIs during the month include Japan and the United States.

These were channeled primarily to manufacturing, real estate, construction, and wholesale and retail trade industries. (PNA)

HERT measures 40 meters in length, runs at a top speed of 50 kph, and can carry 240 passengers per trip. It has two variants-- the 160-passengers per coach model and the bigger 240-passengers per coach model. It runs on a combination of diesel and fuel

and a 260-battery generator, thus referred to as a hybrid. HERT does not need infrastructure reconfiguration as it runs on ordinary paved roads similar to the Bus Rapid Transportation system.
