# Imus commemorates National Flag Day, Battle of Alapan's 125th anniversary

IMUS CITY, Cavite (PIA)

— The city government of Imus and the National Historical Commission of the Philippines (NHCP) led on Sunday, May 28 the commemoration of the 2023 National Flag Day and the Battle of Alapan's 125th Anniversary in Imus Heritage Park.

To mark this year's commemoration, the historic city of Imus unveiled the "Bantayog ng Inang Laya," which was built to represent Philippine Independence.

The inauguration and ceremonial wreath-laying andflag-raising ceremonies were led by Senator Francis M. Tolentino and Mayor Alex Advincula, Cavite 3rd District Rep. Adrian Jay Advincula, National Historical Commission of the Philippines (NHCP) Chairman Emmanuel Franco Calairo, and other local officials.

In his message, Advincula called on the parents to be one with the educators in instilling in their children the love of country and being proud of the Filipino race, stressing the waning spirit of nationalism among Filipinos.

"Tungkulin natin bilang mga magulang at mga nakatatanda na buhayin ang diwa ng nasyonalismo sa kanila. Tulungan natin silang pahalagahan at bigyang galang ang kaganapan ng kasaysayan," Advincula said.

Meanwhile, citing the role of history in the country's progress and development, Dr. Calairo recalled the events leading to the historic Battle of Alapan. He said the battle reignited the Philippine revolution toward the attainment of the nation's freedom.

Meanwhile, recognizing the sacrifices of every Filipino, Senator Tolentino stressed his long-time dream for a second Battle of Alapan — one which will signify equality and freedom of his countrymen from poverty. "Ingatan po natin ang alaala ng Labanan sa Alapan, Ingatan po natin ang ating Watawat na

alaala ng Labanan sa Alapan, Ingatan po natin ang ating Watawat na tunay na sumasalamin sa ating mithiin. Ingatan po natin ang katarungan at karangalan ng ating bayan, at pagyamanin sa bawat sandali, sa bawat dako at sa ibabaw ng lahat, paglingkuran ang ating dakilang bayan," Tolentino said

The Battle of Alapan is considered the first military victory of the Filipino Revolutionary Army under General Emilio Aguinaldo following his return from exile in Hong Kong. It led to the declaration of Philippine Independence on June 12, 1898, in Kawit, Cavite.

Proclamation No. 374, signed on March 6, 1965, by Former President Diosdado Macapagal, declared May 28 of every year as National Flag Day to commemorate the event the national emblem was first unfurled after Aguinaldo's forces defeated the Spanish regiment in the Battle of Alapan.

Section 26 of Republic No. 8491, also known as the 'Flag and Heraldic Code of the Philippines' also declared May 28 to June 12 of each year as "Flag Days," in which, all offices agencies, and instrumentalities of the government, business establishments, institutions of learning and private homes are enjoined to display the Philippine Flag. ## Pag-IBIG releases nearly P16B in cash loans from Jan-April

MANILA - Pag-IBIG Fund released PHP15.82 billion in cash loans in the first four months of the year, an increase of 5 percent from the PHP15.10 billion released during the same period last year, agency officials announced Wednesday.

The amount of Multi-Purpose Loans disbursed by the agency helped 728,653 members with their financial needs.

"We at Pag-IBIG Fund exert all efforts in providing our members with assistance on their financial needs. We are happy to note that through our Pag-IBIG Multi-Purpose Loan, we were able to aid more than 700 thousand Filipino workers gain added funds to tend to their needs. All our efforts are in line with the call of President Ferdinand Marcos, Jr. to provide the best service to the Filipino people," said Secretary Jose Rizalino Acuzar, who leads the Department of Human Settlements and Development (DHSUD) and the 11-member Pag-IBIG Fund Board of Trustees.

Pag-IBIG Fund's Multi-Purpose Loan or MPL is the agency's affordable and easily accessible cash

Under the Pag-IBIG MPL, qualified members can borrow up to 80 percent

of their total Pag-IBIG Regular Savings, which consists of their monthly contributions, their employer's contributions, and accumulated dividends earned.

The proceeds can be used to pay for tuition, medical expenses, minor home improvement, a family trip, or even serve as capital for small businesses.

The loan is payable in 24 or 36 monthly installments, with the first payment deferred for two months.

The Pag-IBIG MPL comes at a low-interest rate of 10.5 percent per year. In the past years, the agency

has returned more than 90 percent of its income to its members in the form of dividends.

Pag-IBIG Fund chief executive officer Marilene Acosta said the agency now provides members with numerous ways to conveniently apply for a Pag-IBIG MPL through its more than 200 branches, its more than 200 branches, its online facility Virtual Pag-IBIG found on its website and the Virtual Pag-IBIG mobile app.

"Each year, over 2.5 million members rely on the Pag-IBIG MPL for their immediate financial needs. More than being a reliable source for cash, our MPL is now more accessible to members. In addition to applying for

a loan by submitting their applications through their employers or at a Pag-IBIG branch, our members may now also apply for a Pag-IBIG MPL wherever they are, online, with the Virtual Pag-IBIG. This makes the Pag-IBIG MPL more reliable and more accessible than ever," Acosta said.

In total, the Pag-IBIG Fund released PHP16.44 billion in short-term loans benefitting 766,258 members from January to April.

This includes the amount released under the Pag-IBIG MPL and the PHP620 million in Pag-IBIG Calamity Loans it released to aid 37,605 members. (*PNA*)

Bonifacio ang mga katagang "Viva La Independencia Filipina! sa mga haligi nuong kweba upang maipahayag ang mithiin ng kanilang lihim na samahan. Pinangunahan din ni Bonifacio ang "Sigaw ng Pugad Lawin", na hudyat ng pagsisimula ng Rebolusyong Pilipino. Pinunit ng mga miyembro ng Katinunan sa pangunguna ni Katipunan, sa pangunguna ni Bonifacio, ang kanilang mga cedula bilang protesta sa pananakop ng mga Kastila. Nagsimula ang Philippine Revolution noong 1896. Ang Kasunduan ng Biak na Bato, na nilagdaan noong Disyembre 14, 1897, ay nagtatag ng isang kasunduan sa pagitan ng pamahalaang kolonyal ng Espanya at ng mga rebolusyonaryong Pilipino. Nuong unang araw ng buwan ng Mayo 1898, nagapi ni Dewey ang mga sundalong Kastila sa Labanan sa Manila Bay, na siyang nagbigay daan para sa Amerika na kontrolin ang pamahalaang kolonyal ng Espanya. Kalaunan sa buwang iyon, inihatid ng US Navy si Aguinaldo pabalik sa Pilipinas. Ika-19 naman ng buwan ng Mayo taong 1898 ng dumating si Aguinaldo sa Cavite.

Ika-5 ng Hunyo taong 1898, naglabas ng kautusan si Aguinaldo sa kanyang bahay na matatagpuan sa noo'y Cavite El Viejo na nagpapahayag ng Hunyo 12, 1898 bilang "Araw ng Kalayaan."

"A priest is called by God to serve other people and help them in their role and mission in life. Let's all keep in him our prayers so he can be a faithful follower of Jesus," he said. The newly ordained priest studied theology at the Melbourne Seminary and received his diaconal ordination at the same cathedral in October 2022.

Before becoming a priest, he was a member of the cathedral parish team and helped ministered at the St. Mary's School and St. John's College, among others.

Taberdo hails from the town of Agoo in the Philippines' northern province of La Union. The newly ordained priest thanked God, his family, and the bishops and priests who supported him throughout his religious journey.

#### DA, partner gov't agencies brace agri-fisheries sector before El Niño starts

In line with the commitment of President Ferdinand R. Marcos Jr. to ensure stable and affordable food supply for every Filipino, the Department of Agriculture (DA) is taking the necessary actions to prepare the agriculture and fisheries sector ahead of the looming El Niño phenomenon this year.

On June 1, 2023, the DA's National El Niño Team (DA-NENT) convened partner agencies from the Food Security Group under the National El Niño Team of the National Disaster Risk Reduction and Management Council (NENT-NDRRMC) for its 1st Inter-agency Meeting to discuss the actions taken and plans of the memberagencies.

"We in the DA are doing our best in trying to allocate the resources like seeds, fertilizers, and other commodities that are necessary for the impact of the El Niño phenomenon to

In line with the commitment of President Ferdinand in the country," Senior R. Marcos Jr. to ensure stable and affordable food supply for every the meeting.

The DA Field Operations Service Director and Chairperson DA-NENT **U-Nichols** Manalo presented the DA El Niño Mitigation and Adaptation Plan for crops, fisheries, and livestock subsectors. The plan is based on the four thematic areas of the DRRM framework, namely, prevention and mitigation. preparedness, response, and rehabilitation and recovery.

The strategies identified include dissemination of information, education, and communication materials, proper water management, prepositioning of resources, crop diversification, adjustment of planting calendar, buffer stocking of inputs, promotion of short cycle and drought tolerant crops, among others.

#### Phase 2 of NGCP's 10.56Bn Mindanao Substation Upgrading Program Underway

The energization of a 100 Megavolt Ampere (MVA) power transformer in NGCP's Toril Substation marks the first milestone in the second phase of NGCP's efforts to upgrade substations in Mindanao. The Toril substation serves the franchise area of Davao Light and Power Company, which provides the electricity needs of Davao City.

The 100MVApowertransformer is the first energization under NGCP's Mindanao Substation Upgrading Project 2 (MSUP2). Under the project, ten (10) substations in Lanao del Norte, Misamis Oriental, Bukidnon, Agusan del Norte, Davao del Sur, North Cotabato, and South Cotabato will be equipped with new power transformers to ensure continuous operations in the case of outages.

The project will also address the N-1 compliance for the Mindanao grid. A requirement of the Philippine Grid Code, an N-1 contingency is the ability of the grid to withstand a major system disturbance with minimal or no impact to the system.

For the first stage of the Mindanao Substation Upgrading Project, power transformers with a 100MVA rating were energized in

NGCP's Agus 6, Pitogo, Placer, NagaMin, and General Santos Substations. Power transformers with a 75MVA rating were also energized Polanco, Opol, and Maramag Substations, and 50MVA power transformers in San Francisco, Bislig, and Kidapawan Substations. Capacitor banks were also installed in NGCP's Butuan, Tacurong, Pitogo, General Santos, San Francisco, and Placer Substations.

"The energization of the transformer in Toril, as well as the energization of high voltage equipment and facilities all over Mindanao, will boost the grid's overall reliability," NGCP said. "These upgrading efforts are ultimately geared towards readying the grid for the influx of businesses, industries, and investments in the region," added NGCP.

The second phase of the MSUP was filed with a cost of PhP5.56 Billion. The first phase of MSUP has an ERC-approved project cost of PhP5 Billion. "The MSUP2 is again testament to our commitment to expand and improve the country's transmission grid, and to provide better services at a lower cost to the consumer," the company said.

# PH, ISRAEL AGREE ON ENHANCED AGRICULTURE, WATER MANAGEMENT COLLABORATION

The Philippines and Israel agreed on a strengthened partnership in agriculture, water management, as well as in establishing direct flights between the two countries, following a meeting on Monday by President Ferdinand R. Marcos Jr. with Israeli Foreign Minister Eli Cohen.

During a meeting in Malacañang, Cohen told the President that his country can work with the Philippines on agriculture to ensure food security.

"I think that we can work together on the segment of agriculture. I just let you know

Aside from agriculture, Cohen said the Philippines and Israel can also collaborate on water management, noting Israel's vast experience in this sector. Because of water scarcity, Israel has been reusing large portion of its water resources and it can share its experience in water management with the Philippines, he said, suggesting that an Israeli expert can visit the Philippines to provide advice.

For his part, President Marcos said he considers agricultural development as very important for the nation, as he expressed admiration for Israel's advancement in agriculture.

The President said he was glad the Israeli official brought up the issue because agriculture has been the Philippines' priority particularly in improving the economy.

"Because when we look at the economy as hard to just test, we said how do we fix the economy. It always comes down to agriculture first, how to fix every policy, then everything else would be great. So that's the position that we find ourselves in," he said.

"So, the offers that you make for assistance and partnership in those two areas are very, very welcome."

In terms of water management, the Philippines, he said, is looking at Israel and Singapore for best practices that the country can imitate.

In addition to agriculture and water management, Cohen raised the issue of establishing direct flights between the Philippines and Israel to boost tourism and economic ties.

"There's another thing that we, both of us, took for an action item - (it) is to have a direct flight... your external sea between Israel and the Philippines," Cohen said referring to his earlier meeting with Filipino officials.

"And I think that we agree that both ministries will work together to have the direct flight and this is also to bring more business people to come to invest and reach the place between us. So this is also another important action item that we will do." | PND

CAGAYAN DE ORO CITY (PIA)--To provide easier access to data, the Department of Agriculture launched the Registry System for Basic Sectors in Agriculture (RSBSA) Finder through finderrsbsa.da.gov.ph. Said system

developed to assist registrants in confirming if their registration was successful and also generate a temporary digital DA Interventions Monitoring Card (DA IMC),

which contains their official RSBSA number.

The RSBSA is an electronic compilation of basic information about farmers, farm workers, fisherfolk and agri-youth that serves as the basis for availing DA interventions.

A verified complaint was filed in this Court which aver that:

SPOUSSES JASMIN MOSADA and REGENALD MOSADA as represented by GEMMA DIGNOS & JOSEPH DIGNOS ("Spouses Dignos" and/or "Plaintiffs"), who are Filipino citizens, of legal ages, with residence address at Phase 3 Block 3 Lot 24, ACM Subdivision Alapan 1-A, Imus, Cavite, by counsel, and by way of this Complaint ("Complaint"), respectfully state:

#### FACTUAL ANTECEDENTS

- 1.1. Spouses Jasmin Mosada & Regenald Mosada constituted GEMMA DIGNOS and/or JOSEPH DIGNOS as their lawful attorneys-in-fact in relation to the construction of a two-storey house (the "Project"). Specifically, they were authorized to do all acts, matters and things whatsoever with respect to the Project.
- 1.1.1.The Special Power of Attorney granted to Ms. Gemma Dignos and/or Mr. Joseph Dignos by Spouses Regenald M. Mosada & Jasmin F. Mosada, notarized 26 December 2019, is marked and attached herein as Plaintiff's Annex "A".
- 1.2. Spouses Jasmin Mosada & Regenald Mosada likewise constituted GEMMA DIGNOS and/or JOSEPH DIGNOS as their lawful attorneys-in-fact in relation to the above-captioned case, with full power and authority to appear in all proceedings, meetings, hearings, conferences and negotiations involving this case, to appear at any and all mediation proceedings, pre-trial or preliminary conference or any meeting before the court and/or a court-appointed commissioner, to sign, verify, deliver and receive any and all agreements, instruments, pleadings, motions, notices, affidavits, and other documents and papers, execute the verification and certification of non-forum shopping, and other documents in relation to the matter at hand, and perform any and all acts incidental and necessary to accomplish the foregoing.
- 1.2.1. The Special Power of Attorney granted to Ms. Gemma Dignos and/or Mr. Joseph Dignos by Ms. Jasmin Mosada, as apostilled on 3 February 2022 by Hon. Roussel R. Reyes, Consul-General of the Republic of the Philippines to Qatar, is marked and attached herein as Plaintiffs Annex "B".
- 1.2.2. The Apostilled Special Power of Attorney granted to Ms. Gemma Dignos and/or Mr. Joseph Dignos by Mr. Regenald Mosada, as apostilled on 3 February 2022 by Hon. Roussel R. Reyes, Consul-General of the Republic of the Philippines to Qatar, is marked and attached herein as Plaintiffs

Annex "C".

1.3. On 5 December 2019, Spouses Mosada and JP Llamoso Home Builders ("JP Llamoso Builders"), as represented by its owner and herein defendant Mr. Jean Paul Llamoso entered

into a Construction Contract.

- 1.3.1. A copy of the said Construction Contract dated 5 December 2019 is attached herein as Plaintiffs' Annex "D".
- 1.4. Under the aforementioned Construction Contract, JP Llamoso Builders is obliged to construct, build, and complete a two-storey house (the "Project").1 JP Llamoso Builders was given thirty two (32) weeks or one hundred ninety two (192) working days from the execution of the Construction Contract and acquisition of the Building Permit.2
- 1.4.1. The Building Permit was issued by the Bacoor City Office of the Building Official on 15 January 2020. A copy of the said Building Permit is attached herein as Plaintiffs Annex "E".
- 1.5. Also pursuant to the Construction Contract, Spouses Mosada were obliged to pay to JP Llamoso Builders the amount of Two Million Seven Hundred Seventy Thousand Pesos (Php2,770,000.00) (the "Contract Price") in different tranches.3
- 1.6. Of the Contract Price, Spouses Dignos, on behalf of Spouses Mosada, has as of even date paid Two Million Five Hundred Fourteen Thousand Five Hundred Pesos (Php2,514,500.00), detailed as follows:
- 1.6.1. On 28 November 2019, a payment was made in the amount of Six Hundred Ninety Two Thousand Five Hundred Pesos (Php692,500.00), for the payment of the downpayment as stated in the Construction Contract. A copy of the Acknowledgment Receipt issued by Jean Paul Llamoso pertaining to the foregoing is attached herein and marked as Plaintiffs' Annex "F".
- 1.6.2. Subsequently, a payment was made in the amount of Thirty Thousand Pesos (Php30,000.00), for the full payment of the Building Plan. A copy of the Acknowledgment Receipt issued by Jean Paul Llamoso pertaining to the foregoing is attached herein and marked as Plaintiffs' Annex "G".
- 1.6.3. A payment was likewise made in the amount of Eight Hundred Thirty One Thousand Pesos (Php831,000.00), for the full payment of the first billing. A copy of the Acknowledgment Receipt issued by Jean Paul Llamoso pertaining to the foregoing is attached herein and marked as Plaintiffs' Annex "H".
- Article 1. Scope of Works of the Construction Contract dated 5 December 2019.

- 1.6.4. Also, a payment was made in the amount of One Hundred Thirty Thousand Pesos (Php130,000.00), for the partial payment for the gate and fence. A copy of the Acknowledgment Receipt issued by Jean Paul Llamoso pertaining to the foregoing is attached herein and marked as Plaintiffs' Annex "I".
- 1.6.5. Moreover, a payment was made in the amount of One Hundred Thirty Thousand Pesos (Php130,000.00), for the advanced payment for the second billing. A copy of the Acknowledgment Receipt issued by Jean Paul Llamoso pertaining to the foregoing is attached herein and marked as Plaintiffs' Annex "J".
- 1.6.6. Lastly, a payment was made in the amount of Seven Hundred One Thousand Pesos (Php701,000.00), for the full payment of the second billing. A copy of the Acknowledgment Receipt issued by Jean Paul Uamoso pertaining to the foregoing is attached herein and marked as Plaintiffs' Annex "K".
- 1.7. Despite the faithful and consistent payment by the Plaintiffs of the Contract Price, the work constructed by the Defendants in relation to the Project remained bare and unsatisfactory, not to mention that the Defendants failed to observe the period of construction agreed upon, as discussed in Paragraph 1.4 and its sub-paragraph of this Complaint.
- 1.8. Pursuant to such non-compliance, the Plaintiffs sent an Official Demand Letter dated 12 May 2021 to demand the return of the sums of money they paid in relation to the failure of the Defendants to construct the Project. A copy of the said demand letter is attached herein and marked as Plaintiffs' Annex "L".
- 1.9. The Plaintiffs also sent a Final Demand Letter dated 23 October 2021, again reiterating the refund of the sums of money they paid. Notably at this juncture, the Defendants already refunded Seventy Thousand Pesos (Php70,000.00) sometime in March 2021 to the Plaintiffs. A copy of the said final demand letter is attached herein and marked as Plaintiffs' Annex "M'.

- 1.10. Failure to heed the said demands, the Plaintiffs were given no choice but to institute this instant action.
- 1.11. It is of note that the promise of the Defendants to refund is contained in their Facebook Messenger message addressed to Spouses Mosada which they share to the Spouses Dignos as their attorneys-in-fact. In the said Facebook message, the Defendant Llamoso mentioned that the Spouses Mosada had the option to either continue with the project but there will be a delay of an additional three (3) months, or stop the same and seek refund. A printout of this Facebook Messenger message is attached herein and marked as Plaintiffs' Annex "N".
- 1.12. In another Facebook Messenger message, Defendant Llamoso mentioned that he will issue post-dated checks for the refund. However, no such

checks were remitted. A printout of this Facebook Messenger message is attached herein and marked as Plaintiffs' Annex •o•.

#### II. RESCISSION

2.1. As held by the Supreme Court in the case of George C. Fong vs. Jose V. Duenas4, "as a contractual remedy, rescission is available when one of the parties substantially fails to do what he has obligated himself to perform. It aims to address the breach of faith and the violation of reciprocity between two parties in a contract.• Moreover, the Court had the occasion to state that "the power to rescind obligations is implied in reciprocal ones, in case one of the obligors

should not comply with what is incumbent upon him."

- 2.2. As applied in the instant Complaint, the Defendants are already in substantial breach of its obligations under the Construction Contract dated 5 December 2019 for-failing to construct the Project within the specified period and for failing to make substantial and satisfactory construction works for the Project. It must be noted that it has almost been three (3) years since the execution of the aforementioned agreement, and also the acquisition of the Building Permit. The construction is now far beyond the period contained in the Construction Contract, as discussed in Paragraph 1.4 of this Complaint.
- 2.3. Under Article 1191(2) of the Civil Code of the Philippines,5 "the injured party may choose between the fulfillment and the rescission of the obligation, with the payment of damages in either case. He may also seek rescission, even after he has chosen fulfillment, if the latter should become impossible.•
- 2.4. In this instant case, the relief sought by the aggrieved Plaintiffs is that of rescission, instead of fulfillment, as the Defendants made themselves scarce when being confronted about the matter.

#### III. DAMAGES

- 3.1. It is likewise provided in the provision of law cited that rescission may be coupled with damages.6
- 3.2. Likewise as held by the Supreme Court in the case of Spouses Luigi
- M. Guanio and Anna Hernandez-Guanio vs. Makati Shangri-la Hotel and Resort, Inc.,7 the mere proof of the existence of the contract and the failure of its compliance justify, prima facie, a corresponding right of relief."
- 3.3. Also as discussed in the aforementioned case, "a breach upon the contract confers upon the injured party a valid cause for recovering that which may have been lost or suffered" (emphasis supplied). The remedy serves to preserve the interests of the promissee that may include his "expectation interest• the interest in having the benefit of his bargain by being put in as good a position as he would have been in the contract been performed; his "reliance interest" which is his interest in being reimbursed for loss caused by reliance on the contract by being put in as good a position as he would have been had the contract not been made; or his "restitution interest" which is his interest in having restored to him any benefit that he has conferred to the other party.
- 3.4. In this case, it is not hard to see that all the three interests mentioned above need preservation. The Plaintiffs expected that their dream two storey house when they return home from working abroad will come to fruition when they entered into the



Construction Contract with the Defendants. Their reliance on the Defendants on the construction of the same is also apparent and hard to deny, as they were the ones in possession and control of the property all this time. Lastly, the Plaintiffs deserve restitution on the sums of money they paid since the Defendants fail to deliver on their promises under the Construction Contract.
