CAVITE CELEBRATES THE 2018 NUTRITION MONTH

THE Provincial Government of Cavite thru the Provincial Nutrition Council in partnership with the International Institute of Rural Reconstruction (IIRR) conducted the Culminating Activity of the 44th Nutrition Month with the theme "Ugaliing magtanim, Wastong nutrisyon aanihin!" at the Ceremonial Hall of the Provincial Capitol Building in Trece Martires City.

More than 200 participants from different cities and municipalities joined in the celebration which aims to intensify the quality of food intake by increasing the number of households, schools and communities who are practicing food gardening or backyard farming. It also aims to improve the healthy food consumption of the Filipinos by providing awareness on the benefits of eating nutritious

foods.

On behalf of Governor Boying Remulla, Mr. Rocel Vince Bae acknowledged the participants for coming and encouraged them to consume nutritious foods. He also voiced out the importance of involving oneself in active lifestyles and engage in sports activities and exercises which can strengthen the body and mind. On the other hand, Ms. Angeles Peñalba, Provincial Nutritionist shared some insights on food gardening and its benefits. She also cited some common reasons why people are prevented from engaging in backyard farming. Meanwhile, Ms Irish E. Baguilat, Program Manager of IIRR discussed "Home Gardening" and inspired everyone to plant local fruits and vegetables that are easy to grow and require less care

but produces more fruits.

Showcased in the nutrition month celebration were NUtri-Agri Fair, photo exhibits, and Nutrition Forum. The highlight of the celebration was the recognition and awarding ceremonies of the municipalities and cities who excelled in nutrition programs for their locality. High 2018 Operation Timbang Plus (OPT Plus) Coverage were awarded to the municipalities of Amadeo, GMA, Indang, Maragondon, Mendez, Naic, Silang, Tanza, Ternate and cities of Cavite and General Trias. The Outstanding Philippine Plan of Action for Nutrition (PPAN) Implementor were granted to Alfonso, City of General Trias, Rosario and Carmo-na. Meanwhile, the 2017 Provincial Outstanding Barangay Nutrition Scholar was bagged by Mylene D.

San Juan of Barangay Putting Kahoy, Silang while Barangay Cabilang Baybay in the municipality of Carmona won the 2017 Provincial Outstanding Barangay Nutrition Committee. Overall, the Municipality of Tanza earned the 2017 Provincial Most Outstanding Municipality.

The celebration was attended by Municipal Nutrition Action Officers (MNAO), Barangay Nutrition Scholars (BNS), representatives from the Philippine Statistics Authority (PSA), Department of Education (DepEd), provincial government employees and other stakeholders. Mr. Jesus Barrera, Provincial Planning Development Officer, Ms. Lolita C. Cavite solon asks DPWH to preserve heritage bridge

GENERAL TRIAS, Cavite – Cavite 6th District Representative Luis Ferrer IV on Monday appealed to the Department of Public Works and Highways (DPWH) to “preserve whatever can be preserved, without compromising the viability of the project” on the heritage bridge that will be affected by the ongoing DPWH road network project at Buenavista 2 village here.

Ferrer made the request noting the clamor of heritage advocates, led by De La Salle University Associate Professor Jeffrey Alfaro Lubang, to spare the said Hispanic bridge, designed with beautiful round arches and buttresses and believed constructed on the

order of the Augustinian friars in the 17th or 18th century.

A known Cavite historian and heritage advocate, Lubang has publicly called on project proponents to stop the destruction of the old bridge citing “the spirit of our core identity lies in our material culture, and sadly, we are fast losing them.”

The PHP45-million DPWH project, which includes the construction of a new Buenavista bridge which spans 40 meters and now 60percent from its target completion by end of 2018, will partially affect the old bridge due to its design, said DPWH 1st District Engineer Oscar Dela Cruz.

Dela Cruz further ex-

plained that the project, which they have been working on since the previous administration, passed through the needed protocol, from public consultation for its feasibility, to groundbreaking ceremony and all, “so why only now?” in reference to the clamor to spare the bridge.

While understanding and respecting the advocates’ views, Dela Cruz hopes “they should also consider the economic viability of this project” and to consider foremost the safety of the locals, composed of students, workers, business owners, as well as the commuters “as only a single motor vehicle are considered safe to pass on the

old bridge.”

Rey Genuino, a resident of Buenavista 2, wished that the project proponents opted for preservation, “instead of having a new one (bridge).”

He, however quickly said he could not fully appreciate the new bridge’s viability, as he is not personally aware of what the project’s purpose is all about.

“Baka me magandang purpose yan, para ba sa safety ng mga nagdaraan, me daan bang idudugtong dyan, alam ko naman na yung lumang bridge e hindi na madaanan ng sasakyahan, hindi lang kse malinaw (The bridge might have its purpose, is it for the safety of passerbys, will there be a road connected to it, I know that the old bridge is not passable to vehicles, it’s just not clear),” he added.

Buenavista 2 Village Chief Danny Potante dismisses this allegation, as they never tire to publicly announce this project during the general assembly held twice every year.

To provide a venue where all heads could meet and voice out their concerns, Ferrer is also calling for a dialogue as soon as possible for a win-win resolution to this concern.

The construction of a new bridge is in response to the residents’ request for funding assistance, as indicated in Sangguniang Bayan (Local Legislative Body) Resolution No. 13-87 which has been approved for second reading on Aug 22, 2013.

In the said resolution, approved by then Municipal Vice Mayor Maurito C. Sison, the fund will be utilized to replace the centuries-old, dilapidated bridge which



The book's focus is the Bacoor Assembly on Aug. 1, 1898 which gathered close to 200 "Presidente Mayor" or the present local chief executives or mayors from different provinces of the Philippines in this old Cavite town then where they took their oath of office and ratified the document on the Declaration of Philippine Independence.

This 'Aug 1 Act of Independence,' authored by Apolinario Mabini, was immediately distributed to other countries and the same document was ratified at the Malolos Congress, "which was convincingly established by Calairo in the book," part of the impressions shared by Bacoor Historical Society President Dr. Jose Andres L. Diaz.

Jose Napoleon L. Cuenca, current head of Bacoor's Tourism Cluster and a great grandson of the origi-

nal owners of "Bahay na Tisa" or Aguinaldo's "Malacañang" at that time, has advised readers to understand the words "declaration, proclamation, ratification and promulgation" for a better appreciation of the message relayed in this important publication.

Cuenca added that this book will level up questions and queries of what truly transpired then during the dictatorial years, the revolutionary government, until the establishment of the first republic in Asia.

Although the (1898) Bacoor Assembly, the event in general, is now recognized as part of the (Philippine) Independence trail: from Alapan in Imus on May 28, to the declaration of the country's independence at Kawit town on June 12, the Bacoor Assembly on Aug 1 and the Malolos Congress on Sept 29, which all happened in 1898, the book seeks to lobby the country's leaders to also recognize this 'Bacoor' proclamation.

Mercado acknowledged that highlighting the Aug 1

event may become controversial matter, because it claims a "proclamation of independence" apart from what is annually celebrated in Kawit on June 12.

"However, the city's commitment towards understanding the real happening in Bacoor and its constituents is our priority in order to show to our people that once upon a time, Bacoor stood up to be the center of the revolutionary struggle in Philippine history," Mercado stressed.

And asked if the book will lead towards a petition to Congress to change the country's proclamation of independence, Calairo's advice is to read the book to find out.

The book launching is one of the highlights of a 3-part program, which includes the unveiling of the Plaza de Mariano Gomez

marker and the premiere showing of the documentary film "Agosto Uno, Kasaysayang Nakalimutan" to commemorate the 120th year of the Bacoor Assembly.

The book containing 250 pages book from cover to cover, a product of a year of research and months of writing, is given free by the city government.

Senator Aquilino Pimentel III was the guest-of-honor and speaker during Wednesday's event with former Prime Minister and President of Cavite Historical Society Cesar E. A. Virata and National Historical Commission of the Philippines (NHCP) Chair Dr. Rene R. Escalante, with provincial and local officials, including the province's various historical groups and advocates. DOH-CALABARZON STARTS PROFILING OF DENGVAXIA CASES

"The profile of the recipients and their scheduled physical examination will generate evidence-based intervention needed for their evaluation. An individual's health profile is important to manage the health information that will include a comprehensive summary of their medical or health history. This must include personal health history, medical conditions, medications and emergency contact information. It will help health workers to clearly organize critical information of every Dengvaxia vaccinee," Regional Director Eduardo C. Janairo stated.

"Without proper action, the Dengvaxia confusion in the country will continue to bring scare and panic not only to affected individuals and their families but also to the rest of the country.

Not only that it will cause lower vaccination coverage and distrust but will also affect the psychological behavior of the children who were vaccinated," he emphasized.

The regional office has been closely monitoring Dengvaxia recipients regularly and providing necessary medical support every time a need arises.

Janairo added that parent leaders of various provinces were also tapped to provide additional support in the reporting and monitoring of vaccinees in their respective areas.

According to the Regional Epidemiology Surveillance Unit (RESU), there are a total of 16,694 Adverse Event Following Dengvaxia Immunization (AEFDI) from December 1, 2017 to July 27, 2018. There are 52 deaths recorded. Majority of cases, 8,553 were female.

Age ranged from 2 years old to 46 years old. Laguna province had the highest number of reported AEFDI cases with 4,998 (30%) cases followed by Batangas with 4,476 (27%), Cavite - 3,336 (20%), Quezon - 2,399 (14%) and Rizal - 1,486 (9%). There are 1,405 AEFDI cases admitted and 321 (23%) were diagnosed with Dengue fever.

"We will work to complete the profiling of patients before the end of this year to be able to have an accurate data and be able to know where to locate each recipient and improve our ability to manage them efficiently and avoid potential hazards to their health," Janairo assured. BOY NAMORA
