PDEA confers first 'drug cleared status' to Tagaytay City

TAGAYTAY CITY, Cavite – Cavite's top highland destination Tagaytay City and the upland town of Mendez-Nuñez will be formally conferred the "Drug Cleared" status during the ceremonial awards rite at 2 p.m. on Sept. 17 at the Sigtuna Hall of the Tagaytay Convention Center.

Police Director General Oscar David Albayalde is the invited guest of honor and speaker for the awarding ceremony here.

Tagaytay City, with its 34 villages (barangays), becomes the first city in the province of Cavite to be awarded the 'Drug Cleared' status by the Philippine Drug Enforcement Agency (PDEA) in the Calabarzon Region comprising Cavite, Laguna, Batangas, Rizal and Quezon.

The declaration was based on the city's compliance to the requirements pursuant to the parameters set forth in Section 8 and 11 of the Dangerous Drug Board (DDB) Regulation No. 3, Series of 2017 entitled "Strengthening the Implementation of Barangay Drug Clearing Program."

Cavite Provincial Police Director Senior Supt. William Mongas Segun sees the award more as a challenge and encourages

his police personnel to further intensify their efforts "to sustain this 'drug cleared' status which has to be maintained, otherwise PDEA will recall it."

Supt Elmer J. Decena, Tagaytay City police chief, said Wednesday that the city police force is "in high spirits" for this honor.

"This (recognition) will inspire us more to be aggressive and not to be complacent in maintaining its drug cleared status against those individuals who might take advantage of committing any drug offense," Decena said.

He likewise thanked the media "for their major

role in our city's anti-illegal drug campaign."

Also, the Municipality of Mendez-Nuñez, with its 24 barangays, will be conferred with the drug cleared status, the first Cavite town to achieve such.

Police Senior Insp. Arnel Mendoza, the chief of police of Mendez-Nuñez, echoed Cavite provincial police director Segun's "challenge" to sustain the drug-cleared status.

Mendoza vowed to intensify police community relations (PCR) to monitor the villages in order to maintain this status.

PDEA Region IV-A (Calabarzon) awarded the

Certification of Drug Cleared to both Tagaytay City and the Municipality for Mendez-Nuñez upon validation by the DDB Regional Oversight Committee when it convened at the Bakasyunan Resort and Conference Center in Tanay, Rizal on Aug. 31.

Department of the Interior and Local Government (DILG) Region IV-A Director Manuel Q. Gotis, served as the Presiding Officer, together with other members of the Committee (PDEA, PNP, DOH and League of the Municipal Mayors) in Calabarzon. (**Gladys Pino-PNA**)

IMUS CITY, Cavite – The Bacoor City Police Station (CPS), headed by Supt. Vicente S. Cabatigan, is this week's 'Top Performing City Police Station on Anti-Illegal Drug Operations.'

The Bacoor police force was awarded the Certificate of Recognition signed by Cavite Provincial Police Director Senior Supt. William M. Segun, citing the city cops perfor-

mance "for conducting 12 Anti-Illegal Drug Operations."

The operations resulted in the arrest of 27 illegal drug personalities covering the period Aug. 28 to Sept 3, 2018.

This merit system is in support of the Regional Search, "where Cavite has been declared as top performing province for 4 weeks now," Segun said.

The award is also meant to "further motivate the group in our intensified campaign against illegal drugs," Segun adds.

A sober plea before RP imports pork

LIFE'S INSPIRATIONS:

ASOBER PLEA BEFORE RP IMPORTS PORK: I am urging the Duterte government, before it implements any importation of pork as Department of Agriculture (DA) Secretary Manny Pinol appears to be staunchly proposing, to conduct first an honest-to-goodness inventory on how big (or how small) really is the country's need for pork at present and until Christmas time, and what is the true and exact number of pigs that can be available for butchering between now and December.

Certainly, Pinol and his subordinates at DA must thoroughly clarify first the existing "supply and demand" situation on the country's production of pork. This is necessary to prove that, indeed, the supposed urgent need to import pork at the present time is genuine and real, not simply made up. I share the concern of some that any permit that the DA will grant for the importation of pork can be used yet again as an instrument of pork smuggling, and also the entry into the Philippines of meat from "double dead" pigs.

Truly, many businessmen are complaining that their operations—and their viability and profitability and continued existence as hog raisers—could be seriously prejudiced with imported pork. They believe that they have the capacity at the moment and even well after Christmas to satisfy the need for pork of our countrymen. I have also been told that the DA move to import pork would favor only a few privileged personalities who are close to the powers that be.

PROOFS OFFERED BY JESUS TO SHOW HE IS GOD THE FATHER (II): From

John 8 of the Holy Bible comes another declaration from Jesus that He is God the Father. In John 8:58, Jesus directly said, in the presence of the Jews who were bothered by His teachings, that He, Jesus, is "I Am". Bhelle's question now is: will there be expenses if she eventually filed her case? In criminal cases, there is no filing fee for the filing of a case before the fiscal's office for purposes of a preliminary investigation. The criminal cases can be filed directly with the fiscal's offices even if the complainant does not pay any filing fee. However, if the complainant seeks the pay-

ment of damages and his criminal cases that involve damages are finally filed in court, that is where a filing fee would be required.

CAVITE PROMOTES LGBT ORDINANCE

BACOOR CITY, Cavite – Cavite Vice Governor Ramon Jolo Revilla III is promoting a provincial ordinance, which upholds the right of constituents here regardless of their sexual orientation and gender identity of expression (SOGIE).

Revilla, on his Facebook page (Jolo Revilla), re-posted Monday a video on Provincial Ordinance No. 200, otherwise known as the "Lesbian, gay, bisexual, transgender, queer (LGBTQ) Community Protection and Recognition Ordinance, crafted by the Cavite Sangguniang Panlalawigan (provincial legislative council) - which he presides.

In the video, Revilla solicited public support for the passage of the House bill counterpart, which is still pending enactment.

"Kung naipasa po natin ito sa lalawigan ng Cavite, mas kayang-kaya natin ito sa buong Pilipinas (If we were able to enact this in Cavite, the more we can do it in the entire Philippines)," Revilla added.

He recently pitched to fellow awardees for this year's 'Outstanding Local Legislator' of Superbrands Marketing International, Inc. his authored provincial ordinance that seeks to uphold and protect the rights of LGBTQ.

Revilla took on the occasion as he received his award in Makati City last Aug. 28, his fifth award (received for five consecutive years) since he became Cavite vice governor in 2013.

He spoke before 30 other local legislators, his co-awardees, in the said category.

As the only vice governor to receive this year's award, Revilla reiterated the public servant's role—that is to ensure equal right and opportunities to all, including those in the LGBTQ community.

"Dapat pantay-pantay, hindi dapat inaabuso, hindi dapat binabastos, dapat tinatratu tulad ng isang ordinaryong Pilipino" (There should be equal treatment.

They should not be abused, maligned, and treated like any ordinary citizen," he said, pertaining to the LGBTQ community who still experience discrimination, maltreatment and bullying, as backed up by the steady and alarming rise of reported violence on its members for the past 15 years.

The provincial government through the Provincial Social Welfare and Development Office (PSWDO), in coordination with non-government organizations (NGOs) supporting the LGBTQ community, would be directly and primarily responsible for

the implementation of the provisions of the ordinance.

On the prohibited acts as specified in Section 4, once the ordinance takes effect, it will be considered unlawful to discriminate against any person and/or group of persons on the basis of their sexual orientation and gender identity and expression or those who belong to the LGBTQ community.

Considered discriminatory are denial of access to public services, refusal or revocation of the accreditation and formal recognition - as well as registration - of any LGBTQ Community in educational institutions, workplaces, communities and similar settings.

The ordinance also prohibits denial of access to and/or the use of private and public establishments, facilities, utilities, transportation and services, including housing, which is open to the general public.

On the subject of 'denial' the ordinance specifies its presence "when a person is given inferior accommodation or services and (there was) rejection of any application, entry or participation.

It also includes subjecting or forcing any person to any medical or psychological examination without the expressed ap-

roval of the person involved, except in cases allowed by law.

It will also be against the law to upload or post of pictures, videos and comments on the internet through social networking sites, websites and other social media intended or will demean, debase, degrade and humiliate a person or group of persons; as well as publication and/or use of derogatory and humiliating statements, remarks, comments, articles, videos and pictures in print and broadcast media against a person/group.

The ordinance also gives the LGBTQ equal rights to avail of medical and health services that is open to the general public.

For an effective province-wide implementation, the ordinance specifies that Cavite's local government units (LGUs) are to observe the tenor of the ordinance and to provide for a more applicable approach in mitigating or further dissolving the social biases and impartiality of the community especially in the areas of employment, inadequate protection from abuses, being victimized on the ground of gender impartiality and any other forms of discrimination. Sec. Cusi further underscored that for deep-rooted developments to occur, such mindset revolution should start from within.

P130-K 'SHABU' SEIZED FROM PUSHER, COHORT IN GENERAL TRIAS

GENERAL TRIAS CITY, Cavite – City police drug enforcers seized some PHP 130,000 worth of suspected "shabu" from a drug pusher and his cohort during a buy-bust operation Monday evening in Barangay Pasong Kawayan 1 here.

Supt. Paul Bometivo, city chief of police, identified the drug suspects as Jerwin Zamora alias "Apoy", a street level target (SLT) drug personality and former "Oplan Tokhang" drug surrenderer, and his companion Rojim Javier, both Pasong Kawayan 1 residents.

Bometivo said the police conducted their drug bust operation around 8:30 p.m. Monday and confiscated from the two suspects 16 heat-sealed

transparent plastic sachets of suspected 'shabu' weighing around 20 grams; nine PHP100 bills as drug money and a PHP 1,000 peso bill used as buy-bust money.

Mother, son nabbed for selling drugs in Dasmariñas City

DASMARIÑAS CITY, Cavite - A 54-year-old mother and her 22-year-old son were arrested by city police drug enforcers Tuesday evening during a buy-bust operation in Barangay Sta. Fe here.

City chief of police, Supt. Nerwin Ricohermoso, said the tandem were caught conspiring to sell the illegal drug, popularly known as "shabu", in the residential area to a poseur-buyer during the City Drug Enforcement Unit (CDEU) Project Double Barrel and drug bust operation.

He described a responsible social media user as someone who "provides and shares only the right information to

He said providing the right information will combat fake news circulating in any social media platform.


"We can spot fake news by considering the source, checking the date, reading beyond content, making a quick search on the author, checking personal biases, verifying supporting sources, such as the link, and consulting an expert," he said.

"Our objective is to make all blood products free, readily available, everybody knows where to get them and to establish a system where no one will ever complain because of the need for blood," this was the statement by DOH-CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) Regional Director Eduardo C. Janairo during the National Voluntary Blood Services Program (NVBSP) Stakeholders Forum held at the H2O Hotel in Luneta, Manila on August 30-31, 2018.

"We will establish a service delivery network for acquiring blood products for CALABARZON. Through this system, a person will know where to get

the type of blood that he/she needs, there will be a proper

transportation of blood products from the facility to the lo-

cation of the person needing blood, and there will be a continuous supply of blood products at all times," Janairo explained.

"There should be no queuing and looking for someone to

donate blood as replacement for the blood needed for transfusion. The patient might already be dead before the relatives can find a suitable blood donor. These scenarios must be avoided because burdens patients

CALABARZON has three blood centers, 14 blood banks with hospital based functions (L1, L2, L3), 4 non-hospital based blood collecting units (BCU)/blood station (BS), 23 hospital based L1 blood station and 56 hospital based L1 & L2 blood station.

According to CALABARZON-NVBSP, there are a total of 144,098 whole blood collected from the target of 146,593 with a 98% accomplishment in 2017.

From January 1 – June 30, 2018 (partial report), there are

a total of 69,070 number of units collected. Laguna has the highest number of units collected with 20,037; Batangas with 17,134; Cavite with 14,137 units; Rizal – 10,199; and Quezon with 7,563 whole blood units.

Janairo also added that the region will work for processing fees to be subsidized by the government. "We will exert efforts to make this system work by next year and hoping that all regions will follow suit."

"We will continue to support all community activities to make blood available for generations to come. We must strengthen and unify our efforts to make this endeavor possible. Blood should be shared. It is a humanitarian thing and it should not be paid for because it is free!", he concluded. **BN**

'Accreditation on wheels' up for Cavite tourism establishments

TRECE MARTIRES CITY, Cavite – The Cavite Provincial Tourism Office will conduct a 3-day 'Accreditation on Wheels' under the auspices of the Department of Tourism (DOT) on Sept. 18 to 20 from 8 a.m. to 5 p.m. at the CaCoDec Bldg. at the Provincial Capitol here.

Cavite Provincial Tourism Head Elinia Imelda Rozelle S. Sangalan said Wednesday the mobile accreditation process aims to boost the provincial tourism sector and provide a convenient venue, where local tourism and leisure establishments can apply and process their DOT accreditation.

Sangalan has enjoined owners and operators of tourist inn, hotel, resort, spa, including tourist land transport operators, agri-tourism farm/site, travel and tour agency, restaurant and tourism recreation center.

Likewise, she also encouraged practicing tour guides to apply for their DOT accreditation.

Cavite, one of the nearest complete destination from Manila, boasts of complete leisure destinations that meet tourist preference for amusement and adventure, beach, family oriented gatherings, food cravings or a taste for luxury in vacation or holiday escapades.

Applicants for DOT accreditation are advised to bring their documentary requirements when they apply such as valid Mayor's permit, Department of Trade and Industry (DTI) Accreditation (single proprietorship) or SEC Registration Certificate and Articles of Incorporation and by-laws (for corporate and cooperatives), notarized list of all employees with TIN, designation and nationality;

For hotel inn, hotel and resorts - a Comprehensive Liabil-

ity Insurance Policy Premium is also required, with a minimum coverage of PHP 200,000 for tourist inn, and PHP 500,000 for each hotel and resort.

Spa owners need to submit a valid Department of Health (DOH) license for duly registered massage therapist and massage supervisors, aside from the govt permit and list of employees.

For Tourist Land Transport Operators, additional requirements include a valid LTFRB Tourist Transport Service Franchise and LTO Registration of the vehicles are required, with a valid NAIA Concession Agreement for Tourist Coupon/Metered Taxi Operator and proof of attendance to DOT conducted seminar for tourist drivers.

Tour guides must bring their valid occupational/working permit (except for Senior Citizens), certificate of training to the tour guide seminar conducted by DOT or DOT accredited training center, valid health/medical certificate and NBI clearance.

Agri-tourism farm/sites and restaurants, as well as tourist recreation centers are advised to bring a valid government issued permit (for single proprietor, corporation and cooperative) and list of employees (with TIN, etc).

On the other hand, travel and tour agency must show proof of a working capital of PHP 500,000 (for corporations, partnerships, this is for paid up/partners capital, while single proprietors are required to submit original copy certification with cheque writer, proof of 3 years minimum managerial experience in Travel and Tour Agency or proof of passing the Travel and Tour Agency Management Training of the DOT (for General Managers).
