RPOC members meet to review peace and order programs in Calabarzon

TRECE MARTIRES CITY, Cavite (PIA) – Regional Peace and Order Council (RPOC) chairperson Cavite Governor Jesus Crispin Remulla met recently with officials from the Philippine National Police (PNP) of the provinces of Cavite, Laguna, Batangas, Rizal, and Quezon along with other Council members at Sherwood Hills Golf Club, Barangay Cabezas here.

Convened by the Department of Interior and Local Government (DILG) Regional Office IV-A who serves as secretariat, the RPOC meeting aimed to review and update the progress of the peace and order programs implemented in the five provinces.

During the meeting, the Philippine National Police IV-A Regional Director Chief Supt. Edward E. Carranza briefed the Council members on the peace and order situation in the region highlighting the significant decrease in the Total Crime Volume by 6.15% in 2018, both index and non-index crimes.

Carranza said: "We can safely say that we successfully sustained the reduction of crimes." He attributed the success to the relentless, consistent implementation

of Police Regional Office IV-A's plans and programs; best practices; and strategic crime interventions.

A 23.90% reduction on crimes based on the comparative distribution of eight focus crimes (theft, physical injury, robbery, murder, rape, carnap mc, homicide and carnap mv) was also noted for the period January 1 to August 31, 2018 as against the same period last year, which Carranza attributed to the sustained efforts of all provincial police offices.

Pointing out the downward trend on the number of crime incidents, Carranza stressed that there is a significant reduction of crimes since his assumption in June 2018, recording the all-time low incidents in August 2018 with 602.

Reports on drug situation in the region, on the other hand, was presented by Philippine Drug Enforcement Agency (PDEA) IV-A Regional Director Adrian G. Alvarino.

Dir. Alvarino said that shabu is still the primary drug of choice being used or sold in the region, adding that previous anti-drug operations revealed the prevailing modus operandi of manufacturing the illegal substance with a number of shabu laboratories raided.

He also cited the different ways of smuggling drugs into the country like the recent discovery of the four magnetic lifters in a leased warehouse in General Mariano Alvarez, Cavite.

Alvarino also reported the arrest of two Chinese nationals in a recent buy-bust operations in Rizal Memorial Stadium by the joint operatives of PDEA, Army Intelligence Regiment, and other counter-intelligence groups.

The Barangay Clearing Program wherein users and pushers were identified in a list of drug personalities with the PDEA operatives was also discussed. In this program, suspected users will undergo drug tests and if results were negative then suspects' names will be cleared from the list while those who tested positive will go through intervention programs for

rehabilitation and counseling before going back to mainstream society.

Suspected pushers are categorized as 'active'; those who 'stop' for more than six months and those that are 'no longer' residing in the barangay. Active suspects will be arrested through anti-drug operations while those that had stopped will be placed under "suspense file" for close monitoring and those that are no longer residing in the barangay should be certified by the respective barangay captain and attested by chief of police or COP.

The Dangerous Drugs Board (DDB) Resolution No. 3 series of 2017, a revised guidelines in the conduct of drug clearing operations was also discussed along with DDB Resolution No. 2 series of 2018 which tackles the guidelines for community involvement in reforming drug offenders into self-sufficient and law-abiding members of society.

In relation to DDB Resolution 2, Dir. Alvarino was happy to share the news of the launching of "Balay Silangan" in the cities of Sta. Rosa, Laguna and Lipa, Batangas which will help in the complete reformation of drug surrenderees/offenders.

Dir. Carranza's also presented the "Oplan Bandila," his brainchild program that aims to promote patriotism and sense of duty to the citizen of CALABARZON.

The initiative deals with proper decorum during flag raising ceremonies and singing of the national anthem or the implementation of RA 8491 otherwise known as the "Flag and Heraldic Code of the Philippines."

Carranza said that the Oplan Bandila is timely because some of the millennials nowadays seem to lack a sense of patriotism and love for country and this is a good way to instill among them the respect for flag, for the national anthem, while also giving them a sense of responsibility to be productive citizens of the country. **(Ruel Francisco, PIA-Cavite)**

MUSEO DE LA SALLE TO FEATURE CIRCA '50s-90s' FASHION IN CAVITE

DASMARIÑAS CITY, Cavite – In celebration of museums and galleries month, De La

Salle University's on-campus museum here will fea-

ture "MODA: Ang Pagtatahi ng Lipunang Kabitenyo" starting 2:30 p.m. on Oct 19 featuring the fashion creations of seven local designers and how these reflect the Caviteño culture.

Museo De La Salle Director Cecille Torrevillas Gelicame said Wednesday that the exhibit, which can be viewed at the museum's FSP Room, is a product of years of research by DLSU-D Faculty of History's Dr. Jesus Medina.

Medina successfully documented the Cavite fashion designers from 1950s to 1990s.

"The project, which forms parts of the museum's 'Glimpses of Cavite' exhibition program, will display selected 'obras' of the featured designers which represent the culture and semiotics of fashion in Cavite, and how it is interrelated to the local culture. And the role it played the establishment of 'Cavitesation' and its contribution to the nation's fashion landscape," Gelicame said.

The featured designers include Adorable's (Sapinoso) from Imus, Beedzee Caimol (Cavite City), Ole' Morabe (Rosario), Adrian Rios (Rosario), Ruben Samson (Imus), Ramon Santiago (Imus) and Michaelangelo Afable (Cavite City).

Moda (a French word which means trend or fashion) is a valuable aspect in the local history of Cavite as it mirrors an important trait of Caviteños who give value to cultural and religious occasions.

"Moda" reflects local practices, from personal occasions like birthdays and weddings, to church-based traditions like 'Santa Cruzan' (a parade of beauties held every month of May) and 'Flores de Mayo' (offering of flowers during the month of May), the Spanish influenced traditional dance 'Rigodon de Honor' and other traditions and merrymaking.

Most important of all, is how each of the designers' unique design, style, and materials used, including the color and what occasion it was used are considered valuable works of art, adds Gelicame.

Entrance to the museum comes with a fee and interested guests may come and visit the museum Tuesday to Saturday, 9 a.m. to 3:30 p.m.

DOH-CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) Regional Director lauded the participants of the province of Rizal for having one of the best hospital health care system in the region during the three-day "Collaborative Planning Workshop on Quality Management for City Health Offices, Rural Health Units and Barangay Health Stations of Rizal Province" held at the Ramada Hotel in Binondo, Manila on October 3-5, 2018

"It is very important that health workers in the community will have to complement the level of health care system in the hospitals to reduce the overload of patients. Patients must patronize rural health units because they are the frontline in providing patient care," he stated.

"It is for this reason that the regional office created the health facility operations and development unit to provide facility, equipment and technical support to rural health units and to ensure their capabilities to provide primary care to their

respective areas," he added.

As of 2017, there are a total of licensed 26 birthing homes, 17 TB-DOTS Centers, 12 Animal Bite Treatment Centers (ABTC), 1 Maternity Care Package (MCP) provider and 1 clinical laboratory.

Janairo emphasized that the regional office has the responsibility and obligation to extend support including human resource in order to ensure that every rural health unit will be functional and properly equipped. "Patients must go to their nearest health unit and not to a distant hospital which can be costly with regards to transportation and other expenses."

join hands and together we can provide greater service to our people," he encouraged.

The nature of public health nurses' work in hospitals and in the community is physically and emotionally demanding. "They don't just deliver care and provide physical and emotional comfort to patients and their families; their work also

entails critical tasks such as monitoring and assessment of their patients and assists in the conduct of disease surveillance and initiating interventions in the communities to prevent outbreaks".

Currently, there are a total of 1,496 deployed in the region under the under the Nurse Deployment Program or NDP. Cavite with 235 nurses, Laguna with 289, Batangas -235. Rizal - 241 and Quezon with 406.

According to Director Janairo, DOH-CALABARZON is the only regional office who have employed all job order nurses for 2018 even with the budget reductions implemented. "We do not want to sacrifice health care particularly now that we have the Dengvaxia concern to monitor for 5 years. We also need the manpower to accommodate the growing health needs of its population of 14,414,774, making it the most populated region in the country."

The Department of Health (DOH) Deployment Program is a composite of several human resources for health that aims to deploy, community-oriented and dedicated human resources for health to difficult areas.

The objective of NDP is to improve access to quality healthcare services, address the inequitable distribution of healthcare professionals and augment the need for human resources for health especially in rural, underserved, hardship communities; improve local health systems that will support the country's attainment of universal health care or "Kalusugan Pangkalahatan" and increase the health workers' employability through the provision of learning and development opportunities;

Director Janairo also assured support to local government nurses who were devolved during the local health devolution of 1991 which caused the decline in the quality and coverage of health services particularly in rural and remote areas. **GA**

NHCP brings Wolf's 'Nutart' exhibit at Museo ni Emilio Aguinaldo

KAWIT, Cavite – Art enthusiasts in Cavite and nearby provinces may still view the ongoing nutart exhibit of visualizer and freelance children's book illustrator Bernadette Solina-Wolf, which runs at this historic town's Museo ni Emilio Aguinaldo gallery until Oct 31.

The Cavite leg, entitled "She Drew It in a Nutshell: The Art of Bernadette Solina-Wolf" is part of the ongoing outreach exhibit project, running for three years now, in various museums and National Historical Shrines of the National Historical Commission of the Philippines (NHCP).

MEA curator Haidee Paulette M. Bedruz said Thursday that the exhibit, MEA's offering for the Museums and Galleries month, will put on display Wolf's artworks depicting fragments of Filipino life in an unconventional canvas, empty coconut shells.

"The exhibit deals with two opposite ends of our cultural milieu—the indigenous, and that which became the Filipino life as a colony," Bedruz said.

A resident of Puerto Galera in Mindoro, Wolf initially painted sea life as subject for her works as she started painting on coconut shells back in 2006.

"Nutart is an on-going personal artistic endeavor with Philippine indigenous peoples and Filipiniana as my favorite theme using coconut shell as my canvas medium," shared Wolf.

Inspired by the rich biodiversity the country has to offer, she also painted the monkey-eating eagle and owls endemic to the country into the 'baos' (coconut shells).

Collaborating with her husband, a German engineer, she has, to this date, created 1,200 paintings.

The exhibit features 21 of her acrylic works, six of which are categorized into 'worn culture' featuring traditional attires, wardrobe, reflecting the self and society the individual belongs to and a visual identification of a person or a group, as evident in their everyday life and in their cultural, social, and spiritual beliefs. Traditional attires also mirror one's environment, social status, or gender. It is the tangible manifestation of what is practical, beautiful, and significant to people.

The other three is under 'Venerated Images,' which speaks of the commitment of the people to the Catholic faith that is nurtured by experience.

Others include five works under 'Nurtured Child,' (various mother and child artwork) and another six depicting 'Everyday Realities' which features old childhood games like 'tumbang preso,' 'luksong tinik,' and 'sipa' plus the backdrop 'Grass Owl.'

MEA is one of the three NHCP museums in Cavite, with Museo ni Baldomero ni Aguinaldo (MBA), located also in Kawit and the Museo ng Paglilitis ni Andres Bonifacio (Bonifacio Trial House) in Maragondon town.

It is located at the ground floor of the iconic Emilio Aguinaldo Shrine, in Kaingen village here and open Tue to Sun, from 8am to 4pm.

DLSU to host Luzon leg of Filipino film centenary expedition

DASMARIÑAS CITY, Cavite – In celebration of one hundred years of Filipino film artistry, the organizers of "Sandaan: Philippine Cinema Centennial Conference – the Filipino Film Centenary Expedition" is gathering Philippine Cinema filmmakers, students, teachers and enthusiasts in Luzon at the De La Salle University campus here for a 2-day Filipino film appreciation from Nov. 22 to 23.

Organized by the National Commission for Culture and the Arts (NCCA) and in partnership with the Communication and Journalism Department of DLSU-D, Ateneo de Cagayan, and Cine Kasimanwa, the DLSU-D leg is part of "Sandaan's" Philippine-wide tour, targeting the three main island groups of Luzon, Visayas and Mindanao from Nov. 16 to Dec 9,

aimed to have wider, nationwide celebration of Filipino film industry's 100th year.

The regional legs were conceptualized "for the regional filmmakers to be given a chance to understand the historical development of Philippine cinema," Rosanni Recreo-Sarile, DLSU-D director for Marketing Communications Office and Sandaan PCCC TFFCE Media Liaison, said.

Besides, the diversity of film outputs from locations outside Metro Manila – the traditional center of filmmaking in the country – necessitates the inclusion of regional filmmakers in the mapping of the future of Philippine cinema.

As cinema is a powerful tool in calling attention to societal concerns and serves as a document of the culture and heritage of a particular time, "it is imperative

that local filmmakers are equipped with the knowledge of the foundation of local filmmaking history and its lessons," Sarile added.

After the 2-day Luzon conference, the participants are expected to gain insights on Philippine cinema and its icons, which could serve as inspiration to local filmmakers, students, film teachers and enthusiasts to re-connect to these foundations and influence their own filmmaking techniques.

Film screening will be conducted to provide models on style and content of iconic Filipino films and forums, talks on various topics related to Philippine filmmaking as managed by critically-acclaimed speakers and experts.

The "Sandaan" have had two Metro Manila legs, one each at the University

of the Philippines (Diliman, Quezon City) and at the College of St. Benilde (Manila).

For the regional legs, it will go first on its Mindanao expedition, at the Xavier University-Ateneo de Cagayan Little Theater from Nov 16 to 17; followed by the DLSU D, Luzon leg, while University of the Philippines Visayas (Iloilo) West Visayas State University (Iloilo), Filamer Christian University (Capiz) and Dept of Education – Schools Division of Capiz (Capiz) are the Visayas venues from Dec. 5 to 9.

The project directors include Artin Umali for DLSU-D event; Elvert Beñares (CineKasimanwa) and Hobart Savior (Ateneo de Cagayan) for Luzon, Visayas and Mindanao, respectively. (**Gladys Pino-PNA**)
