**MAHIGPIT na ipapatupad ng city government ng Dasmariñas ang total ban laban sa mga paputok o firecrackers at ang tinatawag na 'boga.'**

Ang 'boga' ay isang improvised cannon na gawa mula sa PVC pipe, bamboo at tin can.

Ito ay alinsunod sa City Ordinance No. 07-S-2018, na naaprubahan nitong nakaraang October 3.

Isinasaad sa ordinansa na hindi lamang sa paggamit bagkus ay ipinagbabawal din ang paggawa at pagbebenta ng mga ito.

Sa darating na Nobyembre 15 sisimulan ang implementasyon ng nasabing total ban.

Layunin ng pamahalaang lungsod na makatiyak ng kaligtasan ang publiko sa panahon ng holidays o kapaskuhan.

Bahagi rin ito ng pakikisa ng city government sa kampanya ng administrasyon ni Pangulong Rodrigo Duterte hinggil sa regulasyon ng paggamit ng paputok o firecracker.

Gayundin upang maisulong ang tinatawag na zero firecracker-related injury at casualty.

Ang piccolo, super lolo,

whistle bomb, bawang, labintador, five-star, goodbye Philippines/earth, pla-pla, Judas' belt/sawa, skyrocket/kwitis, baby rocket, pull-string, watusi, pillbox, mga walang tatak na firecrackers at ano mang gamit o device na binalutan ng explosive device ay istriktong ipagbabawal.

May regulasyon namang ipapatupad ang city government para sa pyrotechnic devices o 'pailaw' kagaya ng sparklers, luces, fountain, jumbo (kapwa regular at special), mabuhay, roman candle, trompilo, airwolf, at butterfly.

Kukumpiskahin sa mga menor de edad o 18-anyos pababa ang mahuhuhiling dala o ginagamit nilang paputok o 'boga.'

Sa mga matatanda o nasa hustong gulang na ay may kaukulang multang P500 o pagkakakulong ng hindi lalagpas sa isang taon sa sandaling labagin o suwayin ang naturang ordinansa.

Ang mga mahuhuling gumagawa o nagbebenta ng walang kaukulang mga permit ay may multang P5,000 o pagkakabilanggo ng hindi hihigit sa isang taon. **RS/GP**

# CALABARZON INTER-GRADE SCHOOL QUIZ FINALS SET NOV.12

**LUCENA CITY, Quezon –** The regional finals of the annual inter-grade school quiz show in Calabarzon is set at the Manuel S. Enverga University Foundation here on Nov. 12.

Hosted by the Batangas-based Philippine Science High School (PSHS) campus, the activity hopes to showcase the versatility of contestants in answering questions in science and math in varying difficulties.

PSHS Chief of Curriculum and Instruction Division Joni M. Albarico said in PSHS' letter to Cavite Schools Division Superintendent Cherrylou D. Repia that the regional finals will also help promote the PSHS campus in various

public and private elementary school in the region,

The quiz show, entitled "BANGABANG", was inspired by the Batangueño expression, which means unruly or disordered. It will serve as a major event during the Department of Science and Technology's Science and Technology (DOST) Week, Albarico said.

The contest was opened to all public and private elementary schools in Region IV-A (Calabarzon), wherein each school is given a 2-team slot of bonafide Grade 5 students plus coach; and the regional finalists are the top 5 teams

during the provincial eliminations held on Oct. 27.

The competition is divided into easy, average rounds where the first 2 rounds will be composed of 10 questions each and shall earn them 2 and 3 points per correct answer, respectively, while the difficult round will have 5 questions worth 5 points each.

The teams with the top 3 highest scores shall be declared as winners.

# DASMARIÑAS CITY PUBLIC UNIVERSITY TO RISE IN 2020

**DASMARIÑAS CITY, Cavite – A PHP336-million “Pamantasan ng Dasmariñas” (city-run university) is projected to rise at the Burol main village in the city’s bid to further strengthen its education program and provide access to quality tertiary education for residents here.**

The Pamantasan ng Dasmariñas – College Building 1 is targeted for completion by March 2020 and will offer a collegiate degree to financially constrained residents, according to the Office of City Mayor or Elpidio Barzaga Jr.

The public university is expected to open doors of opportunities to city folks to become professionals and self-reliant individuals who will contribute to the progress of the city and nation.

The city, known as melting pot of great minds and exceptional talents, is home to bemedaled athletes such as Veruel Verdadero (fastest man in Palarong Pambansa 2017 and 2018 and Junior Sprinter of the Philippines Team), Jason Jabol (currently the fastest Batang Pinoy runner); Evangeline Caminong (new record holder in high jump, Philippine Team), to name a few.

To produce competitive and world-class athletes in the field of athletics, the city

government also earmarked some PHP136 million for the construction of a sports complex with track and field oval, which will be completed by 2019.

Besides holding sporting events, the ‘grandstand’ would also serve as venue for concerts and other outdoor activities.

Construction of both projects started after the groundbreaking rites on Sept. 22, timed during the birthday celebration of Cavite 4th district Representative Jennifer Austria-Barzaga.

These projects sit on a 12.8-hectare land purchased by the city government in 2006 to be the home of infrastructure projects such as the public university, grandstand, track and field oval and the City of Dasmariñas (COD) Arena.

The COD arena, a small version of the Mall of Asia (MOA) Arena, has a 4,800-seating capacity, equipped with amenities such as function rooms, a media coverage room, an arcade, kiosks, a ticketing office, changing and storage rooms, bleachers, event area, 343 regular parking slots and 27 bus parking slots.

It will be utilized for big sporting events and other entertainment (indoor and outdoor) events.

# COOPERATIVISM IN CAVITE STEPS UP WITH GAD

Seeking to establish more gender sensitive cooperatives in Cavite, almost 200 coop leaders gathered at The Junction in Tagaytay City on October 26, 2018 for the 6th Cavite Cooperative Leaders Conference, which focused on Gender and Development Mainstreaming as part of stepping up with the United Nations Sustainable Development Goals (SDGs).

Caviteños warmly welcomed guest and keynote speaker, Senator Risa Hontiveros, Chairperson Senate Committee on Women and Gender Equality. Senator Hontiveros put emphasis on women's rights and the big role that women play in cooperatives. With this, the lady senator asked cooperatives to support the implementation of the Expanded Maternity Leave providing 55 more days on paid maternity leave, from 60 to 105 days. Likewise, Senator Hontiveros disclosed that the bill includes provision of seven days transferable leave to men, to be known as the "daddy quota," which can be an example of GAD mainstreaming that promotes shared responsibility on child care and equal parenting.

Mr. Alvin S. Mojica, Provincial Cooperative Livelihood and Entrepreneurial Development Office (PCLEDO) head, who introduced the senator prior to her keynote speech, took the opportunity to thank Senator Hontiveros and everyone who attended the event, making the occasion a huge success.

Meanwhile, Cooperative Development Authority (CDA) former Administrator Mercedes Castillo provided a holistic overview on the theme "Cavite Cooperatives: Stepping up with the United Nations Sustainable Development Goals through Gender and Development Mainstreaming," linking women and the development process towards a stronger organization that could successfully contribute to economic progress.

She even encouraged participants to be GAD advocates and must take the initiative to incorporate GAD activities in their respective cooperatives.

In order to help coop leaders on how to begin their GAD plans, Cooperative Development Specialist from CDA, Ms. Jeramel Valdez shared their agency's framework on gender and development, showing different matrix on diverse activities centered on GAD including capacity building as well as linking with partners and service providers. According to Ms. Valdez, coops are a reminder to the community that it is possible to pursue both economic viability and social responsibility.

Furthermore, coop stories of two successful cooperatives in the country added inspiration for everyone to focus on gender equality towards building resilient cooperatives. Ms. Maide Obdianela Jader, GAD Focal Point System Technical Working Group and Chairperson of Government Employees of Tayabas (GET) Multi-purpose Cooperative, talked about their journey as they incorporate GAD activities to their flourishing organization and how it helped them reach their goals. Ms. Jader also underscored the importance of using gender-fair languages in the organization.

On the other hand, Mr. Alexander Raquepo, Chairperson of Sta. Cruz Savings and Development Cooperative and Vice President-Gender Equality Resource Center Inc., proudly shared how GAD affects their coop in a very positive way. Mr. Raquepo, being one of the first male GAD resource speakers in the country who has been in various countries for GAD advocacy, emphasized that gender equality should start at home with families. He even stressed out that men must be involved in achieving absolute gender equality, telling

his experience in Sweden when he encountered men babysitting instead of their wives. Mr. Raquepo emphasized that even doing household chores does not make one less a man. He also happily revealed that the statistics of Sta. Cruz Savings and Development Cooperative showed and proved how having gender sensitive family members have increased their collection and encouraged more participation of members to every assembly and other activities.

Atty. Khervy Reyes, Head, PCLEDO Cooperative Division, led the awarding of certificates and tokens to resource speakers and thanked them for lending their time and skills for the benefit of cooperatives in the province, on behalf of Governor Boying Remulla and PCDC Chairperson Fr. Arturo Balagat.

The event continued with the Koop Awards Night, which highlighted cooperative excellence and gave wider recognition to coop leaders. Among the awards granted include The Most Promising Cooperative, Best in Assets, Best Coop in Micro, Small and Medium-scale Category, Most Diversified, and Most Participative Local Coop Development Officer and other special citations. —(PICAD)
