DOST Calabarzon to inaugurate new S&T hubs in Quezon, Rizal

LOS BAÑOS, Laguna — The Department of Science and Technology (DOST) Calabarzon is set to inaugurate two newly-built Science and Technology hubs in the region during its three-day celebration of 2018 Regional Science and Technology Week (RSTW) from Nov. 12 to 14, with the theme "Science for the People: Innovation for Collective Prosperity."

Rochelle L. Cruz, head of the public affairs, relations and communications unit (PARCU) of DOST Calabarzon, said the inauguration of the Quezon Provincial Science and Technology Center (PSTC) Building at the Southern Luzon State University-Lucena Campus on Nov. 12 kicks off the RSTW celebration.

"DOST-Calabarzon will showcase the extent of Science, Technology, and Innovation programs and services given to our com-

munity-based partners, Micro, Small and Medium Enterprises (MSMEs) and countryside in general through exhibits and fora," Cruz said.

She said each PSTC will house a service laboratory as Center for Hazard and Environmental Resource Mapping (CHERM) in Quezon while a Regional Design and Creativity Hub for Innovation in MSMEs and Education (RD-CHIME) will be established at the Rizal PSTC.

Cruz added that aside from the interactive exhibits, the DOST regional office will also host various forums and activities aimed "at surely making science more interesting for the people and the viewing public and become more aware of S&T programs and projects."

"We innovate. We make a difference. This is DOST-Calabarzon's commitment to its stakeholders. We are continuously

delivering innovative and efficient S&T assistance to make science closer to the people," she said.

The inauguration of Rizal PSTC Building located at the University of Rizal System-Antipolo City Campus will be held the next day (November 13).

The three-day S&T event will feature exhibits from various DOST agencies, private organizations, academe, and MSMEs at the Quezon Convention Center in Lucena City, Quezon.

The featured technologies include Mobile Planetarium, DIWATA, Augmented Reality and Storm Surge Simulator, Therapeutic Handloom, 3D Printer, Nipa Distilled Spirit Processing, Makapuno Island Products and Travelling Exhibits of the Philippine Science Centrum, among others. (**Saul Pa-a**/PNA)

CAVITE STUDENTS JOIN 4TH NATIONWIDE QUAKE DRILL

NOVELETA, Cavite – At the strike of 8 a.m. Monday, scores of grade schoolers and high school coeds joined local government officials and town hall employees here in the simulated drills and mock demonstrations for this year's 4th Quarter Nationwide Simultaneous Earthquake Drill 2018 and "World Tsunami Awareness Day".

Jeg Alix, head of Novelleta's Municipal Disaster Risk Reduction and Management Office (MDRRMO) and the DRRM staff monitored the five public elementary schools and two public high schools as students executed the "Duck, Cover and Hold" positions during the quake drills.

"In this drill, we demonstrate and teach the school children and residents the

proper way to keep safe in case an earthquake strikes in our place. Each of us should be always prepared," Alix said in an interview with the Philippine News Agency (PNA).

Cavite provincial government officials and employees staged their simulated drills at the Provincial Capitol grounds in Trece Martires City with the necessary support mechanisms for search, rescue, recovery, and relief operations.

Meanwhile, the Bacoor City DRRMO staged its "World Tsunami Day" drill and mock demonstration in the event of a tsunami disaster along the stretch of Evangelista St. The Banalo Bridge and Barangay Alima were temporarily closed to vehicular traffic to show the extent and scope of a "tsu-

nami alert" and "disaster waiting to happen" in this Cavite gateway and coastal city.

In Dasmariñas City, chief of the city police Supt. Nerwin Ricohermoso led his men in coordinating with the City DRRMO for the earthquake and tsunami alert drills.

In General Trias City, Hernando Olimpo, head of the city DRRMO, said in an interview that they scheduled the drills on Tuesday, instead of Monday, to give way to the regular flag-raising ceremony in government offices and schools.

Olimpo said they have timed the drills to parade their PHP11.9-million worth of brand-new Nissan Rescue Trucks, at the town plaza. (*Dennis Abrina/PNA*)

DILG, PIA conduct media forum on Federalism

CALAMBACITY, Laguna (PIA) – More than fifty participants composed of media practitioners, government information officers and academe members from the Calabarzon region recently gathered here for a Media Forum on Federalism.

The Department of the Interior and Local Government Region 4A, in partnership with the Philippine Information Agency Region 4A (PIA 4A), led the forum held at the Paseo Premiere Hotel in Sta. Rosa City last October 24.

The event that marked the commencement of the two-day Federalism Roadshow in Calabarzon, served as a venue to clear out misinformation and orient the media and communicators from the government and academic sectors of the facts on Federalism.

Communicators are seen as partners of the current Administration in relaying to the public the correct information and understanding about having a Federal System.

"The issue of Federalism involves all stakeholders. Your presence is an indication of the need for collaboration between the government and the media as partners in disseminating information on the ground," said PIA4A Regional Director Ma. Cristina C. Arzadon in her welcome remarks as she recognized the significant role of stakeholders in intensifying public awareness on the proposed shift to a Federal Government.

Sec. Gary B. Olivar of the Center for Federalism and Constitutional Reform (CFCR) talked about the background and fundamentals of Federalism to enlighten the participants.

Federalism, he said, is a form of government where sovereignty is constitutionally shared between a central authority and states or regions.

The National Government will focus on national interests such as foreign relations, national security, and monetary policy while the autonomous regions or states will be responsible for the delivery of public goods and social services, and of local economic development.

"Understandably people are worried about immediate issues like the rise in prices, rice problem, and inflation, among others, but eventually we will see that Federalism has a big part in establishing a long term solution to this short term problem," Olivar added.

He explained that the government continues with the information campaign on Federalism in the midst of urgent problems faced by Filipinos because in the long term it is one of the important ways to stabilize and grow the economy faster and to resolve issues in food, prices, and inflation.

According to Olivar, the Philippines had been left behind among the Asian countries in terms of Gross Domestic Product and infrastructure in the past years. It is also said to be unique for being the only country in Asia that failed to halve poverty in 25 years from 1990 to 2015.

With this, he pointed out that the proposed Federal System could cure this long time concern since the decentralization of power and budget to states or regions will capacitate them to fast track economic and infrastructure developments within their jurisdiction.

Lawyer Susan U. Ordinario, one of the members of the Consultative Committee tasked to Review the 1987 Constitution, on the other hand, expressed her gratitude to the media practitioners of Calabarzon region as she recognized them as partners in countering

the spread of fake news about Federalism.

"The President directed us to work independently and do what we think will be best for our country and people," she said.

She pointed out that the committee came up with the proposed Federal Constitution not because the 1987 Constitution is a bad constitution; it is actually the best constitution for its time.

However, she said, that anything made by man needs to be updated and upgraded every now and then as we have witnessed the inveterate problems of the system from administration to administration. "What we have seen as solution to these longstanding problems is having a structural change," Ordinario added.

She compared it with a house pestered and damaged by termites that needs to be reconstructed. In the case of the Constitution, it needs a structural change.

"It is not true that the only problem is the one in the position with all the years that have passed, it can't only be because of a person and it is impossible that all of them are bad."

She explained that structures affect behavior given the example of Filipinos not following traffic rules in Manila, while, they do follow traffic rules whenever they are abroad or in Subic, for instance.

Ordinario also tackled the salient features of the Draft Federal Constitution comprised of the structure and distribution of powers of the State Government and Federated Regions; the economic, social and political reforms; the national territory; state policies and principles; constitutional bodies; and transition provisions. CARMONA SLATES COUNTDOWN TO SORTEO FESTIVAL

CARMONA, Cavite – The local government will launch on Monday a “100-day countdown” leading to the holding of its 2019 Sorteo Festival, one of the town’s most anticipated and celebrated event held every three years during the month of February.

Municipal mayor Dahlia Loyola will lead municipal officials in the unveiling of the countdown board to be held at Hon. Marciano Mapanoo Park (also known as the Carmona Town Plaza) at 6 p.m.

Carmona’s ‘Sorteo sa Bukid ng Bayan,’ or simply known as Sorteo Festival, showcases the lottery of communal agricultural lands among local folks.

According to the Sangguniang Bayan (legislative council) some 109 lots of

communal lands are up for lottery next year.

Carmona, formerly a barrio of Silang named ‘Latag,’ gained its independence in Feb. of 1857 and was called ‘Carmona’ (derived from a province of Seville, Spain).

Stipulated in the decree signed by then Governor General Ramon Montero y Blandino granting Carmona’s independence from Silang, was that certain parcels of land shall be communal to town residents for grazing and cultivation.

This ‘communal’ status enticed immigration from different parts of the country and to democratically settle the dispute, the Spanish government initiated ‘subasta de las tierras comunales del pueblo de Carmona’ or the lottery of com-

munal lands of the town of Carmona, which is held every three years and has become a tradition which the town practices until now.

It was in 2003 when then Mayor Roy Loyola turned the unique tradition as a festival, to make it known throughout the country.

The triennial celebration started to be marked with a week-long gala of colorful competitions, showcase of talents and parade of beauty and artistry on top of the three-day actual lottery marathon of communal lands.

The Nov. 12 launch activity will offer snippets of the grandeur of the actual festival as it holds the semi-final round of ‘Gintong Tinig, Gintong Himig’ (golden voice, golden hymn or GTGH) singing competition,

where contenders composed of 10 children and 10 adults outdo the others with their singing prowess (where winners will advance to the grand final round, happening during the Sorteo Festival next year).

Guests will also be treated to a glamorous production number featuring 18 candidates of the much awaited ‘Binibing Sorteo,’ plus other special numbers from dance crews Le’ Go Fam and One Motion Crew to spice up the stage.

The municipal mayor shall leverage the launch event to offer a glimpse of activities for the festival next year and to publicly introduce the festival commissioners. (**Gladys Pino-PNA**)
