Isinagawang IEC advocacy ukol sa pederalismo, dinaluhan ng iba't-ibang HEIs

LUNGSOD NG BATANGAS (PIA)- Pinangunahan ng Commission on Higher Education ang isang information, education and communication (IEC) advocacy ukol sa pederalismo na ginanap sa Batangas State University Main Campus sa lungsod na ito kamakailan.

Ito ay dinaluhan ng mga propesor at mag-aaral mula sa iba't-ibang higher education institutions (HEIs) gaya ng state universities and colleges (SUCs) sa Calabarzon.

Ayon kay CHED Commissioner J. Prospero De Vera, ang advocacy campaign na ito ay maituturing na isang malaking pangangailangan lalo na ng sektor kung saan may 112 SUC's at 350 campus sa buong bansa.

"Ito ay itinuturing naming isang parallel initiative sa ginagawa ng Department of Interior and Local Government (DILG) upang ipaabot sa mga opisyal ng barangay at residente ang mga kaalaman upang maipaunawa kung ano ang pederalismo. Sa bahagi naman namin ay sa mga kabataan na bumubuo sa malaking bahagi ng populasyon, masasabi nating isang napaka-importang network ang mga SUC's upang talakayin ang isang maselang usapin tulad ng pederalismo," ani De Vera.

Dagdag pa nito na ang pederalismo ay paghahati-hati ng powers, pagdedesiyon at pamamahala na sa loob ng ilang dekada ay hindi nagagawa upang mas mapaunlad ang pamumuhay ng mga Pilipino.

"Nakikita ko na hindi resistance kundi kakulangan ng impormasyon ukol sa pederalismo ang dahilan kung bakit hindi ito maisulong, kulang ang alam ng mga tao lalo na ang mga kabataan sa totoong mag-

iging estado ng pamahalaan kung sakaling ito ay maipatupad," ayon pa kay De Vera.

Samantala, tinalakay ni Atty. Susan Ordinario, miyembro ng consultative committee na naatasang mag-review ng 1987 Constitution, kung ano ang Draft Federal Constitution.

"Inatasan kami ni Pangulong Duterte na magsagawa ng pag-review sa Constitution at tignan ano ang mas mainam para sa bansa lalo na sa mga Pilipino. Ang 1987 Constitution ang maituturing na pinaka-maayos na konstitusyon noong panahong iyon ngunit habang tumatagal ang panahon kinakailangan natin ng mga pagbabago lalo at nakikita natin ang mga Sistema mula sa iba't-ibang administrasyon," ani Ordinario.

Nauna na rito, nagsagawa rin ng Forum on Federalism ang BatStateU at DILG na dinaluhan naman ng mga barangay officials at miyembro ng konseho nito. **(Bhaby P. de Castro-PIA Batangas)**

New MPD chief leads surprise drug test



MANILA — Newly-appointed Manila Police District (MPD) Acting Director, Senior Supt. Vicente Danao, spearheaded a surprise drug test on 110 MPD officers and personnel on Tuesday.

In a statement Wednesday, the MPD said the test was conducted before the start of the regular command conference.

Danao was the first one to undergo drug test and he was followed by the members of the Command Group, Station Commanders and PCP Commanders.

He said the conduct of the random drug test shows that the MPD leadership is serious in wiping out scalawags within the organization, stressing that a more comprehensive and holistic approach in weeding out misfits should start from

within.

He said MPD personnel who will be found positive of illegal drug use and involvement in illegal drug syndicates shall be sanctioned accordingly and will be subjected to dismissal from police service.

Danao also said the new leadership of MPD ensures unwavering and steadfast performance of its mandate and duties in serving and protecting the people, and in maintaining the peace and security of the country's capital city.

The new drug tests came after the mandatory drug test done recently also at the MPD on orders of NCRPO head, Director Guillermo Eleazar, and in the wake of the arrest of PO1 Redentor Bautista, who was reportedly caught in the act of sniffing cocaine inside a bar in Taguig.

DOH CALABARZON SIGNS TRIPARTITE MOA FOR BACCOOR DISTRICT HOSPITAL

DOH-CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) together with the provincial government of Cavite and city government of Bacoor signed the "Tripartite Memorandum of Agreement" for the continuous provision of assistance and support for expansion of the hospital facility to serve the growing population and health needs of the city.

"We will be providing the appropriate technical, manpower and logistic support needed to for the improvement and health services of the hospital and ensure that the residents will be given the necessary health care assistance they need, especially the indigents," Regional Director Eduardo C. Janairo stated during the signing held at the Bacoor City Hall in Cavite on November 9, 2018.

"We will be bringing in consultants from Batangas Medical Center to provide clinical support for specific departments of the hospital and also provide training assistance and other technical support based on the health status of Bacoor", he added.

Infrastructure improvements and additional hospital equipment for the district hospital will be accommodated and provided through the DOH-Health Facility Enhancement Program.

According to Janairo, proper assessment will be done to identify the needs of the facility including issuance of appropriate licenses and provision of basic health services for the required level of operation.

"Collaboration and mutual cooperation with local

governments towards the development and improvement of health care system in the community for better health outcomes is one of the main thrusts of CALABARZON Prime".

The Bacoor District Hospital was established in 2019 through Sangguniang Panlalawigan Resolution No.084, Series of 2011. It is a 10-bed capacity with complete with laboratory, ER equipment and services for OPD.

Cavite coop conference promotes Gender & Development mainstreaming

TAGAYTAY CITY, Cavite (PIA) – The provincial government of Cavite thru the Provincial Cooperative Livelihood and Entrepreneurial Development Office (PCLEDO) recently conducted the 6th Cavite Cooperative Leaders Conference held at The Junction here.

Almost 200 leaders of registered cooperatives in the province attended the event which focused on Gender and Development Mainstreaming highlighting the United Nations Sustainable Development Goals (SDGs).

PCLEDO head Mr. Alvin S. Mojica expressed his sincere gratitude to all participants especially to honorable guest and keynote speaker Chairperson Senate Committee on Women and Gender Equality, Senator Risa Hontiveros.

Senator Hontiveros spoke about the important role and the rights of women in relation to cooperatives and elaborated on the Expanded Maternity Leave that provides an additional 55 days of paid maternity leave giving ample time for mothers to rest and take care of their babies, with additional provision that allows 7 days of which are transferrable to the husbands referred to as "daddy quota".

A holistic overview on the theme "Cavite Cooperatives: Stepping up with the

United Nations Sustainable Development Goals through Gender and Development Mainstreaming," was presented by former Administrator Mercedes Castillo of the Cooperative Development Authority (CDA) and encouraged active participation towards achievement of GAD.

Meanwhile, CDA Cooperative Development Specialist, Ms. Jeramel Valdez presented the different matrix on diverse activities focused on GAD and said that "coops are a reminder to the community that it is possible to pursue both economic viability and social responsibility".

Success stories of two cooperatives in the country namely: Government Employees of Tayabas (GET) Multi-purpose Cooperative represented by Maide Obdianela Jader, Chairperson and GAD Focal Point System Technical Working Group, and Sta. Cruz Savings and Development Cooperative represented by Chairperson and Vice President-Gender Equality Resource Center Inc. Alexander Raquepo were shared to give encouragement and inspiration to all participant attendees.

Jader stressed the use of gender-fair languages and the incorporation of GAD activities as important contributing factors in the success of their organiza-

PRRD DECLARES MARCH 22, 2019 AS 'EMILIO AGUINALDO DAY'

MANILA — President Rodrigo R. Duterte declared Mar. 22, 2019 as "Emilio Aguinaldo Day" to commemorate the 150th birth anniversary of the country's first and youngest Philippine president and revolutionary hero.

Under Proclamation No. 621, which was signed by Executive Secretary Salvador Medialdea by authority of the President, the National Historical Commission of the Philippines (NHCP) will be tasked to lead the implementation of the program of activities on Emilio Aguinaldo Day.

"The National Historical Commission of the Philippines (NHCP) is hereby designated as the lead agency for the celebration of the 150th birth anniversary of Emilio Aguinaldo," the proclamation read.

"The NHCP may convene an inter-agency task force to plan, coordinate, and implement effectively

all programs, projects, and activities relative to this milestone event," it added.

Meanwhile, all departments, agencies, bureaus, offices, and national government agencies, local government units, and government-owned or controlled corporations, and educational institutions at all levels, are enjoined to give full support and assistance, consistent with their respective mandates, to the NHCP in the exercise of its responsibilities under this proclamation.

The necessary funding for various commemorative activities shall be sourced from the regular appropri-

tions of the concerned agencies.

The proclamation was signed to recognize Aguinaldo, who "symbolized the desire of the nation to be self-reliant, independent, and free from oppression."

It is also meant to "rekindle the Filipino spirit through the lessons of history and encourages every citizen to emulate and honor our forefathers."

Aguinaldo, who died on Feb. 6, 1964, was also known as the hero of the Philippine struggle for independence for leading the revolution against Spain in 1896. (PNA)
