NAMAHAGI ang may 134 na mga nanay ng kanilang gatas sa "First Regional Human Milk-Donation Campaign ng Department of Health (DOH)- CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon).

Sinabi ni DOH-CALABARZON Regional Director Eduardo C. Janairo na layon ng pagbibigay ng gatas ng ina ay upang matiyak na may sapat at ligtas na human milk ang mga sanggol na premature, undernourished, mga batang may sakit at mga sanggol na walang sapat na madede sa kanilang ina.

"Our objective is to ensure that every child will be provided with safe human milk including premature, undernourished and sick infants and babies who cannot get enough milk from their mothers," paliwanag ni Janairo sa "First Regional Human Milk-Donation Campaign" na may temang "Gatas Mo Inay, Handog ay Buhay" na isinagawa sa Jesus of Nazaret Hospital sa Batangas City nitong Biyernes.

Hinikayat ni Janairo ang mga nanay na may sapat na gatas sa kanilang kawalan na mag-donate sa "milk bank" upang makatulong sa ibang mga bata at ipamahagi ang nautrisyon na nakukuha lamang sa gatas ng ina.

"I encourage every healthy nursing mother who have abundant breast milk

to donate some to milk banks to help other babies to survive and share the optimum nutrition that only breast milk can provide," ayon pa kay Janairo.

Ayon sa World Health Organization (WHO) na ang gatas ng isang ina ay ang pinakamasustansiyang gatas na kailangan ng isang sanggol sa mga unang taon ng kanilang paglaki kung saan may antiviral components ito na magpapalakas sa immune system ng bata at makaiwas sa sakit tulad ng diarrhea at pneumonia, nakakapagpabawas sa posibeling sakit sa breast at ovarian cancer, Type 2 diabetes postpartum depression sa mga nanay.

Ayon kay Dr. Felices Emerita P. Perez, Head of the Family Health Unit of DOH-CALABARZON na ang malilikom na mga gatas ng ina ay ito-turn over sa Batangas Medical Center kung saan nag-iisa na DOH-approved human milk bank para sa processing at pasteurizing upang ipamahagi ito sa mga naggangailangan sanggol gayundin sa mga working mothers.

Gayunman ang mga inang mamimigay ng kanilang gatas ay sasailalim din sa screening process para sa Hepatitis B at human immunodeficiency virus (HIV) upang masiguro na ang ipapamahaging gatas ay hindi kontaminado ng anumang sakit. **GENE ADSUARA**

Museo Aguinaldo brings experience to the blind

KAWIT, Cavite – The 'Museo ni Emilio Aguinaldo' or MEA is now officially a museum, 'also' for the blind, as it translated several art collections into 3D objects, tactile and Braille through its 'Inside Out: Museum Unboxed' project.

The project is under the auspices of the National Historical Commission of the Philippines (NHCP), Rotary Club of San Juan del Monte and Touch the Artists Vision.

MEA curator Haidee Paulette M. Bedruz said Thursday that this project "is aimed to break down the barriers and allow inclusivity to all museum audiences, including the visually impaired."

MEA is the second museum offering this feature after Metropolitan Museum in Manila.

The translated art objects included the Battle of Binakayan, the Oathtaking in Tanza, the Aguirre sword, the Battle of Zapote, Inang Bayan and the Inauguration of the Malolos Constitution, "which can be touched by museum guests, both the sighted and the blind," adds Bedruz.

The project, launched

last Dec. 8 "will be a permanent feature of museum from thereon," adds Bedruz.

NHCP officials, led by Director Ludovico Badoy, HSED chief Gina Batuhan, Rotary Club of San Juan del Monte President Pleshette Wee and TAV's Annette Lee-Esparaz attended the launch activity, where visually impaired students from Ramon Magsaysay High School, together with their guardians, were the first to be treated to the new museum feature.

Joyce Lopez of the Resource for the Blind, Inc. who thinks that dioramas in museums are actually boxes with glass covers, appreciates that she can now 'see' the dioramas through this project.

Also present at the launch was John Baliza of DLS-CSB as partner of the project.

Together with the DLS-CSB School of Deaf Education and Applied Studies, the Audio-Visual presentation of the NHCP museums will be interpreted using sign language.

NHCP targets to apply the same features to other NHCP museums next year. **(Gladys Pino-PNA)**

HUNDREDS GATHER TO END VAW, FIGHT FOR HUMAN RIGHTS IN CAVITE

MUNICIPALITY OF INDANG,

Cavite (PIA) – Around 300 participants from Region IV-A gathered for the regional kick-off activity on the observance of the 18-Day campaign to end Violence Against Women, International Day Against Trafficking (IDAT) and Human Rights Consciousness Week.

The activity was held at Cavite State University here with the following objectives: increasing awareness on the causes and consequences of violence against women, other gender-based violence and different forms of Human trafficking; build partnership to prevent and respond to different forms of violence; and empower both men and women by helping them gauge their current situation and directing them towards appropriate actions and interventions.

The program commenced with a welcoming remarks from Administrative Consultant, Dr. Reynaldo Samonte who repre-

sented Indang Mayor Perfecto V. Fidel while Board Member Irene Bencito delivered a message of inspiration and encouragement to support the advocacy against any form of violence against women, children and other gender-based harassment.

The theme of the activity “VAW-FREE Community Starts with me” was explained by Amanda Lee Centeno, Secretariat, RIACAT-VAW and RIACACP.

Guest speakers indulged the participants with informative lectures on topics of Gender-Based Violence (GBV) and Violence Against Women (VAW): Where Are We Now? which was discussed by PCI Averil Pimo-On, Chief, Family, Juvenile and Gender and Development, PNPPRO IV-A; also The Value of Human Rights, the topic elaborated on by Ms. Brigitte Dulay, Information Of-

ficer III, Commission on Human Rights; while Ms. Mellanie Olano, Reintegration and After-care Partnership Specialist, International Justice Mission tackled the topic on Our Fight Against Online Sexual Exploitation of Children (OSEC) and Human Trafficking.

After the lectures and discussion, an open forum was held to give participants a chance to clarify their queries on the circumstances and the commensurate action to be taken and the proper channels and agencies to approach.

18 FINALISTS GETS RED ORCHID AWARDS IN CALABARZON

DOH-CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) bestowed Red Orchid Awards (ROA) to local government units and government agencies of the region for strictly implementing the "No-Smoking Policy" during the 2018 Regional Awarding Ceremony held in Quezon City on December 5, 2018.

Janairo strongly stated during his opening message at the regional awarding ceremony on Wednesday.

"What we need to do and what is important is to safeguard the younger generation, especially the chil-

dren because most of adult smokers started when they were kids. And it is important to protect their health and well-being, and as parents, let us make sure that they understand the dangers of smoking," he emphasized.

Janairo added that getting the right advice and support from the family, peers and the community will give children a positive outlook in life and instilling to their young minds the importance of practicing health lifestyle will prevent

them from attempting to try substances such as tobacco.

"I congratulate all the winners and may you continue your efforts to curb smoking in your areas and strengthen the implementation of smoke free campaigns and projects towards a tobacco free generation," he stressed.

The regional office awarded 18 ROA out of the 22 finalists for their strict implementation of a smoke-free environment - 12 in the government offices category; 4 government hospitals, and 2 local government units.

Among the government offices who were awarded were the PhilHealth Local Health Insurance Office in Cainta, Rizal, DSWD Haven for the Elderly in Tanay, Rizal, BJMP in Tanauan City, Batangas, BJMP in Calamba City, Laguna, Provincial Capitol in Sta. Cruz, Laguna, Provincial Health Office in Sta. Cruz, Laguna, Laguna Provincial Jail in Sta. Cruz, Laguna, BJMP in Bacoor City, Cavite, BJMP in Sta. Rosa City, Laguna, DSWD CALABARZON Field Office and the 2ID (Jungle Fighter) Division, PA in Tanay, Rizal.

There were four government hospitals awarded, namely BJMP CALABARZON Regional Infirmary in

Calamba City, Laguna, Laguna Medical Center in Sta. Cruz, Laguna, San Pedro Jose L. Amante Emergency Hospital in San Pedro, Laguna and LPH - Cailles Memorial District Hospital in Pakil, Laguna.

Two local government units bagged the Red Orchid Award - Laguna Province and the City Government of San Pedro, Laguna each with a cash prize of P100,000.00 as incentive to be used to sustain their tobacco control activities in the community.

There were seven hall of fame awardees and one pink orchid awardee. A total of 22 finalist were evaluated.

The Red Orchid is the highest score for the DOH Orchid Award, a search for

100-percent Tobacco-Free local government units, government offices and government hospitals. It is followed by the second highest award, the Pink Orchid, and the third tier, the White Orchid. These awards were conceived to fight tobacco use and to work for a tobacco-free environment using the MPOWER initiative.

According to the World Health Organization, MPOWER denotes the six proven tobacco control policies, namely - Monitor tobacco use and prevention policies; Protect people from tobacco smoke; Offer help to quit tobacco use; Warn against the dangers of tobacco; Enforce bans on tobacco advertising; and Raise taxes on tobacco. **BN**
