LAWMAKERS, LGUS DONATE PATROL VEHICLES RIFLES TO CAVITE PNP

IMUS CITY, Cavite — Cavite provincial and local government units donated a total of 35 police patrol vehicles, four motorcycle units and 56 rifles to various police offices in the province on Monday.

Philippine National Police (PNP) Chief, Director General Oscar Albayalde and Calabarzon Police Chief Ted Carranza witnessed the turnover of police assets and equipment during simple ceremony held at the Camp Pantaleon Garcia here Monday morning.

Governor Jesus Crispin 'Boying' Remulla led the turnover of 15 units of L300 FB Van worth PHP14.47 million, 36 brand new units of Armalite rifles worth PHP12 million and crime laboratory equipment to the provincial police office.

General Trias City Mayor Antonio Ferrer and Congressman Luis 'Jon Jon' Ferrer IV, (6th District, Cavite) turned over two Toyota Hilux, two Toyota Vios, one Mitsubishi Strada, one Toyota Innova and 1 Toyota Rush to GenTri police chief Paul Bometivo.

Congressman Abraham 'Bambol' Tolentino of the 8th District, on the other hand, turned over 2 Toyota Innova units worth PHP2.6

PCOO strengthens government-media relations

CALAMBA CITY, Laguna (PIA) - As part of the continuing efforts of the Presidential Communications Operations Office (PCOO) to reach out to media practitioners in the provinces and strengthen media-government relations, Communications Secretary Martin Andanar sat down with Laguna and Quezon media members in San Pablo City on December 16.

"I have made it my mission to reach out to our media men especially in the regions to at least assist and even plan to solve some of the challenges that we have in the regions," Andanar, himself a broadcast journalist before joining the Duterte administration, said.

The Communications Secretary expressed his support to the Filipino media practitioners since he had witnessed and heard their concerns as he traveled around the country.

He also gave emphasis to the importance of Freedom of Information that strengthens what is prescribed in the Constitution which is the Right to Information.

He also pointed out that the Constitution provides for the Freedom of the Press yet it does not guarantee the safety of the press.

This then pushed him and Usec. Joel Egco to create a manifesto and proposal to President Rodrigo Roa Duterte that eventually became the Administrative Order (AO) No. 1 creating the Presidential Task Force on Media Security (PTFoMS).

He affirmed his commit-

ment to resolve other media issues including health and medical problems, among others.

"Making sure that this office that I am holding right now will not go to waste... I will use this position to strengthen even more the relationship between the media and the government and resolve the concerns in the media sector," Andanar articulated.

Andanar said they recently selected 10 media practitioners from different cities all over the country who were severely sick to receive a Noche Buena cash gift solicited from former Special Assistant to the President (SAP) Bong Go.

He then asked the Laguna and Quezon media to choose a media practitioner from their provinces to be given the same assistance.

The Communications Secretary also informed the media that the standing of the Philippines in the list of Most Dangerous Country for Journalists has gradually improved from being 2nd after the Maguindanao massacre where 32 journalists were killed to being in the 5th spot.

"Simula po nang mapirahan na po itong AO No. 1 noong 2016 ay dalawang taon na hong nag-improve iyong ating standing dahil sa Presidential Task Force on Media Security (Our standing have been improving in the past two years because of the Presidential Task Force on Media Security since the AO No.1 was signed)," he announced.

He assured the media that the PTFoMS is looking closely to the Maguindanao massacre case. In fact, the Department of Justice said there is a big possibility that there will already be a promulgation on the case of the 32 journalist victims by the first quarter of 2019.

According to him, the government shall continue reaching out to and addressing the needs in the media sector. He said a press freedom caravan will roll out in the regions to provide updates on the Freedom of Information and the Task Force on Media Security.

Part of the caravan will be the issuance of passports to media members who have yet to process their own passports.



NOVELETA REGION 4-A's TOP PERFORMING LGU FOR HEALTH SERVICES

NOVELETA, Cavite — Mayor Dino Reyes Chua on Monday rallied townsfolk here to sustain the collaborative partnership among residents and the health care workers after bagging the award as Top Performing Local Government Unit (LGU) in health services in Calabarzon (Region 4-A).

Reyes with Municipal Health Officer Dr. Maria Hilda Bucu received the award from the Department of Health (DOH) Calabarzon Regional Office for its Rural Health Unit (RHU) achievement during the recognition ceremony at the New World Manila Bay Hotel last December 14.

"Let us continue to work hand in hand and work hard para sa mamamayan ng Noveleta (for the Noveleta constituents)," Chua told townsfolk.

In an interview with the Philippine News Agency, Chua expressed elation for the town's first award under the health services category. The award carries a symbolic check worth PHP50,000 besides the plaque of distinction.

government health services among residents in the town's 16 barangays.

NAPC EXEC SEES 14% POVERTY RATE IN 2022

President Duterte's point man in the anti-poverty campaign has expressed confidence the country's poverty incidence would have been whittled down to 14% in 2022 once "government services are brought closer to the 14 basic sectors of society without let-up."

The country's poverty incidence currently stands at

21.6%.

But in Davao City last week, National Anti-Poverty Commission Secretary and lead convenor Noel K. Felongco said NAPC has figured out a formula—that combines social reform agenda and poverty reduction activities—in sustaining government services to these basic sectors.

He said this is backed all the way by President Duterte

and former Special Assistant to the president Christopher 'Bong' Go.

The Malasakit Centers, a one-stop medical center established in 10 cities by President Duterte with Bong Go in a crucial role, fits exactly into the system.

Felongco said the approach has been unveiled in Manila on December 7 with at least 10 government

agencies participating to include agencies under the Department of Health, Department of Labor and Employment, Department of Agriculture, Department of Agrarian Reform, Department of Justice and the Department of Environment and Natural Resources.

TESDA unveiled a jobs fair, the DOH provided free medicine and consultation, the public attorney's office gave consultation and notary services,

the DA gave out seeds for urban gardening, the BFAR taught fish culture and the local government unit that hosted the event provided the venue and food, among other things," he said.

The signing of a memorandum of understanding with government agencies sealed the continuity of the program.

Felongco said the approach will be replicated in the regions where "the country's top 40 most poverty-stricken provinces are located." The regions also host the 10 poorest municipalities and the 10 poorest barangays.

With the reduction of poverty the ultimate goal, the program is determined to engage the participation of 14 basic sectors (urban poor, farmers, fisherfolk, labor and informal labor, workers and informal workers, women, persons with disabilities, victims of disasters and calamities, children, senior citizens, non-government organizations and co-

operatives) in the country's top 40 poverty-stricken provinces.

"This is on instruction of President Duterte himself," said Felongco, adding that the Sam-bayanahan or convergence approach will not leave out any province.

"We shall go to all provinces without exception to engage all 14 basic sectors that make up the majority of Philippine society," he said.

Felongco said the approach is meant to capacitate or to show to the basic sectors how to engage government services in addressing the 10 basic needs that included food, water, shelter, work, health care, education, social protection, healthy environment, peace and participation in decision-making.

"The Duterte administration may look harsh against corruption and illegal drugs, but it has the concerns of the poor at heart, hence this continuing social reform program and poverty reduction activities," said Felongco.
