# WALANG UMIINOM NG GAMOT SA KAGUSTUHAN: IMEE MARCOS

(Istorya ni Romy S., mga kuha ni June B.)

**TRECE MARTIRES CITY, Cavite** — “Pero sana tanggalin na ang VAT sa lahat ng gamot, (kse) wala namang umiinom ng gamot sa kagustuhan, o masarap kungdi dahil me sakit.” (I hope VAT (value-added-tax) will be removed from all medicines, nobody takes medicines because they simply like, enjoy it, but because they’re sick)

Ito ang pahayag ni Ilocos Norte Governor Maria Josefa “Imee” Romualdez Marcos.

Ang gobernadora ay dumalo sa Cavite provincial government’s “Ugnayan sa Barangay” program na ginanap sa Golden Horizon covered court sa Barangay Hugo Perez, Trece Martires City kamaailan.

Nagkaroon ng pagkakataon ang Cavite local media para sa isang ambush interview kay Gov. Marcos.

## Arts Month events to be staged at Cavite museum

**KAWIT, Cavite** — The Museo ni Emilio Aguinaldo (MEA), which is run by the National Historical Commission of the Philippines (NHC), will join the nationwide celebration of National Arts Month (NAM) in February.

NHCP-Cavite cluster head and MEA curator, Haidée Paulette Bedruz, said Tuesday the museum’s two-pronged proposition is to make use of the series of activities slated next month as a prelude to the 150th birth anniversary on March 22 of General Emilio Famy Aguinaldo.

“Aguinaldo is acknowledged as the country’s president of the First Philippine Republic and the events aim to deepen the understanding and appreciation of Aguinaldo,” Bedruz said.

The commemorative observance of Aguinaldo’s 55th death anniversary is set on February 6 with simple, traditional rites, such as a wreath-laying ceremony after a Eucharistic Mass at 8 a.m.

On February 23, the NHCP, in partnership with Fundacion Santiago, will launch a special tour of the “House of History,” (the Aguinaldo Shrine), the known historic site where Aguinaldo proclaimed Philippine Independence on June 12, 1898.

The tour, which runs every two Saturdays of every month and scheduled throughout this year, will highlight a first-person interpretation of history to be facilitated by trained actors/actresses performing the first-person narrative.

“This program will encourage the development of greater intellectual and

emotional connections between the shrine and its visitors, and instigate critical thinking about the past and history as a discipline,” she said.

To present Aguinaldo’s youth, the MEA features “Mga Laro ni Heneral” (The Games of the General) on February 15.

Through his book, “Memoirs of the Revolution”, the General revealed his fondness for traditional Filipino games, such as the kalahuyo, sopo, calderon, baticobra San Anton and Tubigan, which are no longer being played now amid the advent of technology.

Bedruz said the former Kawit tourism officer and now freelance curator and Aguinaldo descendant, Angelo Jarin Aguinaldo, will manage the interactive lecture in a bid to reintroduce to the “now” generation the mechanics and history of these traditional games.

She said the revival of these traditional games hopes to encourage not just awareness, but physical activity to the young kids.

To highlight Aguinaldo’s 150th birth commemoration, a modified snakes-and-ladders type of game board will be introduced to the participants containing the timeline of the life of Emilio Aguinaldo adapted to the popular board game.

The museum curator added this will become a permanent interactive activity to future visitors of the shrine.

Other activities include a special exhibit titled, “1869: Cementing the Road to Independence”, where the significant events that paved the way to the declaration of Philippine Independence in 1898 and a

lecture by Cameron Castrillo titled “El Presidente” where the various Aguinaldo monument done by Eduardo Castrillo, will be discussed.

Born on March 22, 1869 in Kawit, Cavite, Aguinaldo, whose name may be synonymous to a plethora of things – from his eventful and exciting life, his courageous and bold political actions, and the various accusations against him, became president at the young age of 29.

Aguinaldo’s most important role in history was

his presidential proclamation of the Philippine Independence in Kawit, Cavite, which paved the way for the birth of the Philippine Republic on January 23, 1899.

The Palace has earlier declared March 22 a holiday, as “Aguinaldo Day”, based on Proclamation No. 621 issued last November.

The MEA is located at the ground level of the iconic Emilio Aguinaldo Shrine, at Kaingen village here, and is open from 8 a.m. to 4 p.m. Tuesday to Sunday. (*Gladys Pino-PNA*)

## Cavite Province distributes ‘bokyo’ to monitor peace and order in barangays

# LGUs, brgys ordered to conduct weekly cleanup along Manila Bay

QUEZON CITY (PIA)—After the Manila Bay Rehabilitation Program kick-off activities on Sunday, the Department of the Interior and Local Government ordered the local government units (LGUs) and barangays along the Manila Bay Watershed Area to conduct weekly clean-up drives to hasten the bay's rehabilitation.

DILG Secretary Eduardo M. Año said the collective efforts and commitment of the LGUs and barangays within the Manila Bay Watershed Area would spell the difference in the rebirth and preservation of the Manila Bay.

"As we all know, Manila Bay is polluted and partly, we have ourselves to blame. But it's not too late, we can still make amends. Sabay-sabay at sasama po nating buhayin ang ating Manila Bay," Año said.

The DILG chief directed 178 LGUs and 5,714 barangays inside the Manila Bay Watershed Area through DILG Memorandum Circular No. 2019-09 to "fulfill their roles and responsibilities pursuant to environmental laws that contribute to the rehabilitation of Manila Bay."

"Sa pamamagitan po nito ay matiyaga naming ipinapaalala sa mga LGU at barangays na sa ilalim ng ating batas ay mayroon silang responsibilidad at panangutang sa pagpapanatili ng Manila Bay at ng ating Inang Kalikasan," the Secretary added.

Under the memorandum, LGUs and barangays must organize clean-up drives in their localities such as, but not limited to, coastal areas and/or inland water systems, on a weekly basis commencing on January 27, 2019.

Año said LGUs and barangays can solicit the support of volunteers, non-government organizations, civil society organizations, academe, among others, "to encourage participation from different stakeholders in the conduct of the clean-up drive."

DILG, together with the Department of Environment and Natural Resources and other national government agencies, was directed by President Duterte to pool efforts "to start cleaning the Manila Bay."

In a separate memorandum, Año enjoined the 5,714 barangays within the Manila Bay Watershed Area to participate in the kick-off activities for the launching of the Manila Bay Rehabilitation Project.

Through DILG Memorandum 2019-07, the DILG Chief emphasized the vital role of barangays and its officials in order to "put an end to the decade-long problem of pollution in the waters of Manila Bay."

"Barangays are important partners of the national government in the rehabilitation of Manila Bay as specified under Republic Act 7160, otherwise known as the Local Government Code. Kaya naman naaahan natin na makakaisa namin kayo sa adhikaing ito," Año said.

He added that barangays are expected to partake in the drive to renew Manila Bay by conducting clean-up drives in their communities by leading the eco-waste management in their respective barangays.

The memorandum states that Punong Barangays must ensure that all barangay officials and employees shall participate in the clean-up activities; that proper segregation, collection and disposal of cleanup wastes shall be observed at all times; and to document said activity for an increased public awareness for social media postings with the hashtags #MBCleanUp and #MBCleanUp(Barangay's name).

"Pangunahan ninyo ang paghikayat at pagkakaroon ng disciplina para sa maayos na pagtatapon ng mga basura sa inyong lugar sa halip na ihagis ito sa katubigan ng Manila Bay," Año said.

Section 20 of the Philippine Clean Water Act of 2004 provides that LGUs shall share the responsibility in the management and improvement of water quality within their jurisdictions.

Similarly, the Local Government Code states that barangays are required to do basic services which include, but not limited to services and facilities related to hygiene and sanitation, beautification, and solid waste collection. (PIA-NCR)

## DTI, nagbigay ng mga kagamitan sa Sampaloc Weavers Association

**SAMPALOC, Quezon (PIA)**- Isang ceremonial turn-over ng mga bagong kagamitan para sa Sampaloc Weavers Association ang isinagawa ng Department of Trade and Industry (DTI) noong Enero 23 sa barangay San Roque, Sampaloc, Quezon.

Pinangunahan ni DTI-4A Assistant Regional Director Marcelina Alcantara, DTI-Quezon OIC-Provincial Director Julieta Tadiosa at Sampaloc Vice Mayor Boy Abeja ang naturang aktibidad.

Ang naturang mga kagamitan na layong maging pulido at mapabilis ang paggawa ng mga produkto mula sa buli ng asosayon ay ang mga sumusunod: 2-unit ng high post sewing machine; 3-unit ng fabric cloth cluster cutting machine; 1-unit ng high speed lockstitch piping industrial sewing machine; 2-unit ng single needle walking foot; 1-unit ng cylinder type walking foot with binding folder; at 1-unit ng electronic weighing scale.

Sinabi ni Alcantara na tutulong ang DTI sa pagbebenta o marketing ng mga produkto ginawa ng samahan sa pamamagitan ng pagdaraos ng mga trade fair sa mga malls at iba pang mga aktibidad ng DTI.

"Si Senator Loren Legarda ay tumulong at patuloy na tutulong pa sa Sampaloc Weavers Association kung kaya't hindi kaya dapat magalala sa pagpapatakbo ng inyong negosyong paggawa ng mga produktong mula sa buli o buri kagaya ng sombrero, pamaypay, bag at iba pa," sabi pa ng opisyal.

Sinabi naman ni DTI-Quezon OIC Provincial Director Julieta Tadiosa na ang DTI ay handa talagang tumulog sa mga maliliit na negosyante o samahan kagaya ng Sampaloc Weavers Association upang mapabilis, mapaganda pa ang paggawa ng mga produkto at mapalaki ang kita ng samahan.

Lubos naman ang ginawang pasasalamat ng pamahalaang bayan ng Sampaloc at ni Gng. Ofelia Gagan na pangulo ng Sampaloc Weavers Association sa DTI sa pagkakaloob ng nasabing mga kagamitan.

Bago ang naturang turnover, may mga kagamitan nauna nang ibinigay sa nasabing samahan ang DTI noong Disyembre 2013 at Pebrero 2015 at ang huli ay noong Enero 23, 2019 na umabot sa kabuoang halagang P1.1M. (Ruel Orunday, PIA-Quezon)

## Ex-college dean faces 16-year jail term for graft

**MANILA**—A former college dean of a state university is facing a 16-year prison term after the Sandiganbayan found her guilty of two counts of graft for the alleged illegal use of an auditorium for review classes in 2012.

The Sandiganbayan's 7th Division, in a 21-page decision dated last January 25, found Southern Luzon State University College of Allied Medicine (SLSU-COAM) Dean Susana A. Salvacion guilty beyond reasonable doubt of violation of Sections 3(e) and (h) of Republic Act No. 3019, or the "Anti-Graft and Corrupt Practices Act".

Salvacion was sentenced to suffer the penalty of imprisonment of at least one month to eight years for each count of the graft cases.

"Having been found guilty for both offenses, accused Susana Ariola Salvacion is perpetually disqualified to hold public office," the Sandiganbayan said.

The cases were filed before the anti-graft court on Aug. 24, 2016 and a hold departure order was issued against Salvacion six days later on August 30.

She was ordered ar-

rested on Sept. 14, 2016 and posted bail for her temporary liberty on September 23 that year.

The Office of the Ombudsman charged Salvacion with graft for allegedly illegally allowing her own private review center, Nurmed Hyperlearn Review and Tutorial Services (Nurmed), to conduct review classes at the COAM auditorium from April 16 to May 14, 2012 without a permit and a contract with SLSU for compensation of the auditorium.

She was also charged with graft for allegedly illegally promoting Nurmed as an alternative review facility to SLSU students who would be taking nursing licensure examinations.

She was arraigned on Oct. 17, 2016 and pleaded "not guilty".

"In this case, it is obvious that Nurmed was favored. Verily, its review classes were conducted at the COAM auditorium, which whether accused Salvacion admits or not, is under her control and supervision being the dean of COAM," the Sandiganbayan said in its ruling.

"The fact that it was the students who chose the

venue is of no help. While students can choose, their choice is not controlling. Fact remains that an auditorium owned by a state university was used in favor of a private entity owned by no less than by one who has a 'say' in said university," it added.

"Indeed, the Court finds the prosecution to have succeeded in its burden of proving its case. Having been found so, there is no need to discuss the evidence adduced by the defense, which the Court finds to be weak, more so, that her only admitted pieces of documentary evidence consisting of a letter request and the official receipts of payments are of little help or no help at all," the Sandiganbayan said. (PNA)

"The new land owners should take care of their land and should not sell their newly-acquired lands and if they decide to give away the properties it would only be to their relatives or family members," Pilias said during the latter part of the flag ceremony.

The Department of Agrarian Reform also conducted an orientation on the rights, roles and responsibilities of agrarian reform beneficiaries at the Jalajala Municipal Complex after the flag ceremony. (**PIA-Rizal**)

## SSS offers loan program for pensioners in Tarlac

**TARLAC CITY (PIA)**—Pensioners and senior citizens can no longer fall for loan institutions that offer steep interest rates as the Social Security System (SSS) continues to offer the Pension Loan Program.

In a radio interview, SSS Luzon Central Division 1 Senior Communications Analyst Maureen Inocencio said the loan program was launched for the benefit of more than 1.3 million retiree pensioners.

"In the previous years, we studied and saw that a lot of our retired pensioners and senior citizens are borrowing financial benefits because of poverty that's why SSS rolled out this program to put an end to the growing incidence of pensioners falling victims to loan institutions that offer high interest rates and to help them with their short-term needs and medical expenses," she explained.

"For pilot implementation in September 2018, the loan program was offered in 20 branches serving the highest number of retiree pensioners but now, this program is already nationwide. Retired pensioners and senior citizens can avail this program in any branch," she added.

Eligible applicants who can avail are the retiree pensioners who are 80 years old and below at the end of the month of loan term, have no outstanding loan balance and benefit overpayment payable to SSS.

Also, have no advance pension under the SSS Calamity Package and have been receiving their regular monthly pensions for at least six months.

"The minimum loan amount is twice the amount equivalent to their basic monthly pension and the additional P1,000 benefit while the maximum is six times their basic monthly pension plus the additional P1,000 benefit, not exceeding P32,000," Inocencio emphasized.

"The pensioner or borrower needs to apply for the loan program personally at any SSS branch and bring his or her Social Security Card or Unified Multi-Purpose Identification Card, accomplished application form, or any two valid identification cards both with signature and at least one photo," she furthered.

The loan program offers 10 percent interest rate per year and shall be payable within 24 months. (**CLJD/CJVF-PIA 3**)

## SC suspends lawyer for threatening Harry Roque

**MANILA** — A lawyer has been suspended for two years from law practice by the Supreme Court (SC) for "underhanded tactics" against his opposing counsel, former Presidential Spokesperson Harry Roque, who filed the complaint 12 years ago.

In a seven-page decision dated December 4, 2018 penned by Associate Justice Estela M. Perlas-Bernabe and made available late Wednesday, the SC found lawyer Rizal P. Balbin guilty of violating the Code of Professional Responsibility (CPR).

The SC also gave Balbin a stern warning that a repetition of the same or similar acts would be dealt with more severely aside from the suspension.

Roque, in his complaint, claimed that after he had secured a judgment against Balbin's client, the latter made various telephone calls and sent text messages and electronic mails not just to him, but also to his friends and other clients, threatening to file dis-

Sa gihanap ng pulong sa Pili, nangako si Duterte na ihahanap niya ng agarang tugon sa problema nito at maaring ilaan ang P46 bilyon ng 'road user's tax' para muling buhayin ang BRBDP. Na-kaambang burahin din ng mga mambabatas ang masalimuot na Road Board.

Paliwanag pa ni Molina, matapos dumaan sa masing pagsisiyasat ng mga dokumento at motorsiklo, ito ay itatalaga ng pulis bilang clean rider sa system ng Campaign Plan Clean Rider.

Tatlong selyong may magkakaparehong serial number ang ibibigay sa bawat motorista na pasado sa pagbeberika. Ang mga ito ay ididikit sa motorsiklo, helmet na my ICC mark, at sa likod ng Driver's License ng motorista.

## NCRPO on full alert status in wake of Jolo church blasts

**MANILA** — The National Capital Region Police Office (NCRPO) announced on Monday that it is on full alert status after the explosion that took place inside and outside a Roman Catholic church in Jolo, Sulu province that left 20 people dead and 112 wounded.

NCRPO head, Director Guillermo Eleazar ordered the five district directors to tighten security around airports, seaports, vital government and private installations as well as places of convergence.

The five districts covered by the NCRPO are the Manila Police District (MPD), Quezon City Police

District (QCPD), Northern Police District (NPD), Southern Police District (SPD), and Eastern Police District (EPD).

"We are full alert since 6 a.m. No cause for panic we want to make sure so we intensify checkpoint operations at entry and exit points of Metro Manila to prevent terrorists from sneaking in bombs," Eleazar told the Philippine News Agency (PNA) in a phone interview.

Full alert means the highest level of readiness in all police offices and units in Metro Manila.

Eleazar said the public should expect more checkpoints and police visibility.
