## No curtailment of press freedom in PH: PRRD

**MANILA** — President Rodrigo R. Duterte on Thursday denied criticisms that his administration is curtailing press freedom in the country after the arrest of Rappler chief executive officer Maria Ressa for cyber libel charges.

In an interview with reporters after the proclamation and kick-off rally of the Partido Demokratiko Pilipino - Lakas ng Bayan (PDP-Laban), Duterte said he is used to criticisms while he served as Davao City mayor for many years.

"Susmaryosep. Far from it actually. I've been mayor for so many years. I have been the subject of all kinds of attack, personal and whatever — silly and everything," the President said reacting to accusations of his administration's involvement in Ressa's case.

Duterte said he does not know businessman Wilfredo Keng, the complainant in Ressa's case.

"I do not know him and what prompted him to file a case," he said.

Duterte, a lawyer, said it is normal for courts to issue a warrant of arrest once a case is filed.

The Manila Regional Trial Court Branch 46 on Wednesday issued a warrant of arrest against Ressa and Rappler writer Reynaldo Santos Jr. after being charged under the provision on content-related offenses, which include libel committed through a computer system or similar means.

This stemmed from a cyber libel complaint filed by Keng in October 2017, who was named by Santos in the article titled, "CJ using SUVs of 'controversial' businessmen", as the owner of a sports utility vehicle used by the late former Chief Justice Renato Corona.

The article was published in 2012 and updated in 2014.

Ressa posted a bail of PHP100,000 on Thursday for her temporary liberty, not long after she publicly denounced the Philippine justice system for allegedly persecuting her. **(PNA)**

## Germany helping boost renewable energy in PH: DOE

**MANILA** — The Department of Energy (DOE) has recognized the help extended by the German development agency, Deutsche Gesellschaft für Internationale Zusammenarbeit GmbH (GIZ), in advancing renewable energy use in the country, for cleaner and more sustainable power.

GIZ has provided the Philippines technical and financial assistance through a three-year project called Shaping and Implementing the International Climate Regime or SupportCCC II. The project began in 2015 and culminated on Wednesday.

Energy Secretary Alfonso Cusi said GIZ has played an instrumental role in boosting the deployment and use of renewable energy in the country.

"For three consecutive years, the Philippines ranked first among 125 countries in terms of energy environmental sustainability. This couldn't have been achieved without the strong collaboration among the different Philippine government agencies, as well as technical and funding support from our international partners, like GIZ," Cusi said.

The DOE noted that the partnership with GIZ has also helped the Philippine government manage the increasing amount of variable renewable energy, adapt power planning, facilitate capacity building for energy stakeholders, such as the grid operator and the distribution utilities on the grid integration of variable renewable energy.

Aside from these, the partnership was able to provide assessment of the state's power planning pro-

cess, policy review on Feed-in-Tariff and net-metering for renewable energy, cost-benefit analysis of the energy sector through the renewable energy country di-

agnostic tool, and analysis of the Negros solar situation.

SupportCCC II is a follow-through on the earlier project Support to the Cli-

mate Change Commission in implementing the National Climate Change Action Plan, which was also implemented by GIZ. **(PNA)**

# DOH-CALABARZON FORMS TASK FORCE VS. MEASLES OUTBREAK

**MANILA —** The Department of Health (DOH) 4-A (Calabarzon) has formed a task force that will urgently address the rapid increase of measles cases in the region by beefing up its immunization program.

DOH 4-A Director, Dr. Eduardo Janairo convened an emergency meeting at the Vivaldi Hotel in Cubao on Monday to form the group, composed of all provincial, city and municipal health officers, National Immunization Program coordinators, and provincial health team officers, including development management officers from Cavite, Laguna, Batangas, Rizal and Quezon.

Janairo said the task force will address the needs of measles patients

in close coordination with local government units, and ensure that DOH strategies and plans will be implemented accordingly.

“Whatever they need for this activity, we will provide it to them,” he said.

Janairo also ordered all health offices here to come up with a uniform strategy in the implementation of the mass immunization activity against measles, especially in the recording, reporting and monitoring of cases for proper documentation and evaluation.

“This is also to ensure that we have enough supply of vaccines at the local level, including health human resource who will administer it to the target population,” he added, emphasizing that the vaccine is still the safest and most effective way to combat the measles virus.

The Calabarzon health office is coordinating with various malls, churches and food chains to set up measles vaccine posts starting next week, “to make the vaccine more accessible to people,” said Dr. Felices Emerita Perez, medical officer of the DOH Center for Health Development 4-A.

“Ilalapit ang bakuna sa mga pasyente (We will bring the vaccine closer to the patients. [These vaccine posts are]) on top of available vaccine in our provincial, city and barangay health centers,” Perez said.

Janairo also initiated a more personalized approach by sending letters appealing to parents to again start trusting the DOH’s vaccines.

These vaccines for measles, polio, pertussis, and tetanus, among others, have been tested and proven safe, he said.

The DOH Regional Epidemiology and Surveillance Unit (RESU) has recorded a total of 972 measles cases from January 1 to February 9 this year, with 25 confirmed deaths. The patients’ ages ranged from nine months to 59 years old.

ed only 124 cases and one confirmed death during the same period last year.

Of the recorded 972 measles cases, 202 received the measles vaccine, 359 were not vaccinated while 174 had unknown vaccination status. Some 192 patients were less than nine months old.

Of the figure, Rizal

province posted the highest with 465 cases; Laguna, 167; Batangas, 142; Cavite, 126; and Quezon, 72.

With no known cure, the highly contagious measles-rubella virus could be contained through proper immunization of children aged six to 59 months. (Gladys Pino-PNA)

## IMEE MARCOS: WHERE'S OUR PAG-IBIG DEDUCTIONS

**GOVERNOR Imee Marcos today called for an accounting of the billions of pesos that government has allocated for its socialized housing program as she noted the continuing backlog in shelter projects for the marginalized sector.**

"The national government has been allocating billions of pesos for its housing programs, and yet we still lack a conducive housing plan that will address the shelter needs of common workers and the underprivileged," Marcos lamented.

Marcos added: "Many families, especially low-income earners, continue to pay rent for their shelter requirements. We see a lot of families living in slum areas. What's holding back the government from providing them homes?"

The governor said it is imperative for the government to bare all to the public and do an accounting on how it has been using its socialized housing funds.

"The public needs to know where their taxes are going, how the government is spending their hard-earned incomes. Monthly PAG-IBIG and GSIS or SSS deductions are made on the salaries of both public and private employees for the government's socialized shelter programs. San napunta ang mga deductions? Bakit hanggang ngayon kulang pa rin ang mga pa-bahay para sa mahihirap?" she asked.

Marcos noted reports that housing projects have been lagging between 168,000 and 190,000 units a year, as she expressed concern over estimates by government policy-makers that the backlog could reach a peak of 12.5 million housing units by 2030 if the problem is not addressed. By 2021, the housing need is projected to be around 6.7 million.

Marcos reiterated her proposal for the government to consider reviving his late father's BLISS housing project which was launched during the late 1970s to provide shelter communities to low-income earners and their families,

free up space and resolve the population congestion problems of urban communities.

"The government should seriously look at reviving the BLISS housing project. The booming real estate industry has made it difficult for many of our kababayans to buy their own houses. A state-funded shelter program will click well with low-income earners, including overseas contract workers, who have little, if not none at all, funds for their dream houses. Kung kaya noon, bakit hindi ngayon?" Marcos said.

BLISS housing communities were put up during the late 70s to address the basic needs of shelter and services of urban poor families. The nationwide housing program did not only provide shelter units to low-income groups but also basic social services and income-generating activities.

Under the scheme, slum areas were rehabilitated and slum dwellers were relocated to more habitable human settlement within Metro Manila and nearby provinces.

BLISS facilities included home lots and housing units; community facilities such as schools, chapels and sports grounds; and small-scale employment, including cottage industries.

# DENR urges massive waste reduction in Calabarzon

**CALAMBA CITY, Laguna** — The Department of Environment and Natural Resources (DENR)- Environment Management Bureau (EMB) in Calabarzon has urged on Monday the massive reduction of wastes by households and commercial establishments in the region in view of limited landfills and dumpsites.

DENR Calabarzon Regional Executive Director, lawyer Maria Paz Luna said all local government units (LGUs) need to expand their solutions to include finding economic uses on garbage or trashes.

"Many LGUs now can derive economic value from their wastes, we only need to increase demand," she said.

Apart from the economic-driven solution, the DENR suggested exploring the possibility of putting up a disposal facility per province through linkage with the Department of Pub-

lic Works and Highways (DPWH).

It also stressed the need for all public infrastructure to consider the testing and use of bricks that remove waste out of the waste stream.

"Landfills are no less public works than roads and bridges. Pag umapaw na po ang palanggana, hagilapin ba muna ang mop o papatayin muna ang tubig? Wala na pong pagpagaan ng mop, ibang paraan na ang dapat hanapin pag 60 percent na ang problema (If the basin overflows, do we look for a mop or stop the water from dripping? If there is no more basin on which to squeeze the mop, then we have to find ways if the problem has reached 60 percent)," Luna said.

It reported that only 38 percent of wastes generated in the region comprising Cavite, Laguna, Batangas, Rizal and Quezon could be accommodated in 35 sanitary landfills spread through localities with

permits to operate as each landfill only has a total capacity of around 2,193 tons of waste per day.

Based on data submitted by the LGUs to the EMB, Calabarzon Region produces 5,695 tons of waste per day with a per capita waste generation ranging from 190 grams to 390 grams per person per day.

Cavite and Laguna rank the highest on per capita while Quezon has the lowest range which is lower than per capita volumes in metropolitan areas and mass tourism places like Boracay.

In their recent meeting with the DENR officials, the LGUs appealed that 100-percent efficiency in waste collection could not be attained due to constraints in the number of operating dump trucks and manpower.

The discussions also tackled garbage collection services that are typically centered around the "poblacion" (town proper) areas, and tip-

ping fees in the landfills range from PHP7,000 to PHP15,000 per truck of wastes.

The Ecological Solid Waste Management law also requires that only residual wastes shall be disposed in sanitary landfills (SLFs).

Thus, stricter household monitoring of waste segregation will lessen these costs by up to half and any LGU breaching the law could face raps before the Ombudsman.

The EMB, however, clarified it has no mandate to put up infrastructures like SLFs and the primary duty for waste management remains in the LGUs.

DENR likewise urged the LGUs to intensify their continuous coordination with the private sector as a holistic approach to waste reduction in the region especially starting at the household level. (PNA)

**MANILA — Prosecutors have dropped the criminal case against Trece Martires City, Cavite Mayor Melandres Desagun and two others for the killing of Vice Mayor Alex Lubigan and his driver Romulo Guillemer in July last year.**

Department of Justice (DOJ) spokesperson Undersecretary Markk Perete on Tuesday informed reporters of this development

in a text message.

On the other hand, the DOJ found probable cause to indict alleged gunman Ariel Paiton for two counts of murder and Maragondon, Cavite municipal councilor Lawrence Arca as accessory to the crime.

Likewise cleared were Luis Vasquez Abad Jr., the alleged driver of the getaway vehicle and Rhonel Bersamina, who allegedly received money on Arca's be-

half.

On July 7 last year, Lubigan, 44 and his driver Guillemer, 50 were travelling along the Trece-Indang Road in Barangay Luciano, Trece Martires City when they were ambushed by several armed men.

Desagun's security aide Romeo Edrinal, 56, who was also on board the vehicle was injured during the attack. (PNA)

## Angeles court orders release of witness in Jee Ick Joo slay

**MANILA —** The Angeles City Regional Trial Court (RTC) ordered the release of a policeman who is now a state witness in the abduction and killing of South Korean businessman Jee Ick-Joo two years ago.

In an order dated January 30 released to media Tuesday, RTC Branch 56 Judge Irin Zenaida S. Buan granted the motion of state witness Senior Police Officer 4 (SPO4) Roy Villegas and ordered his release from the restrictive custody of the PNP Anti-Kidnapping Group.

"Based on the proceed-

ings held in these cases, it appears that witness Villegas already finished his testimony thus it can be concluded that he already fulfilled his duty as a state witness. With the completion of the testimony of state witness Villegas, there is no more valid reason to recall his discharges thus, the effects of his discharge should be given effect," the court said.

Villegas turned witness against his co-accused in the case namely SPO3 Ricky Sta. Isabel, Supt. Rafael Dumlaog III, Jerry Omlang and retired policeman Ger-

ardo Santiago.

Jee was abducted on October 18, 2016 at Friendship Plaza Subdivision, Angeles City by police officers claiming to enforce an anti-narcotics operation under the Philippine National Police (PNP)'s "Oplan Tokhang."

He was brought to the Philippine National Police headquarters in Camp Crame where he was killed the same day.

Santiago was owner of the Gream Funeral Services, where the body of the victim was brought. (PNA)

## Court pilots video 'tele-hearing' for high risk, sickly inmates

**MANILA —** New court rules authorizing the use of video-teleconferencing for high risk detainees to be tried without the need to actually stepping

into courtrooms will soon be tested, the Supreme Court (SC) said Monday.

Court Administrator Midas Marquez said the new system will be pilot-tested in Davao City Jail, where members of terrorist groups Maute, Abu Sayyaf and New People's Army (NPA) are detained.

He said the new "tele-hearing" system is part of the judicial reform agenda of Chief Justice Lucas Bersamin.

Associate Justice Diosdado Peralta, chairman of the new SC revision of rules committee, has been tasked to draft the guidelines that would govern the remote testimony and appearances of the accused from

their cells.

"This is trailblazing because it can pave the way for long-distance court appearances of OFWs working abroad who have pending civil cases in the country," Peralta said.

Arrested members of Maute, Abu Sayyaf and NPA will no longer be required to physically appear before the courts and may face trial while inside the jails.

A 100-foot monopole tower with necessary equipment was built within the Davao Hall of Justice and will be connected to the three jail facilities in the city.

The High Court assured that the constitutional rights of the accused will be protected through procedural safeguards in the implementing rules.

"In order to ensure that the accused's constitutional rights are adequately protected, the counsel of the accused shall be present with the accused in the same designated room in the jail facility throughout the duration of the tele-hearing," Marquez said.

The rule will also apply to detainees diagnosed with grave and serious medical conditions in Davao.

The measure adopted by the judiciary was approved upon the request of Davao City Jail Warden, Supt. Grace Taculin, who cited security threats in the transportation of high-risk detainees with terrorism cases and spread of diseases in courts. (PNA)

## SPD nabs 85 persons, 90 firearms in anti-crime drive

**MANILA** — Operatives of the Southern Police District (SPD) have arrested 85 persons and seized 90 firearms since the start of the election gun ban last month.

In a report to the National Capital Region Police Office (NCRPO) Wednesday, SPD director, Chief Supt. Eliseo Cruz, said Parañaque City has the highest number of apprehensions with 23 persons, followed by Makati (19); Taguig (15); Las Piñas, four; and two in the town of Pateros.

The SPD Chief said that all apprehended persons were already charged criminally before the Department of Justice while the recovered guns and other items were brought to the respective police stations to form part as evidence against the suspects.

Cruz said the recovered guns were mostly .38 caliber revolvers, 12-gauge shotguns, .45-caliber pistols, 9-mm pistols and .22-caliber revolvers while 28 gun replicas were also confiscated.

Apart from firearms confiscation, the authorities also recovered several plastic sachets of shabu and drug paraphernalia

used in sniffing the drugs during the police operations, he said.

For his part, NCRPO chief, Director Guillermo Eleazar commended SPD for its simultaneous police operations which focuses more on illegal firearms through the implementation of search warrants, checkpoints, Oplan Sita and other anti-criminal activities in identified hot spots within its jurisdiction.

"We congratulate the SPD under the leadership of its District Director Eliseo Cruz for his initiative of an all-out drive against crime in the Southern Metropolis area following the start of election ban on Jan. 13," said Eleazar.

Eleazar assured the NCRPO will be relentless in its drive to maintain the peace, order and security in the entire Metro Manila area during the election period.

"We will not allow those who seek to sow terror in our communities. We will arrest those who defy the law and commit atrocities against the people and bring them to the bar of justice and make them accountable for their crime," the Metro Manila top cop

## Experts warn public vs. measles complications

**MANILA** — If left untreated, serious complications from measles could be life-threatening, medical experts said on Wednesday.

Dr. Mario Panaligan, Philippine Society for Microbiology and Infectious Diseases president, said measles-stricken children and adults could suffer from serious complications if they remain untreated.

"Kahit bata o matanda, delikado ang komplikasyon ng tigdas, hindi kumo matanda ay mas mataas ang (Young or old, measles complications are dangerous, not because [you're] old [you'll] have higher) risk to have complications," he said in a health forum in Quezon City.

Panaligan said patients with fever usually experience pain in their throats which

cause secretions to be stuck in the throat.

"So talagang tumataas ang chances na magkaroon ng pulmonya. May mga tao ring nabubulag... ang iba naman ay patulog-tulog dahil namamaga na rin kasi ang utak (the chances of having pneumonia go up, there are people who become blind... other people doze off because their brains are already swollen)," he added.

Philippine Pediatric Society president Salvacion Gatchalian, who is one of the forum panelists, said severe measles cases may also lead to Subacute Sclerosing Panencephalitis (SSPE).

"This can be seen also in adults but this is more common among children who have measles less

than two years (old). It can manifest seven, eleven years after the measles infection. There's an intellectual and behavioral deterioration and eventually namamatay, mataas ang (they die, there is high) percentage of death, mga 90 percent," she said.

Gatchalian urged parents to observe the schedule of measles vaccine for their children which start at nine months old and first dose of booster at 12 to 15 months and second dose at four to six years old.

Apart from vaccination, Gatchalian advised the public to wash thoroughly their hands, cover their mouths when coughing and stay at home when they are sick to avoid contracting measles. (PNA)

Marami kasing naghabol ng oras, sakit na talaga ng marami nating kababayan ito.

Bakit hindi kasi magbigay ng tamang palugit ng oras sa pagkilos para hindi nag-aapura sa pagbibiyahen?

Terrible na talaga ang trapik, 'ika nga ni Gov. Imee Marcos, lalo na sa Kalakhang Maynila.

Kaya nga dagdag pa ng Ina ng Ilocos Norte na kailangan ng gobyerno ang mga kaukulang opsiyon hinggil sa epektibong siste-

ma ng ating public transport at isa na nga rito ang motorcycle taxis.

Ewan ko nga ba at bakit hindi nasosolusyunan ang pagkalat ng mga ganitong hayop sa mga kalsada at mas nakakatakot maging doon sa mga highway ay mayroon din na talaga namang matutulin ang takbo ng mga sasakyan.

Kung sadyang pinag-uukulan ng pamahalaan ang kaligtasan ng mga mananakay ay napakaraming kailangang isaalang-alang.

Sana ay ituloy ni Gov. Imee Marcos ang kanyang stand o posisyon sa isyung ito dahil tulad ng gobernador, ako po ay hindi tutol sa Angkas bagkus ay ilatag lamang ang mga nararapat na alituntunin na titiyaking maipapatupad at susundin para sa seguridad at kaligtasan.
