

General Trias seniors get cash incentives

GENERAL TRIAS CITY, Cavite — This city's 8,500 senior citizens began receiving cash incentives from the city government following the implementation of a new city ordinance, on top of the benefits they enjoy pursuant to the national Senior Citizens law, which grants them even more perks and discount privileges.

City Mayor Antonio Ferrer on Thursday assured that all 8,500 senior citizens from the city's 33 barangays (villages) shall receive cash incentives out of the city government's allocated funds.

DOST APPLIES VALUE-ADDED TECH TO BOOST COOP'S TILAPIA PRODUCTS

AGONCILLO, Batangas — Tilapia harvests in this lakeshore town have been given a boost with the value-added fish processing technology and good manufacturing practices introduced by the Department of Science and Technology (DOST) 4-A (Calabarzon) through the Provincial Science and Technology Center (PSTC) - Batangas and Industrial Technology Development Institute (ITDI).

John Maico Hernandez, information officer and science research specialist of DOST-PSTC Batangas disclosed on Wednesday that the new value-added fish

processing technology devised by the department's ITDI shows growers how to process dried and marinated tilapia products.

"The technology aims to improve existing fish processing and combined training on the integrated current Good Manufacturing Practices (GMP), which are now benefiting the Bilibiwang Multipurpose Cooperative members here," Hernandez said.

PSTC-Batangas gathered coop members last February 20-22, to impart to them new food processing technologies that virtually guarantee better income because they can start sell-

ing processed tilapia products, with their extended shelf-life, rather than just fresh fish.

"The cooperative has been engaged in agricultural services, mini grocery and loan services on its initial operation and has ventured into tilapia fish processing besides the huge harvest of the aquatic resources in their locality," Hernandez added.

He said DOST 4-A, through its grants-in-aid program, provided the mechanical dryer to be used by the multi-purpose coop.

The cooperative is also expected to go into full production with their "upgraded" processed tilapia products using the newly-established fish processing facility provided by DOST, with the support of the Department of Agrarian Reform (DAR).

Among the coop's new tilapia-based products, which are expected to be a best-seller, is the "lamayo" or the semi-dried tilapia, which will benefit greatly from the new equipment.

Hernandez also explained that the training program covers critical points in fish processing, such as cleaning and de-scaling, removal of guts and gills, splitting, washing, and sorting, which could now be done more efficiently using new technology.

He said DOST-ITDI trainers also shared three styles

program," Piñol noted. "It will be a continuing program and we hope that the farmers will respond. Sapagkat malaking bagay yung fertilization actually. To support the project, the government will provide farmers with a solar-powered irrigation system that can irrigate thousands of hectares of farmland, like the one being used in Israel, he said.

The government, the Agriculture chief also said, is extending loan assistance to farmers' organizations for the provision of grains drying facilities.

Meanwhile, the DA has removed the passbook being issued by the National Food Authority (NFA) as a requirement for farmers who want to sell palay to the agency, according to Piñol.

He stressed that the NFA will continue to buy locally-produced palay and sell affordable rice. (PNA)

DA to unveil national fertilizer program

CABANATUAN CITY, Nueva Ecija — The Department of Agriculture (DA) is unveiling a national fertilizer program in a roll-over system, among other initiatives, to make Filipino farmers competitive as pushed for by President Rodrigo Duterte.

Agriculture Secretary Emmanuel Piñol made the disclosure in a brief media interview on the sidelines of his meeting with farmer leaders at the National Food Authority (NFA) regional staff house here Monday afternoon.

"We have to make them (farmers) competitive kaya nga may commitment ang Pangulong Duterte at inutusan niya ako na gumawa ng paraan upang maumpisan 'yung (thus, there is a commitment of President Duterte and he ordered me to make way to start) the national fertilizer support program," he said.

Piñol said the government estimates the fund requirement for the fertilizer procurement at PHP30 billion.

Under the program, the government shall provide farmers with fertilizers which they will pay later.



Taguig fiscals indict Kris Aquino's ex-biz partner for estafa

MANILA — The Taguig City Prosecutors' Office has ordered the filing of estafa charges against embattled businessman and publicist Ricardo M. Falcis II for the alleged misuse of a credit card issued to him by Kristina C. Aquino Productions, Inc. (KCAP), owned by his former business partner and actress Kris Aquino.

In a 10-page resolution dated February 11 and released to the media late Tuesday, Assistant State Prosecutor Claire Eufacia Pagayanan and Senior Assistant City Prosecutor Laarni G. Fabella recommended that criminal charges for estafa through misappropriation or conversion be filed against Falcis even as it ordered the complaint for qualified theft be dismissed.

The prosecutors said "it can be concluded from the acts of Falcis in leaving the

CA junks Rappler plea vs. SEC ruling

MANILA — The Court of Appeals (CA) turned down the appeal of online news website Rappler and its holding company, Rappler Holdings Corporation (RHC), against the Securities and Exchange Commission's (SEC) move to revoke its business registration for violating the Constitution and foreign equity restrictions in mass media.

In a 25-page resolution penned by Associate Justice Rafael Antonio Santos dated February 21 and released to media Monday, the CA's Former 12th Division said it saw no merit on

the motion for partial reconsideration filed by Rappler on the case.

Associate Justices Apolinario D. Bruselas and Germano D. Legaspi concurred in the decision.

"In summary, a motion for reconsideration grounded on arguments already submitted to the court and found to be without merit may be denied summarily, as it would be a useless ritual for this court to reiterate itself. Here, petitioners did not raise any new matter or issue in its motion. Accordingly, this court finds no cogent justification to recon-

The CA, however, said it would not preempt the evaluation and the subsequent finding and conclusion of the SEC which will investigate the legal effect of the alleged donation of foreign funds by Omidyar into Rappler's operations.

Rappler claims that the constitutional limitations on foreign investments does not apply to it since it is not a mass media entity as defined by a 1976 law, Presidential Decree No. 1018, limiting the ownership and management of mass media to citizens of the Philippines.

Contrary to the firm's claim, the CA said that Rappler is a media entity, since under a later law, Republic Act No. 9211 "the definition of mass media was expanded to include electronic media such as the internet".

This definition of mass media was used by the SEC, the CA pointed out.

The appellate court said that Rappler itself in a case before the Supreme Court asserted that it is a mass media entity.

The case involved the firm's petition seeking to be allowed access to live coverage of the 2016 presidential and vice-presidential

debates.

In this case, the CA explained "the Supreme Court agreed with Rappler and ruled that it is an online mass media entity and should be granted equal right with traditional forms of mass media to broadcast the debates via online live streaming."

"The actions and actuations of Rappler, militate against its claim that it is not engaged in the business of mass media and thus, not covered by the foreign equity restriction applicable to mass media entities," the CA added.

The CA said that applying the full beneficial ownership test, Rappler cannot claim to be 100-percent Filipino owned.

"RHC cannot claim that it fully owns the Rappler shares since it does not exclusively exercise the right to vote on the Rappler shares. By virtue of clause 12.2.2 (in its agreement) Omidyar Network is granted the power to direct the voting on the Rappler shares," the CA said.

"(T)he grant of control to a foreign entity over a mass media entity, regardless of the actual exercise of such foreign control, is already considered a violation," the court added. (PNA)

In wake of this, PENRO established the Ternate Pawikan Conservation which aims to conserve and protect from unlawful activities the population of pawikan species mostly Olive Ridley sea turtles (*Lepidochelys olivacea*).

Now on its second year, the municipality of Ternate and PENRO celebrated the annual Pawikan Festival held at the Ternate Conservation Site in Barangay San Juan I here.

The ceremonial program's theme for this year is "Help Save Pawikan! Love Ternate! Protect the Pawikan" and was joined by about one hundred sixty four (164) students from various elementary and high schools in the municipality.

Municipal Mayor Lindo acknowledged the important role of the pawikan patrollers as he officially commenced the festival declaring, "Saludo ako sa mga pawikan patrollers, kung wala kayo wala itong Pawikan Festival na ito."

The Pawikan patrollers patiently collect and gather eggs of pawikan and bring them safely to the Pawikan Nursery area.

As of this breeding season 2018-2019, there are a total of 3,794 hatchlings carefully released to the coastal waters resulting to the increase in numbers of hatchlings released com-

pared to previous years.

Mr. Deonilo L. Bersamina, ABC President commended the local communities for their vigilance to conserve and protect the pawikan. He reiterated the importance of the conservation, "the more pawikan we protect and release, the more it will come back again in 20 years to lay another generations of their species, and we should be very grateful that our town has been part of their journey."

PENR-Officer- Cavite For. Unlayao explained that the conservation measures for the pawikan should also include protection of its natural habitat saying, "Sana po mahalin natin hindi lamang po ang mga pawikan kundi pati ang ating kapaligiran."

Ms. Villaruel of DILG-Cavite appealed to everyone especially the student participants to take part in this undertaking and get involved in the weekly clean-up activities conducted in their barangays that would clean the river systems and its tributaries where garbage from upland areas are washed along down to Manila Bay.

The festivities included poster making contests and an 'amazing race' relay games that entertained and enjoyed by the students.



COURT UPHOLDS DENIAL OF GRAFT RAPS VS. MISUARI

MANILA — The Sandiganbayan has upheld its ruling that denied the motion seeking to dismiss the graft and malversation cases against former Autonomous Region in Muslim Mindanao (ARMM) governor Nur Misuari over the alleged anomalous procurement of more than PHP77-million worth of Information Technology (IT) packages in 2000 and 2001.

"The Court finds the subject motion for reconsideration unmeritorious," the Sandiganbayan's 3rd Division said in its resolution dated March 8.

"It bears stressing that accused-movant Misuari merely rehashed the same arguments regarding his alleged non-liability and lack of participation in the offenses charged, which were raised in his omnibus motion to dismiss and defer arraignment," it added.

"The Court must stress that a comprehensive consideration of the merits of the prosecution's evidence and the defense's arguments, as to the alleged weakness thereof, is premature at this point and better left to trial on the merits. Suffice it to say that the Court has long determined the existence of probable cause and has already resolved to proceed with trial to afford all the parties the full opportunity to present their case," the court said.

In his motion, Misuari asked the Sandiganbayan to reconsider its ruling dated Nov. 29, 2018, which denied his omnibus motion to dismiss and defer arraignment dated September 12 that year.

He reiterated that the court failed to consider that he only served as ARMM governor until Sept. 30, 2001 and that he was no longer a public officer when the alleged anomalous transactions were consummated in 2003 and 2004.

Misuari added that he was illegally detained from 2001 to 2008 and that he

did not receive any money or funds that are subject of the complaint as payment was made when he was no longer ARMM governor.

"These arguments are not evidentiary in nature that require ventilation in a full-blown trial as the Court may take judicial notice of the same," he said.

In its opposition, the prosecution argued that Misuari merely raised the same arguments or matters that have already been raised in his verified omnibus motion to dismiss and defer arraignment.

It added that for a motion for reconsideration to be given proper judicial cognizance, it "must contain not merely a reiteration of the arguments already submitted to and considered without merit by the Court."

The prosecution argued that "there is no truth to the claim of accused Misuari that he had no participation in the consummation of the transactions subject of the information".

It cited the following documents that Misuari allegedly signed and approved in his capacity as ARMM governor:

For the transaction with MBJ Learning Tools: requisition issue voucher dated Dec. 21, 2000 for the procurement of PHP31-million worth of 124 sets of IT package for elementary and high schools; purchase order dated Dec. 23, 2000; and disbursement voucher No. 101-01-08-3190 for the payment of the IT package;

For the transaction with CPR Publishing House: requisition and issue voucher dated July 24, 2001 for the procurement of PHP46,261,260 worth of 170 sets of Multi-Media IT package from CPR intended for elementary and high schools; purchase order dated July 30, 2001; and undated disbursement voucher of PHP46,261,260 for the payment of the Multi-Media IT package. 

1st QUARTER CPPOC, PADAC AND PDC MEETING

Members of the Cavite Provincial Peace and Order Council (CPPOC) and Provincial Anti-Drug Abuse Council (PADAC) convened for the joint 1st Quarter CPPOC & PADAC meeting followed by the Full Council meeting Provincial Development Council (PDC) on March 8, 2019 at Sherwood Hills Golf and Country Club in Trece Martires City. The whole day assembly was spearheaded by the Department of Interior and Local Government in coordination with the Provincial Planning and Development Office in order to discuss matters on peace and order, insurgency and programs for former rebels, drug abuse prevention programs and drug-free city/municipality status of LGUs, and development programs of the province.

The joint CPPOC and PADAC was called to order by Provincial Administrator for Internal Affairs Renato A. Abutan on behalf of Governor Jesus Crispin "Boying" C. Remulla upon determination of quorum by DILG-Cavite OIC Provincial Director and Head Secretariat Eloisa G. Rozul.

Police Chief Inspector Jonathan Asnan of Cavite PPO presented the current peace and order situation of the province with data which reflects a 58.99% decrease in eight focus crimes for the 1st quarter of 2019 as compared to the same period in 2018. Jail Officer 3 Jenylin Quintana of the Bureau of Jail Management and Penology (BJMP) reported the status of inmates in different detention facilities in the province wherein overcrowding of inmates is the most pressing concern. Bacoor City Mayor Lani Mercado Revilla announced that they have put up a new detention facility to address the said problem in their city jail and asked for the support of the council to secure the area through fencing assistance.

F/SInsp. Alyster Castro, Bacoor City Fire Marshal also presented the report of the Bureau of Fire Protection on the programs they are conducting towards fire prevention and the need for additional personal protection equipment of firefighters. For the internal security updates, Brigadier Gen. Arnulfo Marcelo Burgos Jr. shared the various encounters that have had with armed groups operating in the CALABARZON region and the activities that they initiated to curtail the proliferation of left-leaning groups. He urged the council members particularly the local chief executives to be on guard and to not let these groups infiltrate their localities. He announced that Cavite was declared as a province with Stable Internal Peace and Security last December 4, 2018 and proposed for the creation of a Provincial Task Force

to End Local Communist Armed Conflict to spearhead local anti-insurgency measures.

The report on anti-drug abuse initiatives and drug-free status of LGUs was presented by Agent Theonette Solar of the Philippine Drug Enforcement Agency which showed that Tagaytay City and the municipalities of Amadeo, Magallanes and Mendez have been declared drug-free by the Regional Oversight Committee on Dangerous Drugs. The municipalities of Alfonso, General Emilio Aguinaldo and Maragondon have achieved 100% drug-free barangays but are yet to be declared drug-free municipality pending the setting up of Balay Silangan, a reformatory institution for drug-pushers which was included in the criteria for declaring drug-free cities and municipalities.


In the afternoon, the PDC- Full Council Meeting was called to order by Provincial Planning and Development Coordinator Jesus Barrera. The discussion proper for new businesses started with the presentation of Mr. Sammy C.M. Yip of Ove Arup & Partners Hong Kong Ltd. on the Bataan Cavite Interlink Bridge (BCIB) Project that aims to ease the traffic congestion and provide convenience in Metro Manila and South and North Luzon gateway, and provide opportunities for economic growth. The said project sought the endorsement of the PDC to the Regional Development Council.

Updates and Status of Solid Waste Management in the province was tackled by Ms. Anabelle Cayabyab, Head of the Provincial Government-Environment and Natural

Resources Office, revisiting the 10-year solid waste management plan of the province and the different LGUs. Governor Boying Remulla stressed that the current focus is primarily on water security pertaining to the depleting sources including the aquifer and that it is important for LGUs to look into their development direction in order to ensure that the environment is protected to sustain future needs.

Arch. Armando Alli of Century Peak Corporation discussed the Cavite Land Reclamation and Development Project (5 Islands Land Reclamation Project). DTI-Cavite Provincial Director Noly Guevara presented the 2019 Cities and Municipalities Competitiveness Index and encouraged the local chief executives to enhance data collection and submission in order to improve their performance.

Highlight of the event was the awarding ceremony of the 2018 Seal of Good Financial Housekeeping and the top performing LGUs on the Manila Bay Rehabilitation Program. All the 23 cities and municipalities as well as the province of Cavite passed SGFH while twelve LGUs passed for the Manila Bay rehabilitation program. These include Magallanes, Maragondon, Bacoor City, Carmoña, Imus City, City of Gen. Trias, Gen. Mariano Alvarez, Tagaytay City, Rosario, Mendez, Naic and Noveleta. The award was conferred by DILG IV-A Regional Director Manuel Gotis and Governor Remulla. Likewise, Local Government Operations Officers were recognized for their performance. —(PICAD)
