# MEET THE WOMEN 'RAKETERAS' OF CAVITE

**IMUS CITY, Cavite —** They offer various products and services, from ready-to-wear (RTW), beauty products, insurance or just about 'anything under the sun.' As they say, name it, and they definitely have it.

Co-founder Maricris Ansagay described Caviteñaraketeras as an informal, close group of some 691 women members composed of micro, small and medium entrepreneurs (MSMEs), housewives and freelancers.

"(They) bonded together to widen products and services, to share our business knowledge and best practices to the new and aspiring ones, and support each other in reaching out to a wider market," she said on Monday.

Created in October of 2018 by founder Jhodielyn "Nham" Sonit, herself a certified "raketera", a person who juggles with multiple jobs and sells just about anything, the community was built to support Caviteñas who are willing to be entrepreneurs or business owners, part time or full time.

Sonit, who not only works as a virtual assistant for a Canadian firm but also maintains her own business involving chili garlic and shrimp paste on the side, met Ansagay in a bazaar in December last year.

"That's when we thought of the idea to locate people like us, group ourselves and together create our niche in Cavite's wide market," Ansagay said.

The women-only group encourages members to earn, upgrade their skills and services, or just to do something productive, and might soon open its membership to men.

Members are from Cavite, whether aspiring entrepreneurs or business owners engaged in online selling, business owners with brick and mortar store, and other service-based business such as food, crafts and baking.

In May 18, dubbed 'raket day', they will meet with new members and get to know new products and find possible suppliers at the City Works Space at the Aguinaldo Highway here. (**Glady Pino-PNA**)

## Batangas pilgrimage site spruced up for Holy Week

**BATANGAS CITY —** The city government has laid out plans in preparation for Catholic faithful and pilgrims, who are expected to flock to the "Mother of Asia, Tower of Peace," popularly known as the "Monte Maria" pilgrimage destination in Barangay Pagkilatan this city, during the Lenten Season.

City Mayor Beverley Dimacuha told PNA on Tuesday that she has formed a committee composed of various city departments and offices, including village chiefs for the action plans, to usher in the surge of thousands of devotees and tourists who will visit the sacred site where a towering 63-meter image of the Blessed Virgin Mary stands at a hill overlooking the famous Verde Island Passage and Batangas Bay.

Dimacuha said the committee has tasked village chiefs from the coastal barangays Libjo, Ambulong, Tabangao Aplaya, Pinamucan Proper, Pinamucan Ibaba, Simlong, Mabacong and Pagkilatan to ready their respective routes and contingency plans.

The Transportation Development and Regulatory Office (TDRO) will be deploying a huge number of traffic enforcers along the main routes to avert traffic congestion.

Dimacuha also disclosed that the committee has put premium on the safety and security of the devotees, pilgrims and tourists, as scores of barangay tanods (village watchmen) will be deputized to support TDRO personnel.

She said signage on

routes, entrance and exit, and traffic reminders, will be put in place, including the enforcement of a truck ban, for the affected areas starting 3 a.m. to 9 p.m. on April 17 to 19.

The Batangas City Police Office will also deploy cops to ensure peace and order and security concerns for the pilgrims, devotees and tourists.

Health workers and emergency management teams from the City Health Office and City Disaster Risk Reduction and Management Office (CDRRMO) will also be stationed at strategic areas.

In view of the expected surge of vendors and hawkers, Dimacuha said the committee has decided to designate a common vending site to avoid traffic congestion, through the sup-

port of village women sectoral organizations that are encouraged, not only to promote their local products, but also increase their income during the Lenten activities.

Meanwhile, General Services Officer Jocelyn Cantere also said garbage trucks will also be dispatched to collect trashes starting Holy Monday (April 15) until Easter Sunday (April 21).

Cantere said frequent reminders shall be made to village key personnel, and tarpaulins shall be posted for the designated and segregated garbage receptacles along the route and at the pilgrimage site to ensure cleanliness and upkeep of the premises. (**Maroe T. Genosa/PNA**)

## Court orders arrest of Leyte officials over fake documents

**CARIGARA, Leyte —** A municipal trial court here has ordered the arrest of the town's vice mayor and councilor over falsification of private documents.

The local court issued the warrant of arrest Monday afternoon against Vice Mayor Mildred Modesto and town councilor Rachel Makabenta.

The Philippine National Police confirmed that the two local government officials surrendered Monday afternoon at the local police station and each one of them posted the recommended PHP36,000 bail.

The local court issued the warrant of arrest a month after incumbent Carigara Leyte Mayor Eduardo Ong Sr. filed charges against Modesto and Makabenta for allegedly falsifying documents.

The two local officials filed a complaint at the Commission on Elections (Comelec) central office saying that Ong and his son, Eduardo Jr., are not qualified to run due to lack of residency.

In a joint resolution issued March 21, the Office of the Assistant Provincial Prosecutor ruled the vice mayor and the councilor used the sworn statements of a certain Maritesse Canojos, which were sub-

scribed before notary public lawyer Ulpiano Arpon, the town's former vice mayor.

However, both Canojos and Arpon denied that they signed those affidavits submitted by the two officials to the Comelec central office.

Modesto is seeking a reelection bid against Eduardo Jr. while Makabenta is running as mayor against incumbent Eduardo Sr.

Reporters sought comments from Modesto and Makabenta on the case but legislative staff said they have no time for media interviews since they are busy signing documents and attending committee meetings.

Former town councilor Dennis Garay, the spokesman of the Ong family, said they are confident that the disqualification cases filed before the Comelec central office will be dismissed.

"The disqualification cases on grounds of residency appear to be products of respondents' indiscretions. This is a betrayal of a former political ally since in the past two elections, Makabenta endorsed the candidacy of Eduardo Sr.," Garay told reporters.

The Ong family has been known for toppling the Apostol political dynasty, one of the oldest political clan in Leyte.

Eduardo Sr. defeated two members of the Apostol family in the 2013 and 2016 mayoralty race. The mayor's brother, Henry, won in 2016 as Leyte 2nd district representative against Sergio Apostol, former lawmaker and cabinet official, who ruled the legislative district for decades.

Since 2016, the Ong family has been establishing a new political dynasty in Leyte, with Henry seeking a second term in the House of Representative.

Eduardo Sr. picked his 22-year-old son, Eduardo Jr., who has no experience

in government, as his running mate in the 2019 polls.

The younger Ong is reportedly being groomed by his father to replace him in the mayoralty seat after the end of his much-anticipated third and last term in 2022.

The young politician is largely counting on guidance from his father and uncle to woo more than 34,000 voters in Carigara, a second-class town in central Leyte. Carigara is the first municipality established in the Eastern Visayas region. (**PNA**)

## CONSTRUCTION OF CALAEX BEGINS

**IMUS CITY, Cavite** – The construction of the 27-km. Cavite segment of the 45-km. Cavite-Laguna Expressway (CALAEX) began after the groundbreaking at Alapan II-B village here Wednesday.

Envisioned as the “most advanced” expressway in the country, the Cavite segment, with an estimated project cost of PHP12 billion, will ensure a safe, efficient and seamless travel for motorists from Kawit town (in Cavite) to the South Luzon Expressway (SLEX) – Mamplasan Interchange. It is expected to cut travel time from 2.5 hours to less than 45 minutes and help decongest approximately 50,000 cars.

At the groundbreaking ceremony, Public Works Secretary Mark Villar said the project is part of the Duterte administration’s masterplan to connect Luzon from north to south, to be called the “Luzon Spine Expressway Network” (LSEN), to increase the current 300-km. high-speed expressway to 1,000 km. by 2022, the end of President Rodrigo R. Duterte’s term.

“We will deliver not just on our promise to solve traffic, but to bring development to our provinces,” Villar said.

The high-speed expressways are not just expected to reduce travel time but, once completed, create a new period of development for the provinces of Cavite and Laguna.

Cavite is now the biggest in terms of population among the country’s provinces, with an estimated 4.1 million people, 2016 data from the Philippine Statistics Authority show.

As Region 4-A (Calabarzon) now accounts for almost 20 percent of the country’s Gross Domestic Product (GDP), the most productive region.

Cavite Governor Remulla said this “speaks volumes about the dynamism of the government and its private partner.” He said the expressway will connect Laguna and Cavite, and declog the South Luzon Expressway (SLEX).

The Laguna segment of the CALAEX project is now in full swing which, accord-

ing to Metro Pacific Tollways Corp. (MPTC) president and Chief Executive Officer, Rodrigo Franco, is expected to open the first section during the third quarter or as early as July this year.

“In two years’ time, we hope the province of Cavite will have a brand new expressway that will connect the existing Cavite Expressway, which is also operated by the Metro Pacific Group,” Franco added.

CALAEX will employ some 1,200 personnel for its Laguna segment and close to 1,300 more for site and office personnel as its Cavite segment progresses. It is part of the network of toll roads that the MPTC is constructing and developing, which will connect to Cavitex and the C5-South Link and will make transfers from Laguna, Cavite, Las Piñas, Parañaque, and CP Garcia Ave. seamless.

Other projects under the MPTC’s portfolio are the recently opened Harbor Link Segment 10, North Luzon Expressway (NLEX), Subic - Clark - Tarlac Expressway (SCTEX), and the Cebu-Cordova Link Expressway in the Visayas. (**Gladys Pino-PNA**)

## Expanded maternity leave to cut SSS actuarial life by 1 year

**MANILA** — The Expanded Maternity Leave law is estimated to shorten the Social Security System’s (SSS) fund life by one year if a contribution hike is not imposed to correct this situation.

The law, which took effect this month, is projected to increase SSS’ maternity benefit disbursements from

about PHP6 billion in 2017 to about PHP13.5 billion this year.

SSS Acting President and Chief Executive Officer (CEO) Aurora Cruz-Ignacio, in a briefing Monday, said the amended SSS Charter does not include the contribution hike for maternity benefits.

“We will have to source

the fund from other sources within the Social Security fund,” she said.

Under Republic Act (RA) 11199, otherwise known as the Social Security Act of 2018, the state-pension fund for workers in the private sector may increase contributions by one percentage point every other year from the current 11 percent to 15 percent by 2025 without the approval of the President.

This is targeted to increase the pension fund’s actuarial life by 13 years from 2032 to 2045 or upon the full implementation of the law on 2025.

However, the Expanded Maternity Leave law, which SSS is mandated to implement, is seen to reduce this by a year without the additional contribution.

Under the law, pregnant workers will have 105 days of paid maternity leave, 7 days of which are transferable to fathers. It does not discriminate whether the pregnancy already exceeded four pregnancies.

It gives single mothers additional 15 days leave while a 30-day extension can be made but this will no longer be paid.

Of the 11 percent combined contribution of both the members and their employers, only 0.4 percent is allocated for maternity benefit to date.

An informal study conducted by the SSS in 2015 showed that share of contributions for maternity compensation should be increased to 0.5 percent, or even to 0.6 percent to offset contribution deficiencies.

SSS Senior Vice President for Actuarial and Risk Management Group Edgar B. Cruz, during the same briefing, said the impact of the increase in maternity benefits is smaller compared to pension hikes, since the latter is seen to lessen SSS’ actuarial life by 10 years.

He, however, noted that since the law does not mention any increase in contribution to pay for maternity benefits, a big question mark hangs over them.

Asked how long the agency’s funds can absorb the increase of maternity benefit disbursements, Cruz cited that “as an actuary I’m not comfortable whenever we give out benefits without source of funding.”

He, however, pointed out that they are mandated by law to give out this particular benefit, thus, they will do everything they can to fund it.

“We estimated that without additional funding it will set back our fund life by an additional year,” he added. (**PNA**)

## Salceda sa Senado: Ipasa agad ang amyendang batas sa Public Service Act

Hiniling ni Albay Rep. Joey Sarte Salceda sa Senado na ipasa na ang panukalang batas na mag-aamyrnda sa 80-taong gulang na Public Service Act (PSA) sa natitirang dalawang linggong sesyon ng Kongreso sa darating na Mayo “para mawala na ang mga hadlang sa pamumuhunan at kumpetisyon sa ilang sektor ng ekonomiya at masustenihan ang paglago ng bansa.”

Isang kilalang ekonomista, isa si Salceda sa mga pangunahing may-akda ng House Bill 5828 na ipinasa ng Kamara noong 2017 at nakabinbin ngayon sa Senado. Ang panukalang bersyon ng Senado ay aprubado na rin nito sa ikalawang pagbasa. Ang pag-aprubahan nito ay kapaki-pakinabang na pagbabago ng ekonomiya ng Pilipinas kung ihahabing sa mga kapit-bansa nito kaya nanating mahal ang mga bilihin at kulang sa mga kapaki-pakinabang na trabaho dahil sa mahina ang kumpetisyon. Kung marami ang mamumuhunan sa

gong sesyon ng Kongreso sa Mayo, ayon sa mambabatas.

Layunin ng HB 5828 na linawin ang legal na kahulugan ng ‘Public Service’ at ‘Public Utilities’ sa lumang PSA na malimit ay pinagpalit-palit upang paburang ang interest ng mga “monopolies, duopolies and oligopolies” sa ilang sektor ng industriya na dahan-dahan para iwasan ito ng bagong mga mamumuhunan.

Ayon sa pag-aaral ng World Bank, nananatili sa kamay ng ilan lamang ang ekonomiya ng Pilipinas kung ihahabing sa mga kapit-bansa nito kaya nanating mahal ang mga bilihin at kulang sa mga kapaki-pakinabang na trabaho dahil sa mahina ang kumpetisyon. Kung marami ang mamumuhunan sa

mga industriya ng bansa, dagdag nito, “tataas ang antas ng mga serbisyo, maraming trabahong malilikha, ay mababawasan ang kahirapan.”

Titiyakin ng HB 5828 ang “ang wastong implementasyon ng Section 11, Art. XII ng Saligang Batas ng Pilipinas na nagtatatalaga ng tanging mga kumpanyang 60% pag-aari ng Pilipino ang maaaring mangasiwa sa ‘public utilities’ para masiguro ang mataas na antas ng serbisyo publiko sa mababang halaga” git na Salceda.

Tiniyak ni Salceda na aakin ng mga mamumuhunan ang babaguhin PSA bagama’t may laan din itong mataas na multa sa mga Lalabag nito upang “bigyan pangil ang batas at sundin ito ng mga kumpanya.”

Aguinaldo led Filipino revolutionary forces in an uprising against the Spanish Government in 1896 and declared Philippine Independence on June 12, 1898 in Kawit, Cavite.

Recently, President Duterte issued Presidential Proclamation No. 621 declaring March 22, his birthday as "Emilio Aguinaldo Day."



Carranza challenged the newly-promoted officers on their new ranks, saying these come with greater responsibilities and opportunities to renew their commitment to their sworn duties and responsibilities.

"Promotion in the organization is a way to reward high-performing officers, provided they meet all the requisites set forth by the Promotion Board. This boosts the morale of our personnel to do their jobs effectively and motivates them to exceed their efforts from what it was during the previous period," he said.

He also assured the cops that the regional police command would improve its operational capability, and enjoined them to sustain the command's performance as the country's "Best Police Regional Office" in 2018.

## Bulacan, Pampanga rice farmers assured of irrigation water supply

**CITY OF MALOLOS, Bulacan** —The National Irrigation Administration (NIA) has assured that irrigation water supply to rice lands in Bulacan and some parts of Pampanga will last until May 15 this year.

Eliseo Bitangcol, press relations officer of NIA-Central Luzon, said for the current dry cropping season, NIA started releasing irrigation water to its service areas in Bulacan and Pampanga on January 9 this year and its cut-off is scheduled on May 15.

"No problem with irriga-

Meanwhile, Carranza noted that despite the achievement, PRO 4-A's internal cleansing program will be sustained to rid the police force of misfits and scalawags and pursue the police organization's transformation into a "highly capable, effective, and credible police force."

Of this total, 322 were dismissed after testing positive for illegal drugs while 119 were found to be involved in the illegal drug

trade, caught possessing and selling illegal drugs, and protecting drug syndicates.

"May kalalagyan kayo kapag hindi pa kayo tumigil sa ilegal ninyong gawain (There's a place for you if you continue your illegal activities)," he said, urging the promoted officers to serve as "living examples to your junior officers so that they would emulate the wisdom you have had."

Of the 185 newly-promoted personnel, 20 Police Lieutenants were promoted to Police Majors under the Police Commissioned Officers (PCOs) rank, while 165 Police Non-Commissioned Officers were promoted from Police Staff Sergeants to Police Executive Master Sergeants, and from Police Corporals to Police Staff Sergeants.

Their promotion falls under the 1st Semester Calendar Year 2019 Regular Promotion Program (second Level Police Commissioned Officers and Police Non-Commissioned Officers) as part of the Lateral Entry Program for Line Officers.

The simultaneous donning and pinning of ranks and mass oath-taking were held Monday in five Police Provincial Offices and the Regional Mobile Force Battalion 4-A across Cavite, Laguna, Batangas, Rizal and Quezon. (PNA)

## BOC files 6 criminal cases before the DOJ

In its continuing effort to foil law breakers and unscrupulous smugglers, the Bureau of Customs (BOC) today filed six criminal cases before the Department of Justice (DOJ).

The first case is against Agustin Esguerra, owner of consignee Pulinan Motors Truck Rebuilding Center and his Licensed Customs Broker Tomas James Y. Delos Santos, for smuggling of one unit of Bentley Continental GT car and one unit used Hino truck through misdeclaration.

The second case involves fake Rolex watches that arrived at the Clark International Airport from Singapore found in the possession of Gianmarco Macaluso that arrived on 05 February 2018.

According to Customs Commissioner Rey Leonardo Guerrero, BOC is doing its best to curb the entry of illegal drugs and other contrabands into the country. "We have tightened our watch for illegal drugs and other contrabands at the country's various ports of entry, coupled with our strengthened coordination with other enforcement agencies such as the Philippine Drug Enforcement Agency (PDEA), the National Bureau of Investigation (NBI), the Philippine Coast Guard (PCG) and the Philippine National Police (PNP),"

Guerrero said.

"To tightly secure our borders, I have instructed all frontline customs personnel to be doubly vigilant for attempts to smuggle drugs and other contrabands through the Bureau of Customs," he added.

Also charged today before the DOJ relative to these drug importations were importers Jeffrey Samson and Edgar Valencia and their broker Jenille Gacutan for allegedly importing nine hundred thirteen grams of methamphetamine hydrochloride which was declared as baby clothes and another two thousand ninety-two grams of methamphetamine hydrochloride declared as "8 Sauce," respectively.

Other packages were consigned to Marcelino Rotea, declared

as used shirts but found to actually contain 3.165 kilograms of marijuana in six plastic packs and to Mario Jamoroa of Navotas City of which package was declared to contain "1 Pasta Sauce."

The total estimated value of all these goods subject of the six cases is FORTY-SIX MILLION FOUR HUNDRED NINETEEN THOUSAND FIVE HUNDRED SIXTY-ONE PESOS AND SIXTY-FOUR CENTAVOS (Php46,419,561.64).

"There will be no stopping us, we will be relentless, there will never be an end to our battle against evil doers most specially those who want to taint our youth with the vermin of dangerous drugs," Guerrero stressed.



# SC SACKS SHERIFF FOR MISAPPROPRIATING LITIGANT'S MONEY

MANILA — The Supreme Court has dismissed a court sheriff from public office for misappropriating PHP10,000 he received from a court litigant meant for the publication of a notice of an extrajudicial foreclosure.

In a decision, the Court en banc found Manuel H. Gimeno, Sheriff IV, Branch 19, Regional Trial Court, Cebu City, guilty of misconduct.

Gimeno would have been dismissed from the service had he not been earlier dropped from the rolls for being absent without leave. The Court also forfeited his retirement and other benefits, except accrued leave credits.

"[H]is act of appropriating the money given to him by complainant puts the Judiciary and its processes in a bad light. This gives an impression to the public that the courts and its personnel would not hesitate to shun their public duties in exchange for personal gain," the Court said.

The case stemmed from a complaint of the Rural Bank of Talisay (Cebu), Inc., through its president Adele V. Villo.

In 2011, Gimeno received PHP10,000 from Villo as cost for publication of the notice of extrajudicial foreclosure in Cebu Daily News.

However, Gimeno failed to remit payment despite repeated demands.

The Court, however, held that "[Gimeno's] actions were clearly tainted with corruption as he received money from complainant in his capacity as sheriff for the RTC...Even if

it were true that respondent only used it to pay for the hospital funds of his mother, it cannot be gainsaid that he used his position as sheriff to obtain funds from private persons for his own benefit and to the detriment of the latter."

"Measured by the exacting standards imposed on court personnel, it is unquestionable that respondent severely failed to uphold what was expected of him. He readily admits that he appropriated for himself the money given to him by complainant as payment for publication costs. Respondent's liability is indubitable and the only genuine issue to be resolved is the penalty to be imposed for his transgressions," the Court said.

The Court also ruled that Gimeno failed to exhibit contriteness after he continuously failed to make the necessary payments for publications in spite of demands or opportunities for him to correct his wrongdoings.

"Respondent's length of service does not justify the imposition of a penalty lesser than dismissal from service. The length of service had been taken against the erring public official, even if it is for the first offense, in cases involving serious offense such as grave misconduct," the Court added. (PNA)
