PCAARRD eyes more mussel depuration facilities in Bacoor City

BACOOR CITY, Cavite – The Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development of the Department of Science and Technology (DOST-PCAARRD) is eyeing the possibility of putting up more depuration (purification) facilities for green mussels (tahong) along the bay areas of the city to boost its mussel industry.

Last April, PCAARRD installed a small-scale depuration facility model along the bay areas in Barangay Alima to allow mussel harvested in the city's bay area to self-cleanse of bacteria that may pose health risks to consumers when mussels are eaten raw or partially cooked.

Test results of the PCAARRD-funded small-scale depuration facility model allows mussels harvested in the bay area to depurate in short period of time.

PCAARRD's Industry Strategic S&T Program Manager and Science and Technology (S&T) Research Specialist Kristine Joy Tandang disclosed Tuesday that PCCARRD's program partner, and project implementer Cavite State University (CvSU) Naic conducts continuous functional test runs on the facility's cost-effectiveness and depuration time.

Tandang said the series of tests would also aid them

in formulating project output, operations protocol, or help them identify the need for more depuration tanks before handing the facility over to the local government unit (LGU) for commercial use.

The facility is part of the PHP4.9-million project titled "Production of safe mussels using environment-friendly culture methods in sites near urban areas," which aimed to produce S&T-based solutions in producing safe mussels near urban areas.

The PHP300,000 depuration facility was put up in Bacoor City bay area and houses three tanks where each tank can hold 60 to 90 kilos of mussels and can reduce the bacterial content of mussels within 6 to 12 hours.

The facility was established in this city's Barangay Alima and had its "soft launching" in April this year.

During the launch, PCAARRD Deputy Executive Director for Research and Development Dr. Edwin C. Villar assured the community that the project would push the growth of the mussel industry and benefit the fishing community and the seafood consumers.

Villar also assured PCAARRD's commitment and continued support to the programs and activities that would promote development and growth of the

As the funding agency, PCAARRD has collaborated with the Bacoor City government for the depuration facility in the local counterpart management and provision for the facility site.

The Cavite State University (CvSU)-Naic Campus is managing the project implementation of the science and technology-based facility. **(PNA)**

in new students in public schools during Monday's opening of classes that run smoothly and peacefully.

Cavite School's District Supervisors Dr. Laura Garcia, Dr. Edna Bayot and Dr. Prudencio Animas, who personally supervised the class opening especially at the Gov. Ferrer Memorial National High School here, described the situation as generally smooth and peaceful.

They attributed the orderly opening of classes to the collaborative efforts of the school management, faculty, staff, teachers and even parents with the enormous help and assistance of the local police and barangay officials and tanods (village guardians).

As early as 6:30 Monday morning, public school teachers and students trooped to the different public schools in this city's 33 local barangays.

Deputized traffic enforcers managed the traffic flow in each school together with the members of the city police force, headed by Supt. Paul Bometivo, the city chief of police.

In time for the opening of classes, the city government led by Mayor Antonio 'Ony' Ferrer, Vice

Mayor Morit Sison and other city officials with Cavite 6th District Representative Luis 'Jon-Jon' Ferrer IV also inaugurated the 3-storey, 6 classrooms building at Cecilio Saliba Elementary School in Pasong Camachile 1; and a 4-storey, 8 classrooms in Buenavista Elementary School in Brgy. Buenavista II.

Around 32 new classrooms were also ready at the Gov. Ferrer Memorial National High School after these were constructed early this year, through the fund support from the city government and the Office of Congressman Ferrer.

In his remarks, Dr. Animas underscored to education stakeholders that "the child is the center of the educational system" while reminding teachers and students to wear their proper uniform and school IDs.

Animas also disclosed that most public schools in the city have maintained their manageable classroom-student and teacher-pupil ratio over the years.

The city government has also scheduled to distribute school bags and school supplies to all grade schoolers in public schools in the 33 barangays.

Congressman Ferrer also assured that his congressional district office will shoulder the school supplies of all Day Care pupils of this city and in the neighboring towns of Tanza and Amadeo and Trece Martires City.

"It is a good practice for

DOST-NRCP STATEMENT ON THE IMPORTANCE OF IMMUNIZATION

The NRCP Statement originated from the members of the NRCP Division III (Medical Sciences) and had undergone a series of careful deliberation in the Governing Board (GB) which was subsequently adopted after due revisions on 27 April 2018 during the 1013th (18-4B) Meeting of the GB held at the National Institute of Physics, University of the Philippines Diliman, Quezon City.

"We at the National Research Council of the Philippines (NRCP) are alarmed that the controversy involving the use of Dengvaxia as an anti-dengue vaccine has led to sub-

stantial decrease in vaccination rates in other immunization programs of the country.

Scientific evidence has clearly demonstrated that vaccines have dramatically eradicated smallpox and polio and have greatly reduced child mortality in the Philippines and in many other parts of the world.

The NRCP stands by the government efforts to sustain its immunization programs as we strongly urge the public to pay attention to the knowledge claim of scientists on the beneficial effects of immunization."


