

Voter registrants must personally submit

MANILA — The Commission on Elections (Comelec) on Wednesday reminded those seeking to register as regular voter and Sangguniang (SK) Katabaan voter to personally file their application.

According to Comelec spokesperson James Jimenez, all local poll body office, particularly Offices of the Election Officer (OEOs) in city/municipality, will not accept proxy registration. He noted that Republic Act No. 8189, "The Voter's Registration Act of 1996" requires the applicant to personally accomplish his/her application for registration.

"Dahil ang requirement ng batas (It is because what the law requires) is for the individual to "personally register," the poll body official in an interview.

"This is to ensure that each voter on the list corresponds to an actual person, and to give the election office the opportunity to verify the applicant's eligibility," Jimenez added.

The registration period is set to start on August 1 until September 30, during office hours, from 8 a.m. to 5 p.m., Mondays to Saturdays, including holidays.

Aside from application for new registration, the OECs will also accept application for transfer of registration and reactivation of

registration.

With this, the poll body reminded applicants to bring valid ID (includes government-issued ID, driver's license, school ID, passport), two photocopies of front and back of ID (they will be presenting) and three copies of application form which can be downloaded from the Commission on Elections (Comelec) website.

In case the applicant has no ID, the registrant may submit a sworn statement to prove identity from any of the following: a registered voter from the precinct where he or she will vote; a family member (within 4th civil degree of consanguinity or affinity).

Those who are eligible to register as a voter should be: a Filipino citizen, a resident of the Philippines, resides at the locality where he/she intends to vote for at least six months.

For regular voters, he/she must be 18 years old on or before the May 11, 2020 Barangay and SK elections.

For those who will register as SK voters, the applicant should be 15 years old on or before the May 11, 2020 youth polls.

The Comelec will also be setting up satellite registration centers in malls and schools. (PNA)

SC asserts independence over GMA quip on acquittal from plunder

MANILA — A Supreme Court (SC) official on Wednesday said the court acted independently in acquitting former President and House Speaker Gloria Macapagal-Arroyo on plunder charges filed against her two years ago.

"I have not spoken to the Chief Justice (Lucas Bersamin) about the comments of former President and Speaker Gloria Macapagal-Arroyo on her acquittal. However, the public can be assured that the Supreme Court has and will always act independently, and free from influence from the other branches of Government,"

SC spokesman Brian Keith Hosaka told newsmen.

Arroyo, who bows out of office having completed her final term as congressman during a testimonial dinner for her on Tuesday thanked President Rodrigo Duterte for her acquittal by the SC in 2016 on the plunder raps filed against her by the Aquino administration in connection with the alleged misuse of PHP366 million intelligence funds of the Philippine Charity Sweepstakes Office (PCSO) during her term as President.

Voting 11-4, the High Court in July 2016 voted to acquit the former president

1 killed, 8 arrested in Bulacan anti-drug ops

CAMP GEN. ALEJO S. SANTOS, Bulacan --

Another drug pusher was killed and eight other drug suspects were arrested Monday and Tuesday as a result of the intensified anti-illegal drug operations in the province.

Col. Chito Bersaluna, provincial director of the Bulacan Police Provincial Office, said the drug suspect identified as Joe Deocareza was neutralized during the operation conducted in Barangay Gumaok East, City of San Jose Del Monte at around 10:40 p.m. Monday.

"The suspect engaged the operatives in a shootout, which prompted the law enforcers to fire back that resulted in his death," he said.

Recovered from the crime scene were nine pieces of heat-sealed transparent plastic sachets of shabu, one .38-caliber revolver without trademark and serial number, two caliber .38 live ammunition, three fired cartridges cases, and

two 9mm fired cartridge cases.

Meanwhile, Bersaluna said the eight other drug suspects were arrested during operations conducted in Baliwag and Marilao towns. He identified them as Joewel Fabel, Christopher Salvatierra, Reymark Rodriguez, ThomJhay Villarante, Jesus Sicat, Angelo Tumbay, Eduardo Tañedo, and John Reynier Rioflido.

Confiscated were eight heat-sealed transparent plastic sachets of shabu, eight pieces of heat-sealed transparent plastic sachets of dried marijuana fruiting tops, and buy-bust money.

The arrested suspects and seized pieces of evidence were brought to Bulacan Crime Laboratory for appropriate examination, while criminal complaints for violation of Section 5 and Section 11 of Article II of Republic Act 9165 (Comprehensive Dangerous Drugs Acts of 2002) are being prepared for filing in court. (PNA)

SOLGEN ASKS SC TO DISMISS WRIT OF KALIKASAN SUIT ON WPS

MANILA -- Solicitor General Jose Calida on Tuesday asked the Supreme Court (SC) to dismiss the petition filed against government agencies, which seeks unspecified action on

the disputed areas in the West Philippine Sea.

"The petition demonstrates a grave abuse of process, which merits dismissal, if not sanction from the Court," Calida said in his opening state-

ment at the oral argument on the matter, citing that at least three of the supposed fisherfolk-petitioners in the case have executed sworn statements denying that they authorized the filing of the suits against the government in their behalf.

The three, whom Calida identified by their last names as Abogado, Asiado, and Labandelo, confirmed that they do not know of the filing of the suits in their behalf, which had been supported by the Integrated Bar of the Philippines (IBP). "These statements show deception," Calida said.

"As for petitioner IBP, it did not even allege what capacity it is suing or what injury it sustained. Definitely, it's not to safeguard the administration of justice or to advocate for the rule of law because the IBP lawyers involved in this case foisted egregious deceit not only on the fisherfolk petitioners but also on this Honorable court," Calida said.

In any case, the top government counsel, citing legal precedents, said since petitioners claim it was China that is causing environmental degradation, it now becomes a matter of foreign relations, which places it under the jurisdiction of the executive department.

Calida stressed that the Court cannot interfere with or question the wisdom of the conduct of foreign relations by the executive department and explained that "any determination of policy or course of action in the implementation of foreign policy and relations fall within the realm of the executive branch and not with the courts".

In a message to reporters, SC spokesperson Brian Hosaka confirmed that "the Supreme Court decided to suspend the oral arguments in view of the submissions of the Solicitor General and the manifestations of counsels during today's oral arguments". (PNA)

CAVITE HELPS RAISE AWARENESS ON HEMOPHILIA

Medical practitioners in Cavite including city and municipal health officers, doctors and dentists from public hospitals, nurses from the rural health units, members of the PWD federation, employees of the provincial government mainly from the Provincial Health Office (PHO), Provincial Social Welfare and Development Office (PSWDO), Provincial Information and Community Affairs Department (PICAD) and some members of the Hemophilia Advocates Philippines (HAP) convened at the Cavite Collaboration Center for Public Health Auditorium in Trece Martires City on July 9, 2019 for the first Hemophilia Awareness Symposium in the province.

With the noticeable low level of public awareness and even of some hospital personnel on hemophilia, the HAP-Cavite Chapter led by Ms. Lota N. Madamba tapped the provincial government through Provincial Health Officer Dr. Gilbert Illog and Epidemiologist Dr. Nelson Soriano for the conduct of the one-day activity that encompassed talks about the bleeding disorder, its history and how it affects children and female patients. The organization aimed to raise social and political awareness for them to lobby their advocacy and seek legislative measures that will address the hemophilia medical condition.

Dr. Soriano who delivered a message on behalf of Dr. Illog highlighted the importance of having a Hemophilia Treatment Directory and identification cards of PWH which can be presented to healthcare providers in availing medical and dental services. Likewise, Dr. Soriano underscored the value of the activity, believing in the principle that one must know the enemy in order to defeat it. Education is still the key along with proper information dissemination. He also thanked the attendees for their time and hoped that hemophilia be

included in the Universal Health Care Bill.

Provincial Administrator for Community Affairs Dr. Alvin Mojica visited the activity on behalf of Governor Jonvic Remulla signifying support to the advocacy which gave more hope and strength to HAP-Cavite.

Participants showed much interest to the topics presented, thanking pediatric hematologist from the Korean-Philippines Friendship Hospital and a hemophilia advocate Dr. Melissa Montoya, for sharing significant inputs on pediatric bleeding disorder and a few tips on how to manage cases in children.

Dr. Montoya also shared the vital application of the acronym RICE for patients with hemophilia, which stands for Rest, Ice Packs, Compress and Elevate; while hemophilia in female patients was tackled by Dr. Jayson Dadural, an adult hematologist of Emilio Aguinaldo Medical Center. He said that bruising and other symptoms of hemophilia must be taken seriously and should be consulted immediately to doctors.

In addition, Dr. Montoya told audience that she already recommended to the Department of Health (DOH) for the allocation of Factor 8 (F8) concentrate to the Gen. Emilio Aguinaldo Memorial Hospital (GEAMH). Clotting factor concentrate prophylaxis aims to preserve joint function by converting severe hemophilia (factor VIII or IX less than 1%) into a clinically milder form of the disease. This news provided more hope to PWH given the fact that very few hospitals have the capacity to handle patients with bleeding disorders.

On the other hand, PWHs in Cavite gave testimonials on the challenges they face day by day, from pain levels, to hospital bills, transportation, down to stories of being refused by healthcare providers whenever being informed of their case. To assist them, Social Welfare Officer III Brendalyn Salazar of PSWDO discussed the

simplified procedure and requirements on seeking financial/medical assistance, as well as on requesting for wheelchairs to the Office of the Provincial Governor. She also pledged that their office will lobby for PWH patients to be included in the special cases like chemotherapy and dialysis patients who are qualified to receive financial assistance from the provincial government on a regular term. The statement uplifted the spirits of hemophilia advocates, patients and their families, knowing that their needs are also being addressed by the government.

In closing, PHO's National Blood Program Coordinator Ralph Laurence Figueroa, acknowledged the organizers and participants who made the event possible, underlining the significance of equitable distribution of resources, giving priorities to indigents in the province, since majority of Filipinos with bleeding disorders live below poverty line as per study of HAP.

Hemophilia is a genetically-inherited bleeding dis-

order in which the person's blood does not clot normally. People with hemophilia can experience spontaneous bleeds with no known cause, internal bleeding and painful swollen joints. Medical scientists have not found a cure yet for what is termed a Royal Disease. Symptoms of hemophilia may include nosebleeds, bruising, bleeding for no reason, blood in urine and stool, nonstop bleeding after a cut, tooth extraction or circumcision or a heavy prolonged menstruation. Understanding hemophilia is a great first leap towards achieving the "Right to Live" campaign of HAP.

There are about 10,000 Filipinos with hemophilia and about a million others with von Willebrand disease and other bleeding disorders in the Philippines, but only about 1,500 have been registered with the Philippine Hemophilia Foundation. In Cavite, as of June 2019, according to HAP-Cavite Chapter there are 28 registered patients in their organization while others are yet to be identified. PICAD

DTI warns establishments selling substandard products

QUEZON CITY (PIA)—The Department of Trade & Industry (DTI) warned business establishments selling substandard products after the nationwide inspection drive conducted by the Fair Trade Enforcement Bureau (FTEB), Bureau of Product Standards (BPS), Philippine Accreditation Bureau (PAB), and DTI Regional Offices.

In one of the inspections conducted in Valenzuela City on July 5, 2019, DTI Secretary Ramon Lopez and Consumer Protection Group Undersecretary Ruth Castelo led an inspection team that caught two stores selling substandard products.

One store was selling substandard or underweight steel bars and wires with no Philippine Standard certification marks (PS marks), while another was found selling PVC pipes and toilet wares without PS marks.

The substandard products were confiscated. Notice of Violation were also issued to the violating stores which they need to answer within 48 hours. They will also be charged a penalty ranging from P17,500 to P35,000.

The team also inspected a steel manufacturing plant in the area and found that they complied with the product standards and testing equipment required by the DTI.

Lopez said that daily inspections by the FTEB have led to the decrease in violators in Metro Manila.
