Cavite town boosts clean-up ops, fumigation vs. dengue

MAGALLANES, Cavite-- Alarmed by reports about the surge of dengue cases in some areas, the local government here embarked on a massive clean-up in possible dengue-carrying mosquito breeding sites and fumigation over the weekend.

Mayor Jasmin Maligaya-Bautista has ordered the Rural Health Unit (RHU), through its Municipal Health Officer Dr. Jose Jemmel Bacolod, to address the situation in view of eight dengue cases that were reported.

"I am calling on all our constituents to be on alert due to the rising dengue cases in our locality. Let us clean our surrounding especially in possible breeding sites of dengue carrier mosquitos, and avoid mosquito bites," she said in Filipino during the flag-raising ceremony Monday.

Bautista also directed the village chiefs of the 16 barangays, especially in Barangay Ramirez where the eight dengue

cases were recorded, to coordinate with the municipal health office on ways to contain the situation.

Meanwhile, Bacolod also embarked on a massive information and education drive in the barangays for residents to be aware of the dengue symptoms.

The municipal health office also advised residents to never ignore symptoms like sudden high fever, severe headaches, pain behind the eyes, severe joint and muscle pain, fatigue, vomiting, and skin rashes which appear two to five days after the onset of fever.

"If you experience these symptoms, kindly go to the nearest hospital for proper medical treatment," Bacolod said.

He said residents should be more careful because these are known to increase during the rainy season when stagnant water becomes the breeding sites for the dengue-carrying mosquitoes.

Bacolod said dengue could be fatal when unattended, as mosquito bites could transmit the infection, which triggers a severe flu-like illness often followed by a severe drop in a patient's blood platelet count. (PNA)



SC RULES IN FAVOR OF KOKO FACTION IN PDP LEADERSHIP ROW

MANILA—The Supreme Court has upheld the decision of the Commission on Elections' (Comelec) to recognize the group, led by Senator Koko Pimentel, as the "legitimate" officers of the ruling Partido Demokratico Pilipino-Lakas ng Bayan (PDP-Laban).

In a resolution dated June 18 but only released Monday, the High Court, in dismissing the petition filed by the party's Rogelio

Garcia faction, said the suit failed to present evidence showing that the Comelec committed grave abuse of discretion.

"...the Court resolves to dismiss the instant petition for failure of petitioner PDP-Laban represented by Rogelio Garcia to sufficiently show that the public respondent Commission on Election committed grave abuse of discretion in declaring the sworn information update statement (SIUS) and list of authorized signatories (LIAS) filed by respondent Senator Aquilino "Koko" Pimentel III to be the legitimate and official SIUS and LIAS of PDP-Laban for the May 13, 2019, national and local elections in its November 28, 2018 resolution," the SC resolution read.

The Comelec issued the resolution after it received two sets of SIUS and LIAS filed by Pimentel's and Garcia's groups.

In its resolution, the poll body said it took judicial notice on the fact that Pimentel's group has been the same set of officers and authorized to submit the documents since 2016. Pimentel is the president of PDP-Laban while Garcia claimed he was elected party president in July 2018.

The resolution also denied Garcia's plea for the issuance of a temporary restraining order and/or a writ of preliminary injunction on the Comelec resolution.

"As correctly found by the Comelec, without a direct challenge questioning the legitimacy of the group of Senator Pimentel as the officers of PDP-Laban, and a consequent adverse ruling by the Comelec against such officers, it must continue to recognize them as the legitimate officers authorized to act for and in behalf of PDP Laban. Necessarily, the Comelec must recognize the SIUS and the list submitted by such officers," the SC said.

The tribunal, however, said the resolution is "without prejudice to the filing of a direct challenge" by Garcia's group questioning the legitimacy of Pimentel's group before the Comelec. (PNA)

DOH AMASSES 1,590 BAGS OF BLOOD IN CALABARZON

This year, the Department of Health (DOH) strengthens the promotion of its "Voluntary" Blood Donation Program in order to provide an adequate supply of safe and non-remunerated blood supply.

In support of this campaign, the DOH-CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) through the National Voluntary Blood Services Program (NVBSP) has conducted a series of blood donation drive in various provinces in celebration of National Blood Donors Month with the theme "Safe Blood for All" (Be There for Someone Else, Give Blood. Share Life).

"The feeling of responsibility to help others and save their lives by voluntarily donating a pint of blood is the foundation of a safe and sufficient blood supply. But even with the regular blood-letting activities we still have to continue to recruit voluntary blood donors and generate public

awareness on the need for safe blood and blood products." Dr. Noel G. Pasion, Local Health Support Division Chief stated during his message at the opening of the third voluntary blood-letting campaign at the Cultural Center of Laguna in Sta Cruz, Laguna.

"We need to endeavor to attain a community in every province or municipality with dedicated and devoted blood donors who will continue to provide voluntary non-remunerated blood donation yearly," he added.

The blood donation campaign started in June 14, 2019 at the Tagaytay International Convention Center with a total of 681 bags of blood collected and on July 5, 2019 at the Carmona Community Center with 759 bags then at the Laguna Cultural Center in Sta. Cruz, Laguna on July 12, 2019 with 150 bags. A total of 1,590 bags collected for the three provinces in coordination with the coordination of the provincial

health offices and the Philippine Blood Center. The regional office conducts regular blood-letting to employees to help ensure a sufficient supply and the quality and safety of blood and blood products for patients whose lives or well-being depend on blood transfusion.

Republic Act No. 7719, also known as the National Blood Services Act of 1994, promotes voluntary blood donation to provide sufficient supply of safe blood and to regulate blood banks. This act aims to inculcate public awareness that blood donation is a humanitarian act.

According to NVBSP, to be able to donate blood, a potential donor's weight must be about 110 lbs. or 50 kg, blood volume collected will depend mainly on body weight, must have a pulse rate between 60 and 100 beats/minute with regular rhythm, blood pressure must be between 90 and 160 systolic and 60 and 100 diastolic and hemoglobin at least 125 g/L.

Pasion also disclosed that donating blood has its own benefits which can reduce

the risk of having a cancer. "It may also help in improving cardiovascular health and reducing obesity." "A blood is a "gift of life" is priceless and cannot be assessed in monetary terms. Blood products are important in the treatment of serious illness and injuries such as trauma surgery, cancer through blood transfusion. It is also used in the management of blood disorders and for the treatment of complications during pregnancy, like hemorrhage and severe childhood anemia," he emphasized.

The World Health organization estimates that blood donation by 1% of the population is generally the minimum needed to meet a nation's most basic requirements for blood.

The "National Blood Donors Month" is conducted yearly in the month of July as per Proclamation No. 1021 signed on June 9, 1997. It encourages every Filipino to voluntarily donate blood for humane cause and to acknowledge blood donors for their noble act of saving lives through their gift of blood. BOY NAMORA
