## Caviteños urged to observe anti-dengue measures

**TRECE MARTIRES CITY, Cavite** -- As Cavite province is placed under a state of calamity due to the increase of dengue cases in 16 towns and seven cities, a provincial lawmaker on Wednesday appealed to Cavite constituents to conduct cleanups and fumigations in mosquito breeding sites.

Chair of the Sangguniang Panlalawigan's (Provincial Board) committee on health, nutrition and population, Cavite 6th District Board Member Kerby Salazar underscored the need to close ranks to address the dengue outbreak in the province.

"I'm appealing to my fellow Caviteños to participate in the massive cleanup drive and fumigation to ensure the cleanliness of their respective localities," Salazar said. He noted that they have tapped the Liga ng mga Barangay (village league) to help mobilize village folks to carry out the Department of Health's 4S strategy against dengue -- search and destroy mosquito breeding sites, secure self-protection, seek early consultation, and support misting/spraying to address the outbreak.

Salazar and the league's provincial federation president and ex-officio provincial board member Paolo Cristostomo have sought the cooperation of the local government units for barangay assemblies and massive awareness campaigns, in close coordination with the provincial health office.

With the state of calamity declaration last week, Governor Juanito Victor Remulla immediately ordered the release of about PHP4 million for the purchase of blood supplies, intravenous fluids, diagnostics kits, and other medical supplies for patients.

Dasmariñas City has recorded the highest number of dengue cases with 913, followed by Bacoor City with 419 cases.

The provincial health office has directed all government and private hospitals in the province to designate a fast lane for dengue patients. **(PNA)**

## Media urged to exercise 'high degree' of professionalism

**MANILA** - A ruling by the Supreme Court (SC) has advised members of the media to be guided by 'high degree' of professionalism particularly in today's digital age.

In a decision dated April 10 but made available to the public this week, the Court's Third Division through Associate Justice Marvic Leonen affirmed the 2013 Court of Appeals (CA) decision in the libel case against journalist Raffy Tulfo, and officials of tabloid Abante Tonight led by its publisher Allan Macasaet.

The SC modified the CA ruling by increasing the moral and exemplary damages awarded to complainant Michael Guy from PHP1.21 million to PHP1.71 million.

"The protection afforded by the Constitution to the press is not carte blanche that allows journalists to abandon their responsibility for truth and transparency. It is incumbent upon them to exercise a high degree of professionalism in their work, regardless of the subject of their stories," the SC declared.

Guy elevated the case before the SC after the appellate court deleted for lack of factual and legal basis the award of PHP5 million actual damages by the trial court in his favor.

Tulfo wrote that Guy, who was then being investigated by the Revenue Integrity Protection Service (RIPS) of the Department of Finance for tax fraud, went to former Department of Finance Secretary Juanita Amatong's house to ask for help.

Amatong then purportedly called the head of the RIPS and directed that all the documents that the Revenue Integrity Protection Service had obtained on Guy's case be surrendered to her. "Its Code of Ethics espouses the practice that journalism should be accurate and fair, and mandates accountability and transparency in the profession," the Court said.

"As such, journalists should observe high standards expected from their profession. They must take responsibility for the accuracy of their work, careful never to deliberately distort facts or context by verifying information before releasing it for public consumption," it added.

The SC said the credibility of journalists is needed more than ever in light of "recklessness in social media."

"This Court can only hope that respondents appreciate the privilege their fame has brought them and, in the future, become more circumspect in the exercise of their profession," the Court said. **(PNA)**

# SC SAYS UP EXEMPTED FROM REAL PROPERTY TAX

**MANILA --** The Supreme Court (SC) stopped the Quezon City government from selling the University of the Philippines (UP)-Ayala Land TechnoHub property as a way to settle the

university's unpaid real estate taxes amounting to PHP117.18 million.

In an 18-page decision penned by Associate Justice Antonio Carpio, the Court's First Division stressed that UP is exempt

from real property tax imposed by the city treasurer of Quezon City on the parcel of land currently leased to Ayala Land Inc. (ALI).

The Court's ruling voided the statement of delinquency issued by the Quezon City government on May 27, 2014 as well as the final notice of delinquency issued on July 11, 2014 covering the said property.

"Considering that the subject land and the revenue derived from the lease thereof are used by UP for educational purposes and in support of its educational purposes, UP should not be assessed, and should not be made liable for real property tax on the land subject of this case," the SC ruled.

The Court, however, explained that under the contract of lease between UP and ALI, all improvement on the leased land shall be owned by, and shall be for the account of the ALI during the term of the lease.

The SC added that the improvements are not "assets" owned by UP, thus, the tax exemption under Republic Act 9500 does not extend to these improvements during the term of the lease.

It can be recalled that the Quezon City government through its treasurer earlier notified the UP administration that the property will be auctioned off to answer for the unpaid real estate taxes.

On July 22, 2014, UP received the final notice of delinquency dated July 11, 2014 from the Office of City Treasurer demanding the payment of the amount.

The Office of the Solicitor General insisted that UP is exempt from taxes based on Republic Act 9500 or the UP Charter, thus, the issuance of a temporary restraining order (TRO) and/or a writ of preliminary injunction is warranted to enjoin the QC government from disposing the property.

Under Section 25 (a) of the law, revenues and assets of the university are exempt from "all taxes and duties".

The OSG said the exemption applies to UP's properties whether used for

educational purposes "or in support thereof".

The UP-Ayala Land TechnoHub was developed as an information technology hub and a part of the larger science and technology park located along

Commonwealth Avenue.

The Technohub is a PEZA-approved Information Technology Park. UP's share in the revenues of the property, as well as the lease paid by Ayala Land, supplement the univer-

sity's budget.

The QC government insisted that the subject property became taxable when it was leased to Ayala Land, since the beneficial use of the property was granted to a taxable entity. (PNA)

## SC clears lawyer in notary falsification raps

**MANILA --** The Supreme Court has cleared a lawyer of charges of falsification of a public document but ordered administrative charges against him.

In a statement released Tuesday, the tribunal said the court's Third Division, through Associate Justice Marvic Leonen, granted the petition of lawyer Bernardo Constantino to reverse and set aside the Court of Appeals (CA) rulings which affirmed his conviction six years ago by the Laoag City Regional Trial Court (RTC) Branch 14.

Both the RTC and CA found that Constantino had notarized a will of his client Severino Cabrales prior to it being signed by a witness whose name was printed on the document, Dr. Eliezer John Asuncion.

Asuncion did not appear before Constantino who also did not cross out the name of the witness before notarizing it.

Asuncion only signed the will after it had already been notarized.

The SC held that "[it] is presumed when the alleged falsity committed by the notary public pertains to the notarization since only notaries public have the duty and authority to notarize documents."

The SC also underscored that the RTC and CA disregarded that Asuncion signed the Joint Acknowledgment after it had been notarized by Constantino.

It also found that Asuncion signed the document on the prodding of Rene Ferrer Jr., son-in-law of Cabrales' daughter, and that Constantino seemed unaware that Asuncion later

signed the document. Asuncion admitted that his signature was genuine and that he was aware of what he was signing.

In acquitting Constantino, the SC held that "[s]ince Dr. Asuncion did not sign the Joint Acknowledgment before it was notarized, he cannot be considered as having attested and subscribed to its due execution at the time of its notarization. Thus, when Constantino certified that the persons who attested and subscribed to the document were present before him, there could have been no falsity."

The SC found that it was not Constantino who made it appear that Asuncion participated in the execution of the Joint Acknowledgment, but Ferrer and Asuncion himself.

The SC, however, ruled that "while [Atty. Constantino]'s acts may be inadequate to find him criminally-liable, he may still be liable for administrative sanctions."

It noted that the failure of Constantino to cross out Asuncion's name when he notarized the Joint Acknowledgment has allowed Asuncion to still sign the document despite not having participated in its due execution.

The SC pointed out that although the incidents of the case occurred in 2011 and the applicable Notarial Law then did contain a provision on false and incomplete certificates, the Court has already cautioned notaries public from notarizing incomplete documents even before the applicability of the 2004 Rules on Notarial Practice. **(PNA)**

## DOH Calabarzon calls for preventive measures vs. dengue

STA. CRUZ, Laguna

-- The Department of Health (DOH) regional office in Cavite-Laguna-Batangas-Rizal-Quezon (Calabarzon) area is urging the public to embark on intensive preventive measures while there is no available officially approved dengue vaccine yet.

"This is in support of the declaration of Health Secretary Francisco T. Duque III on the National Dengue Alert due to the continuous increase of dengue cases in various regions, including Calabarzon," Regional Director Dr. Eduardo Janairo on Saturday said. Regional Epidemiology and Surveillance Unit (RESU) reported that dengue cases in the region soared to 13,032 from January 1

to July 13, 2019, up by 26 percent from 10,350 cases during the same period last year.

A total of 50 dengue-related deaths were recorded in the region as of July this year, it said.

Janairo also issued dengue alert response and emergency management of cases to all Provincial Health Offices (PHOs), City Health Offices (CHOs), Municipal Health Officers (MHOs), Dengue Prevention and Control Program Coordinators, Provincial Department of Health Office (PDOHO) and other concerned units in the region.

Responses and emergency management include the immediate reactivation of Dengue Task Force in every local government unit (LGU), including the establishment of dengue fast lane in all government and private hospitals.

"We will be prioritizing areas for community-based intervention to control dengue vector, such as areas where there are clustering of dengue cases, occurrence of an outbreak in the past year, recent dengue-related deaths, vector indicators and presence of cases in schools and hospitals," he said.

Janairo assured the DOH will be assisting LGUs,

through the respective PDOHO in every province, to implement anti-dengue activities through enhanced 4S strategy -- Search and destroy mosquito breeding sites, Secure self-protection, Seek early consultation, and Support misting/spraying to prevent an impending outbreak.

"There is still no vaccine for dengue. The best way to prevent dengue virus infection is to take the necessary precautions to avoid being bitten by mosquitoes and consult a doctor immediately if suffering from a high fever," he said.

Janairo vowed to send

disease surveillance officers to investigate and validate reported dengue cases, especially persons vaccinated with Dengvaxia who show signs and symptoms of dengue. He said the World Health Organization has not officially approved the Dengvaxia vaccine.

Janairo further said the regional office will also intensify health education and awareness campaign against dengue by conducting community assembly, and distribution of information and education campaign materials. (PNA)

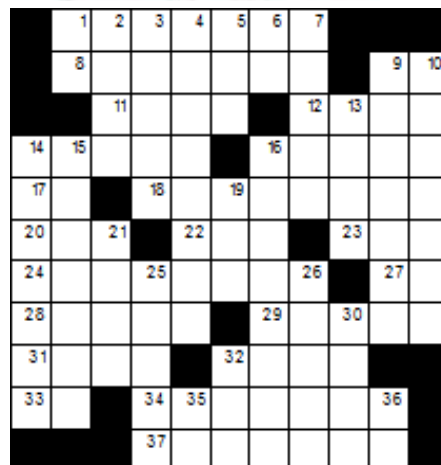

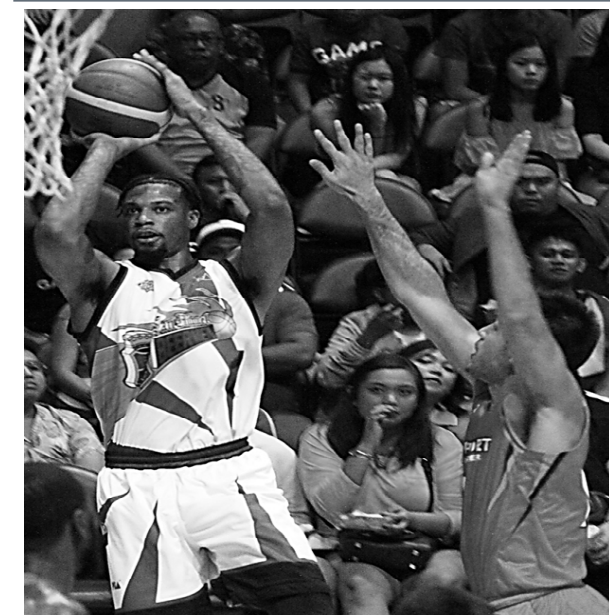

## Manila mayor warns traffic violators vs. bribery

**MANILA -- Manila Mayor Francisco "Isko Moreno" Domagoso on Tuesday warned traffic violators not to bribe any of the traffic personnel in the city.**

Domagoso dismissed on Monday Ricardo Galit, a Manila Traffic and Parking Bureau (MTPB) enforcer caught in the act of extortion on a closed-circuit television camera.

Applying the one-strike policy for MTPB officials, Domagoso said Galit can never be part of the team again and will be facing charges for the illegal activity.

"Totoo pong may mali ang aming enforcer dahil tumanggap ng pera sa inyo (It's true that our enforcer made the mistake of receiving money from you), or what we call 'kotong'. Sana makita rin natin sa ating mga sarili na meron din tayong mga pagkaka-mali (I hope we also see in ourselves our mistakes), induced bribery," Domagoso said in a briefing at the Manila City Hall.

Domagoso said traffic violators who plan to evade any liability would have to face charges as well.
