Community engagement, LGUs vital to police peace building efforts

CAMP GEN. VICENTE LIM, Calamba City – The Presidential Adviser for Southern Tagalog region underscored the vital role of police partnerships with local government units (LGUs) and other sectors in the fight against illegal drugs, rebellion and other hindrances to peace in the community.

This was the message of Secretary Jose Maria Nicomedes F. Hernandez, Presidential Adviser for Southern Tagalog and chair Calabarzon's Regional Task force to End Local Communist Armed Conflict (RTF-ELCAC), when he graced the "24th Police Community Relations Month" observance on Wednesday at this camp.

"I thank the people behind the Community Affairs and Development Division for mobilizing the community towards cooperation and unity in sharing with the government's programs," Hernandez said, recognizing police efforts in peace and order through the cooperation of various sectors.

He likewise acknowledged Calabarzon and MIMAROPA LGUs and other stakeholders for their unrelenting support to the Philippine National Police (PNP). "Everybody should be a key player. Think of the country's future. Let us support the PNP," Hernandez urged.

During the event, Police Regional Office (PRO4A)-

Calabarzon Regional Director Brig. Gen. Edward E. Carranza recognized the outstanding provincial police offices, units and officers "for their selfless contribution leading to the region's success against criminalities and lawlessness".

The Police Community Relations Month themed "Sambayanan, Mahalang Kaakibat ng Kapulisang Pagtaguyod ng Mapayapa at Maunlad na Bayan" observed every July, culminating with the awarding of PNP personnel as well as police offices that have performed admirably.

The National Police Commission (NAPOLCOM) in Region 4A also gave recognition to Local Chief Executives (LCEs) for their "outstanding services to the community and invaluable leadership, diligence and dedication to serve their respective constituents."

Hernandez, assisted by Carranza and other top regional police officials presented the awards to Quezon Police Provincial Office for Outstanding Police Provincial Office; Sta. Rosa City Police Station for Outstanding City Police Station; and Teresa, Rizal for Outstanding Municipal Police Station.

Batangas ranks 3rd among most visited provinces in 2018

BATANGAS CITY – The provincial government took pride in the recognition of the province as the country's Top 3 destination for 2018 based on the volume of both domestic and foreign tourist arrivals, and overnight accommodation in tourism related establishments (TRES).

Another Calabarzon province, Rizal made it to No. 9 in the ranking according to the Department of Tourism (DOT) Calabarzon regional office data on regional distribution of overnight travelers from Accommodation Establishments as submitted by the DOT Regional Offices as of May 2019.

In its Facebook post, the DOT Region IV-A, through its Regional Director Marites T. Castro, said it has extended "our heartfelt gratitude to our hardworking Provincial, City and Municipal Tourism Officers for actively submitting their respective tourism arrivals data—placing the provinces of Batangas and Rizal in the top destinations. Thank you for all your support!"

In a report released to the Philippine News Agency on Thursday, Jenelyn A. Aguilera, chief of Batangas Public Information office, said the provincial government - through Gov. Hermilando Mandanas - attributed this to the apparent success of their "Fun, Food, Faith" tourism campaign on tourism destinations, culinary, heritage and faith-based tourism, among other projects.

She said the list of the country's top destinations was formally announced by the DOT, through its Office of Tourism Development Planning, Research and Information Management, during the Philippine Tourism Satellite Account and Tourism Statistics Dissemination Forum on July 26, 2019.

The DOT listed Cebu province, including Cebu City, Lapulapu City and Mandaue City, at No. 1 followed by Camarines Sur.

She said the province of Batangas ranked third in the country while achieving its Top 1 spot in the Calabarzon Region due to the surge of domestic and foreign tourists who stayed for overnight accommodations. (PNA)

DOH distributes assistive devices to Calabarzon PWDs

SAN MATEO, Rizal

– The Department of Health regional office has distributed some 180 assistive devices comprised of wheelchairs, crutches, canes and walkers to persons with disability (PWDs) in Cavite, Laguna, Batangas, Rizal and Quezon (Calabarzon).

The distribution ceremony culminated the two-day "PWD Health Summit for CALABARZON" which gathered some 130 PWDs, whose federation officials and representatives received on their behalf the 40 wheelchairs, 40 crutches, 40 canes and 40 folding walkers on Wednesday at the Ciudad Christia Resort here.

"In CALABARZON, we have already prioritized the health needs of PWDs by providing them medical services and assistive devices that will enable them to be physically active and help them compensate even with a limited activity,"

said Dr. Eduardo C. Janairo, DOH Calabarzon Regional Director.

Janairo said the PWDs is one sector of the society that should not be left behind, but instead be given equal opportunity in health now that the Universal Health Care Law is ratified.

The DOH regional office hosted the two-day summit themed "Lokal na Pamahalaan: Kabalikat sa Pagtupad ng Karapatan ng mga Taong May Kapansanan," (Local Government: Partner in Upholding the Rights of PWDs), was part of the nationwide observance of the "National Disability Prevention and Rehabilitation Week," held annually every 3rd week of July through Proclamation 361 in Aug. 19, 2000.

"PWDs need more than what we can give them, thus the need to understand their needs and capabilities prompting government agencies to provide them the opportunity for work and make them more productive, self-reliant and empower them to become active," Janairo added.

According to the Philippine Statistics Authority (PSA) 2010 data, Calabarzon Region has the highest number of PWDs with 193,000 followed by the National Capital Region with 167,000; Central Luzon – 139,000; Western Visayas – 138,000; and Central Visayas – 109,000; and Cordillera being the lowest with 26,000 PWDs.

During the two-day PWD summit, the DOH Calabarzon team presented various topics on PWD empowerment; updates on health service delivery concerning PWDs, their Philhealth benefits, and the institutionalization of a national integrated cancer control program.

Dentists from the regional health office also provided free dental cleaning and check-up for PWDs in attendance. (PNA)

The provincial government of Cavite thru the Provincial Government-Environment and Natural Resources Office headed by Ms. Anabelle Cayabyab spearheaded this year's tree planting project in the municipality of Silang with focus on conservation and rehabilitation of streambanks in the province.

On July 31, 2019, environmental volunteers were welcomed by MENRO Merlin Cabrera on behalf of Silang Mayor Corie Poblete, thanking Governor Jonvic Remulla for supporting one of their clean and green campaigns. Likewise, Ms. Cabrera expressed her appreciation to Ms. Flordeliza Dela Rosa, the school principal of Gen. Vito Belarmino National High School in Barangay Calubcub, Silang and the barangay captains of Lucsuhin and Calubcub who accommodated participants during the opening program.

Meanwhile, on behalf of the governor, Provincial Administrator for Community Affairs Alvin Mojica conveyed words of encouragement among the youth and co-public servants to continue joining the Arbor Day for the protection

of the environment. He shared personal advocacy which spans twenty years of doing projects that will benefit mother earth and the future generation, and the fulfillment of having more trees planted.

Moreover, Forester Gerry Lopez from PENRO talked about how the event will also help contribute in the rehabilitation program for Manila Bay, underscoring the importance of river cleanups and tree planting along slopes to achieve stronger streambanks. Land Management Division Chief of PG-ENRO Engr. Ernesto Cenizal added in his closing remarks that apart from the objective to save the Imus Ylang-Ylang River, the Arbor Day is one of the programs in line with disaster risk reduction management.

Among the volunteers who planted different fruit-bearing trees for the successful implementation of the National Greening Program were students from the host school led by their Student Government Organization, uniformed personnel from the Bureau of Fire Protection (BFP), the Philippine National Police (PNP), the Army Reserved

Command (ARESCOM), the Provincial Planning and Development Office (PPDO), PG-COPS, and private stakeholders comprised of I-QOR, Linearworks, Cleanway and Big Philippines, plus members of the LGBT-Q –Silang. A total of 950 seedlings were planted including bamboo, kaong, guyabano, langka, duhat and atis. (PICAD)

SC clears ex-PCSO chair of raps over misuse of intel funds

MANILA -- The Supreme Court (SC) has ordered the dismissal of malversation charges against former Philippine Charity Sweepstakes Office (PCSO) chairman Sergio O. Valencia.

In a decision dated June 10 and released Tuesday, the High Court through retired Associate Justice Mariano C. del Castillo granted the demurrer to evidence filed by Valencia in connection with the alleged misuse of PCSO's confidential and intelligence fund (CIF) from 2007 to 2010.

On April 6, 2015, the Sandiganbayan granted Valencia's demurrer to evidence as far as his plunder case was concerned since the charge involved only PHP13.3 million which was below the PHP50-million threshold for plunder.

The anti-graft court, in the same resolution, ruled that there was sufficient evidence to convict Valencia of malversation under Article 217 of the Revised Penal Code (RPC).

Case records showed that in July and December 2011, two complaints for plunder, malversation, and graft were filed against several members of the PCSO board and other officials led by former President Gloria Macapagal Arroyo.

On July 10, 2012, the Office of the Ombudsman filed with the Sandiganbayan plunder charges against them. In the case of Arroyo and Benigno Aguas, former PCSO budget and accounts manager, they elevated the Sandiganbayan's denial of their demurrer to evidence before the SC which ruled in their favor.

The SC also ruled in favor of Arroyo and Aguas on the issue regarding the sufficiency of the allegations in the information (criminal charge sheet) for plunder as to include the crime of malversation.

The unfavorable Sandiganbayan ruling prompted Valencia to elevate the issue before the SC.

He said "the crime of plunder cannot be downgraded to the crime of malversation as the latter is not included in the former" and "there was no sufficient evidence to hold him liable for malversation."

A demurrer to evidence is a motion filed by an accused in a case to dismiss the charges on allegation that the prosecution's evidence is not sufficient to render a guilty verdict.

"He (Valencia) asserts that he cannot be held liable for malversation in view of the insufficiency of the allegations of its elements in the information. It is well to note that the information subject of the aforementioned cases of Arroyo and Aguas is the very same information under scrutiny in the present case wherein petitioner is their co-accused and where all the incidental matters stemmed and had their origin.

"Hence, there is no reason not to apply the afore-quoted ruling in the present petition since it has reached its finality, per Entry of Judgment, on May 30, 2017.

"We are therefore not free to disregard it in any related case which involves closely similar factual evidence. Otherwise, we would jettison the doctrine of immutability of final judgment and, further, obviate the possibility of rendering conflicting rulings on the same set of facts and circumstances in the same information.

"It is therefore apparent that in denying petitioner's Demurrer to Evidence and ruling that there was sufficient evidence to hold him liable for malversation despite the lack of specific allegations of the factual details pertaining to the crime of malversation in the information, respondent Sandiganbayan is said to have gravely abused its discretion amounting to lack of jurisdiction." DOE turns over 50 e-trikes to Batangas City

BATANGAS CITY -- The Department of Energy (DOE) on Monday turned over 50 electricity-run or e-trikes to the city government which will be distributed to qualified tricycle drivers as part of the city's livelihood program.

"Ang three-wheeled e-trikes na ito ay environment-friendly sapagkat gumagamit ng kuryente sa halip na gasolina o diesel upang mabawasan ang carbon emissions sa kahaligiran. Dimacuha tasked the city e-trikes Project Management Team to evaluate the qualified beneficiaries who must be bona fide active members of Tricycle Operators and Drivers Association (TODA) of good standing, no criminal or police record, have the capacity to maintain the e-trike, has a garage, among other criteria.

Batangas City is one of the local government unit (LGU) recipients under the DOE Market Transformation through Introduction of Energy-Efficient Electric Vehicles Project.

"We need to harmonize efforts and provide similar services and activities, support and assistance for the three regions. Basically, what we have done for Calabarzon, we will also implement accordingly in the two other regions," he said in an interview on Monday.

The Department of Health (DOH) launched in 2016 the Dengvaxia immunization, and was implemented in three regions, including Region 7, on request by

the region's Congressional representative.

But in 2017, the Dengvaxia immunization program had created panic and concerns among parents of the scores of children vaccinees, triggered by the analysis and announcement of its manufacturer.

Janairo bared the task force has monitored that fears and apprehension over the health department's vaccination program attributed to the Dengvaxia controversy, however, has declined.

"Actually, the Dengvaxia scare was short-lived. They (parents, guardians) now realized there are other more important vaccinations needed as protection for their children," he said.

He added parents and guardians have gradually eased their misgivings after they were convinced on the importance of the other vaccines as protection for their children from various diseases.

At the height of the Dengvaxia controversy, health authorities uncovered that a total of 833,000 Filipino children were found to have been administered the Dengvaxia vaccine in the regions.

"We need to keep track with the Dengvaxia vaccinees. We are conducting a series of physical examinations, monitor and strengthen their resistance and ensure their health because this is the only way to protect them from any illness or disease which could affect them," Janairo said in Filipino.

He added the regional health office's routine visits in various communities during the "Aksyon Barangay Kontra Dengue (ABKD)" underscored the need to track down and monitor the anti-dengue vaccination program.





