MAYOR ELM CRACKS DOWN ON ILLEGAL PARKING, CLEAR ROADS

IMUS City --Teams of engineer's office, traffic enforcers, environment and natural resources and local police on Thursday, August 22 swooped down the streets along Barangay Alapan and Bucandala, in the vicinity of city market, section of Gen. Aguinaldo Highway in this city to clear them of illegally parked vehicles and remove road obstructions.

Mayor Emmanuel L. Maliksi personally led the clearing teams together with City Engr. Chris Sarno, City Planning Officer Rodel Pelaez, personnel from the City and Tourism Office, city and barangay officials. In Bucandala, the mayor personally talked to owners of business establishments in the areas to clear the public roads and sidewalks of all obstructions.

Maliksi told this writer that the removal of structures and other public road obstructions would be done in the city's 97 barangays.

Maliksi said the clearing is part of the city government's commitment to comply with the directive of President Rodrigo Duterte to clear major road networks of obstructions. To do this, the mayor said that all barangay heads are also directed to submit report to the local office of the Department of Interior and Local Government (DILG) on the results of their clearing of road obstructions.

The mayor gave a one-week deadline to stall owners in Brgy. Bucandala to remove and dismantle concrete obstructions and clear the sidewalks. The city government started its campaign last two weeks in many streets of the city barangays which are notorious for parked vehicles, ambulant vendors particularly along the side of the highway.

Sidewalks and pathways Bucandala and Malagasang are hosts to many wet and dry flea market, this writer witnessed during the clearing operations conducted by the mayor.

With the help of traffic personnel and Cenro officials, the teams cleared the area of garbage, illegally parked vehicles and the engineering removed structures that have blocked the sidewalks for safe passage of pedestrians.

"Nagpapasalamat po kami kay Mayor na kinausap muna kami at inexplain na kailangan ngang ma-clear ang daanan. We will comply sa utos ni Mayor Maliksi," said one vegetable vendor whose stall occupied the three-meter span of the sidewalk.

Traffic has been a problem in Bucandala and there have been cases of accidents because of illegally parked vehicles and sidewalk obstructions where pedestrians are forced to walk in the middle of the streets.

Last July 29, the DILG issued Memorandum Circular 2019-121 ordering all local government units (LGUs) to reclaim public roads of private use by individuals or entities.

"We hope that with the removal of obstruction of the streets, alleys and sidewalks, mababawasan ang masikip na traffic sa lugar. Male-lassen na ang inconvenience kahit paano sa ating motorista at commuters," Maliksi told this writer.

He said he would conduct simultaneous inspections of the barangays on the progress of the dismantling of road obstructions every Thursday and Friday.

Maliksi told business owners that the DILG memo gives the local government the power to revoke permits that give private entities authority to use parts of any public roads.

"Yung mga hindi susunod at hindi babaklasin ang mga harang at mga pwesto sa public roads at sa mga bangketa, after the one-week grace period, wala kaming magagawa kungdi ang gibain ang mga obstruction at lalapatan namin sila ng penalty at parusa," Maliksi said.

SC AFFIRMS DISMISSAL OF MARINE OFFICER IN 1999 ALLOWANCE SCAM

MANILA -- The Supreme Court (SC) upheld the dismissal of a commandant of the Philippine Marine Corps accused of involvement in anomalies amounting to PHP36.768 million in clothing and equipment allowances for soldiers 20 years ago.

In a July 10 decision made public Tuesday, the SC's Second Division - through Associate Justice Amy Lazaro-Javier - ordered the dismissal from the military service of former Marine commandant, Maj. Gen. Renato Miranda, who was charged by the Office of the Ombudsman along with four other Marine officials of pocketing the Combat, Clothing Allowance and Individual Equipment Allowance (CCIE) for year 1999.

The High Court reversed the Court of Appeals (CA) decision which nullified the order issued by the Ombudsman on February 27, 2009, dismissing Miranda from the service, along with five other military officers, for grave misconduct and serious dishonesty.

The SC ruled that the appellate court erred when it cleared Miranda from the charges despite compelling evidence on record showing that he committed the offenses.

"What respondent did was truly indispensable to the consummation of the unlawful disbursement of public funds which cause prejudiced to the government," the SC ruled.

The Court also ordered the forfeiture of all his benefits except for accrued leave benefits and perpetually disqualified him from re-employment in any branch of service of the government, including government-owned and controlled corporations.

The former Marine commandant is also facing a graft case before the Sandiganbayan for malversation through falsification of public documents in connection with the anomaly.

In its petition before the SC, the Ombudsman insisted that Miranda along with his four co-accused PMC personnel conspired to defraud the government through a fictitious grant of CCIE allowances to enlisted members of the Philippine Marine Corps.

Each enlisted employee was to get PHP8,381.25 as Combat Clothing Allowance and PHP6,337.80 as Individual Equipment Allowance, or a total of PHP14,719.05.

The disbursements were released through 19 checks in various amounts. At least 145 soldiers who were supposed to benefit from the fund attested that they did not receive any amount in full or in part.

Miranda was dismissed from the military service in 2006 for his part in the coup plot to oust then-President Gloria Macapagal-Arroyo but was granted amnesty by former President Benigno Aquino III in 2010. (PNA)

Gunman pleads guilty in murder of bizman Dominic Sytin

MANILA -- The gunman in the killing of businessman Dominic Sytin pleaded guilty on charges of murder and frustrated murder before an Olongapo court on Wednesday.

As a result, Senior State Prosecutor Juan Pedro Navera said Edgardo Luib can no longer be admitted as a state witness in the case although his testimony against other suspects allegedly involved in the crime may still be tapped by government lawyers.

Also linked to the murder are the victim's younger brother Dennis and a disgruntled employee, Ryan D. Rementilla who also goes by the name Oliver Fuentes.

"(Since) he has already been arraigned, he (Luib) can no longer be discharged (as a state witness)," Navera said.

Another hearing was scheduled by the court for Luib to prove the voluntariness of his plea in the murder of Dominic and for the injuries sustained by the victim's aide, Efren Espartero.

The location of the other accused remains unknown.

State lawyers see family business dispute as the motive of the crime.

The family owns United Auctioneers Inc., a local importer of heavy equipment and likewise runs the local franchise of an international truck manufacturer.

Luib, Dennis, and Rementilla are facing charges over the shooting incident in front of the Light House Hotel inside the Subic Bay Freeport Zone resulting in the killing of Dominic and the wounding of his bodyguard, Efren Espartero Jr. in November 2018. (PNA)

CAVITE MULTI-SECTORAL HIV COUNCIL AND COORDINATORS MEETING

THE Provincial Health Office thru its Provincial HIV Program Coordinator, Haydelisa Maderazo, facilitated the two-day Cavite Multi-sectoral HIV Council and Coordinators Meeting held at The Bayleaf Hotel, City of Gen. Trias on August 22-23, 2019. The meeting with the tagline "Act Against AIDS, End It" sought to build a more cohesive network of offices to work on the probable recommendations, programs and policies towards handling the HIV epidemic.

Issues and challenges encountered in the implementation of HIV programs and policies in cities and municipalities were tackled during the first day of the meeting. Two of the major problems cited were the conflict during the testing and screening and the referral system after the patient was diagnosed reactive. It was attended by the municipal and city health officers, HIV program coordinator and nurses, members of POZ Cavite Support Group Incorporated (PCSGI) and members of the Provincial HIV Council.

Dr. Michael Angelo Marquez, Bacoor City HIV Medical Coordinator suggested to formulate IEC materials on HIV-AIDS programs and policies with complete directories of the treatment hubs in the province. Likewise, Dr. Ferdinand Mina of Imus City Health Office recommended to have a massive HIV awareness campaign tapping the LGBT community through creation of an LGBT organization in Cavite.

On the second day, Dr. Nelson Soriano, OIC-Public Health and Technical Services and Head of Provincial Epidemiology Service Unit of the PHO welcomed all the participants and challenged them to improve the HIV prevention and control programs in the province since HIV is a big health issue. According to him, open networking like social media is big help in solving the challenges encountered.

The event was also graced by Sixth District Board

Member Kerby Salazar, Chairperson-Committee on Health, Nutrition and Population and expressed his observation that majority of the HIV awareness programs focused on the LGBT community. He suggested that it's time to design a program for everyone. He also stressed that more than increasing awareness, activities and programs that can help end the stigma should be formulated. BM Salazar promised that as chairperson of the committee on health, he will utilize his term to improve the healthcare and nutrition program in the province to achieve a healthy and livable Cavite. Highlight of the meeting was the presentation of the accomplishments of the Provincial HIV Program where Ms. Haydelisa Maderazo reported that they have conducted HIV awareness campaign to senior high school students from different schools in the province, out of school youths and employees of private companies from September 2018 – August 2019. Simultaneous mobile HIV counselling and testing were also done in the entire province. She also cited other HIV programs like candle lighting ceremony, Buntis Congress for both adult and teenage pregnant women and orientation in different private companies. Likewise, status and accomplishments of four treatment hubs namely, Bacoor Social Hygiene Clinic, Imus Reproductive and Wellness Center, Dasmariñas Social Hygiene Clinic and Gen. MAYOR LUBIGAN REVOKES ALL PERMITS

TRECE Martires City – In a memorandum order dated August 1, Mayor Gemma Lubigan has ordered the revocation of all permits giving authority to private entities to occupy public roads and alleys in the city.

With this memo, the city government started the campaign to clear of obstructions of all city streets and sidewalks in line with the directive from President Rodrigo Duterte.

This paper learned that the permits to use public roads by private individuals and entities were approved during the past administration.

A city official, who requested not to be named, said that there "was nothing personal with the order of the mayor."

The official explained that Lubigan has to comply with the order of the President and the memorandum issued by the Department of Interior and Local Government ordering all local government units to clear all obstructions on public roads, sidewalks and alleys.

"Inutos na rin po ni Mayor Gemma na aming imbentaryuhin ang lahat ng lugar at kalsada sa Trece na nilagyan ng concrete structure na nakaharang at nakasagabal sa mga daan," the official told this paper.

The DILG order gave LGUs 60 days to clear obstructions on all public roads and gave the power to the local chief executives to revoke all permits given to individuals and entities to use public roads.

Likewise, the first lady mayor of TMC ordered all barangay officials to clear their respective communities within 60 days and to submit on a weekly basis the progress reports on the clearing operations to the local office of the DILG and to the Office of the Mayor.

Two-day National Conference on nutrition-sensitive programming

SILANG, Cavite - Food security and nutrition experts culminated on Friday their two-day National Conference to chart ways to strengthen initiatives on nutrition-sensitive programming and successfully implementation of these programs that are identified in the Philippine Plan of Action for Nutrition (PPAN) 2017-2022. The International Institute for Rural Reconstruction (IIRR) - an international development, research and training organization, organized the conference in partnership with the National Nutrition Council (NNC) and Scaling Up Nutrition-Civil Society Alliance Philippines (SUN-CSA Ph) to address malnutrition which remains a public problem not only in the country but across the globe. Held at the IIRR's YBS Hall, the national convention is part of the "Strengthening Capacities on Nutrition-Sensitive Programming" which uses a two-track approach aimed at strengthening capacity of national government agencies to develop more nutrition-sensitive programs through supporting conducts of capacity-building activities for government staff. The program also called for action planning workshops and constant mentoring and monitoring with partner agencies, including civil society sector and local government units (LGUs) on developing and implementing local-level nutrition-sensitive projects/programs. During Thursday's opening program, IIRR Acting Asia Regional Director Emily Monville Oro challenged participants from National Government Agencies (NGAs) and International Non-government Organizations (NGOs), food experts, members of the academe, research institutions, Civil Society Organizations (CSOs) and development organizations and experts on food security and nutrition if "are we moving, shaking enough in our battle on malnutrition?" "We may need to tweak a

bit to make it more nutrition sensitive" Oro proposed, citing the country's policy framework, systems and structures are in place to combat malnutrition. She disclosed results of the 2018 Expanded National Nutrition Survey where stunting prevalence remains high for ages 0-23months, 2 to 5 years old, with increasing anemia prevalence, while overweight and obesity affect those from 10 to 60 years old and above. She also pointed out that although there are significant gains too where stunting has decreased significantly from 31.9% to 26.3% and wasting has decreased but not significant at 5% level for those under ages 10 to 19 years old, she stressed the need to do more to achieve the target, ensuring "no one should be left behind" by addressing immediate causes as well as underlying causes of malnutrition to develop effective programs. She also underscored nutrition sensitive programming is needed to complement nutrition specific interventions that are non-negotiable. "We already know that we need to focus on the first 1000 days - that window of opportunity, otherwise this impact of malnutrition really become irreversible," she warned. She advised that practical yet simple and high impact actions for better nutrition are more important than the mere concepts and that research without action is sterile, as something should be done out of the data and concepts. She also urged to ensure implementation and delivery of the services on the ground where the action is and where it is needed most and called for more sustainability and scaling up as keys to have the enough investments to put into work to generate more impact. During the conference, the participants were briefed on the country's nutrition landscape: from the underlying causes, framework for joint
