## MAYOR COMMITS MORE JOBS FOR KAWITENOS

**IN support of his under-employed and unemployed constituents, Kawit Mayor Angelo Emilio Aguinaldo vowed to mitigate poverty incidence of the historical town in Cavite by providing employment opportunities to hundreds of Kawiteños through the Public Employment Service Office (PESO).**

Aguinaldo said that he ordered the PESO to coordinate with the various fast food restaurants, manufacturing and business establishments in the municipality to first hire for employment registered and qualified residents of Kawit.

"Our program is to significantly reduce poverty incidence in Kawit," the mayor said in an interview with this paper.

The mayor added the PESO is making rounds in business offices in the municipality and will forge partnership with the Department of Social Welfare and Development (DSWD) and the Technical Education and Skills Development Authority (TESDA) to help Kawitenos acquire skills and find jobs.

TESDA has an enhancement of the services and online courses to develop the Filipino workforce with world-class competence and positive values.

Aside from this, the local government has a continuing livelihood program for women like baking, cooking and food processing; hair coloring, beauty care, unisex haircutting, sewing, among others.

"Magkatuwang po ang ating local Social Welfare at ang PESO para matulungan ang mga kababayan natin na maka-acquire ng skills na magagamit nila sa trabaho at makapag-umpisa kahit ng small business," Aguinaldo said.

He added that his office is working closely with the private sector on the provision of business and job opportunities to job seekers.

"Human development is our response to help our

economically challenge constituents, Importante sa lahat ay ang kabutihan ng ating mga kababayan. Kung may trabaho at disentang hanapbuhay ang ating mga kababayan, mare-reduce ang crime incidents at gaganda ang kabuhayan ng ating bayan," the mayor said.

## Media info literacy drive launched in Calabarzon

**CALAMBA CITY, Laguna** – With 70 percent of the youth captivated by Internet, the Presidential Communications Operations Office (PCOO), through the Philippine Information Agency (PIA), launched on Wednesday a media and information literacy (MIL) campaign in the Calabarzon Region. Ma. Cristina C. Arzadon, PIA Calabarzon head, said the campaign, dubbed as #cyberREADI, is the agency's contribution to global efforts for MIL and to provide safe digital spaces for the youth by eliminating disinformation. The project, she said, is part of the Asean-Japan Media and Information Literacy for the youth and supported by the Association of Southeast Asian

Nations (Asean) and the INFOCOMM Media Development Authority of Singapore.

"It aims to turn social media publics especially the Asean youth, into smart consumers and responsible producers of online information," Azardon said during the regional launch of the campaign here on Wednesday.

A recent study by the International Telecommunications Union (ITU) showed that 70 percent of youth are online, making them vulnerable to the improper use of information through social media.

Azardon said the word READI in their campaign actually stands for the core values of media and information literacy: responsibility, empathy, authenticity,

discernment, and integrity. "Responsibility urges people to think before we post, empathy asks for respect and thoughtfulness on our online activities," she said. "Authenticity and sincerity in all our online transactions and being able to stand for what we post, discernment that urges critical evaluation of any information source online before acting upon it, and lastly integrity means that we should do the right thing, stand up for what is right and speak against negativity online," she added.

The University of the Philippines (UP) College of Mass Communication Foundation participated in the event by presenting online videos which show the ill effects of social media if improperly used like disinformation,

fake news, cyberbullying, online scams and child pornography.

Other forms of the campaign, from GIF, social media cards, and similar online materials have been launched through the #cyberREADI page, Azardon said.

The Philippines was the first to launch the campaign among Asean member countries that include Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, Singapore, Thailand, and Vietnam.

A nationwide launch of the project was held on Aug. 14 at the PIA main office in Quezon City.

The Calabarzon launch was attended by representatives from the Department of Information and Communication Technology (DICT), Department of Education- Calabarzon, and the Sangguniang Kabataan Federation-Laguna Province. (Gladys Pino-PNA)

Brig. Gen. Rey Lyndon Lawas was designated as director of the Training Service; and Col. Ronnie Montejo was named acting QCPD director.

# Immunity from suit doesn't cover President's alter egos: SC

on the constitutional principles of accountability and good governance that should guide a public servant. The rule is that unlawful acts of public officials are not acts of the State and the officer who acts illegally is not acting as such but stands in the same footing as any other trespasser," it added. The decision affirms Sabio's conviction by the Sandiganbayan, dated June 22, 2017, and August 25, 2017, respectively. The SC cited Republic Act No 9184 or the Government Procurement Reform Act, which explicitly provides that all government procurement

shall be done through competitive bidding, except as provided for in Article XVI of the same law. The PCGG, being a government office or agency, is covered by Republic Act No. 9184. This means that before entering the lease of the 11 vehicles, the PCGG should have conducted competitive bidding first. The SC also held that there was bad faith on Sabio's part in entering into the said lease agreements without "undertaking the required procurement process, and subjecting government funds to unnecessary expenditure without pre-allocation and

the necessity for the same." The SC also took note that Sabio was also a member of the board of United Coconut Planters Bank, the parent company of UCPB Leasing, when the lease agreements were entered into, giving unwarranted benefit and advantage in favor of UCPB Leasing. "As correctly ruled by the Sandiganbayan, Sabio's acts unmistakably reflect "a dishonest purpose or some moral obliquity and conscious doing of a wrong; a breach of sworn duty through some motive or intent or ill will," the court ruled. ## SC AFFIRMS CA JUNKING OF AMPATUAN BAIL PLEA

**MANILA --** Former Autonomous Region in Muslim Mindanao (ARMM) Governor Datu Zaldy Uy Ampatuan will remain in jail as the Supreme Court (SC) turned down his petition for bail on murder charges, in connection with the Maguindanao massacre.

In a six-page notice made available to newsmen Wednesday, the SC's First Division through Division Clerk of Court Librada C. Buena said the court on July 22 resolved to deny Ampatuan's petition "for lack of merit".

The decision affirmed the April 2018 ruling of the Court of Appeals (CA), which refused to grant bail to the petitioner.

The court explained that ruling on whether Ampatuan, who is among those charged with 58 counts of murder for the Maguindanao massacre, is entitled to bail could inadvertently result in deciding the main case itself, which is now submitted for resolution before the lower court.

"In determining the veracity of the evidence petitioner presented in support of his denial and alibi and to rebut the evidence of the prosecution, the Court will necessarily have to rule on the admissibility and probative value of these (pieces of) evidence. By deciding for or against his bail application on the basis of factual issues raised by petitioner, the court will be prematurely deciding the case beyond the parameters of judicial review at this stage of the proceedings, and preempt the parties from presenting their respective evidence during trial," the court said.

"This court is of the view that these issues are best threshed out in a full-blown trial. The court must defer making a conclusion on this matter since the participation of conspirators, principals, accomplices and accessories are matter adjudged as a whole at the conclusion of the evidence-in-chief," the tribunal pointed out.

Henchmen of the Ampatuan clan allegedly ambushed the convoy of their political rivals, the Mangudadatus, killing the victims who included

32 local newsmen and supporters and relatives of the Mangundadatu clan.

The event is the single most deadly event involving journalists in the country. Among the witnesses were Esmael "Toto" Mangundadatu, Maganoy, Maguindanao vice mayor Sukarno Badal, and Lakmodin Saliao, the alleged personal assistant

of Datu Andal Ampatuan Sr.

The witnesses said the petitioner gave his blessings to the ambush by phone while he was in Manila attending official events and volunteered the use of his cache of firearms and ordered the ambush group to leave no traces after the attack. (PNA)

# TIMELY DATA NEEDED FOR GAD PROGRAMS- CAVITE FOCAL PERSON

**GENERAL TRIAS, Cavite - Timely, disaggregate data per locality would help Gender and Development (GAD) focal persons and advocates to know and closely study a specific concern and design an**

**appropriate program to immediately address such, said a provincial GAD Focal Person on Wed.**

Cavite GAD Focal Person Irene Bencito shared this point during an exchange with members of the Cavite media at the Bayleaf

Hotel here on Wed on ways to make the GAD programs work towards the attainment of the country's sustainable goals in the province and the region, most especially in the grassroots level.

"The national government is providing the data every 5 years," Bencito shared as she asked for possible ways to make the data readily available when needed.

Bencito adds that expecting the local government units (LGUs) to do the data gathering is not feasible due to manpower and monetary constraints, besides it being "a tedious process," Bencito adds.

"For one, we don't have statisticians on board, the people in the Gender and Development Focal Point System (GFPS) are personnel from various units who have their

respective priorities and concerns, plus we don't have the budget for it," she said.

"Maraming issues from malnutrition, teenage pregnancies, lahat puedeng under ng GAD program yan," (a lot of issues from malnutrition, teenage pregnancies, all of these could be under the GAD program) and the data would help policy makers and decision makers in designing not just the appropriate program but help which concern to prioritize, Bencito said.

The data will help provide meaningful connection and insights on issues and concerns, and help understand the underlying reasons where GAD programs maybe based upon.

It is also a helpful tool when downloading the

programs to the LGUs "to make them better understand and embrace the programs, and how these programs are aligned with our development goals," she adds.

Bencito, together Natl Economic Devt Authority (NEDA) Region IV-A Director and Calabarzon RGADC Chairperson Luis G. Banua, Phil Commission on Women (PCW) Dir. Maria Kristine Josefina G. Balmes, NEDA Usec. Jose Miguel R. Dela Rosa and Cavite State University President Dr. Hernando Robles composed the panel of resource speakers during Wednesday's press conference.

The media briefing, a side activity during the opening of the 3-day Calabarzon Regional Gender and Development Council (RGADC) convention,

themed "Gender and Development Towards Attainment of the Country's Development Agenda" is "a way of sharing to the public the efforts of the government agencies, local government units, private sector, for Gender and Development for the Calabarzon region," Banua said.

The annual RGADC Council convention aims to gather stakeholders and GAD advocates from all over the region with the inclusion of other NEDA offices from other regions to discuss the pressing concerns and issues, to share best practices and encourage networking to future GAD collaborations as the convention enters its 8th year.

The 3-day RGADC convention runs from Sept 4 to 6.

## DOH LAUNCHES FIRST SEA AMBULANCE IN CALABARZON

The first sea ambulance purchased by the department to cater for patients in far-flung island communities and geographically isolated and disadvantage areas (GIDA) will be deployed and donated to the rural health unit of the municipality of Panukulan in Quezon and will serve the Polillo Group of islands which lies on the southeast part of the province.

According to DOH - CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) Regional Director Eduardo C. Janairo, the purchase of the sea ambulance was made possible through a sub-allotment fund from the central office worth Php21,000,000 through the Health Facilities Enhancement Program (HFEP) which aims to provide medical transport in order for patients living in island communities to have access to quality health care services.

"We still have to furnish the needed medical equipment and emergency kits that will be placed inside the sea ambulance and we will endeavor to acquire them immediately in order to complete its emergency care services," he stated during his message. "Isang parte lamang ito
