### Sustained basic services delivery for peace and internal security

Local chief executives of cities and municipalities in Cavite, regular members from provincial government offices, national line agencies, academe and civil society organizations convened at the joint 3rd Quarter Meeting of the Cavite Provincial Peace and Order Council (CPPOC) and the Anti-Drug Abuse Council (PADAC) on September 26, 2019 at The Bayleaf Hotel, City of Gen. Trias.

In the report delivered by Col. Cesar Fernandez of the 202 IB of the Philippine Army during the meeting, the AFP recommends to sustain the delivery of basic services, livelihood and development projects especially in critical areas and vulnerable sectors to curtail the infiltration of communist terrorist armed groups and ensure internal security in the province. In addition, they also urge to fast track the Declaration of Persona Non Grata of communist groups in the municipalities down to barangay level in accordance with President Rodrigo Duterte's Executive Order No. 70 stipulating the creation of a National Task Force to End Local Communist Armed Conflict (ELCAC).

Col. Fernandez shared that although there is no terrorist armed group presently operating in the province, the enemy is likely to exploit different issues to further their armed struggle particularly in the labor sector, the youth and students, the urban poor and the transport sector.

DILG OIC Provincial Director Eloisa Rozul lauded the efforts of Maragondon-LGU headed by Mayor Reynaldo Rillo for its proactive stance against attempts of undesirable groups to infiltrate their vulnerable communities in Barangay Patungan and Pinagsanhan through the provision of basic services and other assistance to affected families.

Updates on peace and order situation was reported by Police Maj. Jonathan Asnan showing a notable 37.5% decrease in the crime statistics from January – September 2019 with 980 as compared to the same period in 2018 with 1,567 recorded crimes.

The alarming case of dengue outbreak was also discussed during the meeting. There were 13, 292 cases of dengue reported from January 1 to September 19, 2019 with 51 deaths. Dr. Nelson Soriano, head of the Provincial Epidemiology Surveillance Unit emphasized that the dengue outbreak is public safety concern that must be promptly and rightly dealt with since it has been a recurring problem in the province for years. He called on the LCEs to help the health department in dealing with the issue particularly in terms of legislations that will lay down stricter rules and impose penalty as necessary to mobilize the people to do their share in battling dengue.

Reports on the peace and order and anti-drug abuse programs were delivered by Mr. Jesus Barrera, Provincial Planning and Development Coordinator following the planning workshop conducted on September 17-19 for the formulation of Cavite POPs Plan 2020-2022.

In other updates, Police Lt. Col. Pablito Naganag reported on the security preparations for the upcoming SEA Games to be hosted by the Philippines on November 30 to December 11, 2019 where the CALABARZON, Cavite in particular is among the venue for games and billeting of athletes.

The meeting was presided by Mr. Alvin Mojica, Provincial Administrator for Community affairs on behalf of Governor Jonvic Remulla, chairman of the council. (PICAD)

# DOJ WELCOMES SC SUIT CHALLENGING REVISED GCTA IRR

**MANILA -- Justice officials welcomed Monday the petition challenging the validity of the revised implementing rules and regulations (IRRs) of the Expanded Good Conduct Time Allowance law before the Supreme Court (SC) even as they conceded it will be up to the high court to decide the IRR's fate.**

"I cannot comment on the petition itself. It is the OSG (Office of the Solicitor General) who will represent the public respondents and submit the proper comment on their behalf. All I can say is that I've eagerly awaited the filing of this petition," Justice Secretary Menardo Guevarra told reporters.

"Considering that some important provisions of RA 10592 have been interpreted differently by various groups, I have as much interest as anyone in knowing the correct legal interpretation. Only the Supreme Court has the final word on the issue and I hope that it will affirm mine,"

he added. Justice spokesman Undersecretary Markk Perete for his part confirmed that the legal challenge was expected. "We actually expected a petition coming from them. So I think the revised IRR that we prepared will withstand legal scrutiny so we are pretty confident that the petition will be heard by the court of course but we do believe that the revised IRR that we prepared is in consonance with the law," he said. Perete said criticism that the IRR engages in executive legislation is improper.

"We've addressed that in so many levels before. As I've said we've called a number of laws in order to come up with the interpretation that is most suited based on the provisions of RA 10592 and we've also relied on existing jurisprudence and that where our confidence is based against this particular challenge."

Perete said there can be no violation of the constitutional equal protec-

tion clause in the IRR since "(H)einous crime convicts are in fact segregated by the Constitution itself,"

He added that the constitution itself "says that heinous crimes convict may be penalized by the death penalty so we do not think that the equal protection clause is a valid basis for impugning the basis of the IRR,"

A petition before the SC has been filed by lawyers representing inmates from the New

Bilibid Prison (NBP) and asked the Supreme Court to stop the Bureau of Corrections (BuCor) and the Bureau of Jail Management and Penology (BJMP) to refrain from retroactively applying the exclusions introduced under Section 1 of the Expanded GCTA law and relations to provisions of the IRR.

The petitioners told the high court that said provisions are "disadvantageous to any prisoners." The Expanded GCTA law

has increased the reward of time that are deducted off a person deprived of liberty (PDLs) prison term. The petitioners said "it becomes clear that the deprivation of application of greater GCTA and consequent prolongation of imprisonment of herein petitioners and those similarly situation constitute violation of their substantive rights." They said that the public outrage about the supposed "erroneous" ap-

plication of GCTA led the DOJ and DILG to revise the IRR.

"Ultimately, herein petitioners and those who are similarly situated are the ones who are suffering and are continuing to suffer. Unless these issues befitting our country are clarified by judicial pronouncement of no less than the Supreme Court, they shall continue to suffer from it," the petition read. (PNA)

## CTA grants PAL's P402-M tax refund plea

**MANILA --** The Court of Tax Appeals (CTA) ordered the Bureau of Internal Revenue (BIR) and the Bureau of Customs (BOC) to refund PHP402.8 million in taxes to Philippine Airlines Inc.

In a 20-page amended decision promulgated on Sept. 26 and released to media Tuesday, Associate Justice Esperanza R. Fabon-Victorino of the tax court's Special Third Division, granted the petition for review filed by PAL in connection with the sum representing specific taxes on its importation of jet fuel for its domestic operations. The aggregate sum was paid under protest by PAL at various dates in 2009.

Associate Justice Ma. Belen M. Ringpis-Liban concurred in the decision.

In October 2015, the court originally denied PAL's petition for insufficiency of evidence, citing that PAL failed to prove the imported jet fuel was used for its transport and non-transport operations and likewise failed to prove that at the time, jet A1 fuel was not locally available in reasonable quantity, quality or price.

In June 2016, the court, upon motion of the PAL, allowed the reopening of the case for the presentation of additional evidence.

PAL then presented the testimony of its fuel supply and operations manager Roberto R. Razal and the court-appointed Independent Certified Public Accountant Joel C. Romano to assert its case. (PNA)

# DOH "TANGLAW" SHINES IN POLILLO ISLAND

Department of Health (DOH) - CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) on Thursday, September 26, 2019 launched the second "TANGLAW" (TB Agapan, NGayon Lunasan at Wakasan) TB-Free Island Initiative in Polillo Island in Quezon "TB Agapan, NGayon Lunasan at Wakasan" to eliminate tuberculosis in remote island municipalities through the provision of adequate and responsive delivery of health care services.

"Sa pamamagitan ng programang ito, pipilitin natin na wakasan ang tuberculosis sa isla ng Polillo kasama na dito ang mga kalapit nitong munisipyo at atin ring hahanapin ang lahat ng mga taong may TB sa buong isla upang sila ay maalagaan, mabantayan at mabigyan ng gamot at hindi natin sila pababayaan hanggang sa sila ay gumaling sa sakit na tuberculosis," Regional Director Eduardo C. Janairo stated during his message at the launching program held at the Polillo Sports Complex.

"Hanggang ngayon, 85-90% pa rin ng Pilipino ay mayroong tuberculosis. Kaya sa pamamagitan ng TANGLAW at ang TB-island free program natin, lahat ng mga maysakit sa TB na ating mapapagalang ay sisiguhin nating hindi na mababalikan ng sakit dahil ang karaniwang TB ay pabalik-balik kaya nagkakaroon ng resistance ang mga pasyente at ito ay hindi natin papayagang mangyari," he emphasized.

Janairo also said that the regional office will conduct a massive TB screening of all the residents of the island from children to adult, for them to be diagnosed and be given immediate treatment to prevent the infection from spreading in the community.

The DOH-CALABARZON Strategic TB Elimination Plan was developed to prevent, find and treat, and finally put an end to TB.

According to Regional NTP Outcome Manager and Head of the Communicable Disease Unit, Dr. Maria Elena C. Gonzales, who also developed the "TANGLAW" acronym for the program, three pilot sites for the TB-

Free Island Initiative was chosen as pilot sites namely Tingloy in Batangas and Polillo in the province of Quezon.

"The project has three phases which includes preparation and advocacy; search, treatment and prevention; and eliminate and sustain. We will endeavor to eradicate TB in the islands of CALABARZON and after a year expect to declare it all TB-Free," she added.

A two-day medical and surgical mission was also conducted which includes free Chest X-ray Screening, GX Testing, Health Education through Interactive Panels, IEC Distribution, HIV Counselling & Testing, Condom Distribution, Deworming & Health Education, Skin Disease Consultation "Kilatis Kutis", Distribution of Insecticide Treated Nets, IEC materials, Dengue NS1 RDT, Malaria RDT, Maternal Health: Buntis Kit (50), Hgb & Glucose Screening, Health Education, Dental Examination, Oral Prophylaxis, Fluoride Application, Fit & Fissure Sealant, Dental Kits (provision of 150 dental kits for 150 Adults & 100 Children), Micronutrients Distribution, RBS, BP Taking, Consultation, urynalysis, medical consultation, distribution of medicines, vitamins, antibiotic, ointment, mefenamic acid,
