## SC will be 'well-managed' with CJ Peralta in control: Palace

MANILA -- Malacañang expressed confidence that the Supreme Court would continue to thrive under the leadership of newly-appointed Chief Justice Diosdado Peralta.

This after Executive Secretary Salvador Medialdea confirmed that President Rodrigo Duterte has appointed Peralta, former Associate Justice, to lead the Supreme Court following the retirement of Lucas Bersamin. Medialdea said the President signed Peralta's appointment paper on October 23.

Presidential Spokesperson Salvador Panelo spoke highly of Peralta for serving the judiciary for more than three decades in various capacities. Peralta served in the judiciary as a trial court judge, associate justice and presiding justice of the Sandiganbayan, and associate justice.

"We are certain that with Chief Justice Peralta at the helm of the Supreme Court, the Judiciary will continue to be well-managed as it strives to uphold the principles of judicial excellence, integrity, and independence," Panelo said in a statement.

Panelo also enumerated Peralta's many accomplishments including landmark decisions such as the imposition of the death penalty on a policeman who used his service firearm to shoot an 11-year-old boy

while flying his kite on a rooftop in People vs. Fallorina.

He said it was also Peralta who made the decision on the first conviction for plunder involving a cashier of the Bureau of Internal Revenue (BIR) in People vs. Manalili and the first and only conviction of Qualified Bribery under Article 211-A of the Revised Penal Code, as amended, involving a substantial number of police officers in the case of suspected foreign drug traffickers.

The Palace official said Peralta also convicted the most number of accused involved in big-time drug cases and other serious crimes.

For his contributions, the Supreme Court, during the Court's Centennial Celebration, and the Integrated Bar of the Philippines conferred the Special Centennial Awards in the Field of Criminal Law to Peralta, Panelo said.

The newly-appointed Chief Justice was recognized for his "credible and no-nonsense management and expeditious disposal of heinous crimes and drug cases... [which have] visibly strengthened the Philippine Criminal Justice System and helped bolster and maintain respect, trust and confidence in our criminal courts."

Peralta bested Associate Justices Estela Perlas-Bernabe and Andres Reyes Jr., the two

other magistrates who made it to the shortlist for the country's next Chief Justice endorsed by the Judicial and Bar Council. Perlas-Bernabe was appointed to the Supreme Court by former President Benigno Aquino

III in 2011, while Reyes got a seat at the high court in 2017. Peralta will serve as Chief Justice until his mandatory retirement on March 27, 2022. (PNA)

## 900 VOLUNTEERS FROM CALABARZON REGION PARTICIPATE THE INTERNATIONAL COASTAL CLEAN-UP 2019 ORGANIZED BY PENRO CAVITE

**ROSARIO, Cavite** – PENRO Cavite celebrated the International Coastal Clean-up 2019 in Rosario, Cavite. It was attended by around 900 volunteers from the locality and its neighboring provinces on 21 – 22 September 2019. Volunteers were residents, barangay officials, LGU of Rosario; and representatives from Wellpoint Medical Clinic and Diagnostic Center Inc., MERALCO, PNP-MG, PCG, PG-ENRO, BFAR, DPWH, PETRON, LWUA, DepEd, San Miguel Yamamura Asia Corporation, Knights of Columbus, Samahan ng Maghihipon, Guardian Legendary. Other participants were personnel of DENR Calabarzon and PENRO Cavite who endured the rainy weather just to participate in the ICC. In addition, the activity was conducted as part of community service of

personnel from Regional, PENR and CENR Offices of DENR Calabarzon who undertook the ENR Academy Frontline Course. Presidential Proclamation No. 470 declares the third Sunday of September of each year as the International Coastal Clean-Up (ICC). It primarily aims to free the seas from plastic and other pollutants by gathering numerous participants to do the simultaneous ridding/clearing operation in the coastal areas. It was known to be the largest volunteer effort for ocean's health. During the activity, the volunteers are tasked to record the information/data on the waste collected throughout the activity for records and reporting purposes. A total of 568 sacks with an approximate weight of 5,661 kg of wastes were collected during the two-day clean up. It is comprised pri-

marily of plastic (sachets, wrappers, bags, bottles); diapers, worn-out clothes, rope, fish nests, slippers and shoes; and biodegradable wastes like carton, leaves, stems, twigs, plywood and wood. The length of the clean-up site in Isla Bonita – Silangan I (21 September) is 350 me-

ters stretch; while in Brgys. Wawa II and Sapa III (22 September) is 265 meters stretch. The wastes collected during the ICC activity shall be hauled by the designated garbage collector of Rosario to be disposed in an accredited sanitary landfill. **PR**

## SC rules revival of case vs. Sulpicio exec 'final and executory'

**MANILA** – The Supreme Court (SC) handed down an entry of judgment in connection with the criminal cases against an official of Sulpicio Lines Inc. (SLI) over the sinking of the M/V Princess of the Stars nearly 10 years ago. The Public Attorney's Office (PAO) released this week the court order written by Deputy Clerk of Court Basilio T. Ringol on June 17, 2019, saying the SC decision on Dec. 10, 2018 on the case has become final and executory. The SC decision in turn ruled in favor of consolidated petitions questioning the

March 22, 2013 decision of the Court of Appeals (CA) dismissing reckless imprudence raps against then SLI first vice president for administration Edgar Go over the tragedy. Associate Justices Diosdado M. Peralta, Marvic Leonen, Alexander Gesmundo, and Ramon Paul Hernando concurred with the decision written by Associate Justice Jose Reyes. Go led the crisis management team of the company which handled the incident when the ship under Captain Florencio Marimon capsized and sank in the waters off Romblon at the

height of typhoon Frank. A total of 227 people died, 592 went missing while 32 survived in the tragedy. "(T)he consolidated petitions for review are granted. The decision of the Court of Appeals are reversed and set aside. The Regional Trial Court of Manila Branch 5 is ordered to forthwith reinstate the criminal case as against respondent Go," the SC ruled. The tribunal explained that while the shipping firm's officials faced civil liabilities for failing to safely deliver its passengers, they also face criminal liabilities for possible negligence which

resulted in deaths and injuries.

"The civil action against a ship owner for breach of contract of carriage does not preclude criminal prosecution against its employees whose negligence resulted in the death of or injuries to passengers," the High Court explained. In its investigation report dated Aug. 18, 2008, the Board of Marine Inquiry (BMI) stated that Sulpicio Lines Inc. and its senior officers failed to ensure the safety of the vessel and its cargo because it did not assess the potential danger of the typhoon.

It added that SLI failed to monitor the condition of the vessel during the critical moment on the morning of June 21, 2009 before the vessel sank in San Fernando, Romblon that was in the direct path of the

typhoon. The BMI also observed that the shipping firm did not inform the Philippine Coast Guard immediately when the vessel lost contact with the company. **(PNA)**

# LUZON SUGAR FARMERS JOIN FORCES VS IMPORT LIBERALIZATION

**NASUGBU, Batangas -** Department of Agriculture (DA) and the Sugar Regulatory Administration (SRA) to protect the sugar industry and putting pressure on the

**import liberalization announced by the economic managers.**

After the rice tariffication law, known as RA No. 11203 (aimed to liberalize rice importation in the country and was intended to solve the worsening rice shortage in the country) was signed into law in February this year, the Dept of Finance (DOF) is looking at sugar as the next in the government's list of agricultural products that will see a relaxation of import restrictions.

On Monday, LuzonFed head Cornelio Toreja is echoing the stand of "Tatak Kalamay," an umbrella organization of sugar federations, millers, labor, farmers and agrarian reform beneficiaries where LuzonFed is part of, in condemning in the strongest of terms what is perceived as a sell-off of Philippine agriculture in general.

Toreja, expressed hope that DA Secretary William D. Dar - the concurrent Chair of SRA, remains protecting the agriculture industry, "regardless of whatever personal ties he has with the country's economic managers."

"That over and above that, his heart remains in protecting the agriculture in-

dustry as that is what he is known for, as an agricultural expert," he said.

He likewise called on the SRA leadership that its high-time to flex its muscles and show some resemblance of leadership by saying "enough is enough with the dilly-dallying" and called on SRA Administrator Engr Hermenegildo R. Serafica that if he can't protect the very industry that he vowed to serve, it's time to 'hand out its hat' to give to someone who can truly lead the sugar industry.

Former SRA Board Member Lito Sandoval also reacted on the alleged remark of Serafica that although his personal stand was for the farmers, he will take his "guidance" from the Agriculture Secretary.

This reportedly came at the heels of the Senate budget hearing where both the DA and SRA were grilled by Senators Juan Miguel Zubiri and Cynthia Villar following the appeal from Tatak Kalamay who earlier sought intervention from Senate allies amidst the proposal from the Department of Finance (DOF) that the sugar industry's liberalization program is in the pipeline, following the rice industry.

"What guidance does he (Serafica) need? Isn't it clear to him yet that any import liberalization program will be disastrous to the industry?"

The former member of the sugar body adds that it doesn't take that much to understand that uncontrolled importation will kill us and destroy the lives of 5 million Filipinos who depend on the sugar industry.

He, likewise, brought up the positions made by SRA Board Members lawyers Dino Yulo (for the producers) and Roland Beltran (millers) who publicly opposed the planned liberalization which he finds rather ironic as it will be deemed brushed aside if the SRA Administrator opts to wait for the agriculture secretary's guidance.

## Carpio bids farewell to SC in last flag ceremony

**MANILA** -- Acting Chief Justice Antonio Carpio bade farewell to the Supreme Court (SC) during a flag-raising ceremony on Monday, ahead of his scheduled retirement on Oct. 26 when he completes an 18-year stint as magistrate of the high court.

In his speech, Carpio thanked SC employees and colleagues for their "unselfish support".

"Eighteen years ago I stood here on this very spot to introduce myself as the newly appointed justice of the court. I then asked for your support to

help me dispense justice to our people. After 18 years I stand here on this same spot to thank you for your unselfish support and to bid you farewell as I retire mid-night of Friday this week," Carpio said.

"I dare say that my colleagues in the en banc and my co-workers in the SC family have always shown utmost dedication and professionalism in their work and service to the Filipino people, so let me say a big thank you to all of you," he added.

Last week, the high court, acknowledging his service to the judiciary, voted to

grant Carpio full retirement privileges for a chief justice.

Carpio, who will retire at the mandatory age of 70, is one of the longest-serving magistrates since the Supreme Court was established in 1901. His replacement will be President Rodrigo Duterte's 12th appointee to the SC.

Carpio was able to complete 935 full-blown long decisions, 79 dissenting opinions, 30 concurring opinions, 13 separate opinions and four concurring and dissenting opinions, leaving no backlog. **(PNA)**

## DOH EXEC CITES MORE RESEARCH ON NEWBORN SCREENING

**GENERAL TRIAS CITY, Cavite -- As the newborn screening (NBS) procedure is still considered new in the country's health system, a Department of Health (DOH) official urged NBS implementers to engage in research to open new leads and discover breakthroughs.**

"Pwede nyo gawin yun, we will fund you to do that," (you can do that, we will fund you to do that) said DOH Calabarzon director, Dr. Eduardo C. Janairo in his address before NBS implementers from the region's public and private institutions during the 2nd Regional New Born Screening Awarding Ceremony held at the Bayleaf Hotel here on Tuesday.

He shrugged off the idea that only scientists can do research.

"You just have to get a bunch of committed and very passionate people to look into the newborn screening," Janairo said.

Janairo pointed out that findings in whatever studies conducted abroad on NBS may not be applied locally as the Philippines has a different culture, physiology, and laws.

He advised the participants to start at the local level by simply comparing or looking for perspective, longitudinal, respective studies or even for a clinical trial, as the NBS only started in the country in 1999.

"Yun ang kailangan nating hanapin, all those addresses na nagkaroon ng disorders, boys and girls during those days and see how they went through with the disease that they had, initially identified at ano ang ginawa nila," he said. (Those are the things that we need to search, the addresses of those who had disorders, boys and girls during those days and see how they went through with the disease that had initially identified and what they did)

Janairo likewise asked the participants to check on the relationship or the participation of the traditional complementary and alternative medicine for the care of the newborn, and as they grow old.

Citing that the Philippine Institute for Traditional Alternative Healthcare (PI-TAH) also has funds for research, Janairo said the organization may have modalities that can be used by NBS implementers.

He reminded participants

that Traditional Complementary and Alternative Medicine (TCAM) uses natural/organic food and nutrition, in practicing homeopathy (anything at home that we see).

"And of course you have all others, the balancing of energy, the balancing of the yin and the yang, the removal of blockade on acupuncture pressure, massage, chiropractic - all these modalities can be used to take care of a child to prevent any ensuing disease that is from the NBS," he stressed.

Janairo hopes to include "simple research" among the awarding categories during the 3rd Regional NBS awarding ceremony, with emphasis on what have done in the past or their future findings using TCAM.

NBS, a simple procedure where a few drops of blood are taken from the baby's

heel and ideally done immediately after 24 hours from birth, is conducted to find out if a baby has a congenital disorder that may lead to mental retardation or even death if left untreated.

The expanded NBS program increased the screening panel of disorders from six to more than 28. This test is included in the Newborn Care Package, a PhilHealth benefit package for essential health services of the newborn during the first few days of life.

Republic Act No 9288, otherwise known as An Act Promulgating a Comprehensive Policy and a National System for Ensuring Newborn Screening, was enacted in 2004. The first week of October of each year was declared as New Born Screening month under Proclamation NO. 540 s. 2004. (PNA- Gladys S. Pino)

## IBP voices support for Chief Justice Peralta

**MANILA --** The Integrated Bar of the Philippines (IBP) on Thursday welcomed the appointment of Chief Justice Diosdado Peralta by President Rodrigo Duterte, saying his choice honors the tradition of seniority in the high court.

In a statement, IBP national president Domingo Egon Cayosa said "The Integrated Bar of the Philippines will work and cooperate with chief Justice Peralta to achieve "Justice Bilis," and echoed sentiments that the appointment will mean a more efficient justice system.

"The seniority tradition was maintained in the appointment of Chief Justice Diosdado M. Peralta who has served the longest as Associate Justice of the Supreme Court among the three aspirants nominated by the Judicial and Bar Council. We are hopeful that under his leadership the judiciary will resolve cases much faster inasmuch as his 25 years as magistrate are notable for the speedy disposition of cases and innovations to expedite court processes," Cayosa added.

Peralta, 67, was appointed by former President Gloria Macapagal-Arroyo as the 162nd magistrate of the Supreme Court (SC)

in 2009. He is married to Court of Appeals Associate Justice Fernanda Lampas-Peralta.

Before his appointment to the high court, Peralta served as Presiding Justice of the Sandiganbayan. He was a member of the anti-graft court's special division, which convicted former president Joseph Estrada of plunder.

Peralta is the ponente of the SC ruling which invalidated the implementing rules and regulations of the Expanded Good Conduct Time Allowance Law, thus allowing its retroactive application to persons deprived of liberty serving time before 2013.

Born in Laoag, Ilocos Norte, Peralta completed his law studies at the country's oldest law school, Facultad de Derecho Civil (Faculty of Civil Law) of the University of Sto. Tomas, which has produced several high court magistrates, including the first three chief justices - namely Cayetano Arellano, Victorino Mapa, and Manuel Araullo.

Chief Justice Andres Narvasa was the last UST Law chief justice aside from Ateneo Law alumni Chief Justice Renato Corona who completed his doctorate studies in UST. (PNA)

Stop the Stigma, Fight AIDS," the two-day event focused on raising social consciousness on HIV and how the community can make a difference with unified actions from different sectors of society – health, education, media, non-governmental organizations and more.

As host to the summit, Bacoor City Mayor Lani Mercado welcomed participants with her message of hope and support to the health and rights of people living with HIV. Likewise, Dr. Gregorio "Jojo" Andaman Jr., President of St. Dominic College of Asia where the second day of event was held, gave his warm welcome together with City Councilor Alde Pagulayan of the Sangguniang Panlungsod Committee on Health. Councilor Pagulayan initiated the conduct of the event to help address the alarming health issues in relation to HIV in the province. He also acknowledged the presence of guests and resource speakers who will contribute insights, information as well as inspiration to help fight the stigma. On behalf of Governor Jonvic Remulla and Vice Governor Jolo Revilla, 6th District Board Member Kerby Salazar lauded the efforts of everyone behind the success of the advocacy event and sincerely appreciated the efforts of the City of Bacoor for being the first LGU in the province to join the LGBT+ in fighting for their cause. ## CALAX Laguna portion to open Oct. 30 in time for 'Undas'

**STA. ROSA CITY, Laguna** -- Department of Public Works and Highways (DPWH) Secretary Mark A. Villar on Tuesday announced the opening of the first 10-km Laguna portion of the Cavite-Laguna Expressway (CALAX) by October 30.

"We will ensure that CALAX will be passable and ready to serve motorists this Oct. 30, in time for Undas (All Saint's Day). We will open the entry and exit points at Mamplasan, Biñan Laguna and Sta. Rosa- Tagaytay Road," he said during the roadside press conference following the drive-through and windshield inspections.

Villar, along with his team and officials of the Metro Pacific Tollways Corporation (MPTC) subsidiary MP CALA Holdings, Inc., embarked on their final inspection of the CALAX first sections from the Mamplasan Barrier, Laguna Technopark Interchange, Laguna Boulevard Interchange to the Santa Rosa-Tagaytay Interchanges.

He said there will be no toll fee yet "although eventually, this would be PHP4 to PHP5 per kilometer."

"It's a long weekend and apart from paying respects to the dearly departed, I'm sure a lot of families would want to take advantage of this time to do some bonding in the Sta. Rosa commercial district, Tagaytay City, Nasugbu and other areas in Batangas," he added.

Villar also said the motorists' assistance center will be jointly established by the DPWH with the CALAX project contractor and other private sector partners. He assessed that the CALAX project is 90 percent completed and vowed to fast-track the remaining 10 percent that need to be harmonized in the civil works like the road shoulders, drainage, and other finishing touches.

"We expect around 10,000 cars to pass through these two access points. It will take some 10-minute drive for motorists and commuters traversing along this section, a sizeable travel time reduction from the 45-minute drive from Mamplasan to Sta. Rosa-Tagaytay Road," he said.

According to the DPWH chief, the Laguna portion expects to decongest the Sta. Rosa City-Tagaytay Road, Governor's drive, Aguinaldo Highway up to Cavite, expecting

the total 45-kilometer alignment of the CALAX project to be completed by June 2022, although starting next year, some Cavite segments would be open.

Once completed, travel time for the entire 45-kilometer stretch from Mamplasan Interchange interconnection with the South Luzon Expressway (SLEX) to Kawit, Cavite would only take 45 minutes to an hour drive, expecting some 50,000 vehicles to traverse CALAX daily.

He also said that with the opening of the CALAX Laguna portion, DPWH is closely coordinating with the Department of the Interior of Local Government to make sure the roads are cleared from illegal structures especially by unscrupulous persons who might put up roadsides stores to sell food and other "pasalubong" (souvenir) items.

"Kung may mga obstructions, kailangan nating i-report agad (If there are obstructions, we have to report these immediately)," he urged.

Meanwhile, Metro Pacific Tollways Corporation (MPTC) subsidiary MP CALA Holdings, Inc. President and General Manager Bobby Bontia assured their close coordination with the DPWH, "together we align with the different stakeholders and update them of the developments in the construction."

"We have informed them of the features of the expressway and the benefits that CALAX will bring to the areas it will traverse. We jointly agreed to open and serve motorists who will travel this Undas," Bontia said.

He said CALAX is designed with technologically advanced features such as Automatic License Plate Recognition System enabling barrier-less entry to CALAX, IP Based Speed Detection Cameras strategically installed, and High Definition CCTV cameras to cover the entire stretch of the expressway to ensure safe and efficient travel.

It is a four-lane, tolled expressway connecting CAVITEX in Kawit to SLEX at the Mamplasan Interchange in Biñan City, Laguna with interchanges in eight locations, namely Kawit, Imus Open Canal, Governor's Drive, Aguinaldo Highway, Silang, Sta. Rosa-Tagaytay, Laguna Blvd., Technopark, and a Toll Barrier before SLEX. (PNA)


