## Caffeine may offset some health risks of diets high in fat, sugar

CHICAGO -- Caffeine may offset some of the negative effects of an obesogenic diet by reducing the storage of lipids in fat cells and limiting weight gain and the production of triglycerides, according to a study in rats posted on the website of the University of Illinois (UI) this week. For four weeks, the rats in the study ate a diet that contained 40 percent fat, 45 percent carbohydrate and 15 percent protein. They also ingested one of the forms of caffeine in an amount equivalent to that of a human who drinks four cups of coffee daily.

The researchers performed cell culture studies in which they exposed adipose cells from mice to synthetic caffeine or the coffee or mate caffeine extracts, and found that regardless of its source, caffeine decreased the accumulation of lipids in adipose cells by 20 percent to 41 percent.

To be specific, the rats that consumed the caffeine extracted from mate tea gained 16 percent less weight and accumulated 22 percent less body fat than the rats that consumed decaffeinated mate tea.

The researchers also tracked the expression of several genes associated with obesity and lipid metabolism, including the fatty acid synthase gene (Fasn) -- an enzyme compound involved in the synthesis of fatty acids from glucose, and the lipoprotein lipase gene (Lpl), which codes for an enzyme that breaks down triglycerides.

All of the caffeine treatments, regardless of origin, have significantly downregulated the expression of both Fasn and Lpl.

In the cell cultures, Fasn expression diminished by 31 percent to 39 percent, while Lpl expression decreased by 51 percent to 69 percent among cells treated with synthetic caffeine or the caffeine from mate tea or coffee, the researchers found.

In the rats that consumed the mate tea caffeine, expression of Fasn decreased by 39 percent in their fat tissue and by 37 percent in their livers.

The decreased expression of Fasn and two other genes in the liver evoked lower production of low-density lipoprotein cholesterol and triglycerides in the liver as well, according to the study.

Mate tea is an herbal beverage rich in phytochemicals, flavonoids and amino acids that is consumed as a stimulant by people in southeastern Latin American countries. The

amount of caffeine per serving in mate tea ranges from 65-130 milligrams, compared with 30-300 milligrams of caffeine in a cup of brewed coffee. "The consumption of caffeine from mate or from other sources alleviated the negative impact of a high-fat, high-sucrose diet on body composition due to the modulation of certain lipogenic enzymes in both adipose tissue and the

liver," said Elvira Gonzalez de Mejia, a co-author of the study and director of the division of nutritional sciences at UI. "The decreased expression of Fasn and Lpl brought about lower synthesis and accumulation of triglycerides in the adipose tissue."

The study was published in the Journal of Functional Foods. (Xinhua)

## PhilHealth sets new contribution schedule; assures immediate eligibility to benefits

The Philippine Health Insurance Corporation (PhilHealth) has released a new contribution schedule for its Direct Contributors in accordance to the Universal Health Care Law of 2019 and its implementing rules and regulations.

Direct contributors refer to those who are gainfully employed and bound by an employer-employee relationship. In addition, Kasambahays, self-earning individuals, practicing professionals and Overseas Filipino Workers belong to this membership category as well.

In its PhilHealth Circular No. 2019-0009 published on November 23, 2019, premium rate for Direct Contributors shall still be at 2.75% of their monthly basic salary with an adjusted ceiling of P50,000. In 2020, PhilHealth will increase the rate to 3% and henceforth adjusted to increments of 0.5% every year until it reaches the 5% limit in 2025 as provided for by law. Income floor is fixed at P10,000 during the 5-year period, while salary ceiling will gradually increase by P10,000 each year until it reaches P100,000 in 2025.

For those earning below the salary floor of P10,000, contributions are computed using the minimum threshold; while those who earn the set ceilings/limits shall pay premiums based on the set ceiling. This policy shall also apply to seafarers.

On the other hand, premiums of self-paying members, professional practitioners, and land-based OFWs are computed straight based on their monthly earnings and paid in whole by the member. To ensure accuracy in computation, PhilHealth will require submission of financial records such as latest income tax return received by the Bureau of Internal Revenue, duly-notarized affidavit of income declaration, or overseas employment contract as proof of income. Otherwise, contribution will be based on the highest computed rate.

Pursuant to Republic Act 10631 or the Kasambahay Law, employers shall borne the premiums of their domestic helpers in full, except when monthly salary exceeds P5,000 where Kasambahays shall then be deducted of their equal share in the monthly contribution. In cases of 'employed' Persons with Disability (PWDs) listed in the Department of Health's PWD registry, their contributions shall be equally divided between their employers and the National Government for their personal share.

The new premium schedule takes effect on December 7, 2019 or 15 days after the publication of its Circular 2019-0009. Its application for employed members will be for the applicable month of December 2019 (which is payable on January 2020). Meanwhile, the rest of Direct Contributors may still avail of the existing rate of P2,400/year (or P3,600/year for those earning P25,000 or more per month) for a maximum of three years until December 6, 2019 only. Starting December 7, 2019, the new rate shall apply to all Direct Contributory members using the following schedule:

The state agency said that the new schedule will help ensure sustainability of the National Health Insurance Fund, guaranteeing that all Filipinos are able to avail of outpatient benefit packages that are currently being finalized, as well as immediate eligibility to benefits during confinement.

"Starting November 22, 2019 until such time that a new set of guidelines are issued, all Filipinos including those without the qualifying contributions shall be allowed to avail of the PhilHealth benefits," PhilHealth President and CEO Ricardo C. Morales announced.

While no one will be denied of PhilHealth coverage due to non-payment of premiums, Morales also clarified that members lacking contributions shall be billed for the unpaid premiums with interests (compounded monthly) and penalties of at least 3% a month for employers, sea-based OFWs, and Kasambahays. On the other hand, self-earning members, professionals and land-based migrant workers shall incur a maximum interest of 1.5% for every month of missed payment. Interests, however, shall only be applied effective applicable month of January 2020.

PhilHealth assured that the adjustments in contributions are sanctioned by law and essential in sustaining and enhancing its benefits and services to its 108 million-strong members and beneficiaries here and abroad.

## DOTr compensates, relocates residents affected by Metro Manila Subway Project

**VALENZUELA CITY (PIA)**

– Landowners here who signed Deeds of Absolute sale of their properties affected by the construction of the Metro Manila Subway Project (MMSP) have been compensated financially on Saturday by the Department of Transportation (DOTr).

This after the start of the formal clearing works of the Partial Operability (PO) Section of the MMSP.

DOTr Secretary Arthur Tugade also said that informal settler families have been transferred and given residence at the Disciplina Village in Barangay Bignay, Valenzuela City, an in-city relocation site managed by the local government.

A total of around 460 lots would be needed for the PO Section of the Subway, and some 364 lots of the total number were offered to be bought at prevailing Market Value.

While, 285 lot owners of the 364 lots have earlier agreed to sell their properties to government.

The PO Section of the subway will be composed of its first stations in Valenzuela City and Quezon City, its Line's Depot in Barangay Ugong, and some infrastructures for the Philippine Railway Institute, the first Railway Training Center in the country.

The underground rail line has been considered the "Project of the Century" being able to accommodate around 370,000 passengers daily when fully operational. It, however, targets 2021 to start its partial operations.

Around 15 stations of the Subway Project will service passengers when fully operational, including a terminal station at the Ninoy Aquino International Airport (NAIA) Terminal 3. (PIA NCR)

## Over-speeding of trucks must be controlled: Duterte

**MANILA** -- President Rodrigo Duterte on Monday said he wanted to have over-speeding of trucks regulated by police, lamenting that it has been one of the country's leading causes of deaths in road accidents.

"Pati yang mga truck, i-control ninyo ang speed. Alam mo ang disgrasya ngayon, pag ano ang patay, 10, 20 (The speed of trucks has to be controlled. You know accidents now, kill 10 to 20 people). I have to think about that. That has to stop," Duterte said in a speech in Cotabato City.

Duterte said the number of deaths due to road accidents was "no longer acceptable" to him.

"Itong over-speeding, it has to be controlled kasi mara-mi nang patay (This over-speeding has to be controlled because there are so many deaths)," he added.

Duterte compared deaths caused by over-speeding to a "massacre" that took place almost every day.

"Ang numbers ng patay (of deaths) ... No longer, hindi

na nakakatuwa, hindi na maganda basahin. Parang massacre na almost every day (The number of deaths is no longer a laughing matter. It's not a good thing to read about. It is like a massacre almost every day)," he added.

Earlier this month, nine persons died while five others were injured when a truck hit a dump truck and a jeepney in Cardona, Rizal. In 2013, when he was Davao City Mayor, Duterte issued Executive Order No. 39, which "orders setting the speed limit for all kinds of motor vehicles within the territorial jurisdiction of Davao City".

Section 4 of the said order states that "violators shall, if warranted, be subjected to arrest and their vehicle impounded without prejudice to the imposition of penalties and fines under the provisions of R.A. No.4136 and Davao City Ordinance No. 778, if applicable".

Duterte's two children, Davao City Mayor Sara and former Davao City Vice

Mayor Paolo have previously been apprehended for over-speeding in 2014 and 2016, respectively.

The Global status report on road safety 2018, launched by World Health Organization (WHO) in December 2018, showed that the number of annual road traffic deaths has reached 1.35 million.

Road traffic injuries are now the leading killers of people aged 5-29 years, the report said.

The burden is disproportionately borne by pedestrians, cyclists and motorcyclists, in particular those living in developing countries, it added.

It also noted that drastic action is needed to put these measures in place to meet any future global target that might be set and save lives. Data from the Philippine Statistics Authority (PSA) showed that 10,012 people died due to road crashes in 2015, a 45.76 percent increase from 6,869 deaths recorded in 2006. (PNA)

"Ang totoong gusto ko po ay sa computer [operation] pero baka next year pa raw po i-offer, kaya nag-shift po muna ako sa bread-making business. Pero kasi, interesado rin ako sa ganyane. Magagamit [ko] sa negosyo at malay nyo, baka makapagtatayo rin tayo ng bakery," he said.

Nabanggit din po nila sa amin noonong primerong orientation namin sa munisipyo na mayroong ibibigay na mga gamit pang-baking kapag nakatapos sa kurso," he added.

For her part, Lolita Bon, 52, of Barangay Hulong Duhat, who used to sell her wares beside the Malabon City Square Mall, said she and her fellow vendors were encouraged by the local government to avail of the programs being offered. She said she will avail the

bread and pastry-making course and also train as a therapeutic masseuse due to its readily available potential income.

"Napakaganda po at napakaraming matutulungan na kagaya sa aming mga vendors, bale 75 po kami na mga vendors na willing mag-training kasi po, lalo na ngayong clearing time, wala po kaming pagkakataong magtinda sa kalsada nang maghapon. Hinikayat ko po sila na mag-avail at ito po ang magiging hanapbhuhay namin kapag nakatapos po kami," Bon said.

Training courses would last for as short as 10 days to 18 days depending on its specialty. The convergence program will also provide business opportunities to graduates through-supportive environment such as provision of facilities, mentoring and coaching, training, and networking that will help them establish their respective start-up business.

Graduates of the program are expected to use their skills and knowledge to put up their own business while others can be hired as employees of various business establishments. On the other hand, those who have no business capital may form a group and register as a cooperative so that they can start their own business venture, said Pilar Hernandez-Herbolario of the City of Malabon Polytechnic Institute.

"Ang programang ito, hindi magtatapos sa hilot, mayroon din pang-negosyo, pangkabuhayan, tapos mayroon din, kung 15 na kayo [members], pwede kayong magtayo ng coop para isang grupo na kayo, na hahanapin. O baka sa susunod mayroon na tayong Malabon Tricycle Hilot Tour, at iikutan na kayo ng mga gustong mag-pahilot para iyong serbisyo natin ay naipapa-abot talaga natin," she said.

To recall, Malabon City has started promoting its culinary landmarks by means of accredited tricycles, a local public utility transport, which can easily wheeze through traffic and narrow alley ways.

Also, the national and city governments have ordered for the clearing of streets of obstructions to comply with the mandate of the President. (PIA NCR)

**WHEREAS**, Section 16 of Republic Act No. 7160, also known as the Local Government Code of 1991, states that all local government units shall ensure and support, among others, the promotion of general welfare;

**WHEREAS**, consistent with Presidential Decree No. 1067, known as the Water Code of the Philippines, water is vital to national development and it has become increasingly necessary for government to intervene actively in improving the management of water resources;

**WHEREAS**, DILG Memorandum Circular No. 2016-04 encourages Local Chief Executives, Presiding Officers and Members of the Sanggunian to enact an ordinance establishing guidelines on water conservation, look into the water cycle stages in formulating policies, from rainfall or another sources to strategic collection, appropriate use, adequate treatment and proper discharge of water;

**WHEREAS**, various areas in the province are experiencing shortage of domestic, agricultural and industrial water supply that is essential in supporting human existence;

**WHEREAS**, with this issue, it is but right to promote environmental strategies, formulate an integrated water quality management framework for the benefit of the Caviteños;

**NOW, THEREFORE**, on motion of Hon. Salazar, duly seconded by Hon. Grepo and all the members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

**SECTION I. SHORT TITLE.** This Ordinance shall be known and cited as the "Water Conservation Programs Ordinance in the Province of Cavite."

**SECTION II. DECLARATION OF POLICY.** It is hereby declared the policy of the Provincial Government of Cavite to intervene actively in improving the management of water resources, through the implementation of guidelines aimed towards the conservation of water resources.

**SECTION III. DEFINITION OF TERMS.** As used in this Ordinance, the following terms shall mean:

1. **Water Aerators** - refer to the one found at the of the faucet that creates a no-splashing stream and often delivering a mixture water and air.
2. **Potability** – refers to water that is safe and suitable for human consumption.

**SECTION IV. CREATION OF A WATER CONSERVATION COMMITTEE (WATERCOM).** A Committee on Water Conservation or "WaterCom" shall be created in the Province of Cavite to ensure the proper implementation of this Ordinance and to coordinate with all agencies necessary in implementing the same. Said Committee shall meet at least once every quarter or as frequent as necessary.

The WaterCom shall be composed of the following:

**SECTION V. WATER CONSERVATION PROGRAMS.** The Water Conservation Program is hereby established in the Province of Cavite to actively encourage the civil society, the academe and the business sector in undertaking environmental – related activities, specifically in organizing, educating, motivating and disseminating information to the people in order to address water-related issues and problems.

The WaterCom is hereby established in the Province of Cavite and shall include:

- a.) Conduct of Barangay-based public education and information programs to disseminate the importance of water;
- b.) Establish rules on the regulation of requirements for water conservation in residential, commercial, industrial and institutional establishments, in compliance to existing sanitation and water conservation laws;
- c.) Promotion of the use of rainwater harvesting in all Barangays;
- d.) Installation of water saving devices like water aerators, specifically at the household level;
- e.) Conduct of tree-planting and other reforestation activities in partnership with environmental organizations;
- f.) Integration of lectures on water conservation and water demand management concepts in all schools;

- g.) Adoption of technologies promoting water conservation, which may include water conserving gardens, grey water reuse in irrigation, etc.  
 h.) Monitoring of the safety and potability of all local water resources;  
 i.) Clean-up, rehabilitation and restoration of rivers, creeks and other tributaries and water sources;  
 j.) Dissemination of campaign materials on water conservation.

**SECTION VI. IMPLEMENTATION.**

1. The WaterCom shall be the lead in all information, education and communications (IEC) campaign strategies.
2. The Barangay Chairman and Officials shall help in the implementation of the different water conservation programs identified in Section V hereof of this ordinance.
3. The Sangguniang Bayan/Panlungsod Chairman of the Committee on Environment and Natural Resources, the City/Municipal Environment and Natural Resources Officer (CENRO/MENRO), shall help in evaluating the effectiveness of the implementation of the different water conservation programs conducted.

**SECTION VII. REPEALING CLAUSE.** All ordinances, resolutions, executive issuances or rules and regulations or parts thereof, whose provisions are inconsistent with or contrary to the provisions of this Ordinance, are hereby deemed repealed, amended or modified accordingly.

**SECTION VIII. APPLICABILITY CLAUSE.** The provisions of existing ordinances, resolutions or executive orders dealing with related subject matter, which is not contradictory with this Ordinance, are hereby adopted as an integral part of this Ordinance.







## DOTr compensates, relocates residents affected by Metro Manila Subway Project

### VALENZUELA CITY (PIA)

— Landowners here who signed Deeds of Absolute Sale of their properties affected by the construction of the Metro Manila Subway Project (MMSP) have been compensated financially on Saturday by the Department of Transportation (DOTr).

This after the start of the formal clearing works of the Partial Operability (PO) Section of the MMSP.

DOTr Secretary Arthur Tugade also said that informal settler families have been transferred and given residence at the Disciplina Village in Barangay Bignay, Valenzuela City, an in-city relocation site managed by the local government.

A total of around 460 lots would be needed for the PO Section of the Subway, and some 364 lots of the total number were offered to be bought at prevailing Market Value.

While, 285 lot owners of the 364 lots have earlier agreed to sell their properties to government.

The PO Section of the subway will be composed of its first stations in Valenzuela City and Quezon City, its Line's Depot in Barangay Ugong, and some infrastructures for the Philippine Railway Institute, the first Railway Training Center in the country.

The underground rail line has been considered the "Project of the Century" being able to accommodate around 370,000 passengers daily when fully operational. It, however, targets 2021 to start its partial operations.

Around 15 stations of the Subway Project will service passengers when fully operational, including a terminal station at the Ninoy Aquino International Airport (NAIA) Terminal 3. (PIA NCR)

Section 4 of the said order states that "violators shall, if warranted, be subjected to arrest and their vehicle impounded without prejudice to the imposition of penalties and fines under the provisions of R.A. No.4136 and Davao City Ordinance No. 778, if applicable".

Duterte's two children, Davao City Mayor Sara and former Davao City Vice

Mayor Paolo have previously been apprehended for over-speeding in 2014 and 2016, respectively.

The Global status report on road safety 2018, launched by World Health Organization (WHO) in December 2018, showed that the number of annual road traffic deaths has reached 1.35 million.

Road traffic injuries are now the leading killers of people aged 5-29 years, the report said.

The burden is disproportionately borne by pedestrians, cyclists and motorcyclists, in particular those living in developing countries, it added.

It also noted that drastic action is needed to put these measures in place to meet any future global target that might be set and save lives. Data from the Philippine Statistics Authority (PSA) showed that 10,012 people died due to road crashes in 2015, a 45.76 percent increase from 6,869 deaths recorded in 2006. (PNA)

ro Manila Convergence Program of government, private entities, and civil society organizations held at the Malabon National High School, and spearheaded by the Poverty Reduction, Livelihood and Employment Cluster of the National Capital Region Task Force to End Local Communist Armed Conflict in support of President Rodrigo Roa Duterte's Executive Order No. 70, the beneficiaries were given the option to learn skills on Hilot (Wellness Massage) NC II, Bread and Pastry Production NC II, and Tile Setting NC II, coupled with orientation on livelihood, business management, financial assistance, and employment opportunities, among others.

Malabon City Mayor Antonin "Len" Oreta, who graced the event, expressed his support to the convergence effort. The mayor also assured that the city was working on providing an alternative means of livelihood for the vendors.

Gilberto Dela Cruz, a 64-year old vendor from Barangay Catmon, said he was quite surprised at first, because despite his age, he is still given the opportunity to avail of the skills training on bread-making.

"Sabi ko po interesado ako, gusto ko pong maipakita sa gobyerno at kay Pangulong Duterte na gusto ko pa rin makibahagi sa programa ng gobyerno," Dela Cruz said, adding that he will challenge himself to finish the training course and engage with other vendors to avail of the livelihood opportunities.

"Ang totoong gusto ko po ay sa computer [operation] pero baka next year pa raw po i-offer, kaya nag-shift po muna ako sa bread-making business. Pero kasi, interesado rin ako sa ganyane. Magagamit [ko] sa negosyo at malay nyo, baka makapagpatayo rin tayo ng bakery," he said.

Nabanggit din po nila sa amin noong primerong orientation namin sa municipio na mayroong ibibigay na mga gamit pang-baking kapag nakatapos sa kurso," he added.

For her part, Lolita Bon, 52, of Barangay Hulong Duhat, who used to sell her wares beside the Malabon City Square Mall, said she and her fellow vendors were encouraged by the local government to avail of the programs being offered. She said she will avail the

bread and pastry-making course and also train as a therapeutic masseuse due to its readily available potential income.

"Napakaganda po at napakaraming matutulungan na kagaya sa aming mga vendors, bale 75 po kami na mga vendors na willing mag-training kasi po, lalo na ngayong clearing time, wala po kaming pagkakatao magtinda sa kalsada nang maghapon. Hinikayat ko po sila na mag-avail at ito po ang magiging hanapbhay namin kapag nakatapos po kami," Bon said.

Training courses would last for as short as 10 days to 18 days depending on its specialty. The convergence program will also provide business opportunities to graduates through-supportive environment such as provision of facilities, mentoring and coaching, training, and networking that will help them establish their respective start-up business.

Graduates of the program are expected to use their skills and knowledge to put up their own business while others can be hired as employees of various business establishments. On the other hand, those who have no business capital may form a group and register as a cooperative so that they can start their own business venture, said Pilar Hernandez-Herbolario of the City of Malabon Polytechnic Institute.

"Ang programang ito, hindi magtatapos sa hilot, mayroon din pang-negosyo, pangkabuhayan, tapos mayroon din, kung 15 na kayo [members], pwede kayong magtayo ng coop para isang grupo na kayo, na hahanapin. O baka sa susunod mayroon na tayong Malabon Tricycle Hilot Tour, at iikutan na kayo ng mga gustong magpahilot para iyong serbisyo natin ay naipapa-abot taglagan natin," she said.

To recall, Malabon City has started promoting its culinary landmarks by means of accredited tricycles, a local public utility transport, which can easily wheeze through traffic and narrow alley ways.

Also, the national and city governments have ordered for the clearing of streets of obstructions to comply with the mandate of the President. (PIA NCR)


