After Taal volcano explosion...

PGC EXTENDS ASSISTANCE TO DISPLACED BATANGUEÑOS

Following the catastrophic phreatic explosion of Taal volcano on Sunday, January 12 severely affecting thousands of Batangas residents, the province of Cavite opened its doors to displaced families fleeing for safety.

Although also affected by the heavy ashfall coming from the volcano, several LGUs in Cavite, initially Tagaytay City, the towns of Alfonso, Mendez, Amadeo and Gen. Aguinaldo offered temporary shelter and care to families coming from the affected areas in Batangas.

As waves of evacuees continue to come in, other LGUs have also provided shelter and help to affected families.

The Provincial Government of Cavite on January 13, 2020 organized and facilitated the distribution of E-Balde to families in evacuation centers and temporary shelters of LGUS where the displaced Batangas residents are located. Each E-Balde consists of a hygiene kit (bath soap, shampoo, alcohol, deodorant, toothpaste, toothbrush, underwear, face towel, sanitary napkin, dishwashing liquid, detergent soap, sponge), 2 sardines, mosquito net, blanket, bath towel and water dipper all packed in a water pail.

Leading the distribution of relief assistance were the Provincial Disaster Risk Reduction and Management Office, the Provincial Social Welfare and Development Office and the Provincial Government-Environment and Natural Resources Office with the support of other departments of the PGC. A total of 361 E-Balde were delivered in Tagaytay City

while 432 were distributed in Alfonso. Fourteen (14) were delivered in the municipality of Mendez, 58 in Amadeo, and 100 in the town of Gen. Aguinaldo. Another batch of E-Balde were distributed on January 14 wherein 80 were delivered in the municipality of Maragondon, 10 in Ternate, 280 in Magallanes plus additional 25 E-Balde in Gen. Aguinaldo and 56 in Alfonso.

The provincial and other local disaster risks reduction and management offices of the different LGUs in Cavite also extended the necessary support from the onset of the explosion conducting rescue operations, transport of evacuees and other immediate response activities. Regular coordination with LGUs and partner agencies is in place for necessary actions in the face of the recent adversity.

Relief operations are still ongoing as more evacuees are coming in to nearby municipalities. In a meeting with the heads of different departments of the provincial government, Governor Jonvic Remulla ordered the continuous monitoring of the situation as well as the condition of evacuees to be able to provide for their immediate needs. He stressed that in light of the disaster, Cavite will not turn its back on anyone and provide whatever it can for those affected.

The Sangguniang Panlalawigan also convened in a special session and passed SP Resolution No. 1389-2020 declaring the province of Cavite under State of Calamity and facilitating the release of Php 15M worth of quick response fund.

Coop i-Create Ladderized Training for Cooperatives (LTC)

The Provincial Government of Cavite through the Provincial Cooperative, Livelihood and Entrepreneurial Development Office (PCLEDO) conducted the Coop i-Create, a Ladderized Training for Cooperatives (LTC) on January 10, 2020 at the Cavite Cooperative Development Center in Trece Martires City to provide an alternative way and profitable employment opportunities for individuals who aspire to have their own businesses. The program aims to identify potential entrepreneurs and provide them with comprehensive support to enhance their entrepreneurial skills and competencies to establish and operate their own competitive business on a sustainable basis.

Ms. Liza C. Gabatan, Entrepreneurial Head, PCLEDO welcomed the participants and gave the detailed and comprehensive overview of the training. The seminar-workshop proper was facilitated by Dr. Aldrin P. Antivola, Business Efficiency Advisor/Organization Therapist. He clearly discussed Entrepreneurial Mindsetting which include the topics: Motivating a Cooperative to Start a Business, NACH – Need for Achievement, How to Develop an Entrepreneurial Mindset in 7 Days or Less, Understanding the “Law of Attraction” and Designing and Understanding a Business Model. During the program, the participants were able to get to know each other by sharing the name of their Cooperatives, locations, missions and visions and other pertinent data. The next sessions will be scheduled on January 17, 23, 24 and February 18, 2020.

Meanwhile, Atty. Khervy B. Reyes, Officer-in-Charge, PCLEDO challenged the participants to reach more people and assured them that the PCLEDO employees will always be present to give assistance in order to achieve their goals.

Attended by 15 selected cooperatives with their Chairpersons and Managers, the participants were expected to gain competencies, learn the art of planning, and organize and execute their businesses with the goal of bringing competitive products to a wider market.

Tolentino supports Tagaytay tourism operators' plea to resume business activities

TAGAYTAY CITY (PIA) - Senator Francis Tolentino has supported the reopening of hotels, restaurants and other vital establishments the soonest possible time citing the need for Tagaytay to get back on its feet immediately.

“Hotels and restaurants form the backbone of Calabarzon region’s tourism industry. Their non-operation has an effect on national economy,” Tolentino said. The Senator sat down with Tagaytay’s tourism council in an emergency meeting this morning here to help them come up with a common decision to re-open their businesses simultaneously. The council will pass a resolution addressed to Tourism Secretary Bernadette Romulo-Puyat for her review.

The council, composed of hotel and restaurant owners and operators, has agreed to open on January 24 in time for the Chinese New Year where tourists and guests who have been previously booked in their facilities are expected to arrive.

Tolentino said he will also seek guidance from Philvolcs Director Renato Solidum if it was safe for hotel operators to re-open their businesses to tourists.

Hotels and restaurants in Tagaytay voluntarily shut down operations following Taal Volcano’s eruption on Sunday. Authorities

likewise advised business owners not to accommodate guests for their safety due to Taal’s imminent destructive eruption.

Operators said they are unable to open business until water and power supply in this mountain-resort city is fully restored. (MCA/PIA LAGUNA)

TRECE MARTIRES CITY FIRST PILOT LGU FOR MILK FEEDING PROGRAM

TRECE MARTIRES CITY, Cavite (PIA) -- The provincial government of Cavite thru the Cavite Provincial Council for the Protection of Children recently launched the first Milk Feeding Program here at Sunshine Ville Child Development Center, Barangay Cabuco

with target 100 beneficiaries belonging to the vulnerable group of children aged 2-4 years old.

The program is in accordance with R.A. No. 11037 also known as the Masustansiyang Pagkain Para sa Batang Pilipino Act – a law on the establishment of a national feeding pro-

gram for undernourished children in public day care centers, kindergarten and elementary schools.

Trece Martires City is one of the LGUs with high number of undernourished children due to the relocation of former informal settlers from other cities who are now residents of Sunshine Ville 1 & 2.

Trece Martires City Mayor Gemma Lubigan thanked the provincial government thru the PCPC for selecting her government unit for this program and said, "Sa mga magulang, suportahan po natin ang programang ito para sa ikabubuti ng kalusugan at mabigyan ng tamang nutrisyon ang inyong mga anak," urging the parents to give full support to the program for the improvement of the nutritional status of their children. Marikina to host 2020 Palarong Pambansa

MARIKINA CITY (PIA) -- Marikina is gearing up this year as the Department of Education (DepEd) has chosen the 'Shoe Capital' to host this year's Palarong Pambansa.

Officials from the DepEd recently confirmed that the annual sports meet for elementary and high school students will be held in Marikina City after the withdrawal of the original host Occidental Mindoro, due to the damages brought by Typhoon 'Tisoy' last December.

The Palarong Pambansa is considered as the "flagship sports program" of the DepEd. In this annual event, thousands of student-athletes and coaches from both public and private schools across the Philippines come together to compete in various sporting events and represent their region nationwide.

In 2013, the Republic Act No. 10588 or the "Palarong Pambansa Act" was signed into law which institutional-

ized the national competition and assigned the annual event as the "primary venue for providing in-school sports opportunities to improve the physical, intellectual and social well-being of the youth."

DepEd Undersecretary Atty. Revsee Escobedo, who is also the Palarong Pambansa secretary-general, sent a team last Dec. 27, 2019 to inspect the sports facilities in the city, and tasked the Division of Marikina City to submit the list of possible billeting areas for the delegates.

Marikina Mayor Marcy Teodoro, on Wednesday (Jan. 8) met with school principals, supervisors, and other officials to discuss the city's preparation for Palarong Pambansa.

This is the first time for Marikina City to host the Palarong Pambansa and fifth time that the sporting event will be held in Metro Manila since 1966. **(PIA NCR)**

73% of Pinoys believe drug users decreased since PRRD took office

MANILA -- At least 73 percent of the Filipinos believe that the number of illegal drug users have dropped since President Rodrigo Duterte took office in July 2016, a recent Social Weather Stations (SWS) survey showed. The SWS survey, conducted from December 13-16, 2019, found that around 28% of the number said the drug users have "fallen a lot" while 46% noticed the drug personalities have "fallen somewhat". On the other hand, 14 percent of Filipinos believe that the number of illegal drug users have increased while 12 percent said it stayed the same. In March 2019, Duterte said there are 7 to 8 million drug users in the country, which is double his estimate of between 3 to 4 million users in 2016. Data from the Philippine Drug Enforcement Agency (PDEA) showed that a total of 151,601 anti-illegal drug operations have been conducted resulting in the arrest of 220,728 individuals and 5,552 suspects killed from July 2016 to November 2019. In the same period, a total of 2,799 children involved in illegal drug activities were rescued during anti-drug operations. A total of 8,185 high-value targets (HVTs) have also been arrested from July 2016 to November 2019, it added. In a statement, Presidential Spokesperson Salvador Panelo welcomed the recent SWS survey results as "a fact the Filipinos feel in their communities". "This is what matters most - a genuine and meaningful change. This is the reason why President Duterte continues to enjoy massive approval and trust from the Filipinos," Panelo said. 'Undeserved currency' However, the same survey found that 76 percent of Filipinos believe there have been many human rights abuses in the administration's war on illegal drugs, and 24 percent say there have been few. Panelo said the Palace is unsurprised with the survey finding, noting that the Administration's war on drugs has been "demonized" by the President's critics, the political opposition, and some media outlets. Denying that the extra-judicial killings (EJKs) were state-sponsored, Panelo said the President's critics continued to tag them

to the government's drug-related operations. "This constant vilification have gained an undeserved currency," Panelo said. The Palace official reiterated that drug-related deaths are the result of violent resistance by the suspects in buy-bust and police operations and that law enforcers simply practice self-defense. Other deaths are results of internecine or killings within the drug organization, he added. 'Aggressive strategies' To successfully eliminate the illegal drug trade, Panelo said "aggressive strategies" were required against those who have been used to being coddled by those in power. Panelo emphasized that regardless of the consequences of his drug war, Duterte remained "obedient" to the constitutional command to serve and protect the people. "The President is unconcerned about the popularity of his policies," Panelo said. He assured the public anew that the government will continue to uphold human rights of its citizens as it continues to enforce laws in eliminating illegal narcotics. State agents who abuse their authority will be punished, he added. "As the President says, as against them, there will be hell to pay," Panelo said, encouraging victims or witnesses to alleged abuses to file complaints so that justice will be served. Duterte's sincerity The SWS survey also showed that 44 percent of Filipinos believe that the President was sincere in appointing Vice President Leni Robredo as Co-Chairperson of ICAD, while 27 percent say he was insincere. Meanwhile, 56 percent said they already knew about Robredo's removal as ICAD co-chair at the time of the survey, while 43 percent said they learned about it only during the interview for the survey. It also found that 49 percent agree that Robredo's sacking was an admission by the administration that its war on illegal drugs is failing. On the other hand, 21 percent disagree that her removal is an admission that the drug war is failing while 30 percent were undecided about the matter.

Robredo was appointed as co-chair at ICAD on Oct. 31 to help Philippine Drug Enforcement Agency (PDEA) Director General Aaron Aquino in efforts to curb the

drug menace. She was originally tasked to assume the role of ICAD co-chairperson until June 30, 2022 but was stripped of her role following her

failure to present new measures in curbing the drug proliferation in the country. (PNA)

Discussed in the meeting were plan of actions that will address the condition of animals after the eruption.

In the meeting, it was confirmed that there were no reported damages and deaths of farm animals and pets. The municipalities of Alfonso, Amadeo, Indang, Mendez, Silang and Tagaytay were identified as priority areas for the inter-agency veterinary mission based on the initial damage report submitted by cities and municipalities. Grasses and forages used as feeds in the said towns were all covered with volcanic ash posing imminent feeds shortage.

Partner agencies committed to provide veterinary supplies, medicines, animal feeds, logistics and other needs that may be needed in the mission. Donations in the form of dog food, powder and injectable medicines, veterinary supplies, bottled water and other items already started coming in as early as a day before the meeting was finalized.

SC junks Quirino daughter's hubby bid on condo unit ownership

MANILA -- The Supreme Court (SC) junked the petition of the husband of the late President Elpidio Quirino's daughter for the ownership of a condominium unit in Makati City.

In a 17-page decision dated Sept. 25, 2019 penned by Associate Justice Alfredo Benjamin S. Caguioa and released on Thursday, the High Court dismissed the petition of Francisco C. Delgado, represented by his son Jose Mari, and affirmed the Court of Appeals decision declaring Francisco's claim of implied trust over a unit in the Urdaneta Apartments Condominium waived through the execution of a pre-nuptial agreement with his wife, Victoria Quirino Gonzales.

The High Court found that Francisco and Victoria agreed five days before they got married on June 20, 1987. Both of them were widower and widow at the time.

The agreement, drafted by Francisco's counsel, Romulo Mabanta Law Offices, stated, among others, that the spouses' properties would be governed by complete separation of properties.

Moreover, it also stipulated that "during his lifetime, (Francisco) agrees that the maintenance, support, and care of (Victoria) shall be borne solely by him and any gift which (Francisco) may have bestowed or shall bestow on (Victoria) shall become her exclusive property. Any gift which (Victoria), on the other hand, may have given or may give to (Francisco) shall revert to her after his death for her to dispose of as she may wish."

GQ Realty Development Corp., a family corporation, was established in 1984 after the death of Victoria's first husband, former Philippine Ambassador to Spain Luis Gonzales, for the sole purpose of holding Victoria's properties.

Francisco claimed that he purchased the unit in the Urdaneta Apartments Condominium so "that he could effectively express his support for the ailing (Victoria)."

Francisco further declared that "(t)he best (way to pro-

vide for Victoria) that he conceived of was to acquire real properties, although to have them registered in the name of (GQ Realty)."

The SC found that the reason behind the purchase of the property was that Victoria wanted to live near her daughter.

"(I)t is clear that Francisco bought the subject property for the purpose of accommodating Victoria's desire to live beside her daughter, Rosario," it said.

The High Court ruled that when Francisco purchased the condominium unit and registered the same under the name of GQ Realty, it was a gift bestowed upon Victoria.

"(T)he waiver of Francisco's alleged interests over the subject property — again only hypothetically admitting this to be true — is completely fathomable and understandable, given his professed true love and affection for Victoria," it added.

The SC also said GQ Realty never really operated as a legitimate real estate corporation, except with Victoria's daughter, Rosario, that is when she mortgaged the property with a bank in 2001 and when the subject property was eventually transferred in her name.

Since Victoria's death in 2006, Rosario and her siblings were prohibited to enter the subject property.

The court also said Francisco was not able to provide evidence that he was the one who actually bought the subject property using his funds and that the subject property was merely held in trust by Victoria and GQ Realty.

"Assuming that Francisco really used his own funds to buy the subject property and that he intended to preserve his interest in the subject property, Francisco's failure to reduce such into writing and place protective measures to secure his alleged interest over the subject property in the Ante-Nuptial Agreement and any other document is clearly contrary to human experience. It must be stressed that the Condominium Certificate Title (CCT) covering the subject property, which is currently

under the name of Rosario, is the best proof of ownership of the property and it requires more than the bare allegation of Francisco to defeat the face value of the certificate of title which enjoys a legal presumption of regularity of issuance," the SC said.

Lastly, the SC pointed out that the pre-nuptial agreement was not drafted by Victoria and her children, but was drafted by Francis-

UHC law protects Filipinos from financial burden due to sickness

CEBU CITY – The Universal Health Care (UHC) Law will protect every Filipino from the risk of financial burden in seeking medical treatment.

Secretary Michael Lloyd Dino, presidential assistant for the Visayas, said the national government's health care program will "give citizens access to the full continuum of health services they need, while protecting them from enduring financial hardship as a result," during his keynote speech at the launch for the implementation of the UHC Law in Cebu on Thursday.

Health Secretary Francisco Duque III and Governor Gwendolyn Garcia signed the memorandum of understanding (MOU) shortly after announcing the official start of UHC program in the

province, in a ceremony at the Cebu Provincial Capitol's social hall.

Duque said during the press briefing that the UHC implementation in the province will be done in a progressive scheme.

The implementation here will focus first on assessing and capacitating every level of health-care facilities in the towns and cities in the province.

With the UHC program, Dino said Cebuano now have two-pronged health-care assistance from the national government, the other one being the Malasakit Center.

Last month, President Rodrigo Duterte signed the Malasakit Center Law which bill was sponsored by Senator Christopher Lawrence "Bong" Go in the

Senate.

Dino lauded the Duterte administration for making Cebu "one of the UHC integration sites in the country."

"I would like to congratulate the Department of Health headed by Secretary Duque for the efficient implementation of the Universal Health Care Law with its implementing rules and regulations signed last year in October and I believe congratulations are also in order for Secretary Duque for having the highest awareness and performance rating among Cabinet members for 2019," he said.

Dino said the President has observed that many of the poor have been avoiding medical treatment because of financial constraints and many turn to self-medication or consultation from quack doctors to avoid having to pay huge amounts for the doctor's fee and hospital bills.

This malady, he said, has resulted in increasing morbidity rate over the years.

"Both the Universal Health Care Law and the Malasakit Center Act will work to the people's advantage.

We are lucky to have such a strong-willed President and I'm sure that we all feel his sincerity that is why he has the highest trust and public approval ratings at 83 and 87 percent respectively in the last quarter of 2019," he said.

"And it gives me pleasure knowing that the people here in the Visayas have seen and felt this administration's programs and initiatives which gave the President a 93-percent performance rating in Visayas for the same period."

Malasakit Center's pilot site was launched by Duterte in February 2018 at the Vicente Sotto Memorial Medical Center here.

The Malasakit Center in Taguig-Pateros District Hospital is the 57th center in the whole country as of this writing. (PNA)

Batangas under state of calamity due to Taal Volcano eruption

BAY, Laguna (PIA) — Batangas was placed under state of calamity following a special session of the provincial board on Monday afternoon.

The declaration came after thousands of Batangas residents in various areas were affected as a result of Taal Volcano's eruption on Sunday.

Evacuation within the 14-kilometer radius from Taal Volcano continues even as the number of displaced individuals in Batangas has climbed to more than 15,000 on Monday based on a report of the National Disaster Risk Reduction and Management Council.

The Taal Volcano has remained at Alert Level 4 which means continuous volcanic earthquakes and eruptive activities in its main crater are expected to occur, causing ashfall in Batangas and in nearby provinces and a large part of Luzon.

"Nais kong ibahagi sa lahat ng mga Batangueño na kumikilos ang pamahalaan para matulungan ang lahat ng apektado at maiwasan ang anumang casualties

(I want all Batangueños to know that the government is working hard to help everyone who is affected and avoid any casualty)," Batangas Governor Hermilando Mandanas said in a media briefing.

He assured that the province is prepared while augmentation from other local and national governments has started arriving.

The Batangas PDRMO, Armed Forces of the Philippines (AFP) and other government agencies have already deployed ambulances, trucks and other emergency vehicles in affected areas.

Relief goods from the Provincial Social Welfare and Development Office (PSWDO) are in place, while over 20,000 N95 masks from the Department of Health (DOH) are set to be distributed to affected individuals.

PDRMO Chief Joselito Castro said the most affected towns include Talisay, Laurel, Agoncillo, and San Nicolas. **(Joy Gabrido with reports from PIO Batangas Capitol)**

Para sa Badminton Asia Chief Operating Officer Chit Boon Saw, naniniwala siya na ang Pilipinas ay kasalukuyang sumasailalim sa isa pang boom sa isport kung kaya't oras na upang mag-host ito sa Continental meet. "Sa palagay ko ang Pilipinas ay isa sa pinakamabilis na umuunlad na mga bansa sa badminton. At mabuti na magdala ng isang kaganapang tulad nito sa isang pagbuo ng badminton na bansa," sabi ni Saw bilang huling beses na nag-host ang bansa sa Asian Championships (indibidwal) noong 2001. "Ang laro ay maaaring maipromote sa masa nang mas mahusay sa isang kaganapan tulad nito." Bukod sa pagiging isang kwalipikado para sa Thomas (Men's) at Uber (Women) Cups na itinakda sa Denmark ngayong Mayo, ang paligsahan ay isa rin sa huling pagkakataon para sa mga shuttler na makaipon ng mga puntos upang maging karapat-dapat sa 2020 Tokyo Olympics. Dahil dito, mahigit sa 290 shuttler mula sa buong kontinente ang inasahang darating - pinamunuan ng pagtatanggol sa panlalaki na kampeon ng Indonesia at pambansang kampeon sa Japan. Labinlimang koponan ng kalalakihan at 14 na kababaihan ng mga pulutong ay makikipagkumpitensya sa biennial meet. Ang bawat dibi-syon ay nahahati sa mga pangkat ng apat na may nangungunang dalawang koponan sa bawat pangkat na sumulong sa yugto ng knockout. Ang format ng koponan ay isang best-of-five na nakatagpo kasama ang tatlong mga tugma ng solong at dalawang dobleng tugma. Nakita ni Saw ang paligsahan na ito bi-

lang isang pagkakataon para sa koponan ng pambansang Pilipinas upang makakuha ng bagong karanasan sa isport. "Inasahan ko na ang koponan ng Pilipinas ay kinukuha ito bilang isang pagkakataon upang matuto at lumago sa kaganapan ng koponan. Tulad ng alam mo, walang maraming mga paligsahan sa koponan sa mundo kaya ito ay isang magandang pagkakataon upang malaman sa iyong korte sa bahay," aniya habang nagpunta ang Pilipinas ng 1-2 sa panlalaki at 0-3 sa women's division noong 2018 edition ng meet. Bukod dito, sa ngalan ng Badminton Asia, tiwala ang ehekutibo na lalabas ang Philippine Badminton Association sa paggawa ng kaganapang ito na magiging host ng ilan sa pinakamahusay na mga shuttler sa buong mundo. "Sa palagay ko ito ay isang matagumpay na kaganapan dahil sa lugar at mga taong nagtatrabaho sa kaganapan. Ang venue ay tala-galang angkop. Naniniwala ako na magiging mabuting pag-host ito."

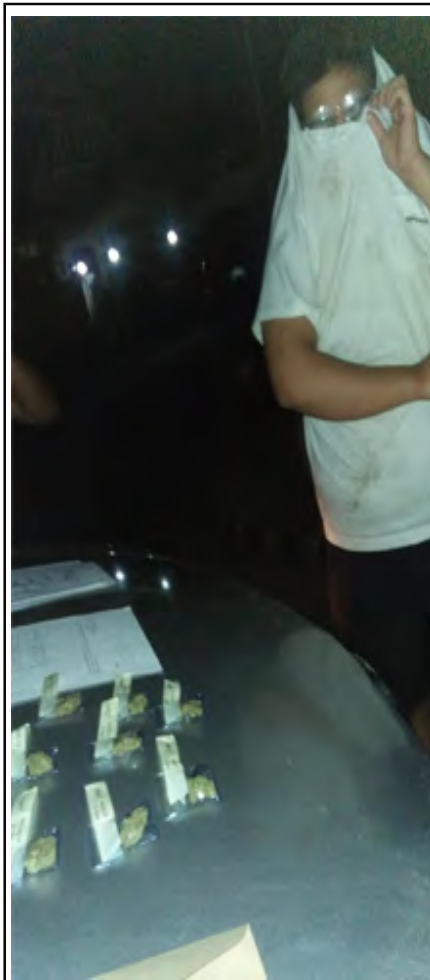
