SOUTHERN TAGALOG REGIONAL HOSPITAL SA CAVITE

HINDI na kailangan pang dumayo ang isang pasyenteng Cavitenyo sa Maynila, Batangas o Las Pinas upang mag-pakunsulta.

Ito ay makaraang normal nang isinalin ng Local government ng Bacoor City ang pangangasiwa sa Department of Health (DOH) ang Southern Tagalog Regional Hospital (STRH). Ayon kay DOH-CALABARZON (Cavite Laguna Batangas Rizal Quezon) Regional Director Eduardo Janairo, sa paglilipat sa DOH ang pangangasiwa ng STRH ay higit na mabibigyang ng atensyon ang serbisyo ng medikal sa mga Caviteño dahil magiging national na ang gagamiting pondo.

"I applaud the Caviteños for initiating the establishment of this facility and envisioning a public hospital that will accommodate the medical needs especially of the unprivileged sector of our society," ayon kay Janairo.

Dagdag pa ni Janairo na sa paglilipat ng pangangasiwa ng DOH, ang STRH ay dadami ang mga nurses, doctors, mga katulong na utilities dahil sa pag-apruba ng P81 milyon personal services ng hospital na habang P41 milyon naman maintenance services na pondo para mag-operate at malalayang na rin ng dialysis, eye center at Malasakit Center.

Ang STRH na matatagpuan sa Salinas 2, Bacoor City, Cavite ay dating Bacoor District Hospital sa ilalim ng pangangasiwa ng local government ng Bacoor City hanggang sa pamunuan ito ni Representative Strike Revilla na mapasailalim ng pangangasiwa ng DOH noong 17th Congress noong 2016.

Kabilang sa kasalukuyang serbisyo ng medikal ng STRH ay ang outpatient consultation para sa Pediatrics, Medicine, OB/Gyne at Surgery. Mayroon din itong clinical laboratory para sa blood services, pharmacy, X-Ray services at Ultrasound at mayroon ding dental, family planning, new born

JBC OPENS APPLICATION TO SC, CA SLOTS

MANILA -- The Supreme Court (SC) on Monday announced that the Judicial and Bar Council (JBC) is now accepting applicants for the position of SC Associate Justice and Court of Appeals (CA) Presiding Justice.

The vacancy in the SC will come with the pending compulsory retirement of SC Justice Andres B. Reyes Jr. on May 11.

The CA vacancy, on the other hand, is the vacancy following Presiding Justice Romeo R. Barza's compul-

sory retirement last August 2.

President Rodrigo Duterte has made 13 appointments to the SC. Two of them have already retired -- Associate Justices Samuel Martinez, and Noel Tijam -- while two others will reach mandatory retirement this year -- Andres Reyes in May, and Jose Reyes Jr. in September.

SERIES OF MEDICAL AND DENTAL MISSIONS IN ALFONSO

Three medical and dental missions were simultaneously conducted in Alfonso, Cavite on January 16, 2020 to cater to the needs of the victims of Taal volcano eruption coming from Batangas province currently sheltered in the municipality. The medical team of General Emilio Aguinaldo Memorial Hospital headed by Dr. Eunice Derequito with the doctors from General Trias Rural Health Unit served 35 patients at Alfonso Central School, the town's main evacuation area.

Meanwhile, 17 patients were treated at Barangay Matagbak by volunteer doctors from the GEAMH headed by Dr. Dona Molato together with the medical mission team of EAC Medical Center-Cavite headed by Dr. Benzon Mangubat, and volunteer nurses.

The other team of doctors from GEAMH treated 116 patients at Alfonso municipal covered court. All the patients underwent checkup and consultation and were provided with prescribed medicines and vitamins. Barangay Health Workers of Alfonso also assisted in the mission.

San Juan, Taytay, Rizal on January 17, 2020 in advance celebration of the first anniversary of the #BattleForManilaBay. Mercado said the residents could make an impact in the lives of the other communities and of the future generations through their active, unceasing and sincere efforts to take care of the environment. Jointly organized by the DENR-PENRO Rizal and the Municipal Environment and Natural Resources Office of Taytay, Rizal headed by MENRO Rodolfo De Leon, Jr., the clean-up activity was participated in by a total of 155 persons from the Cash-for-Work Program of the Department of Social Welfare and Development, Municipal and Barangay Government Offices, Exan Builders Corporation, Atgas Compressed Gas Corporation, Marcbuild Construction, Inc., and Damayan Homeowners Association. The activity was also graced by Rizal Provincial Vice Governor Reynaldo San Juan, Jr., Rizal Board Member Jun Cabitac, Municipal General Services Officer Vic Badagwas, Brgy. San Juan Chairperson Rasel Valera, and Purok 17 Chairperson Marlon Gocalin. The volunteers were able to collect a total of 1,207 kg of solid waste along an 867-m stretch of the creek. Rizal Vice Gov. San Juan reinforced Mercado's call saying, "Sana ang ating responsibilidad sa pangangalaga ng ating kalikasan ay tumimo sa isip, sa puso, sa salita at, higit sa lahat, sa gawa. Dr. Arthur Casanova, bágong fultaym na komisyoner at kinatawan ng wikang Tagalog ng KWF



Dinakip si Janquiang ng mga tauhan ng MPD SMArt na pinangungunaan ni Police Major Rosalino Ibay Jr. at Police Major Cicero Pura noong Biernes, ika-17 ng Enero, sa isang operasyon sa Clark, Pampanga.

Ayon kay Major Ibay, ang naturang suspek ay isang diumanong lider ng isang sindikato sa Quanzhou City, China.

Dagdag niya, mayroon pang isang kasabvat na babae si Janquiang sa ilegal na kalakalan ng droga sa Pilipinas. Siya ay kasilukuyang pinaghahanap na ng mga awtoridad, aniya. (**leonard basilio**)

ISU JOINS PARTNERSHIP IN PRODUCTION OF HERB SUPPLEMENTS

Isabela State University enters the pharmaceutical field as Tripartite Memorandum of Agreement was signed between the Department of Science and Technology- Region II (DOST-R02) and Bauertek Corp., this morning (January 14).

Bauertek Corp. is the first Filipino-owned pharmaceutical firm, manufacturing herbal supplements that aid treatment of various diseases.

It was founded by the company's current general manager Mr. Richard Nixon Gomez, who participated in the MOA Signing, together with University President Dr. Ricmar Aquino, and DOST-Isabela Director Marcelo Miguel, representing Engr. Sancho Mabborang of DOST-R02.

The University will play part in the area of research, producing knowledge inputs to maximize efficiency of raw materials used in the making of herbal supplements. The University will also be housing facilities and machineries for the pre-production and processing phase.

It would mobilize the Uni-

versity's extension arm as said undertaking aims to engage local farmers in the production of raw materials, helping them economically. The efforts would be backed by DOST, supporting the arranged initial financial matters, together with the provision of technical and technology support.

Some 10-hectare area of the Echague Main Campus was dedicated as initial model plantation of "Malunggay", one of the herbal plants needed, for further study and strategic measures regarding development and expansion concerns. Filipino Chinese Chamber, thru Board of Regents member, Private Sector Representative Mr. Charles T. Lim, promised a building that would accommodate the needed equipment.

In a speech, President Ricmar Aquino expressed gratitude for choosing ISU as the SUC partner. He believes that the University can be able to deliver its counterpart, as it currently leads the region in R&D field.

The University President also viewed the undertak-

ing as a way to "provide better opportunities for Isabelinos, especially the farmers". He added, "I am confident that as this col-

laboration prospers, the farmers will be equally benefited".

The forging of MOA was an off-shoot from President

Aquino's meeting with Dr. Gomez and DOST Secretary, Dr. Fortunato Dela Peña in Pampanga last year.



OWWA sets up 'Libreng Tawag' hub for Taal evacuees in Cavite

MANILA -- A mobile communication hub has been set up to cater to close to 2,000 evacuees in Cavite affected by the Taal Volcano eruption, the Overseas Workers Welfare Administration (OWWA) said on Wednesday.

The Task Force Taal Libreng Tawag was put up at Alfonso Central Elementary School where 1,957 evacuees are housed, to offer domestic and international calls, a charging station, free Wi-Fi, and other ancillary services.

For its pilot operation on Monday, the OWWA team led by Deputy Administrators Josefino Torres and Mocha J. Uson, and OWWA Region 4-A led by Regional

Director Maria Luisa Reyes proceeded to the school occupied by people from Lemery, Batangas.

According to Torres, the communication facility is the welfare agency's share of assistance and care to the Batanguenos displaced by the Taal volcano unrest. "The Libreng Tawag is open to all the evacuees, OFW or not, so they can contact their families, loved ones, or whoever they would like to reach out regarding their current situation," Torres said in a statement.

The hub has four mobile phones and a charging station which is powered by two generator sets. An OFW Help Desk was also set up for the evacu-

ees who were OFWs themselves or with OFW relatives, to answer inquiries regarding recently implemented OWWA programs and services like rebate and e-Card.

Of the four lines opened for the evacuees, two lines may be used for international calls. Free Wi-Fi service will be available for evacuees whose contacts can only be reached through social media and email.

OWWA records show there are 43,132 active and non-active OFWs in Alfonso, Cavite and Batangas. Meanwhile, the next "Libreng Tawag" will be in Batangas while its venue has yet to be announced. **(PNA)**

Sandiganbayan convicts DepEd exec in P6.34-M malversation raps

MANILA -- The Sandiganbayan sentenced a former Department of Education (DepEd) official to 17 years in jail for malversation of public funds.

In its 32-page decision dated January 17 released Tuesday, the anti-graft court's First Division through Associate Justice Geraldine Faith A. Econg also found Jesus Loretizo Nieves, former DepEd-9 regional director, civilly liable for the misused amount of PHP6.34 million.

Nieves' co-accused accountant Marilou T. Toloso was acquitted. Associate Justices Efren N. De la Cruz and Edgardo M. Caldona concurred with the ruling. The case involved the transfer in 2007 of PHP6.34 million from the Philippine Veterans Bank (PVB) account of the DepEd-9's ATM payroll account intended for payment of the salaries of teachers to another PVB account.

Nieves, along with cashier Virginia Montero authorized the transfer. Montero died while the case against her remained pending. The recipient PVB account was for the Belgian Integrated Agrarian Reform Support Program (BIARSP), a special project of DepEd project funded by the Belgian government.

Before the transfer of the PHP6.34 million from the payroll account, the BIARSP account had only PHP157 left as the project had been completed as early as 2003 and closure of the BIARSP account had been requested but not acted upon.

After the PHP6.34 million was transferred to the BIARSP account, the same was immediately withdrawn through a check. The sum has since remained unaccounted for.

Nieves claimed he had authorized the transfer of the money from the teachers' payroll account to the BIARSP account, thinking that the amount was transferred into another account which he was made to believe by the late Montero was for teachers' hazard pay.

The Sandiganbayan however did not believe his narration.

"The only apparent and logical reason that can be read from the actuations of Nieves is that he acted in evident bad faith with Montero and that they fully intend to commit fraud and take the amount of PHP6.34 million from the public coffers. After all, there is no coherent reason

for one to transfer funds to an empty account like the BIARSP, only to have the same withdrawn on the same day, if not for the purpose of concealing the misappropriation," the court said.

The anti-graft court concluded that since the BIARSP account was no longer used and was even closed in the books of DepEd, the accused "took the chance that any disbursement from it would no longer be monitored." **(PNA)**



Vet mission for rescued animals in full swing

Cavite Provincial Veterinary Office headed by Dr. May Magno together with a team of volunteers concluded the first leg of the Inter-agency Veterinary Mission on January 18, 2020 for animals affected by Taal volcano eruption.

One mission team headed by Dr. Magno went to Brgy. Zambal, Tagaytay City where they assessed the condition of 64 rescued horses from Taal. They likewise fed them with grass and feed concentrates, conducted vitamin supplementation, antibiotic injection as needed, Tetanus injection for wounded horses and IV fluid infusion for severely dehydrated and weak horses. Veterinary supplies, medicines, supplements and grass (kumpay) were also provided. The other team led by Dr. Gloria Digma visited Brgy. Cabulisan in Magallanes where 300 rescued pets from Taal are temporarily sheltered. After clinical assessment and checkup of the pets, they also conducted deworming, antibiotic injection, wound treatment and IV fluids for sick and emancipated animals. Aside from the vet supplies, medicines, vitamins, electrolytes and dewormers, they also provided dog and cat food, food bowls, leash and cages.

SC junks de Lima habeas data plea vs. PRRD

from suit as the tribunal turned down de Lima's claim that the presidential privilege is not automatic and must first be invoked by the Chief Executive before it takes effect.

"It will be impossible for the Court to enable her cause of action to be established without first determining whether or not said laws, which carry penal sanctions, had been violated," the High Court said in dismissing de Lima's petition.

The court said if the SC was to first require the President to respond to each and every complaint brought against him and then to avail himself of presidential immunity on a case to case basis, "then the rationale for the privilege -- protecting the President from harassment, hindrance or distraction in the discharge of his duties--would be very well defeated."

"It takes little imagination to foresee the possibility

of the President being deluged with lawsuits, baseless or otherwise, should the President still need to invoke his immunity personally before a court may dismiss the case against him," the tribunal said.

The court said the Presi-

dent may only be sued af-

ter his term ends.

"The Chief Executive must first be allowed to end his tenure (not his term) either through resignation or re-
moval by impeachment. Being a Member of Congress, the petitioner [de Lima] is well aware of this,

and she cannot sincerely claim that she is bereft of any remedy," it ruled.

De Lima had sought a writ of habeas data, claiming that her rights are violated by the gathering of information about the person, his or her family, and home.

De Lima, who is facing drug charges for acts committed while she was secretary of justice, filed the case before the SC, asking the high court to order the destruction of the obtained pieces of personal information. (PNA)
