## Continuing care for rescued animals

## DOJ expands VFA study to include impact assessment

**MANILA** -- Department of Justice Secretary Menardo Guevarra on Monday said his office has been directed to include the implications of the termination of the Visiting Forces Agreement (VFA) between the United States and the Philippines in their study.

"We have just been instructed today to expand the scope of our study to include a preliminary impact assessment on the possible termination of the VFA," Guevarra told reporters, referring to the security, economic and environmental impact of the VFA termination into the country.

Guevarra earlier said last week that the memo sought by the Palace would only deal with the procedure for termination, not the wisdom of the executive action and answer such questions as: 'Is the VFA a treaty or an executive agreement?'; 'If it is a treaty, is Senate concurrence required for termination?'; 'Who will give the notice of termination?' (and), 'Is it necessary to state any ground for termination?'

Guevarra explained the legal formalities were easier to determine.

"Yung legal, madali lang. Yung impact assessment ang kailangan ng masusing pag-aaral (The legal questions are easier, It is the

impact assessment that needs scrutiny," the DOJ chief said.

He added that the timeframe for the termination depends on how soon the Cabinet cluster concerned on the matter can convene.

"I may even have to request the Cabinet cluster on justice, security, and peace to convene and discuss this matter," he said.

On Friday, Presidential Spokesperson Salvador Panelo said President Rodrigo Duterte ordered to start the process of termination of the VFA following the cancellation of the US visa of retired top cop and now Senator Ronald "Bato" dela Rosa, who used to be one of those who implemented the government's anti-drug campaign.

Duterte earlier warned the US government that he will scrap the agreement if the cancelation of dela Rosa's visa is not rectified within a month.

Signed by the Philippines and the US in 1998, the VFA is an executive agreement that stipulates how visiting American troops should be treated in the Philippines.

Aside from exempting US forces from passport and visa regulations, the agreement also states that their permits and licenses are also deemed valid in the

## Nutrition status of evacuees in Cavite, a main priority of the health office

Cavite Provincial Health Office called for a meeting of the provincial nutrition cluster and all the city/municipal nutrition action officers in Cavite on January 23, 2020 at the Cavite Collaboration Center for Public Health, Trece Martires City to assess the situation particularly the nutrition status of the evacuees affected by the Taal Volcano Eruption in evacuation centers and those fostered by relatives in order to synchronize the actions of the national, the regional, provincial down to the city and municipal nutrition councils

Dr. Nelson Soriano, head of the Provincial Epidemiology and Surveillance Unit reported the immediate response conducted by the Provincial Health Office through rapid health assessment and needs analysis in evacuation sites and in communities where evacuees are fostered by their relatives. They have provided Vitamin A supplementation and immunization among children aged 0 – 59 months, deworming, onsite health checkup, conducted medical and dental missions, anti-dengue misting, among others. Dr. Soriano stressed some vital provisions that need to be established in

## Fire Safety Education for Children in evacuation centers

The Bureau of Fire Protection-Trece Martires City in partnership with the Provincial Government of Cavite brought the House of Berong, an interactive fire safety education platform, on tour teaching about fire hazards and basic emergency response among children in evacuation sites in Alfonso on January 24, 2020. It provided not just timely fire safety information but also a form of psycho-social support for the young in the aftermath of Taal volcano eruption.

Led by SINSF. Alma Cassandra Gardose, the team of firefighters from BFP-TMC setup the House of Berong in coordination with BFP-Alfonso and the local government and taught the children some basic first aid lessons during emergency, the common fire hazards at home, safety tips, how to extinguish fire from burning pan while cooking, and the proper way to respond in case of fire by crawling down below the smoke. They also had the chance to experience being little firefighters for a day as the team from BFP demon-

strated the use of firehose and let them try using the equipment firsthand. First stop of the fire safety caravan was at Matagbak Elementary School followed by Marahan Elementary School both in the town of Alfonso. The team from BFP-TMC are also targeting to visit evacuation centers in other LGUs to conduct more education campaign for children.

International Institute for Rural Reconstruction Ms. Kirstein Itliong and Ms. Camille Valdemoro explored the possibility of setting up community kitchen in evacuation areas and setting up of Mother-Baby-friendly and Mother-Baby spaces in partnership with their organization and other donors that may be tapped. Ms. Carina Santiago, Regional Nutrition Cluster Head summed up the agreements that were made during the meeting including the provision of nutrition supplements and nutrition services, daily submission of reports to the province, relaying of needs to the regional office for linkage and provision and information campaign on EO 51 on the ban of infant formula for donation through the Department of Education.

## Angono-Antipolo diversion road underway

**ANTIPOLO CITY (PIA)** - A nearly seven kilometer-diversion road that connects Angono and Antipolo is expected to decongest traffic in routes going to the inner towns of Rizal province.

Public Works Secretary Mark Villar said the road construction is in full swing and is expected for completion in June this year. "Going in and out of Rizal will soon be traffic jam-free with the completion of this

project. Packages A and B of the four-lane bypass road now have a significant accomplishment, with a 49.5 percent and 45.08 percent completion rate, respectively," added Secretary Villar.

Based on a report from Department of Public Works and Highways (DPWH) Regional Office 4A Director Samson L. Hebra, Villar the diversion road is anticipated to decongest traffic in the Municipality of Taytay and along Manggahan Floodway which are the frequent route of motorists going to the inner towns of Rizal.

Traversing the Barangay of San Isidro in Angono to Barangay Mahabang Parang near the boundary of Angono and Antipolo, the road spans 6.97-kilometers which were divided into three (3) packages.

In 2018, a 1.02-kilometer portion of the road was finished by the DPWH Rizal 1st District Engineering Office (DEO). Package C of the road project now has an approved allocation of P150-million and will start soon.

With a total funding of P122-million covered by the 2018 DPWH Regular Infrastructure program, packages A and B of the bypass road is targeted to complete on June this year. **(PIA Rizal with DPWH reports)**

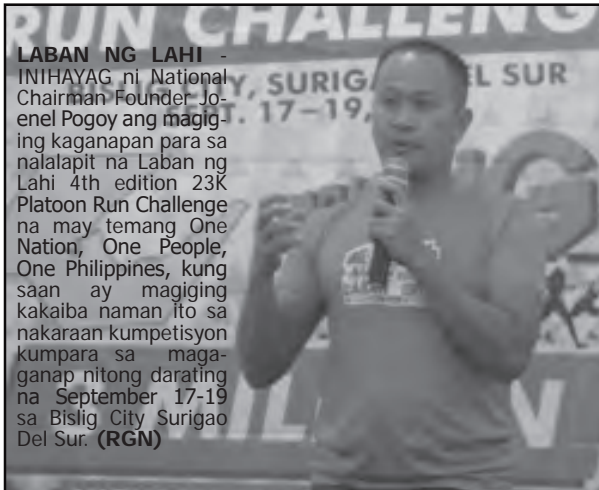

## Calabarzon PNP provides decent burial to deceased NPA fighters

**CALAMBA CITY (PIA)** – The Police Regional Office 4A has provided burial assistance to the family and relatives of two deceased members of a communist terrorist group who died in the recent combat mission of government troops in different parts of the region.

Police Brigadier General Vicente Danao, Jr., regional director of PRO4A said that the communist rebels, despite being a threat to the region's peace and security still deserve a decent burial.

"Bagaman kalaban natin silang maituturing, sila ay mga kababayan parin nating may karapatan sa isang desenteng libing, kaya kami ay nakipag-ugnayan sa kanilang pamilya at kami na mismo ang nagpallibing sa kanila," Danao said.

He stressed that the communist rebels were only victims of deceptive leftist groups.

"Sila ay mga biktima din lamang ng mga kasinungalingan at panlilinlang ng makakaliwang grupo," the Calabarzon police chief said.

In a statement, PRO4A said some members of the police force together with counterparts from the Armed Forces of the Philippines (AFP) embarked on a combat mission on January 19 targeting remnants of New People's Army (NPA) operating in Laguna, Quezon, and Rizal.

It said the troops engaged in a firefight against more or less 20 members of the communist group who were identified belonging to Military Regional Guerilla Unit 4, Southern Tagalog Regional Party Committee. At least two members of the identified communist terrorist group were killed at Sitio Balot Kahoy, Brgy. San Antonio in Kalayaan, Laguna, the police regional office said.

The PRO4A added that the government troops recovered one M14 rifle, and one shotgun with numerous ammunition, improvised explosive devices, bomb components, and various personal documents.

According to PRO4A, the deceased communist rebels were both indigenous people.

One of the members of the tribe (name withheld) told the police that she is thankful to the entire police force for giving proper and decent burial to their deceased tribe member despite the incident.

"Kahit ganyan po ang nangyari sa kanila ay naiyos po nila sa tamang proseso ang kanilang mga bangkay. Nagpapasalamat po kami," she said.

Hard work not in vain For their meritorious performance of duty during the combat operations, three police commissioned officers and at least 32 non-commissioned officers were awarded the Military Merit Medal by the AFP.

During the Regional Joint Peace and Security Coordinating Council Meeting

held on January 24, Danao commended the operating troops in their effort against communist terrorist groups in the region.

"Your hard work shall not be put in vain. I thank you for your dedication risking your lives in the line of duty," Danao said.

He added that the police force will remain relentless in their operations against communist terrorist group in the region and intensify their programs under the Executive Order No. 70 or the Whole-of-Nation Approach to end local communist armed conflict.

## SC designates special competition courts

**MANILA** -- The Supreme Court (SC) on Wednesday designated special commercial courts as competition courts to hear, try, and decide on cases involving violations of the Philippine Competition Act (PCA) and other competition-related laws.

In a circular dated January 28, Court Administrator Jose Midas Marquez said the commercial courts also designated competition courts in the National Capital Judicial Region (NCJR) shall have jurisdiction over competition arising within their respective territorial jurisdiction, while those outside the NCJR shall have jurisdiction within their respective provinces.

The special commercial courts in Quezon City, Manila, Makati, Pasig, Cebu City, Iloilo City, Davao City, and Cagayan de Oro City are authorized to act on applications for the issuance of inspection orders, which shall be enforceable nationwide.

The PCA prohibits entering into anti-competitive agreements such as price-fixing, bid-rigging, abusing a dominant market position, and entering into anti-competitive mergers and

acquisitions.

The PCA covers any person or entity engaged in trade, industry, and commerce in the Philippines. It also applies to international trade that may impact trade, industry, and commerce in the Philippines.

There is price-fixing under the said law when businesses agree to directly or indirectly fix purchase or selling price, instead of letting supply and demand determine the prices of goods and services.

Likewise prohibited are the acts related to abusing a dominant market position by 'predatory pricing' where a dominant firm deliberately incurs losses in the short term by selling goods or services below the cost of its production, which can eventually force its competitors out of business; 'price discrimination' where a dominant firm sets different prices or conditions for equivalent transactions; 'exploitative behavior towards consumers, customers, or competitors,' and limiting production, markets, or technical development.

The prohibited acts are penalized with fines of up to PHP2 million. (PNA)

## Nueva Ecija court convicts Veloso recruiters in separate case

**MANILA** -- A Nueva Ecija court has sentenced the recruiters of overseas Filipino worker (OFW), Mary Jane Veloso, to life imprisonment over separate large-scale illegal recruitment raps filed by three other complainants.

In her 28-page decision dated January 14, Nueva Ecija Regional Trial Court Branch 88 Judge Anarica Castillo-Reyes also ordered Maria Cristina Sergio and Julius Lacanilao to pay PHP2-million fine.

"The prosecution... sufficiently mustered evidence to secure a guilty verdict," Castillo-Reyes said in her

ruling.

The court upheld the charges despite an affidavit of desistance by one of the three complainants, Ana Marie Gonzales, who said she is hard-pressed financially and could not attend court hearings.

"However, said private complainant (Gonzales) still affirmed her positive assertions that both accused proposed overseas employment to her," the court said.

Sergio and Lacanilao are facing separate charges after they were positively identified as having recruited Veloso who is currently detained and included in Indonesia's death row for smuggling heroin into the country in 2010.

Veloso's supporters are hoping that the findings that she had been victimized by the two human traffickers to act as a drug mule would merit leniency from the Indonesian government.

Veloso's execution by firing squad was halted in 2015 after authorities in Manila informed their counterparts in Jakarta that her recruiters had surrendered. (PNA)

# SC REMANDS REYES BBQ DISPUTE CASE TO QC COURT

**MANILA -- The Supreme Court (SC) remanded the case involving a dispute between the brothers behind the Reyes Barbecue restaurants to a lower court.** In an eight-page resolution dated Nov. 13, 2019, and released Wednesday, the Court's Third Division reinstated the civil case

and remanded it to the Quezon City Regional Trial Court (RTC) Branch 216, to conduct an accounting of the profits of the barbecue franchising business. The lower court was also directed to determine the portion of the profits derived from the franchising business of Reyes Barbecue that may be attributed to the contributions made by the brothers; and the portion of the profits derived from the franchising business of Reyes Barbecue that may be attributed only to Francisco Reyes, one of the brothers. In remanding the case, the SC also ruled that a partnership was created between the brothers-owners of the franchising business despite its non-registration

with the Securities and Exchange Commission (SEC). The Court noted and considered that numerous franchises were opened through the contributions of Francisco's brothers -- Adolfo, Ramon, and Carlos. In 1992, Francisco, after working at the Aristocrat Restaurant, thought of putting up his own restaurant and franchising business. He established Reyes Barbecue in 2002 and registered it as a sole proprietorship. In 2005, he filed an application for registration of the trademark "Reyes Barbecue". In 2005, Francisco offered his brothers to form a partnership for the franchising arm of Reyes Barbecue as he needed capital for busi-

ness expansion. Adolfo and Carlos each contributed PHP100,000 in exchange for a 24 percent and 15 percent share, respectively, while Ramon contributed a desktop computer valued at PHP39,000 for a 25 percent share. For Francisco, it was agreed that his contribution will be the Reyes Barbecue trademark registered in his name. Francisco denied having proposed a business partnership with his brothers and insisted that he and his wife Carolina Inez Angela Reyes, his co-petitioner, conceptualized the business on their own; and that the intent, from the start, was to form a franchising corporation with his brothers and not a partnership. Francisco further alleged that the contributions of his brothers were really subscription payments to the franchising corporation.

Francisco further claimed that he abandoned the plan to form a franchising corporation when he discovered that the Reyes Barbecue trademark had been fraudulently transferred to an employee of his nephew, lawyer Adolfo Reyes II. In 2008, Adolfo, Carlos, and Ramon, through a counsel, sent a demand letter calling for an accounting of the business to determine any share in the profits that may be due them. They then filed a complaint for damages. "Although the registration of the franchising arm of Reyes Barbecue did not materialize, numerous franchises were opened through the contributions of all the Reyes brothers. Thus, a partnership for the franchising business of Reyes Barbecue was created," the Court held. (PNA)
