

GOVERNOR REMULLA SPEARHEADS THE TURNOVER OF COMPUTER LABORATORY FOR CAVITE PUBLIC SCHOOLS

Recognizing the importance of integrating information technology and innovation into the education system for public schools in Cavite, Governor Jonvic Remulla led the turnover and launching of computer laboratories on February 3, 2020 for select public schools in the municipalities of Indang in Amadeo and in Trece Maitires City. The provincial government launched and provided computer laboratory with complete set of equipment including desktop computers, computer tables and chairs, 55" Smart TV, routes, switch and network cables, and whiteboard for the use of students enrolled at Cavite State University Science High School, Dr. Pio De Roda Elementary School, Lumampong National High School - Calumpang Cerca Annex and Agus-os Elementary School, all in the municipality of Indang; Halang-Banay Banay National High School and Maitim Elementary School in Amadeo; and, Trece Martires City Senior High School and Luis Aguado National High School - Annex in Trece Martires City. Schools in Indang and Amadeo received 10 computer units each while 20 computers each were distributed to the schools in Trece Martires City. All computer laboratories

were provided with aircon and fire extinguishers for the students' comfort and safety.

Likewise, Governor Remulla brought the good news on fiber optic internet connection in Cavite with more than 300 kilometers of fiber optic cables spread throughout the province making it a free wi-fi zone. The governor also reiterated the importance of modernizing information technology and going with the flow of innovation which mirrors economic development in the province. He stressed that through the computer laboratories, students can continue on making their research, learn typing and printing of paper works, enhance basic computer skills, explore spreadsheet assignments and discover internet applications.

He also announced the readiness of Cavite for the Sangley Airport Project that will soon be operational in the coming years. The 1,500-hectare international airport hub will feature four runways, airside and landside facilities, and can accommodate up to more than 100 million passengers annually. The Sangley Airport will ultimately boost the tourism industry and will give possible job opportunities to Caviteños. The governor also expressed his desire on

the full implementation of providing CCTV all over the province to safeguard and maintain peace and order in the community.

Also present during the turnover of computer laboratories were Vice Governor Jolo Revilla, Board Member Ping Remulla, Indang Mayor Perfecto Fidel and Vice Mayor Sammy Rodil; Amadeo Mayor Redel John Dionisio and Vice Mayor Conrado Viado; Trece Mar-

tires City Mayor Gemma Lubigan and Vice Mayor Bobby Montehermoso; members of the municipal and city councils, Dr. Camilo Polinga, OIC of the Office of the University President and Vice President for Administrative and Support Services of CVSU-Indang Campus; Ms. Merle Baybay, Amadeo District Supervisor, and some school heads and OIC of the recipient schools. **(PICAD)**

Laguna gov't lifts Lambanog ban

CALAMBA CITY, Laguna (PIA) – The Provincial Government of Laguna lifted the ban on Lambanog effective last January 20, following the recommendation of the Provincial Health Office (PHO).

Gov. Ramil L. Hernandez has lifted the temporary ban on the sale and distribution of the coconut wine,

popularly known as Lambanog, within the province of Laguna through the Executive Order No. 04, Series of 2020.

Prior to this, the provincial government issued the Executive Order No. 17 series of 2019 last December which declared the

banning of Lambanog due to the suspected methanol poisoning that killed 11 people and affected more than 200 individuals from the town of Rizal.

Said Lambanog was confirmed by the authorities to have a high level of methanol that caused the poisoning incidents.

The brands of Lambanog that poisoned the victims were confirmed unregistered with the Food and Drugs Administration of the Philippines (FDA) and were already seized and confiscated to prevent any potential hazard to the consuming public.

Despite lifting the ban, the provincial government ought to continuously and strictly monitor the sale and distribution of the distilled fermented coconut sap or Lambanog in the province to thwart possible risk or loss of life.

Through EO 04 s. 2020, the Local Government Units (LGUs) are then encouraged to pass ordinances in their respective areas of responsibility that will help prevent the proliferation of fake and unregistered coconut lambanog.

While, the Business and Licensing Division of all component LGUs and the PHO are directed by the provincial government to conduct regular monitoring of stores and other business establishments selling Lambanog to ensure their compliance with product standards and safety based on the guidelines provided by the Bureau of Product Standards (BPS). **(Joy Gabrido with reports from PIO Laguna)**

Persistent on its goal to safeguard the welfare of the animals who have been affected by the eruption of Taal Volcano, the Provincial Veterinary Office (PVO) led by Dr. May Magno has initiated efforts to visit and conduct veterinary missions at Tagaytay City for the treatment of rescued animals on January 29, 2020.

The Provincial Veterinary Office, together with some veterinarians from the City Veterinarian Office of Tagaytay and the whole staff from Born to be Wild, a Philippine television travelogue show broadcast under GMA Network which was hosted by Dr. Nielsen Donato roamed around the vicinity of Picnic Grove in Barangay Sungay East and gave immediate health assessments and treatments to the animals. Ten goats were given vitamin supplements while four others were dewormed. Out of sixty-four horses which were used in horseback riding in Picnic Grove, 58 were provided vitamins and were dewormed while six were given dextrose through IV line (D5 LRS) and six have undergone eye flushing using the normal saline solution.

A farm in barangay Zambal, also in Tagaytay City was also visited as veterinarians checked the medical conditions of 22 horses. They have provided vitamin supplements to 16 horses, dextrose through IV line (D5 LRS) to six horses and wound treatment and vitamin supplements to five horses. --(PICAD)



SC APPROVES ONLINE MCLE CLASSES FOR LAWYERS

MANILA -- Almost two decades after its inception, the Supreme Court (SC) on Wednesday announced that the Mandatory Continuing Legal Education (MCLE) for lawyers will now be available online.

In an 11-page en banc resolution dated Nov. 26, 2019, the high court has approved the Rules and Regulations in the Conduct of MCLE Online.

"The onset of computer technology made it necessary to adopt current trends of learning and it is relevant with the changing times that an alternative mode of delivery of the MCLE be made available to members of the Bar through online and on-demand MCLE," the Court said.

The court said the online MCLE, which has long been adopted and successfully implemented in other jurisdictions, would address the need for MCLE activities in the provinces, especially in far-flung areas where MCLE activities are few and far between, as well as for Filipino lawyers who are based abroad and would like to update their

MCLE compliance.

Approved by the SC in 2001, MCLE is stipulated in Bar Matter No. 850 which requires members of the Integrated Bar of the Philippines (IBP) to take continuing legal education to ensure that "they keep abreast with the law and jurisprudence, maintain the ethics of the profession and enhance the standards of the practice of law".

Under this rule, lawyers must complete 36 hours of MCLE activities every three years.

The rules define the minimum requirements and responsibilities of accredited MCLE providers that are planning to conduct MCLE online, as well as the guidelines and minimum requirements for lawyers who want to avail themselves of the program online.

Under the rules, MCLE providers must incorporate authentication mechanisms to ensure the identity of the participant while viewing a course. Such authentication includes random snapshots, random video capturing and facial recognition software. **(PNA)**

DOST reiterates support for S&T research on herbal and other products for health and related purposes

The Department of Science and Technology (DOST) has reiterated its support commitments to initiatives and collaboration undertakings in scientific research, production and commercialization of organic herbal food supplements and other product that beneficial to Filipinos and the entire world.

Representing DOST Secretary Fortunato de la Peña at the groundbreaking rites for a facility at the Isabela State University (ISU) main campus in Echague, Isabela recently, Undersecretary Brenda Manzano affirmed their agency's "full support for collaborative undertakings" related DOST's mandate and mission.

The ISU facility is designed as a storage and processing center of materials for the manufacture of herbal food supplements and alternative herbal medicine preparations. It has financial assistance from DOST and the Filipino-Chinese Chamber of Commerce Inc. which was facilitated by former ISU Board of Regents member Charles T. Lim.

The groundbreaking ceremonies were presided over by Usec Dr. Nazareth-Manzano, ISU president Dr. Ricmar Aquino, Charles T. Lim of FCCC, and Bauertek Corp. Board Chair and General Manager Richard Nixon Gomez. The project is a partnership undertaking among DOST, ISU, FCCC and Bauertek Corp. Also present at the rites were Cagayan Valley (R-2) Regional Director Engr. Sancho Mabborang and other officials of the project's partner institutions.

Immediately after the groundbreaking rites, the partner agencies' officials signed a Memorandum of Agreement (MOA) for the project. Dr Manzano described the undertaking as a "rare and ideal partnership among the government, private industry sector and academe."

A 10-hectare area of the ISU Echague campus has been set aside as a prototype model plantation of "Malunggay" (moringa) and other herbs like Pippere (pepper), Curcumin (turmeric) and Guyabano which have been proven to have medicinal value and properties. Scientific botanical research studies on plant growth, nutri-

ent enhancement, medical value exploration and related concerns will be undertaken in prototype plantation which may later be expanded. Gomez noted that the plants mentioned are used in cosmetic and related products.

"Turmeric, however, is a real deal," for herbal food supplements which can be upscaled to global marketing since it is a leading herbal supplement ingredient and tops traditional medicine worldwide, said Gomez, Bauertek's founder. The processed plantation products will subsequently be transferred to Bauertek for laboratory treatments, commercialization and packaging for commercialization and marketing distribution.

In a statement, Manzano said the partnership link-

age will bolster the science and technology (S&T) ecosystem, making it productive". She also lauded ISU president Ricmar Aquino for prioritizing S&T, which commitment will "add to the body of knowledge with outputs that benefit the general public."

Director Mabborang, for his part, stressed the "undertaking goes beyond mere research and would redound to community empowerment." He said it will help farmers cultivate and raise and raise high-value alternative crops that can provide them significantly higher income than traditional farming to which Gomez eagerly agreed.

ISU president Ricmar Aquino thanked the partner-agencies for involving their institution in the partnership. In his speech during

the rites, he pledged that ISU "will do its part with all the technology and resources it has to help make in Region number one" in agricultural productivity.

Simultaneous with the talks on herb production, another agreement was forged between ISU and the Red Dragon Farm (RDF) Feed Livestock and Foods Inc. the firm behind the Fresh Options Meat shop. The accord will make the Technology Business Incubation (TBI) project of ISU's Cagayan Valley Small Ruminants Research Center (CVSRRRC) Integrated Slaughterhouse and Meat Processing Center, as the platform for RDF's North Luzon expansion, and its production of processed-meat products particularly pork tocino, pork longganisa, and pork tapa.



AGUSAN SUR BARANGAY DECLARAS CPP-NPA-NDF PERSONA NON-GRATA ANEW

Loreto, ADS – In a ceremonial activity which highlighted a community dialogue held yesterday at Barangay Binucayan of Loreto town, Agusan del Sur, some 400 residents signed a manifesto declaring the Communist Party of the Philippines-New Peoples' Army-National Democratic Front (CPP-NPA-NDF) and their various front organizations and supporters as "Persona Non-Grata" from their locality.

The said community dialogue, dubbed as "Grand Pulong-pulong", culminated the Community Support Program (CSP) being co-facilitated by the 60th Infantry Battalion of the Philippine Army, the Department of the Interior and Local Government, and the local government units of the Municipality of Loreto and Barangay Binucayan.

Representing the government side of the dialogue were Loreto Vice Mayor

Randolph Plaza who represented Mayor Lorife Otaza, Municipal Administrator Samson Ramilo, MPOC Chairperson and Councilor Roldanito Reyes, Binucayan Punong Brgy Edgardo Magadan, other barangay functionaries, and the representatives of the different municipal government departments (e.g. MSWD, MHO, LCR, MENDRO, MEO, etc.) as well as line government agencies (i.e. DILG, DENR, NCIP, DAR, PNP, etc.).

On the other side of the dialogue, a majority of Binucayan residents—including farmers, small business owners, teachers, students, senior citizens, indigenous peoples, and even CSO representatives—were also in attendance to manifest their support and voice out any more of their concerns to the government.

The dialogue centered on the barangay's peace and order issues; particularly

the recruitment of their residents to become members of the NPA. Later, the various agencies represented in the forum also discussed the ongoing and upcoming government projects for Binucayan and the many other services its residents can avail anytime.

Speaking in behalf of the Mayor, Municipal Administrator Samson Ramilo reiterated the LGU's commitment to ensuring that the services, programs, and projects needed by the people will be duly and promptly delivered to them. Vice Mayor Plaza, on the other hand, asked the residents to be more vigilant and continue cooperating with the government in the spirit of the "whole-of-nation approach."

Backing up statements from the LGU and the other

government reps in the forum, 60IB Civil-Military Operations Officer, 1Lt Ama-deuz Celestial, added: "We need your help. We must choose to end this [local communist armed conflict] now so we can focus our energies and our resources to the development of our communities."

In a separate statement, newly installed Battalion Commander of 60IB, Lt. Col. Ronaldo Sarmiento, vowed to continue 60IB's commitment of "helping establish peaceful and conflict-resilient communities." He, however, called on members of the CPP-NPA-NDF to "stop terrorizing the people and exploiting their vulnerabilities."

"Our current government is trying its best to be better and do better for the people. We have slowly but

determinately eradicated many of the various reasons and excuses the CPP-NPA-NDF have been using to discredit our efforts and bring the people to rebel. To the CNN: stop this terrorism! Lay down your arms and let us help you return to your families. We have a chance at peace. Let us choose it now," Sarmiento added.

Barangay Binucayan was previously identified as CPP-NPA "influenced area" based on the parameters set in the Joint Letter Directive No. 3, s. 2018 of the Armed Forces of the Philippines and the Philippine National Police which prescribes mechanisms by which the said agencies can assist LGUs in the implementation of programs and services for the people.

PERALTA DISTRIBUTES RELIEF ITEMS TO TAAL ERUPTION VICTIMS

MANILA -- Supreme Court Chief Justice Diosdado Peralta on Monday led the distribution of relief goods to court workers affected by the recent eruption of Taal Volcano.

The distribution of relief goods was done during the regular flag-raising ceremony at the Supreme Court quadrangle in Padre Faura, Manila. Earlier, Peralta urged all SC justices, officials, and employees to help court workers affected by Taal's

eruption.

Among the first to respond were judges and court employees in Bulacan province who recently handed over to Peralta their cash donation of PHP110,000 for judiciary employees directly affected by the eruption.

State seismologists on Monday said Taal Volcano, which is under Alert Level Status 3, once more emitted dirty-white to white steam-laden plumes, while volcanic earthquakes were recorded indicating "magmatic activity" that might lead to eruption.

The Philippine Institute of Volcanology and Seismology (Phivolcs) said its seismic monitoring net-

work recorded at least 134 volcanic earthquakes since Sunday, which signified "magmatic activity beneath the Taal edifice that could lead to eruptive activity at the Main Crater".

Taal Volcano also emitted "voluminous" plumes rising 800 meters high, with sulfur dioxide (SO₂) emission recorded at an average of 97 tonnes/day on February 1, Phivolcs added.

Phivolcs said that as Alert Level 3 remains, "entry into the Taal Volcano Island as well as into areas over Taal Lake and communities west of the island within a 7-kilometer radius from the Main Crater must be strictly prohibited". (PNA)
