



LTO CONDUCTS ORIENTATION AND DEPUTATION SEMINAR-WORKSHOP FOR DTROs

AN orientation and deputation training seminar-workshop for Deputized Transportation Regulation Officers (DTROs) which was conducted by the Land Transportation Office Region-IV-A gathered more than 100 participants from the Road Safety Division of the Office of the Provincial Governor and Tanza Municipal Government on May 30, 2019 at the RFC Mall, Molino, Bacoor City, Cavite. The activity aims to update traffic enforcers and support personnel on existing traffic code, related laws and implementing rules that are currently enforced and to qualify them to become deputized regulation officers.

Mr. Rolando D. Alvaran, OIC, OPG-RSD welcomed all the participants and encouraged everyone to participate for their advantage. An orientation about LTO's functions and mandate was conducted by Ms. Darlene P. Oabel, Regional Deputation and Evaluation Committee (RDEC) Secretariat. Among the topics covered were: R.A. 4136 – Land Transportation and Traffic Code and Other Related Laws, Rules and Regulations; Traffic Signs, Signals and Pavement Markings; Understanding and Avoiding Road Rage which were delivered by Ms. Clarisa A. Sulit, Chief Operations Division – LTO IV-A. On the other hand, DOTC Joint Administrative Order (JAO) 2014-01 dated June 2, 2014, Driver's Licensing and Motor Vehicle Registration and Salient Features of Special Laws being implemented by LTO were discussed by Mr. Derwin E. Panganiban, Team Leader, Regional Patrol-Operations Division, LTO IV-A. Among the Special Laws were R.A. No. 8749 – The Philippine Clean Air Act; R.A. No. 8750 – Seat Belts Use Act of 1999, and R.A. No. 10913 Anti-Distracted Driving Act of 2013.

A Road Safety Scenario was initially given by Assistant Regional Director Francisco P. Ranches Jr. Jr., CESO VI, RDEC Chairman before the participants were given information on R.A. NO. 10586 – Anti Drunk and Drugged Driving Act of 2013; R.A. No. 10054 – Motorcycle Helmet Act of 1999 and R.A. No. 10666 – Children's Safety on Motorcycles Act of 2015; Road Safety, Courtesy and Discipline for TROs, Law Enforcement and its Types, Rights of the TROs and Drivers and Good Qualities of TROs. Lastly, the Filling up of Temporary Operator's Permit (TOP) and related topics were communicated with the participants by Mr. Panganiban.

To assess the participants and be qualified as Deputized Transportation Regulation Officers (DTROs), a written examination was facilitated by Ms. Lovely P. Pesor, RDEC Secretariat. The awarding of certificates concluded the event. (PICAD)

Eleazar orders clean-up of Metro precincts' surroundings

MANILA — The National Capital Region Police Office (NCRPO) on Thursday ordered all police community precincts (PCPs) in the region to ensure that their surroundings are clean and orderly.

This, as NCRPO chief, Maj. Gen. Guillermo Eleazar, conducted a surprise inspection of PCPs in the southern part of Metro Manila on Wednesday.

Eleazar said he inspected 10 PCPs in Pasay, Makati, Parañaque, Las Piñas, and Taguig and found out that while these police stations are clean on the inside, the outside premises were found to be filthy.

"Cleanliness not only inside but (also) outside

(is important). There are a lot of cigarette butts, empty water bottles and candy wrappers during my inspection in these PCPs. I told them even if they have old equipment, as long as these are in order, the people will still find it presentable, especially complainants. The comfort rooms should not have any foul smell. It is important to have a good and clean working environment," Eleazar told the Philippine News Agency (PNA) in a phone interview.

"I gave them a warning first. I told them to clean up and then I will go back. I talked to their chiefs of police and station commanders regarding the inspection. They should be watchful of the PCPs under their jurisdiction," he stressed.

Eleazar said that he will inspect 187 PCPs metro-wide, stressing that one of his priority programs is the cleanliness of the stations and their surroundings as part of the internal cleansing program of the PNP.

"Cleanliness and sanitation in the police stations should be a standard. Police commanders should always make sure that the surroundings are clean," the Metro Manila top cop noted.

"In general, I am satisfied but we can do more improvement. The people's trust will be restored if they see clean surroundings of police stations. What I mean here is exaggerated cleanliness," Eleazar said. (PNA)

Bersamin reminds CTA workers to always uphold rule of law

MANILA — Chief Justice Lucas P. Bersamin on Friday reminded officials and employees of the Court of Tax Appeals (CTA) to uphold the rule of law at all times.

"I urge that we remain focused in our jobs and responsibilities and stay committed and persevering in achieving our common goal of delivering fast and efficient justice to all," the top magistrate said in his speech at the tax court's 65th founding anniversary in Quezon City.

Bersamin also underscored that the primary role of workers in the judiciary is to serve the people.

"The people expect nothing less. The people deserve nothing less," stressed the Chief Justice.

Established by virtue of Republic Act No. 1125 on June 16, 1954, the CTA is an appellate court with jurisdiction, not only over civil tax cases but also cases that are criminal in nature, as well as local tax cases, property taxes, and final collection of taxes.

It is currently composed of Presiding Justice Roman del Rosario and

eight Associate Justices, namely Juanito Castañeda Jr., Lovell R. Bautista, Erlinda Piñera Uy, Caesar A. Casanova, Esperanza R. Fabon-Victorino, Cielito N. Mindaro-Grulla, Catherine Manahan and Ma. Belen M. Ringpis-Liban.

The CTA justices may sit en banc or in three divisions composed of three justices each. (PNA)

SC allows ex-DA chief Yap plea to travel abroad

MANILA — Bohol governor-elect Arthur C. Yap has been conditionally allowed by the Supreme Court (SC) to travel abroad.

In a resolution dated June 3, the SC required the former agriculture secretary, who is facing graft charges, to post a PHP100,000-bond for the trip.

The SC likewise required Yap to name a personal agent with authority to act for and on his behalf for the duration of his travel abroad, and to file a written notice of his arrival within 24 hours upon his return to the Philippines.

Yap said he plans to travel to Belgium, the Netherlands, Japan, and South Korea from June 6 until June 29.

He said he plans to attend a convention on solid waste management and desalination in the Netherlands.

Yap and former Department of Science and Technology (DOST) secretary William Padolina were charged with violation of the Anti-Graft and Corrupt Practices Act in connection with the PHP15.8-million car plan of the Philippine Rice Research Institute in 2008 and 2009.

"In view of the manifestations and the assurances by the petitioner (Yap) that he has no reason to flee the jurisdiction or to evade his responsibilities, the Court finds that he has proven that he is not a flight risk," the SC said. (PNA)

The water bodies covered by the DENR-MPIC accord are Esteros de Vitas, San Lazaro, Kabulisan, Magdalena, Binondo, Dela Reina, Sampaloc, San Sebastian, San Miguel, Valencia, Uli-uli, Paco, Pandacan, Tanque, Balete, Provisor, Concordia, Sunog Apog, San Antonio Abad and Quiapo.

MPIC would work closely with DENR, local government units and other concerned government and private agencies to clean up these water ways that lead to Manila bay.

The partnership was sealed through a memorandum of understanding (MOU) signed by DENR Secretary Roy A. Cimatu and MPIC president and

small businesses.

"The event will serve as a venue where they can reach out to their target publics, avail of various skills re-tooling and upgrade training, network with other businesses, and get to know the various programs offered by financial institutions as well as concerned government agencies," she added.

The organizers also have the food lovers and culinary enthusiasts in mind by offering an array of food choices and a pool of culinary experts sharing their know-hows, all under one roof.

The diversified conglomerate also assured that Maynilad will fast-track the rehabilitation of its sewer lines, intensify the connection of domestic and non-domestic customers to the existing sewerage network, install collector pipes and easements, and conduct information and education campaigns related to proper wastewater treatment and disposal.

The DENR, on the other hand, will provide the MPIC with all the relevant data for the conduct of the water quality assessment study, issue the necessary permits and approvals to enable the MPIC and Maynilad to perform their responsibilities, and take appropriate action against violators within the adopted esteros.

The National Historical Commission of the Philippines (NHCP), in partnership with the provincial government of Cavite, the municipal government of Kawit, and their respective tourism offices, have lined up day-long activities composed of commemoration formalities and some side activities.

The fun in the province continues with Cavite City's annual "Regada" Festival from June 15 to 22 where people of different ages and social status join in the fun not only because of its festive mood, but also of the ecological implication and spiritual bonding that they experience.

CA RESUMES HEARINGS ON WRIT OF AMPARO PETITION

MANILA — Sparks flew at the Court of Appeals (CA) Thursday during the hearing attended by state lawyers and counsels from a militant lawyers' group identified by the military as allegedly linked to the terrorist

Communist Party of the Philippines.

Marlon Bosantog, representing the government from the Office of the Solicitor General, started his cross-examination of the witnesses with assurances of the government's

commitment to the rule of law and due process.

"No lawyer should be encumbered in the performance of their duty," said Bosantog appearing for the state as he questioned National Union of People's Lawyers (NUPL) president Edre Olalia's allegations and the legal standing of the left-leaning group to bring the suit.

Bosantog said that as a group, the NUPL is a juridical entity that cannot be the subject of physical harm.

Bosantog also underscored that the legal profession faces "inherent risks not exclusive to NUPL".

The exchange between Bosantog and Olalia became tense after Bosantog described the lawyer as having "split personality" and Olalia, in turn, accusing the government of "coverups" and "victim blaming".

Edgard Arevalo, attended the hearing and formally informed the court that pressing commitments conflicted with the schedule of AFP Deputy Chief of Staff for Civil Military Operations, Major General Antonio Parlaide Jr., thus preventing the latter from attending the hearing.

The Special 15th Division led by chairman, Associate Justice Stephen Cruz, with Associate Justices Pedro Corales and Hermano Legaspi as members, underscored that there was no need for President Rodrigo Duterte to attend even if he had been named as a nominal respondent.

"We are not requiring the presence of the President, that is clear," the magistrates clarified.

Assistant Solicitor General Angelita Villanueva-Miranda assured that the generals led by Parlaide will be informed that their absence in the subsequent hearings will constitute a waiver to be present there.

The government was also asked to comment on the request for a temporary

who are dropped off at the century-old Barasoain Church can take e-trikes going to Casa Real, the Kamestisuhan District, houses of Kadagalagan ng Malolos, and the Cathedral-Basilica of Malolos.

Since 2011, the Malolos City Tourism Office has been offering a city's Heritage Tourism Package which includes 'Lakbay-History' from Barasoain to the different areas of Malolos.

The DOE turned over the 100 e-trikes on May 31 as part of the 3,000 e-trikes the national government has distributed to the different regions of the country under DOE's Market Transformation program funded by PHP 1.7-billion loan agreement with Asian Development Bank.

It features a robust body and strong motor that can transport up to six passengers, including the driver at full load. (PNA)
