# CALABARZON LGUs URGED TO INSTITUTIONALIZE REFORMS

**MANILA --** The Department of Health is urging local government officials to pass local ordinances that would help institutionalize health reforms.

At the sidelines of the Colloquium: Health Leadership and Governance Program here, DOH-Calabarzon Director Eduardo Janairo said that since local leaders have term limits, health reforms should be sustained.

"May naitanim na kami, mahalaga 'yung sustainability at tuloy-tuloy ang programa para hindi mawala ang kalusugan para sa kanila (We have already planted the seed, what's important now is sustainability and continuous implementation of

health programs)," he said.

Local officials from selected municipalities in the Calabarzon region have undergone a training program, led by the DOH, called Municipal Leadership and Governance Program (MLGP), which aims to promote a systemic mindset for overcoming challenges in community healthcare.

The colloquium is held to formally end the two-year partnership program with the eight municipalities – composed of Alfonso and Noveleta towns in Cavite, Sta. Maria and Majayjay in Laguna, Agoncillo and Padre Garcia in Batangas, and Buenavista and Panukan in Quezon, who completed the MLGP.

## Driver's license 10-year validity not absolute: LTO chief

**BAGUIO CITY--** Land Transportation Office (LTO) chief Edgar Galvante said Thursday the 10-year validity of driver's licenses will only be enjoyed by motorists who follow traffic laws as "demerits" can cause its revocation and suspension.

"From the one-year validity of the license, we made it three years. Now, we made it five and so it would be 10 [years] so that you don't have to come back every five years but rather, 10. You have to come back only once every 10 years for you to renew your license but that is if you are not delinquent meaning, you do not have violations," Galvante told the Philippine News Agency (PNA).

He said the license can be revoked any time if the driver has accumulated several traffic violations.

President Rodrigo Duterte ordered the LTO to extend the validity of drivers' license to 10 years for the public's convenience.

On Tuesday, Galvante and officials of the LTO-Cordillera Administrative Region (LTO-CAR) led the formal opening of student permit and drivers' license

renewal center in a mall on Session Road.

The center is complementary to the LTO-Baguio office in Barangay Pacdal, some four kilometers away from the central business district.

Galvante said motorists who want to renew their licenses can proceed to the center.

He said even if the driver's license is still valid, it can be invalidated for incurring demerits and the driver will be suspended or barred from driving a motor vehicle during the suspension period.

"It will be confiscated. You will be suspended and you will have to serve the suspension before you can get it back," Galvante said.

He said on the 10th year when the license will be renewed and the LTO sees that the driver has incurred several demerits, its validity will only be for five years or less.

Galvante said such sanctions have been placed to instill discipline among the drivers who are given the privilege of handling a motor vehicle. (With reports from Argelynne Gem Ramos, OJT/PNA)

## Voter registration resumes in August: Comelec

**MANILA --** Filipinos who would like to register as voters may apply beginning August, the Commission on Elections (Comelec) said Friday.

Comelec spokesperson James Jimenez said voter registration will be held nationwide from August 1 to September 30, including Saturdays and holidays.

"Approximately two million new voters are expected to register during this period," Jimenez said.

He also said that Sangguniang Kabataan (Youth Council) voters who have already turned 18 years old need not register anew.

## MMDRRMC prepares contingency plan for water shortage

**QUEZON CITY (PIA)--** The Metro Manila Disaster Risk Reduction and Management Council (MMDRRMC), concerned government agencies and water concessionaires discuss contingency measures on how to prepare for a worsening water shortage, as water level of Angat Dam continues to drop.

Metropolitan Manila Development Authority (MMDA) and concurrent MMDRRMC chairman Danilo Lim highlighted the need to prepare for the worst when water supply from water concessionaires begin to reduce in the coming weeks.

## CAGAYAN DE ORO CITY

– The Court of Appeals' 12th division has dismissed 24 administrative cases against incumbent mayor Oscar Moreno, a city official said on Friday.

City information officer Maricel Rivera confirmed that the CA has junked the cases in relation to the rental of heavy equipment when Moreno was still the governor of Misamis Oriental.

In a press conference, Moreno said the verdict of clearing him of the accusations was "beyond words."

"Nothing is sweeter than being vindicated," Moreno said, noting that the cases were "designed" to discredit his credibility while insinuating that this was the handiwork of his political opponents.

The 33-page decision was signed by Associate Justices Victoria Isabel Paredes, Marlene Gonzales-Sison, and Maria Elisa

Sempio Diy on May 15, 2019, but city hall released the information on Friday.

Also cleared by the appellate court were former provincial bids and awards committee members Elsie Lopoy, Rolando Pacuribot, Elmer Wabe, Leemar Tina-gan, Divina Bade, and Patrick Gabutina.

All of them were charged before the Office of the Ombudsman with serious dishonesty, grave misconduct and conduct prejudicial to the best interest of public service.

The Ombudsman alleged that the rental of the heavy equipment for the road development project did not follow the bidding process, although the respondents reasoned that they resorted to other forms of procurement.

"The existence of conspiracy cannot be presumed, it must be proven

through clear and convincing evidence," the CA decision read, adding that the acts of the respondents did not, in any way, tarnish the image and integrity of their respective offices.

The CA has also approved the respondents' petition for certiorari or an order by which a higher court reviews the decision of a lower court.

"The Petition for Certiorari and prohibition are hereby granted and the assailed decision issued by the office of the Ombudsman on various dates finding petitioners guilty of serious dishonesty, grave misconduct, and conduct prejudicial to the best interest of service are reversed and set aside. Accordingly, the Administrative complaints against them are dismissed," the CA ruled. (PNA)

still not enough to boost the water level of the Angat Dam.

Angat Dam's water elevation dropped to critical low level mark of 160 meters, foreseen to reduce Metro Manila's water supply.

"According to PAGASA, there will be no widespread rains but only localized rain showers for the next eight days," said Jojo Garcia, MMDA general manager.

To facilitate the delivery of water supplies to areas that may be affected, Lim said trucks of Maynilad Water Services Inc. and Manila Water Company Inc. are still exempted from the number coding scheme.

"We have a standing order authorizing tankers bringing water to affected areas, with no

restrictions on number coding," said Lim.

Maynilad handles the west zone or parts of Metro Manila and Cavite while Manila water handles the east zone or parts of eastern Metro Manila and Rizal.

Garcia also called on the public to learn and practice responsible use of water, rather than saving water.

"It is high time for public to be educated on responsible use of water," Garcia said.

Thinking ahead, Garcia said there should be long-term measures to prevent the problem from happening again in the coming years.

The MMDA has mobile water purifying filters which can be used. (PIA InfoComm/MMDA)

# CAVITE TOWN DECLARED DRUG-FREE

**NAIC, Cavite -- The Philippine Drug Enforcement Agency (PDEA) and Philippine National Police (PNP) have declared this municipality drug-free.**

The municipality received the drug-free locality certificate last Thursday at Camp Gen. Pantaleon Garcia in Imus City. Naic Municipal Police Station led by Lt. Col. Janet Arinabo, along with fellow policemen, finished clearing the 30 villages of illegal drugs in two years from January 2017 to April 2019, and adjudged as the first drug-cleared Class "A" municipality in the province of Cavite.

The PDEA 4-A also issued certificates to 30 drug-cleared barangays last February 2019.

"Maraming maraming salamat po sa suporta ng local government at

ng 30 barangays para malinis natin ito sa mga ipinagbabawal na droga (Thank you very much for the support of the local government and 30 barangays to clean these areas of illegal drugs)," Arinabo said in interview.

Naic Municipal Police Station initiated the accounting of alleged drug personalities and their arrests, and eventual rehabilitation of those who voluntarily surrendered, in partnership with the local government executives, barangay officials, volunteer pastors, and other concerned government agencies.

Police also placed drug-free stickers drive in homes and workplaces.

Mayor Junio Dualan lauded the efforts of the local police force to clear the locality of drugs. (PNA)

## DOST-PAGASA launches new storm surge forecast, warning system

**QUEZON CITY (PIA)**

— The Department of Science and Technology — Philippine Atmospheric, Geophysical and Astronomical Services Administration (DOST-PAGASA) introduced a new system that translates Storm Surge Forecast and Warning into impact-relevant information.

Prior to this, the Agency issues warnings that are focused on the expected hazardous weather but in the new system, focus is more on the possible impact of the weather system to the community.

"The forecast services can give warning to the people on the possibility of the storm surge. This is a tool we use in gearing towards community-based preparedness." Undersecretary for Disaster Risk Reduction & Climate Change Dr. Renato Solidum said during the press launch at PAGASA office in Quezon City, Monday (June 17).

Different ways of providing forecast was initiated due to the gaps seen in the current system.

PAGASA Storm Surge Forecasting and Warning services is designed to provide a new way of presenting easy-to-understand visuals which include impacts brought by the expected storm surge.

The services consists of two categories: Storm Surge Watch, given when a moderate to high risk that may occur within the next 48 hours, and Storm Surge Warning, when a high risk of storm surge that may occur within the next 24 hours at the identified low-lying coastal communities.

The system simplifies the technical data provided and turning it into more actionable information with direct relevance to those affected areas.

"Everyone's safety depends on each person's family and community, so it is essential to have a community-based preparedness measures." Solidum said

Solidum reminded everyone to closely monitor updates from PAGASA since they are the mandated agency to provide knowledge and information on natural calamities and ensures safety and well-being of the Filipino people, thru weather advisories and warnings.

## 35 Chinese illegal workers nabbed in Parañaque

**MANILA** — The Bureau of Immigration (BI) has apprehended 35 Chinese males illegally working as construction workers in a subdivision in Parañaque City.

According to BI Intelligence Division chief Fortunato Manahan Jr., the arrest was conducted on Wednesday which stemmed from a complaint against the foreigners causing trouble at a construction site inside Multi-national Village in the said City.

"The location keeps on popping in different complaints, so this prompted us to conduct surveillance in the area and we indeed confirmed the presence of these illegal workers," he said in a statement Thursday.

Armed with a mission order from BI Commissioner Jaime Morente, the 27-man intelligence team arrested the Chinese who were caught in the act of doing manual labor.

"They were caught doing tile setting, finishing works, wood works, and other construction activities, which is in clear violation of the conditions of their stay," Manahan said.

According to BI policy, foreign nationals are disallowed from engaging in work involving manual labor.

On the other hand, BI spokesperson Dana Sandoval said the arrested foreigners are temporarily detained at the BI facility in Bicutan, Taguig City. (PNA)

## Pag-IBIG execs say salary step increments above board

**MANILA** -- Pag-IBIG

Fund on Wednesday clarified that the pay adjustment of its officers and employees in 2018 was merely salary step increments and not an increase in the salary rates which requires approval from Malacañang.

Secretary Eduardo D. del Rosario, chairman of the Housing and Urban Development Coordinating Council and of Pag-IBIG Fund's Board of Trustees, made this response to the observation issued by the Commission on Audit (COA) on last year's pay hike.

He said while step increments among employees of other agencies are granted automatically every three years on the basis of longevity of service, the step increments granted to Pag-IBIG employees were intended to address the effects of inflation over the years. Del Rosario said the grant of such step increments is within the powers of its Board based on Pag-IBIG's Compensation Plan and since there was no increase in salary rates nor new benefits grant-

ed, presidential approval is not required.

"I want to assure the public that the grant of step increments in 2018 was proper, done according to the right process and, most importantly, was not excessive," Del Rosario said in a statement on Wednesday.

"We have only adjusted the salaries of Pag-IBIG Fund officers and employees to be, more or less, on the same level of SSL4 (Salary Standardization Law 4), which is currently being received by employees of other government institutions. We would like to assure all, our members in particular, that we continue to adhere to the directive of President Rodrigo Roa Duterte in safeguarding the workers' fund," he added.

Del Rosario said the Fund also adjusted the salary rates of all covered contractors and job order personnel to be comparable with positions in government and granted them a premium rate of 20 percent in compliance with the Joint Circular No. 1 issued in November 2018 by COA, the Civil Service Commission, and the Department of Bud-

get and Management.

In complying with the circular, the Pag-IBIG Fund Board agreed with the rationale of the three agencies calling for equal pay among permanent employees and job order personnel in government, pegged at the prevailing rates of the fourth tranche of the SSL4.

Del Rosario said the Pag-IBIG Fund Board had the same intention in granting the step increments to employees and officers of Pag-IBIG Fund last year, even while the step increments applied to the salaries of a majority of its employees still resulted to a lower rate than the prevailing rates of the third tranche of the SSL4.

Pag-IBIG Fund CEO Acmad Rizaldy Moti also clarified that the agency's Board went through all the requisite processes and ensured that all conditions were met prior to the granting of the step increments.

"The Board considered all bases when the step increments were granted in 2018. The intention behind the grant of step increments under the Compensation Plan of Pag-IBIG Fund was not to raise the salaries of officers and employees -- but rather to maintain the purchasing power and value that they had in 2009 or 10 years ago when the Fund's Compensation Plan was first

adopted," Moti said.

He stressed that the granting of the step increments last year was long overdue, saying the decade-old compensation plan was no longer competitive to attract personnel that will allow the Fund to serve its growing membership and their increasing needs.

The salaries of Pag-IBIG Fund employees remained at the same level as it was in 2009, except for a one-step increment in 2013.

"We have to put things into context here. The step increments were granted, in strict accordance with existing rules, to employees of the Pag-IBIG Fund who are occupying permanent positions. The members of the Board who approved the grant, which include myself, were not covered by the step increments because we are presidential appointees. The grant went to career employees and officers who worked hard in order to achieve record-breaking feats and made 2018 the best year ever for Pag-IBIG Fund," Moti said.

Pag-IBIG Fund had a banner-year in 2018 as it achieved highest-ever figures in net income, housing loan takeout, housing loan payment collections, member savings collections and total amount of dividend earnings for its members. **(PR)**

**CALAMBA CITY, Laguna (PIA)** — Together with their parents, children engaged in child labor from the different parts of Calabarzon (Cavite, Laguna, Batangas, Rizal, and Quezon) were gathered for a one-day treat of fun, games, and hope as the Department of Labor and Employment (DOLE) Region IV-A celebrates World Day Against Child Labor.

Labor and Employment Regional Focal Person for Child Labor Ritchmon Ray Jose told PIA that the celebration is in support to the International Labor Organization and as response to the call of curbing child labor in the country.

Curbing child labor Asked about the commitment of DOLE toward ending child labor in the region, Jose told PIA that the DOLE Region IV-A has partnered with various government agencies and private institutions to eliminate child labor in the region.

# SC JUNKS PLEAS VS. MARTIAL LAW EXTENSION WITH FINALITY

**MANILA --** The Supreme Court (SC) denied for being moot the motions for reconsideration filed by parties in four cases which questioned the validity of a resolution by both houses of Congress approving the extension of the decla-

ration of martial law and the suspension of the writ of habeas corpus in Mindanao.

In a resolution dated June 4 and made public Tuesday, the SC en banc through Clerk of Court Edgardo O. Aricheta said "the motion for reconsideration

and the urgent motion for reconsideration both dated February 27, 2018 are hereby denied with finality."

"No further pleadings or motions will be entertained," the court said, noting that while the case

questioning the validity of Resolution of Both Houses (RBH) No. 4 was pending, the Senate and the House of Representatives already adopted RBH No. 6 which again extended the declaration of martial law and the sus-

pension of the privilege of the writ of habeas corpus in the whole of Mindanao for another period of one year until December 31, 2019.

The validity of the more recent joint resolution had already been upheld by the Court, which ruled that a state of rebellion continued to persist and that public safety required the further extension of martial law in Mindanao.

The motions for reconsideration had been filed in four cases seeking the reversal and setting aside of the Court which found sufficient bases for the issuance of RBH No. 4 and accordingly, declared it constitutional.

President Rodrigo Duterte issued Proclamation No. 216 in 2017 which declared martial law and suspended

the privilege of the writ of habeas corpus in Mindanao following the Marawi siege.

As required by the Constitution, Congress issued RBH No. 4 which extended the effects of the proclamation for a period of one year from January 1 to December 31, 2018.

It is this RBH which the petitioners initially questioned before the High Court even as another resolution, RBH No. 6 was subsequently issued by lawmakers extended the proclamation anew until the end of 2019.

Among the petitioners in the dismissed cases are Rep. Edcel Lagman, Christian S. Monsod, Loretta Rosales and Eufemia Cullamat. (PNA)

## 27 suspects nabbed in Bulacan anti-drug ops

**CAMP ALEJO SANTOS, Bulacan** -- Twenty-seven drug suspects were arrested in separate anti-illegal drug operations conducted by Bulacan police Wednesday and early morning of Thursday.

Col. Chito G. Bersaluna, director of the Bulacan Police Provincial Office, said that four of those arrested are on the drug watch list in their respective areas.

He identified them as Rosanta Avila and Jaime Villaluz, both included in the Barangay Anti-Drug Abuse Council Drug (BADAC) watch list of Baliwag; Jhomel Apostle, included in the BADAC drug watch list and former surrenderer and reformist in the "Oplan Tokhang" of Obando; and Ian Del Rosario, included in the drug watch list of San Ildefonso.

Also arrested were Rodrigo Guevarra Jr., Arlo Del Rosario, Brando Riano, Evelyn Peru, Jerzon Villamor, Ruel Custodio, Vergel Valencia, Willy Salas, Val Angkangkol, Jayson Arseno, Noel Sanchez, Joelito Morada, Ricky Victolero, Willy Dela Cruz, Ryan Cruz, Julius Ubongan, John Mark Quisto, Ju-

lius Salazar, Adulraman Barambang, Reymark Obispado, Markson Luciano, Raphael Gulinao, and a 17-year-old boy.

"Our anti-illegal drug operatives confiscated 66 plastic sachets of suspected shabu, marked money and assorted drug paraphernalia during the different buy-bust operations conducted in the towns of Baliwag, Obando, San Ildefonso, Santa Maria and in the cities of Malolos and San Jose del Monte," Bersaluna said.

He said the arrested suspects and seized pieces of evidence were brought to Bulacan Crime Laboratory Office for appropriate examination.

Criminal charges against the arrested suspects are now being prepared for filing in court, he added.

Meanwhile, the Philippine Drugs Enforcement Agency, Department of the Interior and Local Government, Malolos City PNP and City Anti-Drug Abuse Council (CADAC) commended Barangay Sto. Niño in the City of Malolos for being declared as "drug-free".

The barangay is the first in the province of Bulacan to be cleared of illegal drugs. (PNA)

## Campaign vs. illegal drugs spares no one: Calabarzon top cop

**CAMP GEN. VICENTE LIM, Calamba City**-- The police regional head of Calabarzon on Thursday said the campaign against illegal drugs spares no one, following the arrest of two village officials in Bacoor City who were tagged high-value targets (HVTs) in the illegal drugs trade.

In a press conference, Police Regional Office-Calabarzon Director, Brig. Gen. Edward Carranza, said the "relentless" campaign against illegal drugs resulted in the arrest of a village councilor and a chief village tanod (security force) right at the village hall.

"We will continue to wage war against illegal drugs. No matter what your status in the society, until the last pushers in all corners of CALABARZON region, be placed behind bars while giving

chances to those users whom we considered as victims," Carranza said.

The two arrested drug suspects were identified as Aniban village councilor Dante Junio Morales alias "Bok," 50, who is tagged by Bacoor police as newly street-level target listed pusher, and Miguel Dela Cruz Piedad alias "Don Migs," 53, a village security force executive officer, or chief of village watchmen.

The two were arrested in a buy-bust operation at Barangay Aniban 5 Hall, around 10 p.m. on June 15. Operatives seized drug paraphernalia, two PHP100 marked bills and the suspected shabu weighing around 0.89 grams valued at PHP6,052.

"Huwag kayong mag-apologize sa police, sa taumbayan kayo mananagot. Hindi na kayo nahiya, mga barangay officials pa man din kayo (don't apologize to the police, you are accountable to the people. You should be ashamed because you are village officials)," Carranza told the drug suspects who apologized during the press conference.

Carranza said a surveillance video captured the village councilor sniffing shabu inside his office at the barangay hall where the drug transactions were held at least four times a day. Bacoor City chief of police Col. Vicente Cabatingan told the media the surveillance operations stemmed from tips from residents about the duo's illegal activities at the barangay hall.

"Actual ang surveillance footage (we have the actual surveillance footage) which showed Morales rolling up the tin foil like a tooter with the shabu on it and sniffed it, as it is their modus not to sell the item without first checking on it inside the barangay hall which is turned into his comfort zone," Cabatingan said.
