# PWD'S, SC NG CAVITE NAGPASALAMAT SA EPF NG SM CARES

**DUMALO** ang ilang may kapansanan (Persons With Disabilities o PWDs) at matatanda (Senior Citizens (SC) mula sa iba't ibang lugar sa Cavite sa idinaos na Emergency Preparedness Forum (EPF) 2019.

Ang naturang forum na batay sa inisyatibo ng SM Supermalls sa pamamagitan ng SM Cares ay ginanap nitong nakalipas na Hulyo 5 sa SM City Dasmariñas mula alas-10 ng umaga hanggang alas-12 ng tanghali.

Layunin nito na mabigyan ng kaukulang kaalaman ang mga may kapansanan at matatanda sa mga nararapat na gagawin kapag may panahon ng kalamidad katulad ng pagbabaha at lindol.

Ipinakita at itinuro naman ni Dr. Ted Esguerra,

resident rescue analyst ng ABS-CBN, sa mga SC at PWDs ang mga tama o dapat isinasagawa kapag nabiktima ng kung ano mang kalamidad. "Napakarami naming natutunan kung ano pala ang mga kailangang gagawin kapag may sakuna. Natutuhan namin na hindi pala dapat mag-panic dahil ito pala ang mas ikakapahamak. Kaya naman nagpapasalamat kami sa SM Cares sa ganitong programa nila," pahayag ng ilan sa mga PWDs at SC na nakapanayam.

Dagdag pa nila, ang kanilang mga natutunan sa forum ay maibahagi hindi lamang sa mga kaanak kundi maging sa mga kaibigan at iba pa.

"There are possibly a lot of unheard solutions that are appropriate for persons with disabilities. How that we have our subjects experts, Mr. Perez and Dr. Esguerra, closer to our communities. I am sure that many things will be brought to clarify. And from there, we can better plan what's best for us and our friends who may have physical or mental challenges," pahayag naman ni Engr. Bien Mateo, SM Cares Program Director for Persons With Disabilities.

## ATI-4A promotes organic agriculture in farm tour for media

**LUCENCA CITY**, Quezon (PIA)- Around 20 local media practitioners from Cavite and Quezon province attended the two day farm tour dubbed as "Activate: Linking Media in Promoting Organic Agriculture in CALABARZON" on June 24-25, 2019.

The farm tour for media was initiated by the Agricultural Training Institute (ATI) of the Department of Agriculture (DA)-4A which aims to promote organic agriculture in the provinces of Cavite, Laguna, Batangas, Rizal and Quezon.

Among the farms visited by the media in Cavite were Luntiang Republika Ecofarms in Alfonso, Cavite; Rerra Verde Ecofarm in Maragondon, Cavite; and Terra Verde Ecofarm also in Cavite while in Laguna, farms visited were Graco Farms in Pila, Laguna; Forest Wood Garden in San Pablo City; and Ato Belen's farm also in San Pablo City.

Eduardo Cleofe, owner of the two hectare Luntiang Republika Ecofarms shared his knowledge and expertise in operating his farm particularly in crops and livestock production including organic farming to the visiting media practitioners.

Cleofe also thanked other farm owners in promoting agri-sites in CALA-

BARZON.

Meanwhile, Mr. Joel Frago, owner of Forest Wood Garden farm in San Pablo City who promotes organic agriculture and agri-tourism also shared his knowledge and skills in operating their 'farm to table' concept which promotes culinary farm tourism. "We commit ourselves to natural farming practices and our mission is to build a community which produces safe and quality food for the people," Frago said.

Joel and his wife Myrna are also the owner of the Forest City restaurant in San Pablo City which sells organic food.

"With the hopes and vision to bring forest in every city, we would like to use the restaurant as a platform where we encourage people to eat natural healthy food," Frago said. Frago decided to resign from being an OFW for almost 12 years to becoming a farmer due to his interest in farming.

Meanwhile, other

frontline services of ATI includes training services, accreditation of extension service providers, certification of learning site for agriculture and school for practical agriculture, provision of extension grants and scholarship programs, provision of farm and business advisory services among others.

ATI-4A also support the initiatives of extension agencies to forge linkages with other agencies, to reach more clients and stakeholders, and address issues affecting the delivery of extension services.

The ATI-4A has accredited extension service providers, these are private groups composed of NGOs, people's organization and other private organizations currently doing agricultural training and extension work.

To help undertake such task, ATI also provides funds to ESPs for their training and extension activities for the clientele. (Ruel Orinday-PIA-Quezon)

## Tagaytay, 10 Cavite towns now drug cleared

**IMUS CITY**, Cavite -- Tagaytay City and 10 other Cavite towns are among local government units (LGUs) that have been cleared of illegal drugs since the provincial

police office has pursued its campaign against drugs, an official said Thursday.

In a report, Col. William Segun, Cavite Provincial Police Director, said 11 of the 23 Cavite towns and cities made their way to the list.

"We are still in the process and continue to conduct operations against illegal drugs in our province. I have day-to-day monitoring on each police station," Segun said in an interview.

The 10 towns include Naic, Alfonso, Indang, Amadeo, Baile, Magallanes, Maragondon, Mendez, Ternate and Noveleta.

Cavite City has only 36 out of its 84 barangays, while Rosario has seven out of 20 barangays that are cleared of the illegal drugs. Segun said other towns are still striving to be drug-cleared, including Carmona where its eight villages have been 57.14 percent drug-free.

Cities of Bacoor, Cavite, Dasmarinas, General Trias, Imus and Trece Martires; while towns of Rosario, Silang, Tanza, Carmona, Kawit and General Mariano Alvarez (GMA) remain as drug-affected localities.

Based on the provincial police record, around 382 out of 829 barangays in the province are cleared of illegal drugs. (PNA)

## SC JUNKS INVESTORS' PLEA VS. KAPA CLOSURE

**MANILA** -- The Supreme Court (SC) on Tuesday dismissed the petition filed by Rhema International Livelihood Foundation Inc., or Cifund, a key investor of the controversial Kapa Community International Ministry, seeking to stop the closure of the firm.

In a message to reporters, court spokesman Brian Keith Hosaka confirmed the suit filed last June 21 was dismissed by the court en banc Monday.

In a petition filed by Manuelito Traya and Roberto Apduhan, Sr., through lawyer Engracio Icasiano, they asked the High Court to stop the Securities and Exchanges Commission (SEC) from pursuing Kapa's closure.

They asked the court to expunge "Cifund from the list of the unregistered investment entities as it is an online platform of Rhema International Livelihood Foundation, Inc. and further declare that [cifund.org] is backed up with hard documents that support the legality of its business act and deeds, and Kapa to resume their religious activity."

It also sought that all respondents -- President Rodrigo Duterte and SEC Chairman Emilio Aquino be ordered "to pay the compensatory damages amounting to PHP3 billion for allegedly destroying Cifund -- an online platform project of [Rhema] and be dismissed from the office and the President be submitted for an impeachment proceedings for culpable violation of Article II, Section 6 and Article III known as the Bills of Rights of the Philippine Constitution."

The SEC, through Chairman Aquino, issued in February a cease and desist order after it received reports on the recruitment and solicitation activities of Kapa.

It has subsequently filed criminal charges against the group's founder, Joel Apolinario, and other officers. (PNA)

## CTA orders issuance of tax credit to car assembly firm

**MANILA** -- The Court of Tax Appeals (CTA) has ruled in favor of a petition filed by a local car assembler and ordered the issuance of a tax credit certificate (TCC) to the company.

In a 16-page decision dated June 21 and released to media on Wednesday, the tax court, through Associate Justice Catherine Triunfante-Manahan, granted the suit filed by Santa Rosa, Laguna-based Univation Motor Phils. for PHP5.4 million representing its excess and unutilized creditable withholding taxes (CWT).

Associate Justice Juanito Castañeda Jr. concurred in the decision.

In business since 1982, the company has been assembling Nissan Almera, Nissan Grand Livina and Nissan X-Trail CVT for Nissan Philippines Inc. (NPI) since 2014.

## PRRD asks courts to stop issuing injunctions for criminal cases

**MANILA** -- President Rodrigo R. Duterte on Tuesday night discouraged courts from issuing injunctions for criminal cases.

Duterte, a former prosecutor, said that "there has to be not only a semblance, a clear and convincing evidence" before an injunction is issued.

"Itong mga korte minsan (These courts). I hope you would stop the practice of issuing injunctions, lalo na sa mga kasongcriminal (especially for criminal cases)," Duterte said during his speech at the 72nd anniversary of the Philippine Air Force at Villamor Air Base in Pasay City. (PNA)

"Do not do that. Do not hurry up things because I know it is always, pera-pera 'yan (money involved)," he added.

Duterte, meanwhile, pointed out that "injunctions are really for free".

"Either stopping or prohibiting a government entity or persons from doing it or a mandamus compelling us to do something which we think are really, really very wrong," Duterte said.

An injunction is a court order requiring a person to do or cease from doing a specific action while a mandamus is a court order requiring a person to properly fulfill official duties. (PNA)

## 2ID ARMY HOSPITAL GETS P1.5-M ANTI-DENGUE SUPPLIES

**CAMP GEN. CAPINPIN, Tanay, Rizal** — The Army Station Hospital of the 2nd Infantry Division, Philippine Army here received some PHP1.5 million worth of anti-dengue supplies and protective equipment from the Department of Health (DOH) regional office in Calabarzon on Tuesday.

DOH-Calabarzon Regional Director Dr. Eduardo Janairo, along with Regional Communicable Disease Control Cluster Head, Dr. Mara Elena Gonzales, and Regional Dengue Prevention and Control Program Coordinator, Jomell Mojica, spearheaded the turn-over of anti-dengue and other vector control supplies to Army Station Hospital commanding officer, Col. Armando Lacanlao, and hospital staff.

"We have included all sectors including military camps in our efforts to lessen and eliminate dengue in the community. We have to ensure everyone including our uniformed personnel, soldiers are safe and protected against mosquito bites that is why we have provided vector control supplies," Janairo said.

Janairo, together with Lacanlao, DOH officials and hospital staff also led the ceremonial installation of the anti-dengue olyset nets as window screens at

the army hospital.

"The distribution and installation of Olyset treated nets inside the camp including the hospital is accompanied with the regular anti-dengue misting and clean-up operations. The mosquito nets are embedded with permethrin, which will provide (a) five-year protection from mosquitoes and other insects," he added.

DOH turned over the assorted anti-dengue supplies comprised of around 150 rolls of olyset nets worth PHP1.2 million; some 500 insecticide-treated bed nets worth PHP222,500; two spray cans for residual spraying at PHP28,776; five boxes of insecticides for residual spraying worth PHP41,250 and personal protective equipment (PPE) amounting to PHP6,800.

"We shall continue to support our military personnel in the prevention and control of vector-borne diseases that may affect their health and well-being in the performance of their functions and duties for the preservation and security of our country," Janairo assured.

He emphasized the need for preventive measures as best protection against dengue following reports from the Regional Epidemiology and Surveillance Unit (RESU), which recorded a total

of 9,669 dengue cases this year, indicating a 10 percent increase from last year's 8,825 cases during the assessed period.

RESU also reported that the age of the dengue cases ranged from one year to 66-year-old and around 39 deaths were already recorded.

Most affected are males with a total of 5,062 or 53 percent while female cases number around 4,543 or 47 percent.

According to the DOH Calabarzon, Cavite recorded the highest number of cases with 2,651 followed by Batangas with 2,123; Laguna - 1,966; Quezon - 1,653 and Rizal - 1,276.

Calabarzon towns and cities having the highest number of dengue cases include Dasmariñas City, Cavite with 567; Calamba City, Laguna - 457; Lipa City, Batangas - 427; Batangas City - 422; Bacoor City, Cavite - 360; Antipolo City, Rizal - 355; Lopez, Quezon - 354; and Cabuyao City, Laguna with 310. ## Bulacan guv pushes 'people first' policy, reforms at Capitol

"We thank him for inhibiting for reasons that he knows already all the facts of the case because of the West Philippine Sea Arbitration as part of the legal team. It's just right he's inhibiting. I agree with him," Calida told reporters.

Among the substantive issues ordered by the court to

be taken up by the parties is whether the issuance of a writ of kalikasan is the proper remedy for the enforcement of Philippine environmental laws against foreign nationals in the shoals and reefs, or is the remedy political or diplomatic in nature.

Among the procedural issues the parties have been asked to take up also include questions of whether the petitioners violated the doctrine of the hierarchy of courts when they filed the petition directly with the SC, instead of the Court of Appeals, which has concurrent jurisdiction over writs of kalikasan.

The parties will also take up whether the petitioners failed to exhaust administrative remedies when they failed to give notice to re-

spondents, as required by Sec. 138 of the Philippine Fisheries Code, before the filing of the petition; and whether petitioners failed to comply with the rules of procedure for environmental cases considering that several petitioners failed to sign the verification which forms part of the suit.

Ultimately, the parties argued before the court whether the petitioners sufficiently discharged their burden of proof and evidence to support the grounds for their plea for a writ.

Aside from the Integrated Bar of the Philippines, the other petitioners in the case are individual members of the Kalayaan Palawan Farmers and Fisherfolk Association. (PNA)
