TANZA VACCINATION EFFORTS INOCULATE 9.4% OF TARGET RESIDENTS

TRECE MARTIRES CITY, Cavite (PIA) --More than 17K residents or 9.4 percent of the total 70 percent target of the Municipality of Tanza's population were inoculated thru the local government's vaccination efforts.

Tanza Rural Health Officer Dr. Ruth Punzalan said about 7,900 residents had received the 1st dose of the Sinovac while 4,600 received the 1st dose of the AstraZeneca vaccine.

Dr. Punzalan added there were more than 30 doses of AstraZeneca vaccines remaining that were reserved for the 2nd dose beneficiaries. Pfizer vaccines were already administered to intended beneficiaries such as OFWs.

Meanwhile, the ResBakuna on Wheels inoculated hundreds of tourism industry workers who are employed in different resorts and hotels in the municipality.

Under the IATF directive, said workers/personnel are part of the A1 priority group and considered as frontliners.

The LGU had already commenced inoculation of the A4 priority group and targets to inoculate 100 essential workers a day but limits the immunization to those aged 40-59 years said Dr. Čeleste Aida Halili, Tanza RHU Medical Officer.

Members of the A1 to A3 priority groups remain a priority with the LGU's vaccination program since vaccine supply is limited and dependent on the quantity provided by the national government.

Dr. Halili appealed to the members of the A2 and A3, "To all those belonging to the A3 priority group - Persons with Comorbidities, kindly bring along with you your prescription or medical certificate to make the process prior to vaccination easier. If you have maintenance medications we advise you to take it before proceeding to the vaccination site to stabilize vour blood pressure."

RHU officials continue to encourage the townsfolk to register for the vaccination and receive the protection against the CoViD-19 vi-

rus. Dr. Punzalan assured the common side effects that may occur after vaccination are normal such as pain in the shoulder, occasional fever, body pains, and nausea.

She highly advised those who may experience adverse effects to inform the RHU medical staff to be able to evaluate the condition and record the incident.

Punzalan said, "Still the benefits of the vaccination outweigh the risks of adverse effects."

The petitioner had been those charged among by the Ombudsman with grave misconduct, gross dishonesty, and conduct prejudicial to the best interest of the service and had been placed under preventive suspension last October 26.

Timbreza claimed before the Ombudsman that the copy of the complaint did not contain any supporting affidavits or documents and should no longer be used against her. Last March, the Ombudsman subsequently furnished her a copy of the said supporting affidavits and documents.

84,000 seedlings to be planted in UMRBPL under a Tripartite Agreement in Rizal

A tripartite agreement between DENR CALABAR-ZON, WawaJVCo, Inc and Tulungan sa Kabuhayan ng Calawis Inc. for the management. maintenance. and rehabilitation of 135 hectares of forest land at Mt. Dumiri, Sitio Apia, Brgy. Calawis, Antipolo, Rizal was signed this month at the Provincial Environment and Natural Resources Office - Rizal.

DENR CALABARZON Regional Executive Director Nilo B. Tamoria recognized that the tripartite agreement is a milestone for the implementation of National Greening Program. He shared that the Region has more or less 550,000 hectares of forest land from which 26,000 hectares are in UMRBPL. "Kung tutuusin 'yong 135 hectares MOA natin ng graduated NGP site ay tuldok lamang sa forest land sa Upper Marikina, pero sabi nga 'yong tuldok ay nakakapuwing kaya malaking bagay po ang isinagawa nating aktibidad ngayon dahil po ang NGP ay mayroon lamang hangganan ang pondo na ibinibigay ng pamahalaan. Dito po pumapasok ang tulong ng iba't-ibang sektor. Matapos po ang tatlong taon ay inaasahan po sana natin na tuluy-tuloy na ang paglago ng ating pananim at kagubatan at umaani na ng produkto ang people's organization," RED Tamoria said.

In-Charge - PENR Officer of Rizal For. Ernesto Diso explained that the agreement was sealed for the reforestation efforts in Sitio Apia, Brgy. Calawis, Antipolo City within the 200hectare indigenous species plantation established under NGP CY 2012, and is within the Upper Marikina River Basin Protected Landscape. "Only 135 ha of the 200-hectare 2012 NGP plantation will be adopted by our partners for maintenance and protection purposes which is more or less equivalent to 70,000 replacement seedlings. Hopefully after three years ay makita natin na

yumabong na ulit ang ating kabundukan," For. Diso said.

Meanwhile, Mr. Karl Zapanta, Government Affairs and Public Relations Head of WawaJVCo, pledged to deliver and abide by all the responsibilities and commitment reflected in the MOA. In his speech he said, "in our support to the National Greening Program, instead of planting only 70,000 seedlings, we will be planting 84,000 seedlings.'

Further, continuous monitoring of the progress in the adopted NGP site will be held by the DENR CALA-BARZON through its Management Services.

DENR CALABARZON Assistant Regional Director for Technical Services Alfredo C. Palencia also shared the strategies of DENR to ensure higher survival rate of seedlings planted. "Yong mga previously planted NGP sites na tinatawag nating graduated NGP mula 2011 up to 2016, ito po ay inaassess ng ating tanggapan para muling balikan, taniman, alagaan, at i-maintain." He also challenged the partner People's Organization to strive to make the adopted site a model NGP area. In doing so, he assured the support of the DENR from its Provincial to its Regional Office.

Ms. Virginia Bañaga, Chairperson of the Tulungan sa Kabuhayan ng Calawis a People's Organization within the identified area, expressed their gratitude to DENR and WawaJVCo for providing a means of livelihood for their organization. SC DISMISSES CASE AGAINST SHELVED POC PRIVATIZATION

MANILA – The Supreme Court (SC) has declared moot a petition filed seven years ago questioning the privatization of the Philippine Orthopedic Center (POC) after the plan was subsequently scuttled.

In its 12-page decision written by Associate Justice Ramon Paul Hernando and published online re-cently, SC said it "finds that the petition has indeed become moot and academic by virtue of the supervening termination of the BOT (Build-Operate-Transfer) agreement that transpired after the filing of the petition".

The suit was filed in 2014 by patients and employees questioning the planned privatization of the hospital, claiming it violates constitutionally guaranteed rights to health care and equitable access to health services.

The privatization would have been carried out under a 25-year BOT scheme with Megawide Construction Corporation and World Citi Medical Center. The POC, located along

Banawe St. in Quezon City, was planned for relocation to the National Kidney and Transplant Institute compound on East Avenue and finished in 2017.

In 2015, the private consortium served a notice of ter-mination of the P5.7-billion BOT agreement because of the Department of Health's delayed compliance with the agreed delivery of the project site through a cer-tificate of possession. The deal would have al-

lowed the government to relinquish its duty and responsibility to provide and ensure basic social service



MANILA – The Supreme Court (SC) has ruled to partly grant the plea for judicial clemency filed by former Sandiganbayan Associate Justice Gregory Ong, who was dismissed from the service seven years ago.

In its ruling recently published online, the SC en banc said that as a measure of mercy, it is granting Ong's retirement benefits but less than two-thirds of his lump sum as penalty.

His disqualification from reemployment in any branch, agency, or instrumentality of the government, including government-owned or controlled corporations, was also lifted.

"Considering the lapse of more than five years and subject to the usual clearances, Gregory Ong is not entitled to his full pension," the court ruled.

The court also noted Ong's current plight.

curred, which now requires him to undergo an operation and possible chemotherapy.

"Since his dismissal, he claims to have been having a difficult medical and financial state, and if he will be allowed to work again for the government, he can use his remaining productive years to redeem himself and to be of service to the public," the court said. In September 2014, the SC voted 8-5-2 to dismiss Ong from the service over his links with alleged pork barrel scam mastermind Janet Lim-Napoles.

The year before, during a Senate Blue Ribbon Committee hearing, whistleblower Benhur Luy testified that Ong had visited Napoles in her office.

The SC said the visit was grossly improper and in violation of the New Code of Judicial Conduct as "a judge must not only be impartial but also appear to be impartial."

"Fraternizing with litigants tarnishes this appearance," the SC ruled then.

In 2019, Ong pleaded for judicial clemency and asked that his retirement benefits be restored and that the ban on his reemployment in the government be lifted.

Testimonies from retired SC Justice Jose Perez, former Integrated Bar of the Philippines president Vicente Joyas, and Antipolo priest Fr. Alexander Balatbat affirmed Ong's uprightness.

"Remorse and reformation must reflect how the claimant has redeemed moral aptitude by clearly understanding the gravity and consequences of the conduct," the SC said in partially granting Ong's petition. (PNA)

7 BARANGAYS IN TANAUAN, BATANGAS ORIENTED ON WASTE MANAGEMENT LAWS

THE barangay officials, selected residents, and members of various organizations and associations from seven barangays in Tanauan, Batangas were oriented on laws pertaining to solid waste and wastewater management through the Daluynungan or "Flow of Knowledge" activities of the Department of Environment and Natural Resources (DENR)-Manila Bay Site Coordinating Management Office (MBSCMO)-4.

The said barangays include Brgys. Ulango, Balele, Janopol Oriental, Santor, Darasa, Poblacion V, and Pantay Bata. In view of the pandemic, the information drive was conducted through video conference with a mix of face-to-face sessions with a limited number of participants at the respective barangay halls and covered courts. The webinar focused on the discussion of the salient provisions of the Republic Act Nos. 9003 and

9275 otherwise known as the "Ecological Solid Waste Management Act of 2000" and "Clean Water Act of 2004", respectively.

It was emphasized in the webinar that the entire city of Tanauan is connected to the Manila Bay through its water system, particularly, the San Juan River. Results of the water quality monitoring conducted by the Environmental Management Bureau Calabarzon along the upstream (Brgy. San Lucas, Lipa City), midstream (Brgy. Darasa, Tanauan City), and downstream (First Philippine Industrial Park, Sto. Tomas City) of San Juan River last March 2021 showed that the fecal coliform count in the said river increased compared to that of the monitoring conducted in January 2021 and February 2021.

Queenie Borero, Project Support Staff of DENR-MBSCMO4, stressed that the LGUs should share the responsibility in the man-

agement and improvement of water quality within their territorial jurisdiction in accordance with Section 20 of the Clean Water Act. She added that each LGU, through the passage of an ordinance, should appropriate the necessary land for the construction of sewage and/or septage treatment facilities in accordance with the Local Government Code.

Borero explained that proper sewage and septage systems allow for the treatment of wastewater before it flows into the river. "Proper maintenance of sewage systems prevents waterborne diseases from being spread. It is also vital for protecting water resources," she said.

Christian Libang, Project Support Staff of DENR -MB-SCMO4, shared that the entire city of Tanauan has a daily waste generation of P167,199.42 kilograms, per data from Tanauan City Environment and Natural Resources Office. Thus, he emphasized to the barangay government units the importance of applying the "4Rs" in waste management such as Refuse (the use of single-use plastics), Reduce (the amount of unnecessary packaging), Reuse, and Recycle to lessen the waste going to the sanitary landfills. He explained further the system in the collection and disposal of different kinds of waste. MBSCMO4 also provided a brief training on composting and vertical gardening. DENR-MBSCMO4 Deputy Coordinator Cynthia Rozaldo expressed her gratitude to the Local Government and hopes that the strengthened partnership will be beneficial to achieve their goal of having a cleaner, healthier and safer environment for all. DENR-MBSCMO4 will hold Daluynungan activities in four more barangays in the coming months.

PORT OF NAIA PERFORMS AMID 2021 CHALLENGES

As trade and business sectors continue to face various challenges halfway through 2021, the Bureau of Customs Port of NAIA elevates efforts and initiatives to perform its mandate and mission of improving revenue collection, strengthening border protection, and enhancing trade facilitation. **Postive Midyear Collection**

The Port of NAIA was able to contribute P18.556 billion in duties and taxes, exceeding its P18.485 billion midyear collection target by P71.557 million or +0.4%, in spite of the effects of the COVID-19 pandemic to the overall trade environment. For June 2021, the Port posted a surplus of P224.886 million or +8% as it collected P3.037 billion against its target of P2.812 billion.

Strengthened border protection

In the key area of border protection, an estimated P45M-worth of Illegal Drugs from 33 drug busts from January to June 2021, such as Ecstasy Ketamine, Kush, Liquid Marijuana, and Shabu, which were detrimental to the wellbeing and safety of the public, were intercepted. Likewise, attempts of wildlife smuggling of poisonous spiders, tarantulas, snakes and even marine animals. were detected and seized by the Port of NAIA at the borders.

Belgica on the Ease of Doing Business efforts initiatives , and from Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) Testing Czar Secretary Vivencio 'Vince' Bringas Dizon on the expeditious facilitation and the flawless port management of the COVID-19 Vaccine importations halfway through 2021.

DHSUD readies nearly 1K shelters for Taal-affected families

QUEZON CITY --The Department of Human Settlements and Urban Development (DHSUD), thru its key shelter agency National Housing Authority (NHA), has readied 950 housing units for families affected by the ongoing activities of Taal Volcano.

DHSUD Secretary Eduardo Del Rosario said that there are currently 950 housing units in the towns of Sariaya and Tiaong both in Quezon province, being offered by the NHA.

"These housing units are readily available to serve as temporary or permanent shelters for those affected by the Taal volcano eruption," Secretary Del Rosario said.

"The Office of Civil Defense, the Department of Interior and Local Government, as well as the NHA, have already inspected the housing units and they can be utilized whenever the need arises," the housing czar added.

The DHSUD chief likewise announced that the Social Housing Finance Corporation, another attached key shelter agency of the department, will provide assistance to families within affected areas through its Community Mortgage Program.

"The government, through DHSUD, is always ready to

provide necessary assistance to families affected by disasters. It is part of the Department's mandate to help relocate and provide decent housing to those impacted by calamities," Secretary Del Rosario said.

Meanwhile, DHSUD-Regional Office 4A Director Jann Roby Otero said that in coordination with his NHA counterpart, they have started preparation for the provision of temporary electricity and water supply in the Sariaya and Tiaong sites just in case they will be utilized.

Otero added that profiling of houses and intended beneficiary families are underway.

Prior to the latest eruption of Taal Volcano, DHSUD has been actively engaging local government units affected by the January 2020 eruption.

In fact, a memorandum of agreement was signed with the Mataasnakahoy LGU for the establishment of an evacuation center. Two more similar MOAs are in the pipeline with two other Batangas LGUs.

DHSUD also allotted funds for other LGUs affected by the Taal Volcano eruption in 2020 to assist them in relocating their constituents out of harm's way.



Complaints for Unlawful Importation and Misdeclaration THE Bureau of Customs Bureau's Action Team against Smugglers recently filed two (2) criminal complaints before the Department of Justice (DOJ) against Green Nature Alliance Venture Corp. and Humility Trading and their signing customs brokers for the alleged unlawful importation and misdeclaration of smuggled goods.

Nature Alliance Green Venture Corp. and its customs broker were charged for alleged misdeclaration of 540 boxes of Marvels cigarettes and 500 boxes of Mighty cigarettes with a value of P56,374,355.20. This is a violation of the Customs Modernization and Tariff Act (CMTA); Customs Memorandum Order No. 20-2006; Tax Reform Acceleration and Inclusion Law; National Tobacco Administration (NTA) Board 079-2005: Resolution National Tobacco Memorandum Circular No. 03,

s. 2004; and the Revised Penal Code, as amended. The violation was committed on February 10, 2021 at the Manila International

Container Port (MICP). HumilityPR Trading and its customs broker are also facing criminal complaint for their involvement in the alleged unlawful importation and misdeclaration of 79 bales of used bed sheets and 229 bales of used clothing last October 13, 2020 at the Port of Cagayan de Oro. The respondents purportedly violated the CMTA; Republic Act No. 4653 otherwise known "An Act to Safeguard as the Health of the People and Maintain the Dignity of the Nation by Declaring it a National Policy to Prohibit the Commercial Importation of Textile Articles Commonly Known as Used Clothing and Rags"; and the Revised Penal Code, as amended.
