### DENR HOLDS CONSULTATION TO INVOLVE CAVITE FISHERFOLK IN THE REHABILITATION OF MANILA BAY

The Department of Environment and Natural Resources (DENR) Secretary Roy A. Cimatu directed its regional office, DENR CALABAR-ZON to regulate illegal fishing structures along Manila Bay and its tributaries. The regional office immediately organized a consultation meeting with the fisherfolks, baklad and sapra operators, and mussel growers of Cavite City, Noveleta and Kawit, Cavite on July 30, 2021. The meeting was particularly conducted to discuss with the fisherfolks as well as the LGUs the issue regarding the bamboo poles recently observed floating on Manila Bay, which were later on found out to be parts of the fishing structures illegally installed on Cavite waters. During another consultation meeting with fisherfolks of Bacoor City held on July 9, 2021 which was presided by DENR CALABARZON Regional Executive Director Nilo B. Tamoria, it was raised that the said bamboo poles were washed out to the bay by the recent typhoons.

Per data from the respective LGUs, there are 351 tahungan operators in Bacoor City, 26 illegallyinstalled bamboo fish traps in Cavite City, and 23 pond-type operators in Kawit. The LGU-Noveleta, on the other hand, released a certification stating that the same has not issued any permit to any fish pens, fish cages, and sapra operations and that all such fishing activities observed within their area of responsibility are considered unauthorized and illegal.

The said LGUs admit that some of the fishing structures installed within their respective municipal waters are made of bamboo. Moreover, some fisherfolk said they are aware that

the ruined bamboo-made fish pens, fish cages, sapra, tahungan, and other aquaculture structures become wastes on water bodies.

During the consultation meeting, the fisherfolk were encouraged to shift to the longline method of growing mussels, a new technology being promoted by BFAR. Kawit Municipal Agriculture Officer, Ronaldo Lontoc stated that the said type of fishing is fairly expensive, however, is environment-friendly as it deviates from using bamboo and other materials which could pollute the water bodies. He said, in their area, they will oblige the big fishing operators to shift to longline fishing and that they will provide assistance to the smallscale fisherfolks.

The said meeting was attended by some officials and staff from DENR Calabarzon and PENRO Cavite respectively led by Assistant Regional Director (ARD) for Technical Services, Alfredo Palencia and PENR Officer Ronita Unlayao, Bureau of Fisheries and Aquatic Resources (BFAR) Calabarzon, Philippine Navy, and concerned local government units through its City and Municipal Agriculture Officers and City and Municipal Environment and Natural Resources Officers.

Director Tamoria urged the fisherfolks of Cavite to practice environmentfriendly fishing methods to promote responsible use of the marine resources not only for their generation but also for the generations to come. ARD Palencia, on the other hand, asked for help from fisherfolk to accomplish the objectives of the Manila Bay Rehabilitation Program by being sensible in their fishing activities, especially in managing their wastes.

### PRRD signs law expanding jurisdiction of RTCs, MTCs

MANILA – President Rodrigo Duterte has signed a law further expanding the jurisdiction of the Metropolitan Trial Courts, Municipal Trial Courts, and Municipal Circuit Trial Courts to address the delay in the disposition of cases due to overloading of cases assigned per judge.

Republic Act (RA) 11576 amends Section 19 of the Judiciary Reorganization Act of 1980 or the Batas Pambansa Bldg. 129.

One of the amendments included in the law is the increase in the jurisdictional amount under the regional trial courts (RTCs) in all civil actions involving the title to, or possession of, real property from PHP20,000 (PHP50,000 in Metro Manila) to PHP400,000.

The RTCs shall also have jurisdictional supervision "in all matters of probate, both testate and intestate, where the gross value of the estate exceeds PHP2 million" from PHP100,000 to PHP200,000.

RA 11576 further delegates to the Supreme Court (SC) the power to further increase or decrease the jurisdictional threshold of the first and second level courts in line with the SC's power of administrative supervision over all courts.

"The Supreme Court, unless otherwise provided by law, without prejudice, however, on the part of the Congress to adjust the amounts when the circumstances so warrant, may adjust the jurisdictional amount for first and second level courts to: (1) reflect the extraordinary supervening inflation or deflation of currency; (2) reflect change in the land valuation; or (3) maintain the proportion of caseload between first and second level courts," the law read. The provisions of RA 11576 shall apply prospectively to all civil cases filed in the second-level courts and first-level courts from the date of its effectivity thereof.

If any provision in the act is declared unconstitutional, the same shall not affect the validity and effectivity of the other provisions thereof.

All laws, decrees, and or-

ders inconsistent with the provisions of this act shall be considered amended or modified accordingly.

RA 11576 was passed by the Senate as Senate Bill 1886 on Feb. 8, 2021 and adopted by the House of Representatives as an amendment to House Bill 6589 on May 19, 2021.

Senator Richard Gordon, chairman of the Committee on Justice and Human Rights and sponsor of SB 1886, expressed hope the law would unclog the court dockets of the RTCs, and speed up the disposition of cases.

Gordon said there are so many cases to be heard but very few judges are deciding on the cases. (PNA)

### **Tutok Senior initiative to keep SCs safe vs. Delta variants**

Imus City, Cavite (PIA)

— In the wake of the dreaded CoViD-19 Delta variant that had been detected in the country, the city government of Imus launched the 'Tutok Senior' vaccination initiative that will protect the Senior Citizens of the city.

On Wednesday, July 21, 2021, the first of the two-day Tutok Senior vaccination activity was conducted at the Imus Sports Complex and at the Ospital ng Imus amidst the inclement weather brought by Typhoon Fabian and the

South Monsoon rains. Though the turn-out of the SCs was lower than expected for the target 1K local elderly residents, the eagerness to get the Johnson and Johnson Covid-19 vaccine jabs improved the number of vaccinations on the second day.

With news of the detection of two (2) cases of the Delta variants in the province, the LGU came up with the 'Tutok Senior 2.0' that aims to lessen the chances of infection of the SCs thru the convenience of bringing the government services to the barangays.

Thus, the said program was simultaneously conducted in Woodland Village, and Green Estate subdivision in Barangay Malagasang on Monday, July 26.

About 300 elderly residents from these villages received their Senior Citizen Identification cards, cash subsidy from the LGU, and the Janssen Covid-19 vaccine jabs to those who wish to get vaccinated.

"We offer these programs to ensure the safety of our grandparents as we provide their needs during the ongoing pandemic especially in the wake of the threat of the dreaded Delta variant," said Mayor Emmanuel Maliksi.

The Imus LGU had already administered 115,042 doses of the CoViD-19 vaccines as of July 24, 2021 with a total of 713, 913 given for the 1st jab and 41,129 finished the 2nd dose.

The city's vaccination sites: Imus Sport Complex, Ospital ng Imus, Maharlika Elementary School, and Drive-Thru vaccination site in Robinson's Place had resumed operations as soon as the weather improved. (Ruel Francisco/Emmanuel Maliksi FB page)

#### **LGU'S BEST PRACTICES** AID DEVELOPMENT AND **REHABILITATION OF PWDS**

Trece Martires. Cavite (PIA) - The Local Government of Carmona thru its Persons With Disabilities Office (PDAO) had launched several programs and projects that aim to promote the rights, and care for the development of the members of this sector of society.

One of these programs is the Comprehensive Approach Responsive Education and Rehabilitation Program (CARER), an educational and rehabilitation program launched in 2008 that aims to develop the personality, and the academic and adaptive skills of individuals with disabilities to help them pursue their studies from kindergarten to college.

The students may be placed in a Center-based program or a Normalization program, whichever is suitable to the needs, and is dependent on the diagnosis of the developmental pediatric doctors or government doctors.

However, with the restrictions due to the ongoing pandemic, online tutorial classes had been adapted for the 90 learners currently enrolled in the program.

PDAO launched a follow through program, the Disability Inclusive Employment for Persons with Disability that helps the CARER graduates to land a job thru job coaching, training, and monitoring.

One of the basic services that the PDAO extends to the PWD sector is the physical recovery or development of the disabled.

This had been a big challenge to the officials of the PDAO with the restriction for physical contact, and the danger the CoViD-19 may bring the PWDs.

PDAO, with partnership and coordination with the De La Salle Medical and Health Science Institute (DLSMHSI) launched the TeleRehabilitation program on July 2020.

The said program gives free occupational, physical, and speech therapy thru exercises taught by the intern therapists together with a clinical preceptor to PWD patients and their parents/guardians. These exercises will help with their physical, sensory, cognitive, and emotional needs with the assistance of their parents in their own homes. In aid of those without the capacity to have their own gadgets, the Tech4Ed Centers in the barangays could help them thru the free computer and internet access.

These program initiatives assure the PWDs of the municipality to get a chance to have a normal life, be productive, with their rights protected. (Ruel Francisco/Municipality of Carmona)

MANILA – For bribing a policeman in exchange for the dropping of cases against two suspects in a frustrated murder case, a deputy City Prosecutor and a lawyer will spend the next six to 10 years behind bars.

In a decision promulgated on July 29 and recently made available online, Sandiganbayan's Sixth Division found Zamboanga City Deputy City Prosecutor Roselyn Murillo-Mamon and defense counsel Pherhram Surian Saiddi guilty of violating Republic Act 3019, otherwise known as the Anti-Graft and Corrupt Practices Act.

Mamon is also perpetually disqualified from public office.

The charges arose after the two offered PHP200,000 to Police Officer 3 Flavio Enriquez Jr. in 2013 in exchange for the dropping of frustrated murder cases against Phon Mohammad and Dadoh Mansul filed before the Zamboanga City Regional Trial Court Branch 14.

An entrapment operation by the National Bureau of Investigation (NBI)-Western Mindanao Regional Office, headed by lawyer Peter Chan Lugay on Aug. 16, 2013, subsequently led to Mamon and Saiddi's arrest.

Saiddi, Enriquez said, directly handed him the brown envelope containing the money.

The court also said an amicable settlement of the case should have been raised in a proper venue considering that the case is still pending in court."

The frustrated murder charge was filed by Enriquez, then connected with the regional police office intelligence unit, after he was shot by Margani Samla while he was part of a team serving an arrest warrant on the latter.

Samla, Mohammad, Mansul, and six others were all facing frustrated murder charges being handled by Mamon.

At that time, Samla was one of Zamboanga's most wanted criminal, charged with illegal possession of firearms and was implicated in the death of a local judge.

In 2014, Mohammad was arrested by the NBI along with four others in a safehouse in Las Piñas City. (PNA)

### **BOC exceeds July 2021 Target Collection**

IN spite of the effect of the continuing logistical restrictions brought about by the COVID-19 pandemic to trade environment, the Bureau of Customs (BOC) collected P58.183 billion against its P53.751 billion July 2021 collection target, posting a surplus of P4.432 billion or 8.2%

Based on the preliminary report from the BOC-Financial Service, 14 of the 17 Collection Districts hit their target, namely the Ports of San Fernando, Manila, NAIA, Batangas, Legaspi, Tacloban, Surigao, Cagayan De Oro, Zamboanga, Davao, Subic, Clark, Aparri, and Limay.

Remarkably, the BOC was able to meet and exceed its monthly target collections since the onset of pandemic in 2020. Last year, the Bureau collected

P539.687B or 106.23% of its target collection. Further, the Bureau maintains the feat by collecting P359.930B or 104.15% against its target collection of P345.584B from January to July 2021.

Indeed, the bureau continues to prove the intensified collective efforts of all ports this year, not to mention, the improvement of volume of importation while maintaining border security and trade facilitation.

BOC Commissioner Rey Leonardo Guerrero commended the efforts of the frontliners and employees of the Bureau of Customs who, despite the risk to their health and safety as Delta variant cases surge, showed their unwavering commitment and dedication to service. **PR** 

### 'Irregular' notarization makes docs questionable: SC

MANILA - The Supreme Court (SC) has ruled that irregulàritiés in the notarization of public documents may put to question the genuineness and presumption of regularity of transactions, as it sternly warned a notary public who failed to register a deed of sale of real property he notarized which later became the subject of adverse claims. In a 19-page decision written by Associate Justice Samuel Gaerlan and recently posted online by the high court, the court's First Division said regardless of the reason, the failure of the notary public to register the subject deed of sale "casts doubt on the authenticity" of a document signed by a notary public.

The case involved the title of over 171,900 square meters of agricultural land at Barrio Concordia, Alitagtag, Batangas sold by Francisco P. Madlangbayan who had been given a special power of attorney (SPA) by the lots' eight registered owners from the de Joya, Castillo, and Cordero families. The SPA granted to Madlangbayan was revoked by the owners after a conflict over the PHP17-million purchase price after Madlangbayan claimed PHP13.6

million in commissions. A

demand for the return of the

owners' certificate of title in

June 1996 went unheeded.

In response to a complaint filed on July 14, 1997, Madlangbayan claimed he had already sold the property for PHP10 million on April 8, 1996 before his authority was revoked. The buyers, Rolando and Maria Florita Dalida, said the payment was deposited in Madlangbayan's account in the Rural Bank of Bauan. The Dalida couple then sold the property to another group led by Renato Go, who claimed that the deed of sale to them is valid.

The SC, in its ruling, reinstated the original ruling of the Batangas City Regional Trial Court Branch 84 and said because there is no valid transfer of the properties, the petitioners remained to be the owners adding that "buyers in a simulated sale acquired no right of ownership".

The court noted that while the deed of sale dated April 8, 1996 stated that it was notarized by lawyer Henry Adasa, the same did not appear in his notarial registry -- a record of the notary public's official acts for that year.

The court explained that documents recorded in a notary public's notarial registry are considered public documents and a document which does not appear in the notarial records or without a copy of it "suggests that the document

### HONTIVEROS: ASEAN DAPAT MAGKAISA SA POSITION LABAN SA PANGHIHIMASOK NG TSINA

NANAWAGAN si Senador Risa Hontiveros sa Department of Foreign Affairs na himukin ang ASEAN member states na magkaisa sa posisyon laban sa panghihimasok ng Tsina sa mga pinagtatalunang teritoryo. Ipinahayag ito ng senadora kasabay ng ASEAN Foreign Ministers meeting na isinasagawa mula Agosto 2 hanggang Agosto 6, 2021.

"ASEAN should stand as one. Pagdating sa mga kilos ng Tsina sa West Philippine Sea, ang prinsipyo ng non-interference ng ASEAN ay hindi nararapat. Kung hadlangan ng Tsina ang kalayaan sa pagnavigate sa buong South China Sea, hindi lamang ang Pilipinas ang lubhang maaapektuhan, kundi pati na rin ang buong rehiyon. Kung natalo ng Pilipinas ang diplomatikong labanan na ito laban sa China, talo din ang ASEAN," sabi ni Hontiveros.

Mula noong 2016, nakapaghain na ang DFA ng higit 100 diplomatic protests laban sa iba't ibang aktibidad ng China sa West Philippine Sea.

"It cannot be treated as a public document and as such is not entitled to the presumption of regularity," the court said.

It added that irregular notarization reduces the "evidentiary value" of a document from public to a private document which requires "proof of its due execution and authenticity to be admissible as evidence."

The court also sternly warned Adasa that a repetition of the same or similar acts in the future "shall be dealt with more severely". (PNA)

Ayon sa mga ulat, nawala sa Pilipinas ang higit sa P800 bilyong halaga ng marine life at resources dahil sa Tsina.

Idinagdag ni Hontiveros na ang mga mangingisdang Tsino ay nahuli rin na iligal na kumukuha ng mga taklobo sa WPS, na maaaring mangyari rin sa ibang mga bansa sa Southeast Asia. Dahil ang ASEAN ay pumirma sa Convention on International Trade in Endangered Species, sinabi ng senador na maaaring ito ay isa pang common ground na maaaring pagtulungan ng ASEAN upang labanan ang Tsina.

"Southeast Asian nations should already start our accounting of the environmental damage wrought by China in our territories. Utang ito ng Tsina sa ating rehiyon. Ito ang mga danyos na kailangan nating singilin sa Tsina. Ang ASEAN ay binubuo ng masasabing mas maliit na mga bansa ngunit kapag nagsama-sama, our fighting spirit is bigger than any bully can handle," pagtatapos ni Hontiveros. PR

### Philippines Makes Headway in Launching the ASEAN Customs Declaration Document Exchange



THE Bureau of Customs (BOC) successfully received concurrence from the United States Agency for International Development (USAID) for the completion of the bidding process for the ASEAN Customs Declaration Document (ACDD) Management System. The procurement of the System for BOC formally started in May 2021 based on the ACDD Business Processing Analysis (BPA) Report developed by the BOC

ACDD Project Team.

This milestone will help link the Philippines to electronically exchange ACDD information on the ASEAN Single Window (ASW) regional trade facilitation platform. It will broaden economic integration and meet the Philippines' ASE-AN commitment in digitizing trade processes and maximize the potential of intra-ASEAN trade.

USAID, through the ASE-AN Policy Implementation (API) Project, is also assisting the BOC to develop a National Master Data Plan for Information Sharing and Interoperability using the Technical Reference Model approach.

During the 10th ACDD Project team Meeting, Mr. Dennis C. Pantastico, ASW Regional Advisor explained the USAID Concept Paper that will be used in develop-

ing the technical reference guidelines. It encapsulates the overall operational environment of the Single Window enabling platform for operational transactions, data extraction for risk profiling, business and informational rules, inter-agency information exchange, and the whole of government approach driven by business rules.
