

VACC TO NORMAL CAMPAIGN, **INILUNSAD SA IMUS**

LRT-1 Cavite Extension now 58% complete

MANILA - The Cavite Extension project of the Light Rail Transit Line 1 (LRT-1) is 58.03 percent complete after the girder has been installed along the Manila -Cavite Expressway (Cavitex).

Once completed, the project is seen to reduce travel time between Baclaran and Bacoor, Cavite from 1 hour and 10 minutes to just 25 minutes and increase passenger capacity from 500,000 to 800,000 daily.

Department of Transportation (DOTr) Secretary Arthur Tugade said the girders, or horizontal support structures, were installed using the full span girder launching method using special equipment and were completed faster compared to traditional pre-casting.

"Further, these girders will no longer have to be transported via road transport. so as not to cause traffic congestion along the affected areas," Tugade said in a Facebook post Wednesday.

Initially approved by the National Economic and Development Authority (NEDA) Investment Coordination Committee in August 2000, the DOTr said zero percent of the right of way (ROW) was certified as "free and clear" by the project's independent consultant back in 2016.

In May 2019, the DOTr expedited the acquisition of ROW for the project's first phase and worked with the Light Rail Transit Authority and the Light Rail Manila Corporation to begin its construction. (PNA)

Calabarzon dengue cases fall in 2021 - DOH

CALAMBA CITY (PIA)

- Dengue cases in the Calabarzon region have decreased this year, according to the Department of Health (DOH).

In a press release, the DOH - Center for Health Development CALABAR-ZON said that around 4,179 dengue cases have been reported this year, around 41 percent lower compared to last year's data during the same period with 7,933 cases.

According to the Regional Surveillance and Epidemiology Unit (RESU), most of the patients are aged between two (2) to 88 years

The province of Rizal has the highest reported cases with 1,377; followed by Cavite province with 1,276 cases; and Laguna province with 895 cases. Among these cases, 15 deaths were recorded.

Regional Director Eduardo C. Janairo advised residents to be wary of mos-

quito bites, especially during the rainy season.

"Panatilihin po natin ang kalinisan, sa loob at labas ng ating bahay upang hindi po pamahayan ng mga lamok. Wala pong pinipiling oras ang mga ito upang mangagat at makapagdulot ng sakit na dengue," he emphasized.

[Let us maintain the cleanliness inside and outside of our homes so mosquitoes will not multiply. They choose no time to attack which causes illnesses [like] dengue.]

The region's top doctor also said that children aged two (2) to 10 are most prone to mosquito bites, advising parents to safeguard their children against insects.

"Use insect repellent, wear bright colored long-sleeved shirts and long pants and most important is to control mosquitoes inside and outside your home by destroying their breeding sites," Janairo advised. (PB/DOH

Ex-PNR exec cleared of graft raps

Court (SC) had cleared the former manager of the Administrative and Finance department of the Philip-National Railways (PNR) of graft charges in connection with a 2009 supply contract.

In its decision recently published online, the court's First Division granted the petition filed by Lynna Chung and set aside the Ombudsman's charges that she failed "to ensure that the payments were made in accordance with the terms of the contract" of the PNR's procurement of rail fastenings, clips, and insulators from Pandrol Korea Limited (Pandrol Korea) worth USD7.9 million.

The procurement was for the repair of rail tracks and replacement parts in Quezon Province and Bicol Re-

The court noted that the Ombudsman's resolution itself declared that there was no substantial evidence on the alleged shortage of delivery to PNR of Pandrol products.

This raises the question then that if all had been delivered to PNR, where is

the undue injury to the government?" the court said. The tribunal said while it has a policy of non-interference in the Ombudsman's exercise of its constitutionally mandated powers, "this should be weighed against the purpose of a preliminary investigation, which is securing the innocent against hasty, malicious and oppressive prosecution, and protecting one from an open and public accusation of crime from the trouble, expense, and anxiety of a public trial".

"The State must be protected as well from useless and expensive trials" and a finding of probable cause in the preliminary stages of a case "should not be enough reason to proceed with the trial of the case which, in every indication, stands on shaky grounds, the SC ruled.

While Chung was among the members of the PNR Bids and Awards Committee (PNR-BAC), she inhibited from the proceedings because she is the adoptive mother of Jaewoo Chung, the Manila liaison officer of Pandrol Korea. Still, Chung was included

in the Ombudsman charges, along with former PNR General Manager Manuel Andal and officials Rafael Mosura Jr., Edgardo Remonte, Jose Marayag, and Constantino Domingo.

The SC said "while it may appear that the acts of all the defendants in this case are connected in that they sprang from the same transactions, the act taken against petitioner (Chung) is distinct and severable from the acts of her codefendants".

In January, the Sandiganbayan convicted Andal for two counts of graft for unlawfully entering into contracts with Pandrol Korea and Nikka Trading without authorization from proper authorities and despite knowledge of irregularities. Andal was sentenced to eight years and a month up to 12 years in prison, with perpetual disqualification from holding public office. He was also ordered to indemnify the government PHP86.5 million.

The case started in January 2016 when the Ombudsman Field Office filed a complaint against PNR-BAC, includ-

ing Chung, and the PNR Board of Directors for alleged violation of the Anti-**Graft and Corrupt Practices** Act, citing "unusually hasty payments" to the firm and a delivery shortage apparent from importation documents of 70,000 rail clips.

The PNR deal with Pandrol involved 170,000 sets of rail fastenings at a unit cost of USD44.58 per set or a total of USD7.624 million and 50,000 pieces of clips and insulators at a unit cost of USD3.90 per piece for an aggregate price of USD195.000.

Pandrol Korea owns the patents of certain types of rail fastenings and does not have a sub-dealer in the Philippines.

The prices indicated in the BAC resolution were based on the quotation from K.B. Hong of Pandrol Korea that Andal had requested. (PNA)

ISSUANCE OF BUILDING PERMITS SOLELY LGU'S RIGHT: SC

MANILA - The Supreme Court (SC) has upheld the power of local government units (LGUs) to require a builder to secure prior clearance from homeowners' association before granting a building permit.

In ruling against Arturo Garin, a resident of Pasig and who also wanted to build a house in Katarungan Village in Muntinlupa City, the High Court 's Third Division said it was within Muntinlupa's police power to require clearance from a homeowner's association as a prerequisite for granting a building permit.

In a decision recently published online, the SC also affirmed Pasig Regional Trial Court (RTC) Branch 167's ruling that the question on the homeowner association's clearance requirements, in turn, must be resolved before the concerned government agency.

It is the Department of Human Settlements and Urban Development (DH-SUD) which can settle disputes between a nonmember homeowner and homeowner's association.

Garin was to secure a clearance from the Katarungan Village homeowners' association as a requirement for the issuance of a building permit in 2014.

The association, however, refused to give the required clearance until after he paid an assessment fee and signs up for membership.

Garin filed a petition before the Pasig RTC against the Muntinlupa City government and the Katarungan Village homeowners' association, claiming the unconstitutionality of requiring a homeowners' association clearance before the issuance of a building permit. The Pasig RTC denied the relief sought by Garin and said he should first exhaust administrative remedies with the Housing and Land Use Regulatory Board, which became the DHSUD in 2019.

The SC noted that the trial court found that the petitioner "failed to establish a clear right or any substantial injury that would be caused since he has not yet commenced the construction".

In upholding the RTC's order, the SC said the case "can be resolved without having to pass upon the constitutional question" raised about the validity of the ordinance, adding that the petitioner's "cause of action is against respondent Katarungan (Homeowners' Association), not the City of Muntinlupa". Katarungan Village in

Barangay Poblacion is a 106-hectare project which converted a portion of the prison site of the New Bilibid Prison into a housing program financed by the Government Service Insurance System and the Home Development Mutual Fund.

Under Proclamation No. 792, workers of the Department of Justice, attached agencies, other government agencies, and the local government of Muntinlupa are the beneficiaries. (PNA)

BFAR recommends longline method in growng mussels

MARTIRES CITY, Cavite (PIA) --The Bureau of Fisheries and Aquatic Re-(BFAR) has sources recommended the use og longline method in mussels, a growing new technology that is environment-friendly as it does not use bamboo and other materials that could pollute the water bodies.

Kawit Municipal Agriculture Officer Ronaldo Lontoc said that although this fishing method is fairly expensive, nonetheless he would urge the big fishing operators to shift to longline fishing while the LGU will provide assistance to the small-scale fisherfolks.

The BFAR conveyed its recommendation during the consultation meeting recently held by the Provincial Environment and Natural Resources Office (PENRO) with fisherfolks, baklad and sapra operators, and mussel growers of Cavite City, Noveleta and Kawit.

This is in line with the Department of Environment and Natural Resources (DENR) directive to regulate illegal fishing structures along Manila Bay and its tributaries.

Recent observations of

floating bamboo poles on Manila Bay raised concerns which later on were found to be parts of the fishing structures illegally installed on Cavite waters that were believed to be washed out during the recent typhoons.

DENR (CALABARZON) Regional Executive Director Nilo B. Tamoria in a previous meeting urged Cavite fisherfolks to practice environment-friendly fishing methods to promote responsible use of marine resources not only for their generation but also for the generations to come.

Likewise, DENR-4A ARD Palencia, appealed to the fisherfolks to accomplish the objectives of the Manila Bay Rehabilitation Program by being sensible in their fishing activities, especially in managing their wastes.

Based on LGU data, there are 351 tahungan operators in Bacoor City, 26 illegally-installed bamboo fish traps in Cavite City, and 23 pond-type operators in Kawit, and fish pens, fish cages, and sapra operating without permit in Noveleta LGU. (Ruel B. Francisco with reports from PENRO-Cavite)

DENR CALABARZON CELEBRATES WORLD MANGROVE DAY IN LIAN, BATANGAS

Calamba City, Laguna- A total of 250 seedlings of Rhizophora apiculata. Rhizophora stylosa and Avicennia sp. were planted along the coastal area of Barangay Luyahan, Lian, Batangas during the celebration of the World Mangrove Day. Meanwhile, 17 sacks or approximately 255 kilograms of wastes consisting of food wrappers, plastic bottles, fishnets, disposable diapers, slippers, shoes, and other solid wastes were also collected.

The Department of Environment and Natural Resources CALABARZON Region through the Conservation and Development Division spearheaded the mangrove planting and coastal clean-up. There were 70 individuals from the DENR CALABARZON Regional Office, PENRO Batangas, CENROs Calaca and Lipa, Municipal ENR Office, Local Government Unit (LGU) of Lian, Batangas, and the People's Organizations actively participated in both activities.

For. Isagani Q. Amatorio, the Community Environment and Natural Resources Officer of Calaca, Batangas, said that the Philippines has approximately 7 Million hectares of forest cover that are left and that only 4.3% is classified as mangrove forest. He added that almost 400 hectares of mangrove forest remain in Batangas Province. tional Day for the Conservation of Mangrove Ecosystem was adopted by the General Conference of the United Nations Educational Scientific and Cultural Organization (UNESCO) in 2015 and celebrated annually every 26th of July. It aims to raise awareness about the importance of Mangrove Ecosystems as a "unique, special and vulnerable ecosystem" and also to promote solutions for their sustainable management, conservation, and uses . SC affirms COA disallowance of Pampanga town road rehab

MANILA – The Supreme Court (SC) has affirmed the Commission on Audit's (COA) move to disapprove the payment of PHP22.63 million to a local firm that bagged government contracts for road rehabilitation projects in Mexico, Pampanga in 2010.

In an en banc decision recently made available online, the SC dismissed the petition filed against COA by Sto. Cristo Construction, represented by its proprietor Noel Cruz, who said the COA should have considered corrective measures he undertook on the projects.

This came after notices of disallowance (NDs) were issued by the state audit body's quality inspectors and auditors who determined that there had been discrepancies in the amount of embankment materials used.

In its ruling, the SC said despite the rectification measures undertaken by the firm, the issue that needs to be resolved is the "excessive use of public funds to procure a surplus of embankment materials, which can only be settled upon the return of the excess payment made to the petitioner (firm)".

The SC said the COA acted correctly in issuing the ND and when it did not consider the rectification works by the petitioner in the road projects.

The construction company was awarded government

contracts for road rehabilitation/improvement in Mexico, Pampanga in 2010.

From Nov. 15 to 20, 2010, the Quality Assurance Unit (QAU) of the Department of Public Works and Highways (DPWH) reassessed 10 projects of the DPWH Pampanga 1st District Engineering Office (DEO).

After the DPWH's reassessment yielded adverse findings, COA technical inspectors were called in to inspect the completed projects which showed an overstatement of embankment materials actually used. Four NDs were then issued disapproving the payment of PHP22.63 million for 10 projects.

In 2013, the company requested a survey to evaluate the rectifications made but the DPWH Pampanga said the rectification works were done outside the approved plan.

In appealing the ND, Cruz claimed the engineers who inspected the construction sites did not consider the deterioration of the road, the effects of flooding, and "wear and tear".

The COA, meanwhile, claimed that "the fact that the DPWH officials did not invoke the rectifications as a defense in their appeal only shows that they were not convinced that the deficiencies found during the evaluation and inspection of the projects had been sufficiently addressed".


