SC disbars lawyer for 'gross immorality'

MANILA - The Supreme Court (SC) has ordered the disbarment of a lawyer for gross immorality after abandoning his wife and family in order to cohabit with another woman.

In a per curiam (unanimous) resolution uploaded December 4, the high court found lawyer Allan Contado guilty of violating the Code of Professional Responsibility and disbarred him from the practice of law.

"It is well-settled that a married person's abandonment of his or her spouse to live with and cohabit with another constitutes gross immorality as it amounts to either adultery or concubinage," the SC ruled.

The case arose from an administrative complaint filed by Crisanta Hosoya, who filed a petition for disbarment in February 2015 against Contado, her erstwhile live-in partner.

Hosaya said she agreed to move in with Contado after the latter said he had already separated from his legal wife.

They have two children,

born in 2011 and 2013. However, she discovered that the lawyer had other affairs and even impreg-

nated some of them.
When financial problems arose, Hosaya said the lawyer left her, took her vehicle, and did not support their children.

Contado denied the allegations, which he said were meant to exact revenge for a relationship gone sour. He confirmed he was already separated from his

ready separated from his wife when he met Hosaya. As for the car, Contado claimed it was in Balangkayan, Eastern Samar and no longer road-worthy for a trip back to Manila.

Subsequently, Contado said Hosaya threatened to ruin his reputation and he provided receipts of money and supplies sent to their children.

"Atty. Contado likewise admitted the fact of his relationship with Crisanta, while being married to his wife. In so admitting, he effectively admitted to living a life of deceit and immorality," the tribunal said. (PNA)

CA upholds 14-year sentence on Illegal recruiter

MANILA - The Court of Appeals (CA) has affirmed a Baguio Regional Trial Court (RTC) decision convicting a woman who charged applicants for employment in New Zealand as milkmen and hair stylists.

In a resolution uploaded Monday, the appellate court denied for lack of merit the motion for reconsideration filed by Sheila Tan in December last year.

The CA upheld Baguio RTC' Branch 3's decision in 2019 that found Tan guilty of illegal recruitment in two cases and sentenced her to up to 14 years and pay fines and damages of more than PHP1 million for each.

Brothers Renato and Fernando Gumilab testified on Tan's involvement in the prohibited recruitment

rans involventer in the prohibited recruitment. "They positively identified the appellant as the person who represented that she can send them to New Zealand for employment as a dairy farm worker and as a hair stylist," the resolution written by Associate Justice Florencio Mamauag, Jr. read. The tribunal added that Tan

The tribunal added that Tan "cannot escape criminal liability even if her name does not appear in the receipts presented by the prosecution".

"Proof that the accused re-

"Proof that the accused received monetary consideration from the victim is not material to a prosecution for illegal recruitment considering that the definition of illegal recruitment under the law includes the phrase 'whether for profit or not'. It is sufficient that the accused promises or offers for a fee employment to warrant conviction for illegal recruitment," the resolution read.

The complainants claimed they were recruited by Tan in 2016 for supposed jobs in New Zealand and they

The complainants claimed they were recruited by Tan in 2016 for supposed jobs in New Zealand and they shelled out P95,000 and P150,000, respectively, for processing fees and show money.

After his pre-departure

After his pre-departure orientation seminar, Fernando received an employment contract for Saudi Arabia but was assured by Tan that it would only be a "jump-off point" to New Zealand.

While in Saudi, he sent money to Tan, who said she would work for his eventual employment in New Zealand.

Renato, on the other hand, underwent training in Manila as hair stylist and received an employment contract and flight details for New Zealand but the trip did not materialize.

A certification from the Philippine Overseas Employment Administration later showed that Tan was not licensed or authorized to recruit workers for employment.

Tan denied taking part in the recruitment and said she is a cosmetics company agent. She said she knew the complainants "very briefly" in 2015 through her then live-in partner.

"As long as the prosecution is able to establish through

credible testimonial evidence that the accused-appellant has engaged in illegal recruitment, a conviction for the offense can very well be justified," the CA ruled. (PNA)

Various NGAs and LGUs Award the Best Eco-Gardens in Lucena City

The Department of Environment and Natural Resources (DENR) CALABARZON together with the concerned local government units and other government agencies awarded the best ecological gardens in Lucena City, Quezon on November 26, 2021. The awarding ceremony was

The awarding ceremony was the culminating activity under the Project Urban TANIM (Tayo ang kalikasan: ANI para sa Mamamayan) which is a synchronized program of the DENR-Provincial Environment and Natural Resources Office (PENRO) of Quezon and the Provincial Government of Quezon in partnership with the City Government of Lucena, Alona Partylist, Office of the Representative of the 3rd Congressional District of Quezon Province, and Department of Agriculture CALABARZON.

The said project is an edible garden competition which aims to ensure food safety, food security and livelihood in urban and other similar areas amid the threat of COVID-19, and reduce solid waste generation.

At the onset of the project early in July 2021, the Provincial Government of Quezon took the initiative to encourage the residents of Lucena City, particularly those who belong to the marginalized sector of the society or the urban poor, to grow foods right at their own homes. The Office of the Provincial Agriculturist of Quezon distributed to the participants seeds and other planting materials and provided them with training on recycling, composting, and hydroponics.

On the other hand, DENR-PENRO Quezon partnered with the Federation of Lucena Homeowners Association, Inc. (FLHAI) and Dangal at Sigla ng Sambayanan sa Lucena City Homeowners Federation (DASSAL) to encourage the residents of Lucena City, not only those who are living in urban area but also those who are residing in subdivisions and villages, to advocate on environmental clean-up and to reduce solid waste generation. Per data provided by the Provincial Environmental Management Office of Quezon, Lucena LGU is collecting 27 tons of solid wastes within its jurisdiction, 14 tons of which are biodegradable while 13 tons are non-biodegradable.

DENR CALĂBARZON Regional Executive Director Nilo B. Tamoria said, "isa sa mga mithiin ng aming tanggapan ang mabawasan ang mga basurang napupunta lamang sa mga sanitary landfill. Kung

Among them, 70 entries were selected as finalists for different categories: 10 entries each from both organizations for open space and community categories; 20 entries from FHLAI and 10 entries from DASSAL for backyard and frontyard categories; and 10 entries each from both organizations for pocket and window categories. The entries were judged based on creativity, visual attractions, diversity of ornamental crops, innovations, sustainability plan, solid waste management, use of recycled materials, and vlog content, likes/views, and documentation including records,

Isko's offer proof of Duterte's many accomplishments: Palace

MANILA – The offer of Manila Mayor Francisco "Isko" Moreno Domagoso to adopt President Rodrigo Duterte as his party's fourth bet for the Senate is proof of the latter's many accomplishments, Malacañang said on Tuesday.

Acting Presidential Spokesperson and Cabinet Secretary Karlo Nograles made this remark after Domagoso said he believed Duterte was a qualified candidate for the position and that he is also willing to adopt him as the fourth senatorial candidate of his Aksyon Demokratiko Party.

"Ito po'y patunay sa maraming nagawa si Pangulong Duterte sa kanyang panunungkulan at sa maraminiyang ginagawa at gagawin pa. At patunay ito sa kumpiyansa ng marami sa ating mga kababayan sa kanya na pag binigyan po siya nag pagkakataon na makapagpatuloy ng kanyang serbisyo sa Senado, ay maipagpatuloy niya ang lahat ng mga ito (This is proof that President Du-

terte has accomplished a lot during his term and in the future. This also proves the confidence of many of our citizens in him and that if he is given another chance to continue his service in the Senate, he will do it)," he said in a Palace press briefing.

Nograles, however, refused to say whether or not Duterte will accept Domagoso's offer.

"Ayaw ko rin pong pangunahan kung ano ang mangyayari sa susunod na araw at sa susunod na buwan. At ayaw ko rin pangunahan ano magiging desisyon ng iba't-ibang mga kandidato na tumatakbo at iba't-ibang mga partido na nais pang mag-endorse kay Pangulong Duterte (I don't want to preempt what could happen in the following days or months. And I don't want to preempt the decision of other candidates running and other parties that also want to endorse President Duterte)," he said.

Should a party eventually decide to adopt Duterte or

forge an alliance, Nograles said it remains to be seen. Duterte filed his candidacy for senator under the Pederalismo ng Dugong Dakilang Samahan (PDDS), an allied party of the ruling Partido ng Demokratikong Pilipino-Laban (PDP-Laban).

"Siyempre, si Pangulong Duterte ay tumatakbo sa partido ng PDDS at sinusuporthan din po siya PDP-Laban. mayroon mang mangyayari pagkatapos nito na mga pag-adopt o di kaya magkaroon ng alliances, ayoko po pangunahan kung anong mangyayari sa mga susunod pang mga araw, linggo, at maging sa susunod na buwan (Of course the President is running under the PDDS and is also being supported by PDP-Laban. If there should be any move to adopt or forge an alliance, I do not want to preempt what could happen in the following days, weeks, and months)," Nograles added. In an interview with reporters in Lapu-Lapu City, Cebu, Domagoso said he will vote for Duterte as senator due to his "many accomplishments."

"I'm going to vote for him personally, I'm going to endorse him kung papayag siya, I'll be honored. I'll be humbled and honored na umoo si Pangulong Duterte. Nakuha ko nga siyang iboto, hindi ko pa ba makuhang siya'y i-adopt (I will vote for him, why can't I adopt him, too?)," Domagoso said.

He said it would be an "honor" should Duterte accept his invitation for him to be an adopted senatorial candidate of his party but noted that the President is free to decide whether he would accept it or not.

"Let's give credit where credit is due. President Duterte has so many accomplishments. And I believe that he can be an effective senator since through legislation, he can ensure that his legacy will be institutionalized," he added. (PNA)

LGUs adapt mandate on full vaccination of onsite workers

Trece Martires, Cavite (PIA) - The local government units (LGUs) of the municipality of Kawit and Tagaytay city approved and passed their respective local ordinances adapting the Inter-Agency Task Force (IATF) against CoVid-19 resolutions mandating the full vaccination of on-site workers in public and private sectors.

With the province declared under Alert Level 2 since November 16, operations of manufacturing companies in the processing zones and other business establishments, including public offices had slowly returned to normal thus, the IATF recommendations for health protocols to protect both the employees and the public they serve.

On November 23, Kawit LGU ordered the immediate implementation of Executive Order No. 037-2021 directing all public and private establishments and its employers to make it a requirement for all eligible on-site employees/workers to be fully vaccinated or had received the complete doses of the CoVid-19 vaccine.

Establishments or its employers are also given the right to refuse to admit or serve individuals who do not have or have not been vaccinated, especially if they are eligible to receive the vaccine.

The city government of Tagaytay likewise approved and passed a city ordinance, Executive Order no. 403 S. 2021 an order adapting the same IATF resolutions which will be effective on December 4, 2021.

Both local ordinance requires unvaccinated eligible workers to undergo regular RT-PCR testing every two weeks at their own expense which also applies to partially vaccinated eligible workers with the due date for their 2nd dose had already lapsed.

As a consequence for failure to submit the requirements of full vaccination and/or negative result of RT/PCR tests will result to absences deducted from their sick leave or vacation leave credits if sick leave credits had already been consumed or the No Work, No Pay rule shall apply for those without leave credits. BOC Completes Validation Sessions on Integrated Risk Management, e-Commerce and Authorized Economic Operator (AEO) Program with ARISE Plus Philippines and the International Trade Center

The Bureau of Customs timely delivery, treatment, Project Team for Strengthened Trade Facilitation Capacity Building convened a two-day validation session with ARISE Plus Philippines and the International Trade Center (ITC) Team on 2-3 December 2021. These sessions studied the Operational Framework and Practices of the Bureau of Customs in three (3) priority trade facilitation areas namely Integrated Risk Management (IRM), Authorized Economic Operator (AEO) Program, and e-Commerce.

The first day of the validation session focused on the existing BOC Risk Management Framework, how it can be enhanced to ensure compliance with the World Trade Organization-Trade Facilitation (WTO-TFA) Agreement commitment on Risk Management. Jemky Sacar, Chief of the Risk Management Office (RMO) led the discussions on how to improve the traditional risk and governance strategies to a program that integrates end-to-end cargo clearance with full visibility and seamless interagency sharing of risk activities with Trade Regulatory Government Agencies (TRGAs). Further, the ongoing development of the data warehousing system, its functionality matrix for BOC units, linking service charter policy with risk targeting parameters, and guidance on how to perform data analytics for informed decision.


During the e-commerce validation session, Atty. Julito Doria, who is the Vice-Chair of the BOC Project Team, supported the review of e-Commerce clearance mechanisms by identifying the barriers on the

and availability of documentary requisites associated with cross-border e-Commerce. The sessions also provided valuable insights on the importance of capturing pertinent data to identify legitimate de minimis transactions under expedited clearance procedures, including embracing robust data warehousing system and effective risk management for a resilient and sustainable supply chain.

Lastly, the Interim AEO Office headed by BOC Legal Service Director Atty. Maria Yasmin Obillos Mapa joined the validation session to share their views on how to strengthen the implementation of the AEO Program in the Bureau of Customs. Three (3) core strategies were identified during the session namely a) development of a proposed Trader's Compliance Scorecard (TCS), b) development of an AEO Micro, Small and Medium-Sized Enterprises (MSMEs) Program, and c) the modification of the AEO self-assessment questionnaire by making it simpler and easier to submit supporting materials.

The validation sessions serve as a starting point to support the readiness of the BOC in complying with its international trade facilitation commitments and address new or evolving requirements. The 2nd phase of the activity will engage the ITC team (Ms. Maria Esperanza Alconcel, Mr. Dennis C. Pantastico, and Ms. Theresita Eisma) to dialogue with the TRGAs and MSMEs in understanding better their awareness level, role dynamics and processes that affect their ability to cooperate properly.
