## CAVITE TOWN SEES BETTER HEALTH CARE SERVICES WITH DEVOLUTION

The local government of General Mariano Alvarez (GMA) in Cavite expects more benefits, including health care services, through devolution of government functions.

In June 2021, President Rodrigo Roa Duterte signed Executive Order (EO) 138 mandating the transfer of certain functions from the national government to Local Government Units (LGUs).

This is in connection with the Supreme Court's landmark Mandanas-Garcia decision, which will increase local governments' share in national taxes beginning next year.

With the impending government decentralization, the national government delegates programs and projects and gives more power to LGUs.

Along with the increased funding due to the said SC ruling, the LGUs are now preparing to take on these tasks such as the case of GMA

Mayor Maricel Torres of GMA, Cavite said citizens will benefit from improved services due to devolution. "Ang nakikita nating magiging benepisyo o kapakinabangan ng napipintong debolusyon para sa bayan ng General Mariano Alvarez, [Cavite] ay mas maiaabot po namin ang mga serbisyo na ibinigay ng mga nasyonal sa ating mga residente (What we see as a benefit of the imminent devolution for the town of General Mariano Alvarez is that we will be able to better give the services provided by the nationals to our residents)," Torres said in a recent exclusive interview

When asked about GMA's priorities once the SC ruling takes effect in 2022, she said the LGU intends to put health services first among other social services.

"Sa social service, unanguna yung health, sunod ang children, tapos ang housing (In social service, first would be health, followed by children, and then housing)," Torres answered

"Ang GMA, alam naman natin, as of 2020, ay top 1 sa density population, so mas kinakailangan naming tutukan ngayon yung health services. (GMA, as we know has the highest

population density as of 2020, demanding a focus on health services)," she added

Torres said while the municipality has already-existing healthcare facilities, the lack of health care personnel remains to be the LGU's key concern as she foresees a major challenge in the next three years of the devolution transition period.

"Meron na tayong existing na building for the [health] cluster, health facilities, yun nga lang, yung personnel... kulang na kulang kami in terms of health services. (We already have health-care facilities. However, we are short on personnel in terms of health services)," she said.

She said the big challenge is if the LGUs can implement the devolution effectively and with quality.

GMÁ also intends to establish local finance and economic enterprise that will serve as an additional funding source and expand the scope of social services to reach more sectors.

Despite the lack of personnel, she said the town will find ways to achieve quality service to its constituents. (PR)

## DHSUD issues measure to sustain housing sector's vibrancy

QUEZON CITY -- Department of Human Settlements and Urban Development (DHSUD) Secretary Eduardo Del Rosario has signed an order authorizing the issuance of Temporary License to Sell (TLS) to developers to sustain vibrancy in the housing sector and contribute to the country's economic recovery.

Department Order 2021-008 aims to address the concerns of the private sector on the issuance of other pre-requisites from national and local agencies before they can secure a LS. These pre-requisites coupled with restrictions in movement brought about by the COVID-19 pandemic, pose substantial delay in the issuance of LS by the Department to housing developers. "With this order, we expect

"With this order, we expect continuity and sustainment of the vibrancy in the housing and real estate sector. It's definitely a huge boost to our private developers. Of course, the issuance of TLS comes with strict conditions and guidelines to protect the interest of home buyers," the housing czar said.

It is part of DHSUD's mandate to streamline and expedite regulatory processes for new and pending applications for permits, licenses and certificate of registration by developers of subdivision and condominium projects. Developers are only allowed and authorized to start selling lots and units after ob-

"A TLS can address the urgent need of private developers to sell lots and units,

taining LS, hence, they can immediately generate more funding and capitalization for

opers to sell lots and units, thus in turn will give premium to the housing sector in aiding the economy to recover faster amid the COVID-19 pandemic," Secretary Del Rosario stressed

Rosario stressed.
"Our Department will ensure that the interests of homebuyers are protected through the imposition of certain conditions and other requirements before a TLS is issued," the DHSUD chief

Secretary Del Rosario likewise has emphasized that the new measure is part of DHSUD's proactive steps in helping the housing sector remain robust amid the health crisis, ensure the production of housing units across the country, and provide employment for hundreds of thousands of Filipinos working in the housing and construction industry.

"With this Department Order, we are not only contributing to pump-priming the economy, we are also helping our kababayans working in the housing and real estate sector to continue providing for their families amid the pandemic," the housing czar said.

The new measure covers all residential, commercial and industrial subdivision and condominium projects, as well as any similar real estate undertakings such as cemeteries, memorial parks and columbaria.

Developers may be issued a TLS pending the issuance and/or submission of the project's building permit and other related permits, Environmental Compliance Certificate and/or a Verified Survey Return, as may be applicable.

The new Department Order's terms and conditions include the validity of the TLS for one year from the date of release (a six-month extension may be granted upon appeal for valid reasons) and that TLS holders shall submit a monthly report of sales and project operations.

Any project applying for the issuance of a TLS, except for socialized housing projects, will be required to comply with existing rules and regulations pursuant to the Balanced Housing Development Program. Violations shall have corresponding fines and penalties.

## SC reduces sentence of 2 minors convicted of murder

MANILA – The Supreme Court (SC) modified the sentence imposed on two men who were minors when they committed murder on Christmas Eve of 1999.

The SC Third Division said the Sta. Cruz, Laguna Regional Trial Court Branch 26 erred when it convicted the two to a suspended sentence of reclusion perpetua or up to 40 years in prison in 2015, the full service of which would have been conditioned upon a two-year rehabilitation program and after proving that they have reformed.

In a 16-page decision written by Associate Justice Rosmari Carandang and recently uploaded on the SC website, the high court sentenced the two to a penalty of 10 years but "on account of their minority when they came in conflict with the law, they may serve their sentences in an agricultural camp or training facility."

The two were 15 and 17, respectively, at the time of the incident.

Their names were not re-

vealed pursuant to court rules to protect the confidentiality of proceedings against minors and to conceal material information leading to their identity

"We agree with the CA (Court of Appeals) that the trial court erred when it ordered the automatic suspension of sentence of the accused because the said suspension of sentence lasts only until the child in conflict with the law reaches the maximum age of 21 years. In this case, the two were more than 21 years old when the RTC promulgated its decision in 2015," the SC said.

The SC also ordered the two to pay PHP160,000 in damages to the family of the victim, Rolando Abetria, who was 19 years old when he was killed in a melee 22 years ago.

The minors and two others were intoxicated when they ran into the other group.

Witnesses testified seeing the two stab the victim before they were apprehended by village watchmen. (PNA)

## SHFC, DBP launch new credit lifeline for housing developers

QUEZON CITY -- Developers and contractors accredited by the Social Housing Finance Corporation (SHFC) can soon avail of financing from the Development Bank of the Philippines (DBP) under the new credit scheme established by the two government institutions.

This came after SHFC President Atty. Arnolfo Ricardo Cabling and DBP President and Chief Executive Officer Emmanuel Herbosa signed a memorandum of agreement for the creation of the "DBP Credit Facility for SHFC Accredited Contractors and Developers" on December 13 in Makati City.

Under the scheme, accredited developers and contractors can apply for a loan with DBP to fast-track

and scale up the construction of socialized housing projects, particularly those classified under SHFC's Turnkey Community Mortgage Program (CMP).

"There is more to be done to put a significant dent in the housing backlog. We acknowledge that it is an important but daunting task. It is very complex that we cannot solve it on our own," Cabling said. "That is why we are very excited to work with a new and valuable partner today in the Development Bank of the Philippines. Together, we will surely contribute more to genuine development."

The CMP aims to improve the living conditions of underprivileged families by giving them an affordable financing scheme wherein they can borrow as a com-

## Subordinate's fault can't be blamed on superior: SC

MANILA – The Supreme Court (SC) has reversed the state auditor's findings that held a Customs official liable for his subordinate's failure to remit more than PHP400,000 in collections in 2011.

The SC en banc reversed the 2016 decision of the Commission of Audit (COA) against Rafael Crisol, chief of the Cash division of the Bureau of Customs' District II-A (Port of Manila).

The 11-page decision, uploaded to the SC website on December 9 and written by Associate Justice Ricardo Rosario, underscored that the COA erred in insisting on Crisol's liability even though he had conducted the initial audit on his subordinate, Special Collection Officer Arnel Tabije.

Tabije went absent without leave (AWOL) with PHP425,555.52 in collections unremitted.

The SC said "petitioner (Crisol) directly set in motion the investigation against Tabije, and resulted in the latter being charged with dishonesty, unauthorized absences, inefficiency and gross neglect of duty."

"Indeed, without said actions, the amount of PHP425,555 may have never made it back to the coffers of the government,"

After Tabije went AWOL, Crisol discovered that the former failed to deposit the collections and did not turn over the auction fund passbook.

Letters were sent to Tabije informing him of said irregularities and required him to settle the amount but he did not respond, prompting Crisol to refer the matter to the COA, which recommended that the erring employee be charged.

The COA's notice of charge determined, however, that aside from Tabije, District Collector lawyer Rogel Gatchalian, as head of office, and Crisol, as chief of the Cash division, were likewise liable.

The COA National Government Sector initially granted Gatchalian and Crisol's request for exclusion from liability in 2012 on the ground that they were included for merely being the head of the offices, "which cannot be deemed as badges of participation and/ or taking part in the unremitted collection."

Upon automatic review, however, the COA in 2016 disapproved it and directed the COA Legal Services to forward the case to the Office of the Ombudsman for investigation and filing of appropriate charges, prompting Crisol to question the ruling before the

"To say that failure to remit could have been avoided had petitioner required and reminded Tabije to comply with the pertinent rules and regulations is not only speculative but absurd," the SC said, adding that "even if petitioner (Crisol) reminded Tabije, there would still be no assurance that the latter would comply."

"In any case, even assuming that there was a duty on the part of petitioner to remind his subordinate, the failure to remind certainly does not rise to the level of gross negligence," the court ruled. (PNA)
