

DHSUD ROLLS OUT AID FOR 'ODETTE'-HIT FAMILIES

QUEZON CITY -- The Department of Human Settlements and Urban Development (DHSUD) has started rolling out assistance to thousands of families affected by Typhoon Odette that struck various parts of the country recently.

DHSUD Secretary Eduardo Del Rosario personally carried out days of inspections and assessment to determine the extent of damage, particularly on housing, in areas hardest hit by the typhoon, including Surigao City, Siargao, Cebu and Dinagat Islands.

As of Monday, it was established that at least 506,4040 residential structures were either damaged or destroyed by "Odette", composed of 339,327 houses partially damaged while 167,077 were totally destroyed by the storm in regions 4B, 6, 7, 8, 9, 10, 11, 12, 13 and BARMM.

In coordination with USAID and the International Organization for Migration, DHSUD had already distributed shelter-grade tarpaulin sheets to affected families. A total of 5,598 shelter-grade tarpaulin sheets were handed over to 'Odette'-affected localgovernment units in Cebu, Bohol, Southern Leyte and CARAGA region.

The Department likewise joined forces with the Philippine Coast Guard in distributing 14,000 more shelter-grade tarpaulin sheets, 250 modular tents for evacuation centers and 1,310 solar lamps in other typhoon-hit areas.

Meanwhile, 700 Shelter Repair Kits, which contain CGI sheets, lumber, plywood, tarps, nails and carpentry tools were sent to the CARAGA region on Monday while 300 more such kits are slated to arrive in Maasin City on Friday.

DHSUD also handed out a total of PHP487.5-million worth of financial assistance to typhoon-affected regions 4B, 6, 7, 8, 10 and CARAGA, with recipient families set to receive

PHP5,000 each. A total of 97,500 families will benefit from the cash assistance. According to Secretary Del Rosario, the Department intends to complete its commitment of providing PHP100 million per typhoon-hit province with severe damage to housing and procurement of housing materials for targeted island LGUs with onsite delivery during the first quarter of 2022.

"We are hastening efforts to immediately assist families in typhoon-hit regions, especially those whose homes were damaged or destroyed by Odette. We are also stepping up coordination with other government agencies to ensure faster delivery of relief and financial assistance to regions that were battered by the typhoon," the housing czar said.

"Rest assured that the government is doing the best it can to help all affected families as soon as possible," he added.

Meanwhile, the Pag-IBIG Fund, a key shelter agency of DHSUD, has allocated PHP5 billion in calamity loans for members affected by Odette.

According to the Fund, members may borrow up to 80% of their total Pag-IBIG Savings, with an interest rate of only 5.95%, which is the lowest in the market. Such loans are payable for up to three years with a grace period of two months.

Secretary Del Rosario had personally conducted ocular inspections in Surigao province in the aftermath of Odette. The housing czar flew to Dinagat Island and also visited Palawan with President Rodrigo Duterte to check on local residents and assess the extent of damage brought about by the typhoon.

President Rodrigo Duterte has reportedly instructed government agencies to "use all government assets we can" in order to provide for people affected by the typhoon. **(DHSUD)**

SC improves further in 2021 with 110% clearance rate

MANILA – The Supreme Court (SC) disposed of a record number of cases this year -- more than the new cases filed -- for a clearance rate of 110 percent, according to data provided by the Office of the Clerk of Court En Banc and the Divisions Clerk on Tuesday.

There were 3,603 new cases and one reinstatement filed, but the SC managed to resolve 3,975 cases, including those from the backlog. The SC also resolved 1,176

The SC also resolved 1,176 administrative cases and bar matters cases out of 1,116 new cases for a 105percent clearance rate. SC's clearance rate last

year was at 95 percent. "The 110-percent clear-

ance rate posted by the SC for 2021 comes as a ray of light in a year that has been marred with work suspensions, limited movement, and restrictions due to the pandemic, and speaks volumes of the Court's strength in staying true to its commitment of service to the nation and its people," Chief Justice Alexander Gesmundo said in a statement.

When he assumed his post in April, Gesmundo emphasized that he would focus on two things: decongestion of the Court's dockets and make the Judiciary technology-driven.

"I have resolved to decide all petitions, cases, or matters that have been filed before the Supreme Court after April 5, 2021 strictly within the said 24-month period from the date of submission pursuant to Section 15(1), Article VIII of the 1987 Constitution, and to strictly observe requirements for the proper exercise of its power of judicial review," he said then. Anti-Terror law

The year also saw the SC resolve a number of controversial cases, including the more than three dozen suits challenging Republic Act (RA) 11479 of the Anti-Terrorism Act.

The high court said aside from portions of Sections 4 and 25, all the other challenged provisions of RA 11479 are constitutional. Section 4 deals with excluding mass actions and similar exercise of civil and political rights from the definition of terrorism while Section 25 is about requests by foreign agencies to designate persons or organizations as terrorists. Petition vs. PRRD policy on territory

In June, the SC also affirmed the presidential prerogative in choosing the best course of action in handling territorial disputes with other countries, particularly in the West Philippine Sea (WPS).

In a nine-page decision by Associate Justice Rodil Zalameda, the high court dismissed "for utter lack of merit" the petition of lawyer Romeo Esmero, who accused President Rodrigo Duterte of "inaction/failure" to perform his duties in connection with the WPS dispute with China.

Esmero said the filing of diplomatic protests against China is "not a defense", saying the proper way for the Philippines to act is to ask the United Nations to send patrol boats, sue China before the International Court of Justice (ICJ), and demand payment and damages for taking Kalayaan Island.

The SC said no law justifies the action sought by the petition for the President to go to the UN or the ICJ to sue China nor is there any law that prescribed specifically how the President is to respond to any threat from another state.

The SC noted that a decision in the case against China before the United Nations Convention on the Law of the Sea had been handed down on July 12, 2016, but "If President Duterte now sees fit to take a different approach with China despite the said ruling, this does not mean that he has unlawfully abdicated his duty to protect and defend our national territory".

"Being the head of state, he is free to use his own discretion in this matter, accountable only to his country in his political character and to his own conscience," the court added.

Legal ed requirements clarified

In November, the SC upheld the jurisdiction of the Legal Education Board (LEB) but affirmed as unconstitutional its requirement for students to pass the Philippine Law School Admission Test (PhiLSAT) before being allowed to pursue a Law degree.

The SC struck down in its entirety LEB Memorandum Order (LEBMO) No. 7-2016 on the PhiLSAT requirement for being "unreasonably exclusionary, restrictive, and qualifying". The Court explained that LEB's requirement for prospective students to take

Post Office releases new stamps for 125th yr. of Rizal martyrdom

MANILA – The Philippine Post Office will issue new postage stamps on December 30 to commemorate the 125th anniversary of the martyrdom of Dr. Jose P. Rizal with this year's theme,

the PhiLSAT does not per se render it unconstitutional for as long as the results will only be recommendatory, with the law schools retaining the discretion to accept the applicant based on their policies and standards.

However, as an eligibility requirement, PhiLSAT is not a lawful method to attain the lawful subject of the State.

The ruling affirmed the 2019 decision, which declared unconstitutional paragraph 9 of the LEBMO which provides that all college graduates or graduating students must pass the PhiLSAT to gain admission to any law school in the Philipoines.

Indigenous peoples group get a break

At the start of the year, the SC ruled on a petition questioning the conviction of members of a Mindorobased indigenous peoples group for violation of Section 77 of Presidential Decree No. 705 of the Revised Forestry Code of the Philippines.

The SC acquitted the group on January 5, ruling that the Iraya-Mangyan tribe is a publicly known indigenous cultural community that can inhabit areas within Oriental Mindoro.

The case stemmed from a March 2005 incident in Barangay Calangatan, Municipality of San Teodoro, Oriental Mindoro when the IP group, without authority, knowingly cut a dita tree with an aggregate volume of 500 board feet.

In defense, they said the dita tree is planted within their ancestral domain and they cut it to construct a community toilet as instructed by their leaders. What to expect

In 2022 and beyond, Gesmundo said the country's courts must be "consistently efficient and accountable havens for the disadvantaged, the wronged, the injured".

Reforms are also necessary to keep in step with the changing times.

"Filipino talents and ingenuity should be recognized around the world. Rizal's sheer determination to achieve his goals to succeed should serve as an inspiration to Filipinos, especially the youth. Therefore, we should emulate the traits and ideas of our national hero," Postmaster General Norman Fulgencio said in a news release issued on Wednesday.

"The post office is now recognizing the talent and industry of the Filipinos here and abroad in pursuit of excellence and distinction in their work or profession by issuing stamps to honor artists, sports personalities, musicians and scientists, as well as other national and international figures, both living and posthumously."

Fulgencio said it would be nice to showcase all the Filipinos who have greatly contributed to the joy, inspiration, and pride of the nation.

PHLPost has printed 40,000 copies of the stamps, which were designed by in-house graphic artists Israel A. Viyo and Eunice Dabu. They will be sold for PHP12 each.

Stamps and Official First Day Covers are now available at the Philatelic Counter, Manila Central Post Office.

SC orders RTC to execute decision on Ortigas developers' dispute

MANILA – The Supreme Court (SC) has directed the Pasig Regional Trial Court (RTC) Branch 70 to proceed with the enforcement of a judgment in connection with a 2005 damage suit between developers in Ortigas.

The SC Second Division, in a 13-page decision uploaded on December 14, reversed the Court of Appeals (CA) and directed the Pasig RTC to examine officers of Meridien Far East Properties, Inc. (MFEPI) that will satisfy the judgment rendered in favor of Linden Suits Inc. (LSI).

LSI sued MFEPI as the latter's One Magnificent Mile encroached on its property, Linden Suites.

MFEPI removed the wall in question but did not finish the work, leaving LSI to hire a contractor to complete the demolition.

LSI then demanded PHP3.9 million from MFEPI that prompted the court case, filed in 2002.

The Pasig RTC found MFE-PI liable in 2005, a ruling subsequently upheld by the CA and the SC.

In 2009, the RTC issued a writ of execution in favor of LSI to enforce the judgment but it was returned unserved as the registered address belonged to Meridien East Realty and Development Corp, (MERDC), not MFEPI.

LSI pointed out that in documents submitted to the Securities and Exchanges Commission, MFEPI and MERDC had the same set of officers, same shareholders, and similar addresses.

LSI then asked that the officers of Meridien appear before the court for an examination of the income and properties owned by MFEPI to satisfy the judgment but the RTC turned it down, saying MFEPI is a juridical entity separate from the officers and that its principal business address is in Makati City which is not within Pasig's jurisdiction.

Ruling otherwise, the SC said it is the Pasig court that rendered the judgment against MFEPI and it "has supervisory control over the execution of its judgment".

The SC added that the RTC "should have issued auxiliary writs and employed processes and other means necessary to execute its final judgment" and likewise conducted an examination of MFEPI and its officers "so as to disclose the properties which can be subjected to execution". (PNA)

MANILA -- With consumers expected to do millions of pesos worth of shopping online this holiday season, the Land Bank of the Philippines (LANDBANK) advises its customers to remain vigilant against online banking fraud and assures that the Bank maintains the highest level of security in all its systems.

"As online shopping becomes a more prudent option to limit physical contact during this season, we would like to remind our customers to be on their guard against different forms of cyber fraud. The best way to avoid becoming a fraud victim is to stay vigilant by being familiar with the online red flags," said President and CEO Cecilia C. Borromeo.

The state-run Bank warns customers to ignore suspicious emails, social media messages, SMS, links and attachments, especially from unknown senders. It also reminds customers to be wary of fake websites. social media accounts and fraudulent transactions by checking and verifying the site's URL, the sender's email address, social media account, or phone number.

Customers are advised not to share their username or log-in ID and password to anyone, and keep critical financial information private, including the card number,

DOJ, bankers boost measures to combat cybercrime

MANILA – The Department of Justice (DOJ) and a bankers' group will draft a memorandum of understanding (MOU) as part of a consolidated effort to fight online fraud.

DOJ Office of Cybercrime (DOJ-OOC) officer-incharge lawyer Charito Zamora said pending the approval of the MOU, the agency has been consistently cooperating with the Bankers Association of the Philippines (BAP) through capacity building and public awareness on cybercrime. "The collaboration eyes achieving the common goal of establishing a collective, coordinated, and strategic

cyber response within the

banking industry through information sharing and collaboration," she told reporters via text message on Monday.

"To this end, an MOU between DOJ and BAP is being finalized to establish a formal agreement that would promote a genuine atmosphere of collaboration and alliance through an effective and efficient partnership meant to curb cybercrime and cyber-related offenses nationwide," she said.

Recently, depositors of a universal bank lost money through an online fraud which involved transfer to another bank, bypassing the security measure of sending a one-time PIN (Personal Identification Number) to the registered mobile number of the account holder.

The bank promised to return their money.

Ramon Jocson, BAP cybersecurity committee vice chair, said in a November report that banking fraud during the pandemic reached PHP1 billion in terms of unauthorized withdrawals and transfers.

Republic Act 10175 or the Cybercrime Prevention Act of 2012 created the OOC under the DOJ and designated it as the central authority for international mutual assistance and extradition for cybercrime and card expiry date, credit verification value (CVV), and one-time password (OTP). Official LANDBANK representatives will never ask for critical financial information of its customers.

Specific to raising awareness on phishing activities, customers are also advised to be wary of emails, text messages, and websites offering free perks or games in exchange for personal information, which are designed to steal customer's hard-earned money and identity. LANDBANK said reminders and best practices to avoid cyber fraud are also being posted regularly on its social media channels. These include tips on spotting cyberattacks, preventing different forms of phishing, and keeping online credentials confidential, among others.

DENR, LGU join hands to expedite land titling in Taal, Batangas

MANILA – The Supreme Court affirmed the 2019 ruling of the Sandiganbayan that found a former regional director of the Philippine Drug Enforcement Agency (PDEA) liable for grave threats on a subordinate eight years ago.

The SC First Division upheld the guilty verdict on Juvenal Azurin and sentenced him to two months and one day in prison, according to a 12-page decision written by Associate Justice Alfredo Caguioa and published online December 10.

A fellow PDEA employee, Jaime Clave, accused Azurin of berating him and threatening his life through a phone call on Nov. 15, 2013.

Three years after the incident, Clave said he regretted filing the case and submitted an affidavit of desistance and a motion to dismiss to the Sandiganbayan.

The SC, however, ruled that the felony of grave threat "is consummated as soon as the threats come to the knowledge of the person threatened".

Azurin. director of the Regional Office No. 2 in Tuguegarao City, Cagayan at the time, accused Clave of sending text messages to PDEA higher-ups about the goings-on in the regional office and issues pertaining to operational funds.

Clave, an agent since 2007, stated in his administrative complaint before the Internal Affairs Services Office that he feared for his life when Azurin made the call. (PNA)

NCR, Calabarzon top list of areas with new Covid-19 cases

MANILA - The Department of Health (DOH) on Monday logged 318 new coronavirus disease 2019 (Covid-19) cases, bringing the nation's overall tally to 2,838,792.

Monday's new infections were slightly lower than Sunday's 433. This brought the total number of active infections to 9.579.

The top regions with the most cases in the last two weeks were the National Capital Region with 130 or 41 percent, Calabarzon with 45 or 11 percent, and Central Luzon with 28 or 9 percent of the country's new cases.

In its Covid-19 bulletin, the DOH said 255 new recoveries pushed the total recovery count to 2,778,002. Of the active cases, 3,644 are mild, 445 are asymptomatic, 374 are critical, 1,777 are severe, and 3,339 are moderate.

"Of the 318 reported cases today, 315 or 99 percent occurred within the recent 14 days -- December 14 to 27, 2021," the DOH said.

The death toll has reached 51,211 with 11 new deaths. "Of the 11 deaths, 9 or 82 percent occurred in December 2021 and 2 or 18 percent in October 2021," the DOH said.

The COVIDKaya is a digital

application used by health care workers to collect and share data about Covid-19

cases. The DOH added that this issue is currently being coordinated with the Epidemiology and Surveillance Units to ensure information is up to date.

According to DOH data on December 25, about 2.2 percent of 14,237 who were tested turned out positive for Covid-19.

"There were 166 cases that have tested negative and have been removed from the final case count and reclassified as recoveries," the DOH said.

It added five cases that were previously tagged as recoveries were reclassified as deaths after final validation.

Two laboratories were not operational on December 25 and 26 and were not able to submit their data to the Covid-19 Document Repository System.

Of the 26 laboratories, 12 confirmed that they were closed and non-operating on December 25.

The DOH noted that the 28 laboratories contribute. on average, 9.5 percent of samples tested, and 6.4 percent of positive individuals based on data in the last 14 days.

The Department of Environment and Natural Resources (DENR) CALABARZON enters into a Memorandum of Partnership Agreement (MOPA) with the municipal government of Taal, Batangas for the conduct of the Rapid Land Tenure Appraisal (RLTA) in the said municipality, on December 13, 2021.

It paves the way for the faster titling of lands in a municipality or city as all potential lots for patent applications in the area will be identified once land tenure profiling is completed.

DENR CALABARZON Regional Executive Director Nilo Tamoria said the main purpose of land titling is to provide security of tenure to the locals. 





TAGUIG CITY -- The Technical Education and Skills Development Authority (TESDA) is now providing relief efforts in areas hit by Typhoon Odette and are set to conduct construction-related skills training to the affected residents.

Amid the Christmas season, several TESDA Regional and Provincial offices have started their "TESDAmayan" activities in the communities affected by the typhoon.

"TESDAmayan" is the agency's banner program that aims to aid communities affected by any crisis brought about by natural calamities, disasters, or any other untoward incidents which causes displacement among the residents.

In Region VI, several personnel from the field offices were deployed in the affected areas to help rebuild damaged buildings and to conduct clearing operations.

Likewise, Provincial Training Center (PTC) – Kabankalan in Negros Occidental has installed solar-powered charging station freely available for residents who need to recharge their mobile phones.

Also, in Region VIII, food packs, clean water, and used clothing were distributed in the region. It added that they are preparing for other interventions to be provided by its provincial offices.

In Region XIII, PTC - Agusan Del Norte provided food, bottled water and facemasks to some 225 individuals at Brgy. Humilog in the municipality of Remedios T. Romualdez last December 18. Meanwhile, in a memorandum, TESDA Sec-

randum, TESDA Secretary Isidro Lapeña reiterated his previous di-

rective to all regional and provincial offices to immediately prepare training programs in areas affected by disasters and natural calamities.

Field offices, according to Lapeña, shall provide community-based training and training-cum production on constructionrelated qualifications to make the affected residents capable of rebuilding their houses.

"I have directed our Regional and Provincial Offices to expedite the provision of training on construction-related courses such as Carpentry and Electrical Installation so the displaced residents can immediately rebuild their homes. May 160 pesos allowance per day pa silang matatanggap," the TESDA Chief said.

"Since it will also take some time before electric power is restored in these areas, there will also be training on solar panel installation, the Photovoltaic Systems Installation, so that solar power can be generated," Lapeña added.

President Rodrigo Duterte has declared a state of calamity in areas battered by Typhoon Odette, particularly Mimaropa (Region IV-B), Western Visayas (Region VI), Central Visayas (Region VII), Eastern Visayas (Region VIII), Northern Mindanao (Region X), and Caraga (Region XIII).

"Despite the pandemic, TESDA is here to provide relevant training programs as part of the collective action to support the rehabilitation of these disaster-stricken areas and ensure the well-being of all affected Filipinos," Lapeña said. (TESDA)

4.7M DISPLACED WORKERS BENEFIT FROM AID PROGRAMS: DOLE

MANILA – As the coronavirus disease 2019 (Covid-19) andemic took a toll on economies and greatly displaced many industries and workers, the Department of Labor and Employment (DOLE) has achieved significant accomplishments in assisting local and overseas workers in coping with the challenges of the new normal.

Citing the latest DOLE data released on Monday, Secretary Silvestre Bello IIII said the agency has further intensified the implementation of its three major social amelioration programs to help affected workers recover from the pandemic.

Covid-19 response

Bello said a total of PHP26.1 billion worth of social protection assistance under the Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers (TUPAD), Covid-19 Adjustment Measures Program (CAMP), and Abot-Kamay ang Pagtulong (AKAP) benefitted 4.707 million distressed formal and informal workers, including overseas Filipino workers (OFWs). Under TUPAD, 1.993 mil-

lion workers from the informal sector were hired thru an emergency employment program amounting to PHP9.62 billion.

The TUPAD is a community-based amelioration program that provides jobs for displaced, underemployed, and seasonal workers for a minimum period of 10 days to a maximum of 30 days, depending on the nature of work to be performed.

They are paid based on the prevailing minimum wage in the region and will be received through a money remittance service provider.

For CAMP, a total of 2.173 million workers from private establishments, including those in the tourism industry and the education sector, received financial assistance amounting to PHP10.894 billion.

Each employee received a one-time cash assistance of PHP5,000.

A total of 540,876 displaced OFWs benefitted from the AKAP Program with a budget of PHP5.487 billion. The workers received a one-time financial aid of PHP10,000 (US\$200).

Looking after OFWs Bello said government services also served a significant number of Filipinos working abroad.

He reported that some 759,158 OFWs were served by the 18 One Stop Shop Service Centers nationwide of the Philippine Overseas Employment Administration (POEA).

The 39 Philippine Overseas Labor Offices (POLOs) assisted 1.522 million OFWs onsite.

As of December 15, the Overseas Workers Welfare Administration (OWWA) has repatriated 837,080 OFWs. It also provided scholarships to OFW dependents totaling 95,387 through its Tabang OFW and scholarships under the Emergency Subsidy Program (ESP).

The DOLE added that President Rodrigo Roa Duterte signed Executive Order 154 on December 7, hastening the completion of the OFW Hospital that will cater primarily to the health care needs of overseas Filipino workers (OFW) and qualified dependents.

Also this year, it signed two bilateral labor agreements with two countries, namely: Romania and the United Arab Emirates to set standards and conditions on employment of OFWs. Bello also assumed the chairmanship of the government group at the International Labor Organization, the first non-regular member country of the ILO to take such a role.

On the other hand, 9,610 seafarers were trained with maritime-related courses, while 102,661 graduates of professional courses were administered with licensure examinations.

Meanwhile, the DOLE has also inspected 90,327 establishments covering 3.692 million workers to enforce labor laws and occupational safety and health standards.

It also certified 900 establishments with Safety Seals and trained 26,295 workers

on occupational safety and health standards as of December 15.

Employment opportunities The DOLE has facilitated the employment of 1.66 million jobseekers through the Public Employment Service Offices (PESOs) and assisted 188,782 youth through the Special Program for Employment of Students, Government Internship Program, and JobStart Philippines. Provided labor education and workers' organization and development program to 836,612 beneficiaries.

At the same time, it also resolved 72,040 cases benefitting 141,143 workers resulting in PHP8.551 billion monetary awards. The DOLE also provided training to 14,099 establishments benefitting 14,988 employers and workers to stimulate the competitiveness of micro, small, and medium enterprises (MSMEs).

To continuously aid the vulnerable sectors from the effects of the pandemic, the Department provided livelihood assistance to 66,186 beneficiaries; and emergency employment to 2.143 million beneficiaries to help workers particularly those needing income support during this pandemic. Bello, meanwhile, said more countries such as Canada, Israel, and Germany are offering job opportunities for Filipino workers.

Among the available jobs in these countries are chefs in restaurants and nurses in healthcare institutions. (PNA)

PH 2021 population growth lowest in 7 decades

MANILA – The Philippines' population for 2021 increased by 324,000 or a mere 0.3 percent compared to the 2020 data of 914,797 births.

The Commission on Population and Development (PopCom) said on Monday the annual "natural increase" was the lowest since the period 1946 and 1947 when the population grew by 254,000.

"Filipinos remained prudent by continuing to delay having children or forming families during the combined economic crisis and Covid-19 health emergency. Couples in growing numbers continue to avail of family planning commodities and services in all regions of the country, with eight million users of modern family planning methods in 2020, or an addition of about 500,000 from 2019," PopCom chief Dr. Juan Perez III ex-

plained in a livecast. The data came from PopCom's computations based on the Philippine Statistics Authority's preliminary reports from January 2020 to August 2021.

With the estimate, the

Filipino population will be about 109,991,095 by the end of 2021, lower by two million than earlier projections based on a 1.63 percent population growth rate.

Perez said the low 2020-2021 population growth means a greater chance for the country and households to recover from the Covid-19 outbreak, coupled with the national and local governments' increased capabilities in providing quality services. "If integrated population and development measures are sustained, we can look forward to a more stable population that can effectively support Philippine development. Smaller family sizes need to be supported by a national living wage structure that also allows parents to save for their households' unmet needs in food, housing, and education. Uneven regional wage structures only lead to individuals falling further behind than those in progressive areas such as the National Capital Region, Calabarzon, and Central Luzon," Perez said. (PNA)

CHIZ SA PHILHEALTH: PIGILAN ANG PAGKALAS NG MGA OSPITAL, RESOLBAHIN ANG PAGKAKAUTANG

"Papaano mabibigyan ng universal health care ang mga Pilipino kung patuloy na nilalayasan ng mga ospital ang PhilHealth? Siguradong mapipilayan dito ang pagpapatupad ng Universal Health Care Act dahil importante ang private hospitals sa pagkakaroon ng masasandigang health service provider network, lalo na sa mga siyudad at bayan na walang public tertiary hospitals," ani Escudero.

Kahit na nagbibigay ang mga ospital ng dokumentasyon para makapagreimburse sa PhilHealth ang mga pasyente, hindi naman ito uubra para sa mahihirap na pasyente na walang kakayanang magpaluwal sa kanilang gastusing medikal, anang gobernador at senatorial aspirant.

"Kung ang mga malalaking ospital mismo ay pipiliing kumalas sa PhilHealth dahil hindi sila makasingil, paano pa ang mga mahihirap na walang koneksyon o panahon para mag-follow up ng mga claims nila? Kaya nga tayo may PhilHealth para mabawasan ang babayaran natin at hangga't maaari ay walang out-ofpocket expenses ang mga pasyente," aniya.

Nitong umpisa ng buwan, pitong malalaking ospital sa Iloilo ang kumalas sa

PhilHealth dahil may utang sa kanila na P545 milyon ang ahensiya habang sa Metro Manila naman, ang Far Eastern University-Dr. Nicanor Reyes Medical Foundation ang unang pribadong hospital na hindi nag-renew ng accreditation sa PhilHealth dahil sa unpaid claims na nagkakahalaga ng P200 milyon.

Nagbabala ang Private Hospitals Association of the Philippines Inc. na may mga ospital sa Quezon, Isabela, at General Santos ang inaasahang kakalas na rin sa PhilHealth sa kaparehong rason at nangangahulugan lamang ito na lalong darami ang mga pasyente sa buong bansa ang kailangan munang magbayad nang buo bago isauli ng PhilHealth ang kanilang pera.

"Kailangang ma-explain ng PhilHealth kung bakit nagkakautang-utang sila sa mga ospital. May budget naman sila para magawa nila ang kanilang mandato na siguruhin ang kalusugan ng bawat Pilipino sa pamamagitan ng insurance coverage at dito pa naman nakaangkla ang health reforms na nilalaman ng UHC Act," ani Escudero. **PR**




