Matapos ang pananalasa ng super typhoon Odette sa bansa na nakaapekto sa libo-libong Pilipino, isinusulong ni Sorsogon Gov. Chiz Escudero ang pagtatayo ng mga permanente at ligtas na bahay para sa mga pamilyang naninirahan sa mga baybayin at peligrosong lugar upang maprotektahan ang kanilang buhay at ari-arian, lalo na kapag may matitinding kalamidad.

Kasabay nito, ipinapanukala ni Escudero sa gobyerno na ideklarang "no build" zones ang mga lugar na sa tingin nito'y delikadong tirhan ng tao at bukod pa ito sa isang nilalaman ng Republic Act 11038 o ang "Expanded National Integrated Protected Area System (NIPAS) Act of 2018" kung saan tahasang ipinagbabawal ang pagtatayo ng mga bahay at iba pang permanenteng estruktura sa mga napakapeligrosong lokasyon.

"Saksi naman ang lahat na sa kada panahon ng tagulan at lalo na kung may malalakas na bagyo, nagkukumahog tayong iligtas ang mga kababayan natin na nakatira sa mga bavbayin at peligrosong lugar. Binigyang-diin ni Escudero na bukod sa mga tinukoy na "no build" zones sa mga rehiyon na sinalanta ng super typhoon Yolanda noong 2013, kailangan ding maglabas ng gobyerno ng isang komprehensibong listahan na naglalaman ng lahat ng peligrosong lugar sa bansa na hindi kailanman puwedeng tirhan ng mga tao.

Habang nakabinbin ang pagkompleto sa nasabing listahan at ang buong implementasyon ng RA 11038 na nagbabawal sa pagtatayo ng mga permanenteng estruktura sa loob ng 40 metro mula sa bavbayin, sinabi ni Escudero na dapat nang maghanap ang pambansang gobyerno at ang mga lokal na pamahalaan ng mga lugar ng relokasyon at maglaan ng sapat na pondo para sa pagtatayo ng mga bahay ng mga maaapektuhang pamilya. SC orders physical closure of courts in Alert Level 3 areas

MANILA – Chief Justice Alexander Gesmundo on Wednesday ordered the physical closure of all courts in areas under Alert Level 3 until the end of January amid the continued surge in coronavirus infections.

In Memorandum 10-2022 cited Gesmundo the unabated rise of cases of Covid-19 due to the Omicron variant in the Capital Region, National Bulacan, Ecija, Nueva Cavite, Rizal, Laguna, and other areas placed under Alert Level 3--Baguio City in the Cordillera Autonomous Region; Dagupan City in Region 1; Santiago City and Cagayan in Region 2; Angeles City, Bataan, Olongapo City, Zambales in Region 3; Batangas and Lucena City in Region 4-A; Naga City in Region 5, Iloilo City in Region 6 and Lapu-Lapu City in Region 7.

"All courts in the above mentioned-areas from the Supreme Court down to the first level courts shall be physically closed to all users and may be reached only through respective hotlines, their and email addresses Facebook accounts, and if available, effective tomorrow, 13 January 2022, Thursday until 31 Monday," January 2022, Gesmundo said.

directive, Under the all in-court hearings suspended but fully remote videoconferencinghearings may proceed on urgent matters, such as inquests, bail hearings, promulgation of acquittals or dismissals, temporary or permanent protection order, habeas corpus suits, and similar cases and election-related cases.

The high court earlier announced the extension of deadlines for all court papers due in January as soaring coronavirus infections affected operations of several institutions. (**PNA**)

CA affirms grant of disability benefits to seafarer

MANILA – The Court of Appeals (CA) has affirmed the grant of US\$60,000 (around PHP3 million) in full permanent and total disabilitybenefitstoa Filipino seafarer who was found to have been no longer fit for work by his company's doctors following a medical condition in 2018.

In its 12-page decision dated December 29 and recently made available, the CA's Ninth Division affirmed the arbitrator's judgment dated November 4, 2020, in favor of seafarer Artemio G. Oberes Jr., and said parties may request a third opinion from a physician in such cases.

Among other things, the CA said Oberes' employer Magsaysay Maritime Corp. (MMC) failed to refer his case to a third doctor despite a request from Oberes and said the assessment of the company-designated physician is not binding.

The CA noted that the Philippine Overseas Employment Administration Standard Employment Contract (POEA-SEC) does not require a specific period within which the parties may seek the opinion of a third doctor, and they may do so even during the mandatory conference before the labor tribunals. "Accordingly, upon being notified of Oberes' intent to dispute the company doctor's findings, the burden to refer the case to a third doctor has shifted to MMC. This the company failed to do so, and Oberes can no longer be faulted for the non-referral. Consequently, company-designated the assessment of doctors' Oberes' disability is not binding," the court said. In January 2018, Oberes suffered multiple joint pain and disembarked was and admitted to a medical facility in Panama and was eventually he medically repatriated back to the country where he was diagnosed with seronegative rheumatoid arthritis.

On August 28, 2018, he underwent medical examination where he was found by doctors to be unfit to work as a seafarer given his condition.

In November of that year, Oberes sought a grievance meeting regarding the payment of his disability benefits and the possibility of referring him to a third doctor for an independent medical assessment. He then sued to be granted full disability benefits claiming his disability is work-related. (**PNA**)

PNP focal persons as journos' 'first line of defense' lauded

MANILA - Describing it as journalists' "first line of defense," Undersecretary Jose Joel Sy Egco, executive director of the Presidential Task Force on Media Security (PTFoMS), has welcomed the directive of the Department of the Interior and Local Government (DILG) to officers designate of Philippine National the Police (PNP) as Media Security Focal Persons in each province and city nationwide.

"With the elections fast approaching, we are very grateful to DILG Secretary Eduardo Año and Undersecretary Jonathan Malaya for this welcome and important development in our quest to protect the life, liberty and security of media workers," Egco said in a news release on Wednesday.

He added that "this is a significant milestone to shield journalists from threats and other forms of violence throughout the archipelago."

Egco earlier cited the increasing incidents of violence against journalists before, during, and after the elections which the Task Force seeks to prevent as one of the reasons for the request to designate Focal Persons coursed through Malaya as Undersecretary for Plans, Public Affairs and Communication.

"The infamous massacre in Ampatuan, Maguindanao in November 2009 is a constant reminder that media workers are mostly vulnerable a few months before, during and a few months after every election," Egco said. "We will never let this happen again."

PTFoMS' request was expeditiously and favorably acted upon by the DILG in anticipation of a possible increase in violent incidents involving mediamen during the election season as it shared the views of Egco as head of the Task Force on the need to protect journalists and other media practitioners from threats and violence during this critical period.

The DILG and the PNP are both members of the Task Force under the Office of the President.

Egco said as the "first line of defense" of journalists even in the most far-flung areas of the country, the Focal Persons will be the first to receive and respond to all threats leveled against any media worker.

He said the Focal Persons will also coordinate directly with the assigned PTFoMS Special Agents (SAs) in expediting the resolution of cases of violence against journalists.

"We took this initiative to request for high ranking PNP officers as Focal Persons because we could foresee what will be necessary for the future in terms of safety and security for members of the 4th Estate as mandated by President Rodrigo Duterte in his Administrative Order No. 1 (AO1)," the Palace official added.

Created by Duterte in 2016 to stop the slew of media killings that happened during past administrations, by 2021, PTFoMS oversaw the 51st case of media killing that resulted in a guilty verdict, bringing to 68 the total number of media killers that were convicted by the courts.

He said media freedom in the country is stronger than ever as proven by Reporters Without Borders' (RSF) 2021 Press Freedom Index where the country's ranking for the past five years remained better than during past administrations. This, as the RSF noted a global decline in the Index because of the pandemic. Egco said Duterte's lowest grade in the index was the late President Noynoy Aquino's highest grade. He added that far fewer journalists have been present the killed in administration than during the terms of former President Gloria Arroyo or Aquino, a testament to the political will of Duterte to end media violence.

Egco also pointed out that with the immense support of Duterte, it was only in 2019 that justice was finally served to the perpetrators of the Ampatuan Massacre when the masterminds and their cohorts were convicted by a Quezon City court for multiple counts of murder, including members of the once-powerful Ampatuan clan.

The Ampatuan Massacre of 2009 claimed the lives of 58 individuals, including 32 media workers. Considered to be the worst attack

QC to give unvaxxed vendors financial aid to get jabs

MANILA – Acknowledging that most of those who unvaccinated remain against the coronavirus disease 2019 (Covidvendors, the 19) are Quezon City government will provide incentives to encourage them to get their jabs.

In a statement Wednesday, QC Mayor Joy Belmonte said among those who are still unvaccinated are market vendors, market employees, and ambulant vendors who are earning their livelihood on a day-today basis.

Belmonte said the city government will thus provide these market employees and vendors a financial aid of PHP2,000 to offset their income lost because of closing their stalls to go to the vaccination sites amid the rising number of Covid-19 infections.

"Most market vendors cannot leave their stalls because of possible loss of income. So to encourage them to take a day off to get vaccinated, we will provide them with incentives," she said.

Among those who will be eligible to receive the financial assistance are QC resident market vendors, market employees, and ambulant vendors that have not been vaccinated as of Jan. 7, 2022, and who are willing to be vaccinated and are able to show proof of at least a first dose vaccination from January 8 to January 31.

Memorandum No. 03-22 issued by Belmonte on January 7 states that a masterlist of eligible persons shall be prepared by the Market Development and Administration

Eligible persons should be able to prove their status as market vendors, ambulant vendors, or market employees through previous registration with MDAD, or by presenting a vending permit, certification from their barangay, or reputable vendors association, and proof of residency in QC through valid identification any cards.

The list shall then be submitted to the City Health Department (CHD) for the facilitation of their inoculation schedule at vaccination sites nearest them.

Belmonte said any person caught providing false information to obtain financial assistance may be prosecuted under Ordinance No. SP3032 which prohibits Covid-19 vaccine fraud.

She said with the issuance of MMDA (Metropolitan Development Manila Authority) Resolution No. 22-01, those who fail or refuse to get vaccinated shall be required to undergo a Covid-19 swab test every two weeks at their expense and present a negative result before being admitted to work onsite.

She added the city government further reinforced the resolution through City Ordinance SP 3076-S2022 that provides employees and workers a grace period of one month to get at least a first dose before the provision for a mandatory bi-monthly reverse transcriptionpolymerase chain reaction (RT-PCR) or antigen test is implemented.

Violators will be charged with a penalty of PHP500 for the first offense, PHP1,000 for the second offense, and PHP3,000 for the third and subsequent offenses.

"This program is aimed at protecting both the market vendors and their customers who they come into close contact with every day. If they get vaccinated, we are protecting them from serious illness and improving the city's overall immunity," Belmonte said. (PNA)

HAVE KIDS WITH MILD SYMPTOMS CHECKED BY DOC: HEALTH EXPERT

MANILA Children experiencing cough, colds and fever, also the symptoms of coronavirus disease 2019, should get checked by a physician better evaluation, for an infectious diseases expert advised parents on Tuesday.

Department of Health (DOH) Technical Advisorv Group member Dr. Ana Ong-Lim said this flu season, it is difficult to whether these identify symptoms are caused by Covid-19.

"Pinakamaganda pa rin na magkaroon tayo teleconsult o na kaya kumusulta sa doctor para mai-evaluate, kung iyan ba ay pwedeng ipagpahinga na lang or kailangan pang mag-work up para malaman kung ito nga ay Covid (It is best for them to have a teleconsult or be consulted by a doctor so it can be evaluated, if rest will do or a workup must be done to identify whether it's Covid)," she said during a televised public briefing.

If a child with mild symptoms belongs to a household with a Covid case or adults are experiencing symptoms of the disease, the child could "Covid-19 probable," be Lim said.

As the vaccination of children ages 5 to 11 vears old nears, Lim disclosed that the DOH would prioritize those with comorbidity for this age group - the same strategy used in the inoculation of children ages 12 to 17 vears old.

there is However, а possibility that children for such age group - with or without comorbidity - can be vaccinated at the same time if the country gets enough supply of the jabs specifically formulated for them, Lim added.

Earlier, health experts explained that the expected adverse events following immunization for 5- to 11-year-old children are similar to those in other age groups.

BOC collects P1.5 BILLION additional revenues through Post Clearance Audit in 2021

In its bid to collect lawful revenues, the BOC through the Post Clearance Audit Group (PCAG) reported its annual accomplishment and revenue collections Executive during an Committee Meeting of the BOC in January 2022.

In its report, the PCAG highlighted its successful collection of additional revenues from January to December 2021 amounting to Php 1,522,216,793.42 as part of the 349 Audit Letters (ANL) Notice issued.

Said collection is 25% higher than its revenue collection from the previous year.

Additionally, PCAG stated that it is optimistic to legally collect more revenues from post clearance audits with pending status from 2019

to 2021. Presently, there are Fifty Five (55) demand letters amounting to Php 12,468,110,546.82 billion which have become final and executory for failure of the audited importers to contest the same. These are now being referred to the BOC Legal Service for filing of the necessary collection suit.

PCAG headed by Assistant Commissioner Vincent Philip C. Maronilla, BOC the and under leadership Commissioner Rey Leonardo B. Guerrero, emphasized the importance of post clearance audit and the additional revenues that it generates especially as the nation continues to recover from the impact of COVID-19.

PH economy seen growing 6-7% in 2022

MANILA – The Philippine economy is expected to return to its 6 to 7-percent growth trajectory in 2022 after nearly two years of grappling with the pandemic despite the threat of the Omicron variant, according to the investment banking arm of the Metrobank Group.

First Metro Investment Corporation (FMIC) said year's economic this growth will be driven sustained domestic by demand, easing inflation, election expenditures, and accelerated government spending on infrastructure projects.

"Notwithstanding the ongoing pandemic, and sparking the Omicron third wave of infections, we are still optimistic that growth Philippine will further accelerate and get back on its trajectory of 6-7 percent in 2022," FMIC president Jose Patricio Dumlao said in a virtual briefing Tuesday.

Dumlao said the economy registered a 4.9-percent growth in the first three quarters of 2021 and the growth momentum likely spilled over in the fourth quarter given further economic reopening and easing mobility restrictions. He added business and consumer confidence are cautiously positive also given wider availability of vaccines and relaxation of lockdowns, quarantine measures, and mobility restrictions.

University of Asia and the Pacific (UA&P) economist Victor Abola said Dr. the 6 to 7 percent gross domestic product (GDP) projection this year will be led by the industry sector --both construction and manufacturing.

Abola said services will still be the lagging sector as the pandemic measures hit hotels and restaurants.

"The Philippine situation is that there is recovery but still on the way to reach the pre-pandemic levels," he said.

GDP country's The posted a -9.5 percent fullyear growth rate in 2020 compared to its 5.9 percent pre-pandemic performance in 2019.

Abola said the business

process outsourcing (BPO) is a major contributor to the resiliency of the economy amid the pandemic.

"And it's not the same as usual call centers, etc. You can see there are new, emerging segments and that is what companies are focusing on," he said, citing insurance, life sciences, healthcare, and data analytics, among others. Aside from BPO revenues,

FMIC chairman Francisco Sebastian said the overseas Filipino workers (OFW) remittances are boosting the economy.

"These two things are not as sexy as other things like technology and telecoms... This is what is holding us up. OFW remittances continue to grow," he said. (PNA)

DepEd posts 96% budget utilization rate, higher than past admin

Gov't sets sights on 90M full doses, 71M booster shots this year

MANILA - More than 71.16 million adult Filipinos are expected to have received booster vaccine doses against Covid-19 by the end of the third quarter this year.

They will come from the projected 90 million fully vaccinated Filipinos before the end of June.

In his report during President Rodrigo Duterte's Talk to the People aired late Monday night, National Task Force Covid-19 Against chief implementer Secretary Carlito Galvez Jr. also enumerated the various challenges of the vaccination program.

On top of the list is the rising infection rate among health care workers that have depleted the manpower of vaccination sites.

Some local government units are also busy with electionrelated activities while brand preferences "greatly affect and compromise the shelf life of other effective vaccines'

The regions most devastated by Typhoon Odette still have low vaccination output as electricity has yet to be completely restored.

"We will pursue the vaccination of 77 million Filipinos before the end of [Quarter 1] 2022, while at the same time, finishing the 12-17 years old by end of Q1 also," Galvez said.

'Our last milestone is to finish the booster of 71.16 million by end of the third quarter and we will push also for the vaccination of the rest of the population to make sure that all Filipinos are protected by the vaccines," he added.

Based on the latest data from the National Covidvaccination dashboard, 19 the Philippines has already administered 114.249.221 doses nationwide -- 52.849.101 with complete doses and 3,577,703 with booster shots or additional doses. (PNA)

Law granting benefits to deceased state prosecutors' kin inked

MANILA – President Rodrigo R. Duterte has signed into law an act granting survivorship benefits to the surviving legitimate spouse and dependent children of a deceased retired member of the National Prosecution

Service (NPS). Republic Act (RA11643 mandates the surviving spouse and legitimate dependent children of said deceased member to be entitled to receive all the retirement benefits that the deceased was receiving or entitled to receive, provided that the deceased state prosecutor is eligible to retire optionally at the time of death.

Members of the NPS shall include all prosecutors in the Office of the Secretary of Justice, the Regional Prosecution Offices, and the offices of the Provincial and City Prosecutors.

RA 11643 refers to "dependent" as а legitimate, illegitimate, or legally adopted child who is chiefly dependent on the said deceased member of the NPS.

They should be aged 21 and below, unmarried and not gainfully employed, or regardless of age, is

incapable of self-support because of any mental physical defect or or condition.

Under the law, the surviving legitimate spouse shall continue to receive during their lifetime said retirement benefits until such spouse remarries, provided that the surviving spouse and dependent children shall each equally share the retirement benefits.

The amount necessary for the immediate implementation of this included Act shall be in the annual General Appropriations Act.

The benefits provided in this Act shall also be granted to the surviving spouse and dependent children of the member of the NPS who died one year prior to the effectivity of this Act.

RA 11643 was signed by Duterte on Tuesday but was released to reporters on Thursday,

This act is a consolidation of House Bill No. 9087 and Senate Bill No. 2373 was passed by the House of Representatives and the Senate of the Philippines on November 29, 2021 and November 8, respectively. (PNA)

Shrimp head: From food waste to business

MANILA – To mitigate food waste, the National Fisheries Research and Development Institute (NFRDI) pushed to turn some of it into "something valuable."

Bassig, senior Rosa science research specialist of the Fisheries Postharvest Research and Development Division of NFRDI, said one of the most common food wastes is shrimp head that can be converted into shrimp powder and can be a potentially good source of income.

Based on her study released Wednesday, one kilogram of fresh shrimp heads can produce about 200 grams of shrimp power.

"Not bad for business, considering that what would have been just a waste was converted into something valuable," Bassig said.

The powder can be used as shrimp flavor seasoning, seafood broths, or soups, among others, she added.

The product has a storage life of up to six months when stored at 28-30°C based on a study published in The Philippine Journal of Fisheries.

The waste makes up approximately 50 percent of the raw material, which means almost half of the money spent goes down the drain already, it added. It also noted that improper disposal of these wastes may cause harm to the environment due to their nutrient-rich properties.

Locally produced Covid drug molnupiravir can cut prices up to 50%

MANILA - As Philippine pharmaceutical firm Lloyd Laboratories Inc. (LLI) aims producing molnupiravir in the country, prices of this coronavirus disease 2019 (Covid-19) drug could go down by 30 to 50 percent. LLI Business Development director Christopher Bamba said retail prices of imported molnupiravir cost around PHP100 to PHP150 per 200-milligram capsule.

"For our pricing, we are usually 30 to 50 percent lower and this is our price strategy being a local manufacturer and a generic company," Bamba said in a media interview Thursday. If the local production will push through, prices of this medicine could be reduced to PHP50 to PHP75 per capsule.

Before the incident, Angeles had resigned from Radyo ni Juan to run for councilor in his hometown of Lambayong.

"Even if Mr. Angeles is a former media practitioner, the Task Force will not stop until the masterminds and their cohorts are caught, charged, and convicted for this heinous crime. There is no justification for murder, whatever Angeles may have been involved with in the past," Egco said.

The incident occurred after the Department of the Interior and Local Government (DILG) recently directed the PNP to designate Media Security Focal Persons in each province and city nationwide upon the request of PTFoMS, citing the increasing incidents violence against of iournalists before, during, and after the elections.

PTFoMS' request was expeditiously and favorably acted upon by the DILG in anticipation of a possible increase in violent incidents involving media workers during the election season.

Eaco said as the election draws near, the focal persons will serve as the "first line of defense" of journalists even in the most far-flung areas of the country as they will be the first to receive and respond to all threats leveled against any media worker.

He said the focal persons will also coordinate directly with the assigned PTFoMS Special Agents (SAs) in expediting the resolution of cases of violence against journalists.

"We took the initiative to request for high ranking PNP officers as focal persons because we could foresee what will be necessary for the future in terms of safety and security for members of the 4th Estate as mandated by President Rodrigo Duterte in his Administrative Order No. 1 (AO1)," Egco said. intensified anti-illegal The drug effort of the Bureau of Customs - Port of Clark once again resulted in a successful controlled delivery operation, in coordination with PDEA, CAIDTF, ESS, XIP, and CIIS, as it arrested the claimant of a seized shipment containing Methamphetamine Hydrochloride and Marijuana last January 12, 2022.

The shipment was declared as "pens" from Henderson, Nevada, USA and upon arrival was subjected to profiling and noted for a physical examination which resulted in the findings of eight (8) pcs. Expo Marker Pens, one (1) pack of Dart Flights, one (1) pack of Dark Fights, one (1) pack of magazine labeled as "Pop Boys" concealing three (3) self-sealing transparent plastic sachets of suspected Shabu, and one (1) self-sealing transparent plastic labeled as "black label brand" of suspected Liquid Marijuana.

Said shipment was likewise Said shipment was likewise subjected to K9 sweeping conducted jointly by BOC & PDEA K9 Unit which gave positive indications. Representative samples were then turned over to PDEA for the conduct of chemical laboratory analysis which confirmed the presence of Methamphetamine Hydrochloride or Shabu on the three (3) self-sealing transparent sachets and

Tetrahydrocannabinol/ Marijuana on the self-sealing sachet of "black label brand". District Collector Alexandra Lumontad immediately issued a Warrant of Seizure and Detention against the subject shipment for violation of Sections 118 (g), 119 (d), and 1113 par. f, i & I (3 & 4) of R.A. 10863 otherwise known as the Customs Modernization and Tariff Act (CMTA) in relation to R.A. 9165 otherwise known as the Comprehensive Dangerous Drugs Act of 2002.

Thereafter, a controlled delivery operation was conducted on January 12, 2022 by the joint elements of PDEA, CAIDTF, ESS & CIIS to the consignee's address at Quezon City, Manila which resulted in the arrest of the claimant.

The subject illegal drugs with an estimated street value of Php 90,000.00 were turned over to PDEA for proper disposition and the claimant will be subjected to inquest proceedings.

PNP active Covid-19 infections reach 3.2K

MANILA – The Philippine National Police (PNP) on Thursday said active cases of coronavirus disease 2019 (Covid-19) have exceeded 3,000. This, after 450 new cases raised the total active case tally to 3,262 out of a total of 44,635 confirmed infections since the start of the pandemic. Atotal of 31 new recoveries,

meanwhile, brought the recovered cases to 41,248 while the death toll remains at 125.

Earlier, PNP chief Gen. Dionardo Carlos said many of the Covid cases among police personnel developed mild symptoms,

which will only need home or facility isolation. Carlos assured that the surge in infections will not affect the operations of the police force police force. The PNP

has added more quarantine facilities and beds inside its headquarters in Camp Crame as it continues to see a spike in Covid-19 infections among its personnel personnel.

Meanwhile, the Kiangan Emergency Treatment Facility remains the primary quarantine facility in Camp Crame for Covid-

19 cases. Carlos also noted that asymptomatic personnel could go quarantine on but home need to submit their regular to the to submit their regular body conditions to the monitoring medical team. Legarda: Recognize that our farmers and fisherfolk are our saviors, provide them with support for climate-resilient agriculture

Deputy Speaker and An-Congresswoman tique Loren Legarda expressed her strong commitment to champion the farmers and fishers, as the country moves towards becoming self-sufficient and food secure, during the AGRI2022 Online Forum. Highlightingthesuccesses in the province of Antique, which saw significant increases in palay production (27.4%) and yield (3.8%) in 2021, Legarda emphasized, "With the exceptional support of the government: from providing seeds, tools, equipment and market access, self-sufficiency in agriculture can be achieved." The province of Antique boasts as one of the very few provinces to achieve a "rice self-sufficient" status.

"I note that we are the only country in the ASEAN region that is a net importer of food. This is unacceptable, as our country is rich in resources and we have more than 10 million hardworking small farmers, forest settlers, and fisherfolk." Legarda added.

Legarda stressed the need for the sector to benefit from scientific research and innovation, especially for climate-resilient technologies. "During Typhoon Odette, Del Carmen in Siargao was miraculously spared from storm surges because it is home to 4,871 hectares of mangroves." Legarda added: "We need to work with and alongside natural processes. Nature-based solutions, such as planting mangrove greenbelts, have been very effective in preventing further loss and damage. Our farming and fishing communities could benefit from policies and plans that build with nature."

Aside from coastal greenbelts, Legarda drew attention to the community production of seeds, which are locally adapted to the soil and climate, or the use of integrated solutions such as integrated duck-rice farming. When asked about water scarcity, Legarda noted that: "if we had healthier soils, we can prevent erosion or run-off. For example, if our farmers used the straw from their palay and applied it to their rice fields, the straw is converted to organic matter. They would be close to achieving one (1%) percent organic matter, which translates to about 50,000 gallons of water retained." The Deputy Speaker is a proud backvard farmer. She saves and starts her own seeds, utilizes mulching and a rainwater catchment for irrigation, and grows her own food.

She added: "We need to rethink our food system. We urgently need to move from environmentally exploitative farming to regenerative practices. Presently, our policies are focused on large scale farming and production for export. Considering that we have about 10 million small farmers, forest settlers, or fisherfolk, it is in small holder agriculture where change is needed to increase the food supply. If the government provides adequate support and intervention, small producers will have additional income generating opportunities while encouraging local food supply."

The three-term Senator, now Deputy Speaker, has co-authored and filed House Bill 8385 or the Integrated Urban Agriculture Act, which seeks to promote and institutionalize urban agriculture as the country to be selfa sustainable land use system. She is also the co-author of the Rural Farm Schools Act under Republic Act 10618. Legarda Additionally, called attention to the plight of women farmers, who comprise 27.3 percent of workers employed in the agricultural sector but who remain underval-

ued if not invisible. "Support to the sector should also include support to our women farmers, who have less access to productive resources than men do."

Today is a unique opportunity to undertake a new course in food production, processing, distribution, and consumption. The COVID-19 pandemic emphasized the role of agriculture in our country. When import and ex-

Manage mild symptoms at home to decongest hospitals: mayor

MANILA - The city government of Manila will strictly allot its six district hospitals for patients with severe to critical symptoms of the coronavirus disease 2019 (Covid-19) and those with comorbidities.

Mild to moderate infections may be dealt with at home if there is proper space for isolation.

As of noon on Tuesday, the Covid-19 beds of Manila's six hospitals are 42 percent occupied.

A total of 206 beds out of 494 are in use at the Ospital ng Maynila, Ospital ng Sampaloc, Jose Abad Santos General Hospital, Gat Andres Bonifacio Memorial Medical Center, Ospital ng Tondo, and Sta. Ana Hospital.

On the other hand, the Manila Covid-19 Field Hospital that is also beport grounded to a halt, it showed the need for sustainable. For the second consecutive year, Noveleta LGU opened their Business One Stop Shop or BOSS at the 2nd Floor of Primark Town Center in Barangay Magdiwang.

Mayor Dino Reyes-Chua said, "We made it here once again to give convenience to our local tax payers with ample space for safety in accordance with government guidelines."

Likewise, the city government of Bacoor used the STRIKE Gymnasium to set up their BOSS program for the whole month of January 2022.

Business permit applications and renewals and other transactions under the BOSS are directed to the Imus Pilot Elementary School in the city of Imus. Processing of applications and other transactions will be from January 2 - 20, 2022 at 8am-7pm Mondays to Fridays, and 9am -4pm on Saturdays and Sundays to give more time to taxpayers and businessmen clients.

The Trece Martires city government opened their tax payment system at the city hall area from January 3 to 20, 2022 with only 200 persons accommodated daily.

Trece Martires, Cavite (**PIA**) – A number of hospitals and medical facilities in the province were reported to be operating on full capacity, and on limited medical services that focused on crucial, and emergency cases. ABS-CBN broadcaster

ABS-CBN broadcaster Noli De Castro announced that these developments happened due to the overwhelming increase in the number of patients being admitted in hospitals during the start of the year.

Dasmariñas City's public hospital, the Pagamutan ng Dasmariñas is currently at almost full capacity with the admission of fifty patients suspected to be infected with the covid-19 disease.

Making matters worse, a number of their healthcare workers have tested positive for Covid-19 while almost ninety of them are in quarantine thus, hospital services are limited to those most crucial and important services like dialysis, and the Emergency Room services, said Dr. Luisa Caguingan Medical Officer.

Meanwhile, Dr. Edgardo Figueroa of the Ospital ng Imus revealed that there are 15 hospital staff who tested positive for CoViD-19 that is why the hospital has also limited its services due to shortage in medical staff.

"I recommended that all elective surgeries be temporarily delayed except for emergency cases and child birth delivery. Our ICU section was closed to be able to deploy the staff to other departments," Dr. Figueroa said.

SC extends January deadline of all court filings until Feb. 1

MANILA – The Supreme Court (SC) on Monday announced the extension of deadlines for all court papers due in January following the surge in Covid-19 cases that have halted or paralyzed operations in several institutions.

Circular 01-2022, dated January 10 and signed by Chief Justice Alexander Gesmundo, stated that the filing periods of any and all pleadings and other court submissions due this month "are hereby extended until Feb. 1, 2022", citing the alarming number of Covid-19 infections and the lingering effects of Typhoon Odette. Some "Odette"-hit areas in

the Visayas are still without electricity and water supply.

The extension was requested by the Board of Governors of the Integrated Bar of the Philippines.

The circular has been disseminated to all judges, justices, court personnel, lawyers, litigants, and court users.

The SC is also implementing reduced on-site work capacity starting this week. Only one third of SC's work force will physically report on Mondays and Tuesdays, another third on Wednesdays and Thursdays, and the remaining third on Fridays and Saturdays.

When not at the office, the work-from-home arrangement will be implemented. However, personnel of the Office of the Bar Chair and Office of the Bar Confidant involved in the Bar Examination on January 23 and 25 and personnel of the Judicial Records Office involved in e-filing are still required to report on-site. On Monday, 33,169 new Covid-19 cases were re-

capabilities. Program number one, Implementation of Customs Computerization Program. The BOC automated 80.75% or 130 over 161 of the customs processes. These Information Com-Technology munication (ICT) systems were fully implemented in 17 Collection Districts to provide streamlined and efficient customs services. It also includes the creation of the Customs Training Institute, the integration of the Ports of Manila, Cebu, Davao, and Manila International Container Port (MICP) to the Customs Operations Center (COC), and the issuance of the Customs Memorandum Order (CMO) on Cargo Targeting Svstem.

Program number two, Intensification of Post-Clearance Audit and Post-Entry Modification Measures. Through the Post-Clearance Audit Group (PCAG), the BOC developed a Post-Clearance Audit Group Operations Manual; recommended 455 companies for audit; issued 342 Audit Notification Letters; collected a total of Php610 Million from Final Audit Reports.

Program number three, Onboarding of the Trade Regulatory Government Agencies (TRGA) into the National Single Window (NSW). The BOC, as the Chairman of the National Single Window (NSW) Technical Working Group (TWG), spearheaded the implementation of activities for the establishment, implementation, operation, and monitoring of the NSW and the ASEAN Single Window (ASW) in the country. As a result of its consistent monitoring and efforts, a total of 22 TRGAs successfully onboarded into the NSW as of December 31, 2021.

Program number four, Implementation of the Authorized Economic Operator (AEO) Program. The BOC issued the Customs Memorandum Order No. 26-2021, implementing the AEO Online Portal. Also, the Bureau completed the evaluation and committee deliberation for the Level 1 AEO Application.

Program number five, Promotion and Application of Advance Ruling Program. The BOC migrated the Advance Ruling System from manual to online through the Customer Care Portal and was fully implemented and utilized by the stakeholders on September 22, 2021.

Program number six, Pursuit of Integrity Development and Quality Management. To date, seven (7) offices, ports, and subports have been successfully awarded

with the ISO 9001:2015 Quality Management System Certification. Further, the Bureau has consecutively bagged the Gold Governance Trailblazer awards as it passed the first three (3) stages of the Performance Governance System (PGS) under the Integrity for Solidary in Asia (ISA).

Program number seven, Strengthening of Port Surveillance, Marine, Interdiction and Water Patrol Capability.
