TRECE Cavite (PIA) - A total of sixteen public schools in the city of General Trias re-opened their gates to welcome students in the conduct of the limited faceto-face classes on March 14.

school Re-opened include the Sunny Brook Elementary School (ES), Tropical ES, and San Francisco ES in Barangay San Francisco; Parklane ES and Mary Cris ES in Brgy. According to General School Division Trias Superintendent Dr. Doris Estalilla, the 16 elementary and secondary schools passed the evaluation and simulation exercises with the local government and Department of Education (DepEd) - Cavite officials for the limited F2F as part of the ongoing transition to the "New Normal" system of education.

DHSUD rolls out more housing projects in Mindanao

BALINGASAG, Misamis Oriental (PIA)--Days after rolling out housing projects intended for indigenous peoples (IPs) in Luzon, the Department of Human Settlements and Urban Development (DHSUD) led by Secretary Eduardo Del Rosario launched more shelter projects for IPs in Mindanao.

Del Rosario Secretarv spearheaded the signing memorandum а of agreement of and groundbreaking five ceremonies for housing projects intended for members of the Higaonon tribes in Region 10 and 13. in line with the Department's mandate providina Filipino of families access to decent. sustainable, resilient, and more affordable housing communities.

The housing projects under the government's BALAI Housing Program will be funded using developers' incentivized compliance to balanced housing, under the scheme, 250 housing units will be established in Barangay Kibanban in Balingasag town and Barangay Minalwang in Claveria--both in Misamis Oriental, and in Barangay Kamagong in Nasipit and Barangay Bokbokan in Las Nieves in Agusan Del Norte; and Barangay Sinakungan in Esperanza, Agusan Del Sur.

"These projects are in compliance with President Rodrigo Duterte's directive of prioritizing IPs in the provision of safe, resilient and affordable housing communities," Del Rosario

shared.

Aside from the housing units, the construction of five tribal halls in each location, as well as a multi-purpose covered court in Barangay Samay, Balingasag, will also be included in the projects. Del Rosario said such undertakings are part of the government efforts under the National Task Force to End Local Communist Armed Conflict's initiatives to insulate IP villages in the far-flung communities from communist influence.

'These projects will ensure the safety of our IPs, and keep them away from harm both natural and man-made," he added. The latest IP housing projectswillbeimplemented jointly by DHSUD and the local government units

MARTIRES, Pasong Kawayan 2 ES and Governor Luis A. Ferrer, Jr. East National HS had started conducting in-person classes for their pilot implementation.

Guidelines for the conduct of limited F2F classes require students to stay in the school for a maximum of 4.5 hours daily with only fifteen (15) students allowed per class.

If he makes it this May elections, foremost in Hidalgo's program of government are the farmers, who should benefit from the government's programs. "If I win, I'll move for the review if rice tariffician law Down prod tariffication law. Do we need to abolish this or add more provisions?" the candidate for Congress said. He would also strengthen the farmers' cooperatives in the province, for the latter to avail of loans with low interest.

He disclosed that loans extended by rich families to poor farmers bear high interests, thus turning the field workers poorer. He lamented that farmers fail to avail of loans from banks like Land Bank with only two percent interest per annum, because such are only made available to rich traders.

Currently, supposedly there is P120-billion fund from the Philippine Coconut Authority (PCA) for the farmers but Hidalgo doubts if this can go to the target beneficiaries.

Another project he wants to pursue for the sake of farmers is tuba production. Tuba is a wine made from the coconut sap. This can generate income for the farmers.

Another platform of govt. he wants is to push for the continued construction road infrastructures, many of which have been discontinued. "Ito ang madalas na dahilan ng aksidente sa kalsada," he said.

The third platform of governance that Hidalgo wants to put in place is to "amend" the Omnibus Election Code regarding the multi-party system, where there will only be two parties to vie for the presidential and vice presidential positions.

He proposed that the different parties form alliances to establish only one party. Then hold party conventions and select among party members who

will represent the party. "In this way, vote buying and possible creation of political dynasty can be avoided, Hidalgo stressed.

To date, he noted that there's no law stopping anyone from running for a position.

Hidalgo's reason for running is to help "fix" the aovernment. "Kailangan magising ang mga tao na hindi lang puro pera ang isipin tuwing election. Ang iba kasi ay ni-negosyo lang ang boto. Pag nanalo kasi ang mga ʻyan (mayayaman), wala namang ginagawa. Ang binabantayan lang nila ay 20 porsiyento komisyon sa mga projects," he said. This supposedly caused

the Philippines to be the laughingstock of other countries. The Philippine political system should change, the lawyer added. The candidate likewise dreams for the federal form of government for the Filipinos, where each region will be given autonomy in some aspects.

To address the pandemic or Covid-19, Hidalgo wishes to build a center for disease control to conduct studies on various viruses. There should also be state-sponsored vaccine manufacturing. "We should be forward-thinking at hindi 'yong kelan may problema, saka lang aayusin," he said.

The practicing lawyer explained if he fails once more in the coming elections, he doesn't consider himself a loser but the people themselves. "Natalo man ako, gumastos lang ako ng pera sa administrative cost pero kikitain ko 'yon. Abogado ako eh pero kayo saan kayo tatakbo? " he said, addressing the voters. For the education sector,

Hidalgo said he would push for teachers' training to be conducted in school during summer. Upgrading of skills should be done in school, Hidalgo explained, saying that assessment should also be done following the training.
