IMUS NEW GOVERNMENT CENTER FORMALLY OPENS

Martires, Cavite (PIA) -The city government of Imus held the blessing and inauguration of its New **Government Center last** Monday, April 25.

City Mayor Emmanuel Maliksi who led other officials and guests said while the fight against the Covid-19 crisis is very much the city government's priority, this should not hinder the administration's desire to accomplish other programs and projects aimed at providing for the welfare of the citizens.

The building which is part the legacy projects Mayor Maliksi's administration is designed to be an 'Eco-Friendly Green Building' because of the green architectural principles such as the solar panels installed to power its lighting and other electrical fixtures. A rain water harvesting system which is stored in tanks can supply the building occupants for at least four days.

Also, a sewage treatment ensures water plant wastes safe and

treated before it is released to the sewerage while a material recovery facility contributes to the solid waste management and recycling as well.

All these features aim to lessen its carbon footprint from its daily operations.

The government building is also considered a "Smart Building" because its computer-based building management and maintenance system.

The system could control lighting, the alarm system, its elevator system, 500 CCTV surveillance cameras and other facilities to give access to Persons with Disabilities (PWD).

The 53,761 sqm lot is located at Pedro Reyes St. in Barangay Malagasang I-G while the Executive Building sits on the 32,871 sqm area near the Ospital ng Imus and Imus Grandstand.

Now that all 72 offices of the city government is housed under one roof, the public is assured to expect a much better service from the city government. (RF)

Trece Martires, Cavite (PIA) - President Rodrigo Duterte graced the Philippine National Police Academy (PNPA) Class of 2022 43rd commencement rites on April 21, 2022 in Silang.

A total of 229 cadets of the ALAB-KALIS (Alagad ng Batas na Kakalinga sa Sinilangang Bayan) composed of 201 male and 28 female cadets graduated and will join the country's law enforcement. SC denies with finality all challenges vs. Anti-Terrorism Act

BAGUIO CITY - The Court (SC) Supreme en banc on Tuesday slammed all doors on challenging petitions Republic Act 11479 or The Anti-Terrorism Act of 2020 as it denied with finality the motions for reconsideration of its Dec. 7, 2021 decision.

In a statement during its summer sessions here, the SC said it "resolved to deny the motions for reconsideration due to lack of substantial issues and arguments" raised by petitioners of more than three dozen suits.

The members of the SC maintained their votes in December, written by now retired Philippine Judicial Academy Chancellor Rosmari Carandang.

The final copy of the decision has yet to be released as of posting time In December, the SC upheld the validity of the law except for two provisions.

Aside from portions of Sections 4 and 25, all the other challenged provisions of RA 11479 were deemed constitutional.

Section 4 deals with excluding mass actions and similar exercise of civil and political rights from the definition of terrorism while Section 25 is about requests by foreign agencies or bodies to designate persons as terrorists and organizations.

The SC voted 12-3 to declare unconstitutional the qualifier portion of Section 4 that states "which are not intended to cause death or serious physical harm to a person, to endanger a person's life, or to create a serious risk to public safety".

This qualifier to the proviso in Section 4 "is declared as unconstitutional for being overbroad and violative of freedom of expression," the court said.

Likewise stricken down by a vote of 9-6 was a portion of Section 25. paragraph 2 which allows "request for designations by other jurisdictions or supranational jurisdictions may be adopted by the ATC (Anti-Terrorism Council) after determination that the proposed designee meets

the criteria for designation of UNSCR No. 1373".

Among other provisions, United the Nations Security Council resolution urges members to "find ways of intensifying and accelerating the exchange of operational information, especially regarding actions or movements of terrorist persons or networks: forged falsified travel documents; traffic in arms, explosives or sensitive materials: use of communications technologies by terrorist groups; and the threat posed by the possession weapons of mass destruction by terrorist groups".

This year's SC summer sessions are the first since the coronavirus pandemic broke out in March 2020 and the first under Chief Justice Alexander Gesmundo, who was appointed on April 5, 2021. (PNA)

Postal stamps mark 10th PH Rise adoption anniversary

Postal Corporation (PHLPost) issued stamps and official first-day covers to commemorate the "10th Anniversary of the adoption in full of the extended continental shelf (ECS) in the Philippine Rise", the agency announced on Monday.

Philippine (formerly Benham Rise) is a 13 million-hectare undersea plateau that lies 216 kilometers east of Aurora province.

The ECS is estimated to be wider than the island of Luzon, according to the Maritime Research Information Center.

The stamps, released in coordination with the National Mapping and Resource Information Authority, reiterate the significance of the Philippines' first successful

NPC denounces Facebook attack on public platforms

MANILA - The National Press Club of the Philippines (NPC), one of the country's oldest and biggest organization of active members of the press, on Sunday denounced in the strongest possible term, the ongoing 'flagging' being made by Facebook and its 'fact checkers' on nearly all public platforms.

In a statement, NPC described the flagging not only as acts of harassment and intimidation and a brazen curtailment of civil liberties, particularly the right to freedom of information and expression but more importantly, an assault on the country's sovereignty.

"It has been barely two days since April 19, when the NPC issued its statement criticizing Facebook and its 'fact-checkers,' Rappler Philippines and Vera Files, for their callousness in warning Philippine national security adviser, Secretary Hermogenes Esperon over his post involving the threat pose to our nation's security by the communist terrorist groups," NPC president Paul M. Gutierrez said.

The criticism by the NPC has received overwhelming support not only from the public but even among our peers and those in government.

He added that instead of

being shamed to do what is right and responsible, Facebook has shown to all Filipinos that is the 'Lord of the Realm of Social Media' by flagging down and warning official public platforms such as the Philippine News Agency (PNA), our media colleague in the public sector," Gutierrez added.

"This is dangerous alarming. truly and Increasingly, Facebook, on the proddings of its fact-checkers and other state enemies, such as the CTGs, is demonstrating its capacity to resort to the neo-fascist method of wholesale censorshipand of an entire country at that— unmindful that it is already trampling on the laws and the sovereignty of our Republic," he said.

Trash traps, cleanup drives stop 800+ tons of wastes from draining to Manila Bay

More than 800 tons of trash coming from the provinces of Cavite, Laguna, Batangas and Rizal were kept from finally draining to Manila Bay through the trash traps installed along the waterways and the regular cleanup activities of the river rangers on the first quarter of 2022, per report of the Manila Bay Site Coordinating and Management Office (MBSCMO)-4.

About 600 tons of the said wastes were collected by the river rangers while the remaining volume were gathered from the trash traps. The monitoring of installed trash traps and the conduct of cleanup drives by river rangers are part of the Manila Bay Rehabilitation Program of the Department of Environment and Natural Resources (DENR) CALABARZON.

Most of the said wastes were from the province of Cavite with a total volume of 634 tons, a whopping 72% of the overall amount of waste collected for the quarter. Rizal province was distant second with 120 tons total waste collection, followed by Batangas and Laguna with 68 tons and 56 tons, respectively.

465 river rangers across the said provinces were hired and mobilized during the said period: 198 in Cavite being the most populous province of the four and being the area largely covered by the Manila Bay Region, 123 in Laguna, 80 in Rizal, and 51 in Batangas. The river rangers were able to clean an 80 km stretch along the identified river systems, shorelines, and waterbodies in the region. On the other hand, 82 of the 97 trash traps installed all over the region were able to collect solid waste during the quarter: 36 in Cavite, 19 in Rizal, 17 in Laguna, and 10 in Batangas.

The collected solid wastes were transported to various sanitary landfills and

materials recovery facilities through the assistance of the concerned local government units.

For this year, DENR CALABARZON through its provincial offices will install 24 more trash traps at the identified waterways in the four provinces covering the Manila Bay Region. Moreover, the office will continue to hire river rangers who will regularly conduct cleanup activities along the various tributaries of the bay within the region.

The installation of trash traps and the hiring and mobilization of river rangers are under Phase 1 (Cleanup/Water Quality Improvement) of Manila Bay Rehabilitation Program which launched in January 2019 during the administration of former DENR Secretary Roy A. Cimatu. The said activities were coupled with information and awareness drives among the affected residents

DENR CALABARZON continues to call on the public to religiously practice proper waste segregation and disposal to lessen the waste leading to Manila Bay and to the ocean. *PR*

Enough vax supplies secured for next admin: NTF chief

MANILA – No need for the next administration to procure additional vaccines for this year's Covid-19 inoculation program, according to vaccine czar, Secretary Carlito Galvez Jr., on Wednesday, noting that the country has enough supplies.

"So matutuwa po ang next administration, Mr. President, dahil more or less 98 to 100 [million] vaccine doses pa po ang matitira at hindi na po sila kailangang bumili (The next administration will be glad Mr. President because we have more or less 98 to 100 million vaccine doses that will be left and they don't need to buy anymore)," Galvez told President Rodrigo Roa Duterte during his prerecorded Talk to the People.

Galvez, who is also the chief implementer of the National Task Force (NTF) against Covid-19, said the World Health Organization (WHO)-led COVAX facility has renewed its commitment to provide more vaccines in the Philippines—which is on top of the 74 million doses of donation last year.

The COVAX also vowed to replace the country's expired vaccines, he added.

"Andaccordingtothem, they have already a flexibility on supply. Puwede na po silang magbigay po ulit sa atin at palitan 'yung mga po na mga na-expire na mga vaccine at saka po 'yung mga pangangailangan

pa po natin (They can provide vaccines again and will replace the expired vaccines and our other needs)," Galvez said.

The pronouncement of the COVAX on replacing the expired vaccine doses will reduce people's doubts about vaccine efficacy and will somehow address the hesitancy of the people to get vaccinated, he added.

"Sa kanila po ang pinakatalaga (the most important for them) is to save more lives rather than magkaroon po ng tinatawag na pagdududa sa tinatawag nating mga expiring vaccine (to have doubts on the expiring vaccines)," he said.

Galvez said the Philippines has been able to procure Covid-19 vaccines at a much lower price from various pharmaceutical companies, allowing the government to save more funds on pandemic response.

"Actually 'yung 100 million na doses po na 'yun parang savings na po natin 'yun eh. At saka 'yun pong 100 million doses po na 'yun ay talagang kayangkaya pong ireserba sa next administration (Actually, that 100 million doses will serve as our savings. And that 100 million doses will be enough to reserve for the next administration)," he added.

He said the government will no longer use the PHP45-billion budget allotted for this year's Covid-19 vaccine procurement, through a multi-lateral agreement with the World Bank, Asian Development Bank, and Asian Infrastructure Investment Bank

Of that total concessional loan amount agreed with these international banks, PHP2.5 billion will be sourced from the Department of Health (DOH)'s 2021 budget, while PHP10 billion is from funds under Republic Act No. 11494 or the Bayanihan to Recover as One Act (Bayanihan 2).

"Alam po natin na mayroon po tayong PHP45 billion na naka-allot sa multilateral financier natin na PHP2.5 billion sa DOH. Ito po, hindi pa po natin nagagalaw hanggang ngayon (we know we have allotted PHP45 billion from multilateral financier and PHP2.5 billion from DOH. This has remained untouched)," Galvez noted. (PNA)

Gesmundo, who is here for the court's first summer session since the pandemic started, however, had reservations on whether they would also put up an account in the popular video sharing platform, TikTok, which claims a billion active users.

Minsan, most of the time, satire (I do not know, TikTok seems to be difficult because what it generates is mostly satire)," Gemundo said but added it could be an avenue for the judiciary to correct misinformation.

"We will have a study on that as a means of communication using TikTok. We will get experts to advise, we are consulting experts on effective communication," he said

Gesmundo said the SC website would be also "redesigned and contain information that is reliable and accurate, understandable by laymen"

"That is basically the essence of our innovation as far as providing the general public the information that affects the judiciary," he added.

SC to rearrest ex-Palawan guv

MANILA-Undersecretary Joel M. Sy Egco, executive director of Task the Presidential Force on Media Security (PTFoMS), supports the move of the Office of the Solicitor General (OSG) in urging the Supreme Court (SC) to have former Palawan governor Mario Joel Reyes rearrested of the murder environmentalist and broadcaster Dr. Ortega.

In a statement, Egco, as head of the task force under the Office of the President charged with protecting media workers, said he "fully backs and supports" OSG's move for the lifting of the March 23, 2022 temporary restraining order (TRO) the High Court issued which prevented the Regional Trial Court (RTC) of Puerto Princesa City from enforcing the warrant of arrest against Reyes.

Presidential "The Force shares the Task sentiments of the OSG in its motion to lift the TRO which is preventing the re-arrest of the former governor. We believe that the evidence of guilt is strong in the criminal case filed against Reves in connection with the slaying of Gerry Ortega," Egco said.

In its 62-page comment, the OSG also asked the SC to dismiss the petition for review filed by Reyes with the High Court.

"I have full trust and confidence with the OSG, as a member agency of PTFoMS, in its commitment to attain justice for this heinous act. The task force will not stand idly by until all those responsible for the killing of Ortega, including the masterminds, are put behind bars," he said.

Ortega was gunned down on Jan. 24, 2011 in Puerto Princesa City after having just finished his program "Ramatak".

He was considered by many an "environmental hero"

Marlon Recamata, the gunman, was arrested and pleaded guilty to murder in February 2011.

Reyes was tagged by a former bodyguard, Rodolfo Edrad, as the mastermind

behind the killing of Ortega, who had criticized the former governor for the supposed destruction of the environment in the

Also implicated in the killing is his brother, former Coron Mayor Mario Reyes. The two are running for governor and mayor, respectively, in the May 9 elections.

Egco earlier backed the action of the OSG in initiating an investigation to find any anomaly with regard to the Court of Appeals' (CA) 2018 decision to release Reyes from detention due to the alleged insufficiency of evidence in the murder case.

In 2019, the CA reinstated the murder charges against the former Palawan governor. (PR)

PTFoMS backs OSG move urging Diokno hints on possible rate hike in June

MANILA Monetary officials will likely consider a hike in the central bank's key rates in June, or once 2022 first-quarter domestic output report is out, Bangko Sentral ng Pilipinas (BSP) Governor Benjamin Diokno said.

In an interview over Bloomberg television on Tuesday night, Diokno said BSP's policy-making Monetary Board (MB) will assess data on domestic growth, which "maybe around 6-7 percent."

The Board will have its third rate-setting meeting on May 19.

"And so, on the basis of that, maybe we'll make another cycle, which is we have another meeting, and maybe that's the time when

we will consider increasing (key policy rates)," he said. The MB is scheduled to have its fourth rate-setting meeting on June 23.

It has kept the BSP's key rates steady after slashing it by 200 basis points in 2020 --a move aimed at aiding the domestic economy from the impact of the pandemic.

However, economists have been factoring in a hike starting in the first quarter of this year because of expected acceleration of inflation rate given the rising prices of oil and some commodities in the international market.

The Federal Reserve, for one, hiked its key rates by 25 basis points last March, the first since December 2018, as consumer price index (CPI) in the US registered its four-decade high starting last January. Asked if he fears that the BSP will be behind the curve amid the decisions of its counterparts overseas, Diokno said the big difference is the real interest rate in the Philippines and

said.

PH offers \$153-B investment opportunities in energy sector

MANILA - The Department of Energy (DOE) has urged Singaporean businesses, as well as other foreign investors, to look into the country's investment prospects in the energy sector, which amounts to USD153 billion.

During the 3rd Philippine-Singapore **Business** and Investment Summit Wednesday, DOF Undersecretary Felix William Fuentebella said these required energy investments would help the country achieve the clean energy scenario under the Philippine Energy Plan.

About 80 percent of the total investment requirements are for power, which include USD115.3 billion for new power plants and USD6.97 billion for transmission projects.

'The required investments for RE (renewable energy) alone amounts to USD94.3 billion," Fuentebella said.

He added that about 15 percent of the needed investments are in the upstream sector composed of oil and gas exploration development and at USD10.05 billion, coal exploration and production at USD13.12 billion, and pre-development activities for renewable energy at USD510 million.

The downstream energy sector, on the other hand, will be needing USD2.94 billion investments in oil distribution depots and import terminals; USD1.78 billion for liquefied natural terminals; and USD2.38 billion for biofuels production.

"Given the capital-extensive nature of the energy sector, we anticipate the active participation of the private sector as well as the publicprivate partnerships to help us finance in bringing these critical energy infrastructure projects into fruition," Fuentebella said. He said the Duterte administration has spent more than five years setting up a sound and long-term plan to help in building a sustainable energy future for the Philippines.

"Whatever we invest today would have far reaching returns and benefits for the Filipino nation in the years ahead," he added. (PNA)

POLOs in KSA still under DOLE: Bello

MANILA - Department of Labor and Employment (DOLE) Secretary Silvestre Bello III has reminded Philippine Overseas Labor Offices (POLOs) in the Kingdom of Saudi Arabia (KSA) that they are still under his jurisdiction.

In a memorandum to Labor Attachés Fidel Macauyag, Roel Martin, and Hector Cruz dated April 26, the DOLE chief said until the Department of Migrant Workers (DMW) is fully constituted, said offices will be under the DOLE.

"In the light of the recent issuance of Department Order No. 04, dated 25 April 2022 by Secretary Abdullah D. Mama-o, Department of Migrant Workers (DMW), all POLOs are hereby reminded that POEA the (Philippine Employment Overseas Administration) and all POLOs shall remain under the direct supervision and control of the DOLE Secretary and shall maintain a status quo in their daily operations," he said.

The DOLF chief noted that the DMW has to comply with Section 23 of Republic Act No. 11641, otherwise known as the Department of Migrant Workers Law.

The law mandates compliance with

three enabling conditions before the DMW is fully constituted -- Approved and effective Implementing Rules and Regulations; Approved staffing pattern; and Approved budget under the 2023 General Appropriation Act. "Relative thereto, Executive

Salvador Secretary Medialdea has issued a memorandum dated 5 April 2022, stating among others that since the DMW has not been fully constituted, the government agencies enumerated in Section 19 of R.A. No. 11641 shall continue to exist separately and shall perform their mandates," respective Bello said.

"Until the foregoing conditions are fully satisfied, the Secretary of the Department of Migrant Workers cannot impose any policy over the Philippine Overseas Employment Administration (POEA) and the POLOs," he added.

At the same time, the DOLE chief also reminded the Labor Attaches that the deployment of the new hires to the host country is still not allowed.

"As such, the verification of employment documents for new hires bound for the Kingdom of Saudi Arabia shall remain suspended, until further instructions now at 8.5 percent, which was the rate last March, while average inflation in the Philippines in the first quarter was at 3.4 percent. "So, given that, I think we can afford to wait as to what will be the move of the Fed in the next two meetings," he added.

"It is managed by Common Room PH, a local retailer that houses over 200 local crafters and brands. SC rules in favor of Taguig in Fort Bonifacio territorial dispute

MANILA – The Supreme Court (SC) has ruled in favor of the City of Taguig in a decades-old territorial dispute against Makati City over vast swaths of prime real estate in Fort Bonifacio.

In a 53-page decision uploaded by the high court on April 27 and written by Associate Justice Ricardo Rosario, the tribunal upheld the decision of the Pasig Regional Trial Court (RTC) on the 729-hectare property which potentially generates billions of pesos in local government revenue.

"Indeed, it was only in 1972, during the administration of President (Ferdinand) Marcos, that Makati was included as a situs of Fort Bonifacio together with Pasig, Taguig, Parañaque, Pasay, and sometimes Pateros. But even the subsequent proclamations did not consistently declare that Fort Bonifacio lies within Makati. Clearly, the greater weight of evidence, consisting in contemporaneous acts of lawful authorities, favor the position of Taguig," the tribunal said.

The court added, "an appraisal of the issuances and laws pertaining to Fort McKinley and later, Fort Bonifacio, reveals that most refer to the disputed areas as either within the jurisdiction of Taguig or outside the jurisdiction of Makati."

Taguig based its claim on its existence for over 400 years initially as a pueblo of the province of Manila (now Rizal)

Rizal). In 1903, the municipality of Pateros absorbed Taguig and Muntinlupa but in 1905, the municipality of Pateros was changed to Taguig and reacquired its former area and absorbed territories of Pateros and Muntinlupa.

Included in the areas was the large estate named Hacienda Maricaban which fell under the jurisdiction of several towns.

In 1902, the owner, Dona Dolores vda de Casal, sold a portion to the US government which later turned it into Fort McKinley.
On July 12, 1957, President

On July 12, 1957, President Carlos P. Garcia issued proclamation No. 423 establishing Fort Bonifacio on what was Fort McKinley, and stated that the military reservation was located in Pasig, Taguig Parañaque, and Pasay but did not state that the military reservation was located in Makati.

On Jan. 20, 1995, President Fidel V. Ramos issued Special Patent No. 3595 conveying the land in favor of the Bases Conversion Development Authority (BCDA) and special patent 3596 which conveyed parcels of land within Taguig in favor of the Fort Bonifacio Development Corp. (FBDC).

The ruling affirmed the Pasig RTC Branch 153's decision on July 8, 2011 that "Fort Bonifacio Military Reservation is confirmed to be part of the City of Taguig".

The court also affirmed a 1994

The court also affirmed a 1994 writ of preliminary injunction issued by the Pasig RTC as it enjoined the City of Makati from exercising jurisdiction over making improvements on, or otherwise treating as part of its territory, parcels 3 and 4 comprising Fort Bonifacio.

The SC avoided ruling on

one of Taguig's arguments, particularly its claims that two Presidential Proclamations, No. 2475 and 518 issued in 1986 by President Ferdinand Marcos and 1990 by President Corazon Aquino, violate the constitutional guarantee of self-determination when they altered Taguig's boundaries without complying with the requirement for a plebiscite by the inhabitants to be affected. It added the property dispute may be resolved without ruling on the validity of the said proclamations. (PNA)

In a statement Thursday, Chief Justice Alexander Gesmundo said Republic Act No. 11691, or the Judiciary Marshals Act, will be a "great help" not only to the SC but to the entire judiciary, as well in ensuring an efficient and effective delivery of justice. "Indeed, the creation of RA 11691 will not only secure, protect, and safeguard the judiciary but will also boost the morale of its members, officials, and personnel at this time when there is the concern of the threats to judges and killings of lawyers," he said.

Gesmundo said the judiciary is one of the three pillars of republican democracy, which "itself hangs on a careful balance between and among

governmental powers."

"To threaten our judges and our lawyers is no less than an assault on the judiciary. To assault the judiciary is to shake the very bedrock on which the rule of law stands," he added.

From 2016 to 2021, five lower court judges and one retired Court of Appeals (CA) magistrate were killed.

In February, Gesmundo met US Embassy in Manila Chargé d'Affaires ad interim Heather Variava to discuss the assistance of the US government in the operationalization of the Office of the Judicial Marshals, particularly in establishing a judicial marshals academy.

Variava reaffirmed the commitment and support of the US government to the Court's judicial reform projects, as well as to the creation of the Office of the Judicial Marshals. (PNA)

Tamoria directed all Provincial Environment and Natural Resources Offices (PENRO) and Community Environment and Natural Offices (CENRO) within the region to remove election materials posted by political candidates in compliance with the directive of DENR Acting Secretary Jim O. Sampulna.

Section 9 of the Republic Act No. 9006 or the Fair Election Act of 2001, posting of campaign materials may only be allowed in common poster areas. Moreover, Section 21.b. of COMELEC Resolution No. 10730 dated November 17, 2021 or the Implementing Rules and Regulations (IRR) of R.A. No. 9006 "Fair Election Act of 2001", stipulates that no instance shall an Election Officer designate as common poster areas any trees, plants, shrubs, located along public roads, in plazas, parks, school premises or any public grounds". Section 3 of the Presidential Decree No. 953 dated July 6, 1976 states that "any person who cuts, destroys, damages or injures trees of any kind shall be penalized to six (6) months to 2 years of imprisonment or a fine of Php 500.00 to Php

5,000.00". PENRO Laguna conducted its operation last February 22-26, 2022 in the cities of Biñan, Cabuyao and Calamba in coordination with the concerned LGUs, COMELEC and PNP. Likewise, CENRO Sta. Cruz, Laguna conducted their operation on April 23, 2022

For Batangas, CENRO Lipa conducted its operations on February 26, 2022 and April 21, 2022 within its areas of responsibility, removing more than 2500 pieces of campaign materials. On the other hand, CENRO Calaca conducted operations on February 26 and 28, 2022 within municipalities of Agoncillo, Sta. Teresita, Taal, Nasugbu, Lian, Lemery,

of the PNP personnel is to maintain the peace and order and to keep themselves unbiased with any political personality or party.

"As a whole, it requires the concerted efforts of the DILG, the COMELEC, and the local government units (LGUs) to maintain and ensure the public's trust for a clean, fair, peaceful and orderly elections this coming May 9, 2022," Dalope stated. *Ruel Francisco*

San Nicolas, Tuy, Balayan and Calaca resulting in the removal of approximately 1000 pieces of illegally posted campaign materials.

On April 13, 2022, PENRO Cavite spearheaded an operation in Ternate and Gen. Trias, Cavite in close coordination with the LGUs. The campaign materials were turned over to the local barangays so that the same may still be posted on designated areas only.

PENRO Rizal, on April 20-21, 2022, conducted removal of illegal campaign material on trees along Marilaque Road, Jose, Antipolo City and Manila East Road, Brgy. Lagundi, Morong, Rizal. They also informed political candidates to advise followers and supporters to stop posting campaign materials on trees, and reminded them of the existing rules and regulations. The said office conducted its third operation on April 26, 2022 in Antipolo City and Taytay, Rizal, wherein, pieces of campaign materials had been removed.

PENRO Quezon also conducted joint operation with Tayabas removing CENRO a total of 1,335 campaign materials nailed and tied on trees on April 21, 2022 along roads of Barangays Lakawan, Ibabang Alsam, Lawigue, Kanlurang Palale, and Ibabang Palale in Tayabas City. The team leaders of Patrol Sectors under CENRO Tayabas were also instructed to conduct similar activities within their respective areas of jurisdiction. CENRO Catanauan removed campaign materials within its AOR on March 25, 2022 in coordination with DILG, PNP, and COMELEC.

Similar activities conducted **CENRO** by Catanauan on April 23, 2022 along the national highway of Catanauan, Quezon removing 2.0 kilos of campaign materials. Moreover, simultaneous 'Oplan Baklas' was conducted by CENRO Real together with COMELEC and PNP within the municipalities of Real. General Nakar and Infanta, Quezon on the said date. On April 26, 2022, CENRO Calauag, Quezon undertook its operation along Maharlika Highway in Calauag, Quezon. DENR CALABARZON thru its PENROs and CENROs continue to remove illegally posted campaign materials and conduct IEC activities to raise awareness on the existing environmental laws. rules and regulations.

"Information is a capital and those who wield it possess an insurmountable amount of power at their disposal," Villanueva said. This privilege however, entails adherence to truth and dignity and allegiance to nothing else. "This adherence is made even more challenging due to

Covid-19 pandemic that we are all subjected to, changing the usual way we go about with our daily lives."

front against any form of injustice and that institutions like the PAPI has the stake to see to it that this is judiciously pursued and earnestly promoted." Marquez said he has been closely working and collaborating with PAPI for around 10 years, even when he was still a court administrator. The close relationship between PAPI and Marquez continues up to now.

Led by president Santos, PAPI thanked all the guests from regular to associate members of the association, to community newspaper publishers, media executives, editors, print and broadcast journalists, public information officers, campus journalists and their faculty advisers.
