Noveleta town commenced inoculation of A4 priority group

Trece Martires, Cavite (**PIA**) –The local government of Noveleta thru the Rural Health Unit announced the gradual inoculation of the members of the A4 priority group on Wednesday, June 9, 2021 in conjunction with the ongoing vaccination of A2 and A3 priority groups.

Municipal Health Officer Dr. Hilda Bucu said that the local health office currently accepts online registration for the vaccination of residents under the A4 priority groups such as frontline personnel in essential sectors, uniformed personnel, religious leaders, and Overseas Filipino Workers.

"They can register online through our local registration site on Bagong Noveleta Facebook page. No walk-in registration will be held at the vaccination site at Primark Town Center." Dr. Hilda Bucu said.

According to Bucu, the vaccination program will be exclusive for the A4 priority groups starting on June 21 and expects big turnout of residents.

Currently, a total of 5,091 Noveleteños had already been vaccinated in the 40 days of the vaccine rollout

since March 23 to June 4, 2021 comprised of Healthcare workers both from public and private health institution (A1), Senior Citizens (A2), and Persons with Comorbidities (A3). The town also has the highest percentage of vaccination for the A3 priority group or Non-Senior with Comorbidities at 148% among the other towns and cities in the province according to the latest data released by the Provincial Health Office. For this, Mayor Dino Reyes-Chua acknowledged the healthcare workers for their unwavering sacrifice, dedication and hard work during this

time of pandemic. Chua also encouraged his constituents to register for the Free CoVid-19 Vaccination program of the local government to get the protection they needed against the virus.

The latest CoViD-19 update in the town has recorded a total of 773 Confirmed Cases as of June 4, 2021, out of which 24 are Active, 723 had already recovered, and 26 died from the disease. (Ruel Francisco with reports from Dennis Abrina)

Plateau in number of CoViD cases still not seen, deaths beyond 100

Trece Martires, Cavite (**PIA**) –The latest CoViD-19 update from the Rural Health Unit (RHU) of Tanza town showed the total number of Confirmed cases at 3,463 out of which 294 are considered Active cases, 3,065 have fully recovered, and alarmingly Death toll pass beyond the 100 mark.

This record still show a spike in the number of CoViD-19 cases, and RHU officials are not seeing signs of reaching a plateau yet with the current situation.

Municipal Health Officer Dr. Ruth Punzalan explained that family transmission still is the number one cause of the increase in the CoViD-19 cases with members of the family working in nearby cities and municipalities, and in the NCR bringing home the virus.

Punzalan said that what's worse is that the situation is not brought to the attention of the health authorities and families prefer home isolation.

RHU officials reiterate that they do not encourage home isolation because the patients are not properly monitored and treated.

Dr. Punzalan expounded. (In case we cannot control the condition, we can send the patient to the hospital early so that we can save the life and prevent the patient's disability. As I said, so far we have sufficient Isolation Facilities. We have Tanza High, Kapipisa, Main and for Senior Citizens and Persons with Comorbidities the use of Saint Augustine School Covid Outreach Facility is available.)

Punzalan said, "Kung ikaw

MANILA – For the next two years, the Philippines will be positioned as a "safe, fun, and competitive" destination, the Department of Tourism (DOT) said Thursday as it banks on strong partnerships with communities and visitors.

The DOT said it would develop more tourism products that focus on nature and culture while continuing its "safe travel" campaign to ingrain worldrecognized health and hygiene protocols in every Philippine destination.

The statement came as the agency noted a 61.2 percent decrease in the tourism contribution to the Philippine economy last year as the pandemic hit hard the industry.

Data from the Philippine Statistics Authority (PSA) showed that the Tourism Direct Gross Value Added (TDGVA) dropped to PHP973.31 billion last year from PHP2.51 trillion in 2019.

This is only 5.4 percent of the industry's contribution to the country's gross domestic product (GDP), a steep decline from 12.8 percent in 2019, the agencv said.

More than the losses in tourism arrivals and revenue, it added that these also translate to millions of tourism workers who lost their jobs.

Fully vaccinated workers to get free bicycles: DOLE

MANILA – Economic frontliners or those under the A4 category who have completed inoculation against coronavirus disease 2019 (Covid-19) will be given an opportunity to start their own business next month.

This as the Department of Labor and Employment (DOLE) through the Bureau of Workers with Special Concerns (BWSC) will be providing free bicycles as incentives for those who have already received two jabs.

Labor Secretary Silvestre Bello III, in a virtual forum on Wednesday, said the Free Bisikleta (FreeBis) project which was launched last year, will be reintroduced as Bak-Sikleta, to help encourage the people especially the said workers to have themselves vaccinated.

an industry that was flourishing before the Covid-19 pandemic, the dismal figures reflect the gargantuan challenge that the DOT and the entire tourism industry is faced today," the DOT said.

"For an industry highly dependent on the mobility and face-to-face interaction of people, the severe damage of the global pandemic crisis is both unprecedented and unavoidable," it added.

The agency said it would explore "all means possible" to facilitate the gradual recovery and reopening of the tourism industry while it also adheres to government restrictions. Under its Tourism Re-

sponse and Recovery Plan, the agency said its thrust is focused on the following:

1. Ensure protection of jobs and safety of tourism workers, visitors, and communities;

2. Support the recovery of tourism enterprises; and 3. Rebuild confidence and grow demand in the domestic and foreign market.

"The DOT is optimistic that this transient situation will soon be over and that with the collective effort of the private and public sectors, the Philippine tourism industry will emerge bigger, better, and more resilient in the new normal," it said. Merrier Xmas for Pinoys seen as vax rollout gains steam

MANILA – Christmas this year will be merrier for Filipinos as more vaccines arrive and the vaccination rollout gains steam, Interior Secretary Eduardo Año said.

Interior Secretary Eduardo Ano said. Año, who is vice chair of the National Task Force Against Covid-19, said the government sees a significant chunk of the population protected against the coronavirus before yearend. "We'll have a merrier/happier Christmas this year because we will be hitting the popula-

"We'll have a merrier/happier Christmas this year because we will be hitting the population protection level before the end of the year. That means at least half of our total population has been vaccinated. Almost all businesses are opened by then and almost all restrictions are eased (by then)," he said in a text message to the Philippine News Agency (PNA) on Tuesday night. As of June 13, a total of 6.048.640 dose, have been

day night. As of June 13, a total of 6,948,549 doses have been administered, according to data from the Department of Health. Of this number, 5,068,855 are first doses and 1,879,694 are second doses

second doses. The total doses administered during the 15th week of the vaccination rollout reached 982,898 doses.

At the Department of the Interior and Local Government central office in Quezon City, Año said 1,300 doses of Sinovac vaccine were allotted for use by personnel who would get vaccinated on June 16-18.

Earlier, he said about 50,000 police and fire personnel would be deployed to provide support and security to the national vaccination rollout, which now includes persons under the A4 category or the economic front-liners.

The Philippines has received a total of 12,705,870 vaccines, both government-procured and donated, as of June 16. (*PNA*)

MANILA – The Supreme Court (SC) ordered the dismissal of a stenographer after the Civil Service Commission (CSC) concluded that another person took the examination on his behalf.

In a resolution recently posted online, the High Court en banc dismissed from the service Nueva Ecija Municipal Trial Court stenographer Nestor D. Bulaong who was found auilty of dishonesty.

The court also ordered the forfeiture of all of his retirement benefits and with prejudice to reinstatement or appointment to any public office.

"His actions prejudiced not only the civil service but the public in general, as he improperly secured the government position when someone else was probably more qualified to hold it," it said.

The CSC, in 2013, referred the case to the Office of the SC Court Administrator and alleged that Bulaong committed dishonesty and grave misconduct in relation to the Career Service Professional Examination,

Court stenographer dismissed for fake CSC credential

held on Dec. 17, 1995 in

Malolos, Bulacan. Bulaong claimed that he took the examination and earned a rating of 88.01 percent. Eventually, he was appointed as Court Stenographer I.

However, the CSC discovered the scheme because there were glaring differences between the photograph and signature of Bulaong in his Personal Data Sheets (PDS) and in the examination's seat plan.

Aside from the photograph, the CSC also noted significant differences in the signature affixed in the PDS and the one appearing in the seat plan.

Further scrutiny revealed the loops, lines, slant, pressure, fineness, contours, and style of the two signatures belong to different persons.

"(I)t can be deduced that the fake examinee did not even try to imitate respondent Bulaong's signature as appearing in the PDS. Clearly, as aptly concluded by the CSC, this is a case of impersonation," the court said. (PNA)

YOUTHS' CRUCIAL ROLE IN GLOBAL DRIVE VS. CLIMATE CHANGE CITED

MANILA – Finance Secretary Carlos Dominguez III underscored Tuesday the importance for young Filipinos to be at the forefront of national efforts to mitigate the effects of climate change, as they have the biggest stake in saving the planet from the environmental crisis that will "hit us like a tsunami" unless its "destructive course" is halted.

Youths who will have to face the worst effects of climate change as these intensify over time comprise the last generation that can end the planet's environmental destruction, he said.

"Climate change is happening. It is real. We see its effects in our daily lives. People do not realize it, but climate change will hit us like a tsunami if we continue to do nothing about this worsening crisis. It could wipe away all our economic gains in one go if we fail to mitigate it," Dominguez said at the opening this morning of Sulong Pilipinas 2021: Climate Change and the New Normal with the Youth Sector.

Dominguez told over 500 leaders and members of various youth organizations gathered virtually for the event that the participation of today's young generation is critical in achieving the country's climate ambition and in building "a greener, healthier, and climate-resilient future" for the planet.

"As bearers of the future, the youth--who will have to live through 2030 and beyond--have the greatest stake in overcoming this crisis. It is therefore very important that you understand this issue and take the lead in reversing this destructive course," said Dominguez, who is concurrent chairman-designate of the Climate Change Commission (CCC).

He said the greatest defense that can be mounted in this battle is climate literacy, which is why the government is utilizing the Sulong Pilipinas forum to raise public awareness and spur climate action, especially among the youth.

"Today, we recognize and celebrate the crucial role of the vouth in our society. You are the last generation that can end the climate crisis." he said.

The next period following the end of the Covid-19 emergency will be "one of multifold challenges," as "we have a country to redeem from the ravages of the pandemic," "an economy to rebuild," and "a planet to save from the carelessness of past generations," he added. Dominguez told the par-

ticipants that their fresh insights and perspectives will prove valuable in forming the government's climate policies that will help shape the course of their future. He called on the youth to "reimagine everything" in crafting solutions to the climate crisis.

"You are capable of coming up with ambitious, creative and doable ideas that can make a lasting difference," Dominguez said. "We need your determination to build a greener, healthier and climate-resilient future. We want you to use your talents, knowledge, and passion to achieve our climate ambition." (PR)

BOC Files 2 Criminal Cases before DOJ

THE Bureau of Customs (BOC) filed two (2) criminal complaints before the Department of Justice (DOJ) on June 11, 2021 against Ben Zachary Agricultural Trading and the employees of Happy Chef Inc. for the alleged violation of Customs laws.

The first case against Ben Zachary Agricultural Trading is for the alleged unlawful importation of 1,992 bags of onions without the necessary Import Permit or Clearances required under the Department of Agriculture. The goods worth P925,131.20 were shipped into the country on April 02, 2021 at the Port of Davao. The importer was charged for one count of violation of Section 1401 (c) in relation to Sections 1430, 1113 (I)

"This time, the strategy is to bring outside money inside the province, which we can make it happen by inviting non-residents of llocos Norte to work, study, or live in the province," said Soya Cheng-Bueno, INvest office Head.

DOH, WHO say PH polio outbreak 'officially over'

MANILA – The Department of Health (DOH) and the World Health Organization (WHO) on Friday declared that the polio outbreak in the Philippines has officially ended.

In a virtual briefing, DOH Undersecretary Maria Rosario Vergeire said as of March 31 this year, 87.3 percent of the target population has been covered by the country's polio supplemental immunization

campaign. "This level of coverage is an outstanding accomplishment for the country in combatting polio. And this was duly recog-nized by the WHO," Vergeire said.

She said the WHO conveyed the recognition in a June 3 let-ter to the DOH.

The fact that we were able to do this amidst the Covid-19 pandemic means that we can no longer have any excuse to address the outstanding gaps in our national vaccina tion programs. Every unvaccinated child remains at risk of contracting this disease,

Vergeire said. emphasized that the She country's vaccination efforts against polio will continue and aims to "reach every child and thoroughly minimize the risk of another outbreak.

In September 2019, she said a polio outbreak was declared in the Philippines after initial cases were reported and found that there was a transmission of the two types of Polioviruses in areas with low polio vaccine coverage. "These Polioviruses were de-

tected through the enhanced

And we salute all of you who have made this possible during this extremely challenging period by your commitment and dedication to achieve the closure of this outbreak," Abeyasinghe said.

SC TAKES BACK LAWYER'S **SUSPENSION DUE TO ECONOMIC HARDSHIPS**

MANILA – The Supreme Court (SC) has reconsidered a lawyer's suspension after the latter cited undue hardships brought about by the coronavirus disease 2019 (Covid 19) pandemic.

in a resolution recently made available online, SC's Special Second Division modified its earlier resolution against lawyer John Nathaniel Marasigan, deleting its earlier order of suspension for three months.

Marasigan was meted out a three-month suspension on October 14, 2020 for violating Section 20(d), Rule 138 of the Rules of Court and Rules 10.02 and 10.03, Canon 10 of the Code of Professional Responsibility (CPR).

In lieu of the suspension, the SC reprimanded Marasigan and sternly warned that a repetition of the same or a similar offense will warrant the imposition of a more severe penalty.

The Court is not unaware of the severe economic hardships and health risks brought about by the Covid-19 pandemic. With this in mind, the Court exhibited a degree of leniency in respondent's case," the court said.

The Court ruled last year that Marasigan knowingly misrepresented the contents of an Ombudsman resolution, dated Nov. 5, 2007, when he stated in a motion filed before the Davao City Prosecutor's Office that no public officer

CHILDREN'S NUTRITION PRIORITIZED THRU LGU PROGRAMS

Trece Martires, Cavite (PIA) - The City Government of Imus thru the City Health Office and the City Nutrition Council had successfully completed its two-pronged Supplemental Feeding program and is now preparing for the coming Nutrition month.

First was the Blanket Feeding under the 'Kusina ng Kalinga' that provided additional nutritious food to augment the normal diet sustenance of children aged 3 - 12 years who belong to the vulnerable group.

According to Mayor Maliksi, the program was conducted in two batches that benefitted a total of 1,635 children from 62 barangays in the city. The first batch provided for more than 1,000 children, and the second batch fed about 635 kids.

On the other hand, the Complimentary Milk Feeding program benefitted 106 pre-school learners who are identified priority children of the city. This is a milk rationing that was provided every month for four months.

Mayor Maliksi emphasized the importance of proper nutrition especially during the formative years of growing kids.

"Naniniwala ako na napakahalaga ng tamang nutrisyon para sa mga bata, especially during their formative years hanggang sa kanilang paglaki. Kaya nga tinutulungan natin ang ating mga mommies to create food with high nutritional value," Maliksi said. Meanwhile, in preparation for the celebration of Nutrition month, the city government has several activities lined up highlighting the importance of nutrition for the first 1,000 days of a child's life.

According to Imus City Health Nutritionist, Ms. Cristina Balana, the City Health Office with the support of the City Government is planning to hold once again the virtual cooking competition #KusiNanay year 2 that would showcase the best practices of mothers in the preparation

and provision of nutritious foods for their growing children amidst the ongoing pandemic.

Balana also shared that a Mommy's Forum under the City Nutrition Council is also lined-up that will be using the FB Live platform to give educational awareness and informative skills to pregnant, and lactating mothers. The resource speakers for the forum are medical experts such as Ospital ng Imus Pediatrician, Dr. Randy Kalingasan, and City Nutrition Action Officer Dr. Fernando Mina. Legarda: Enact Laws, Design Out Plastic Waste to Free our **Rivers and Oceans from Plastic**

HOUSE Deputy Speaker and Antique Representative Loren Legarda urged all sectors and stakeholders to implement ecological waste management and environmental protection laws in order to reduce plastic waste in our rivers, tributaries, and oceans, as well as to support the transition towards a circular economy to design out plastic waste out of our societal systems.

Legarda made the statement following the study by The Ocean Cleanup that identified 19 Philippine rivers among the world's top 50 rivers that carry plastic waste into the oceans, with seven out of the top 10 plastic-emitting rivers coming from the Philippines, namely: Pasig River (1st), Tullahan (2nd), Meycauayan (5th), Pampanga (6th), Libmanan (7th), Rio Grande de Mindanao (9th), and Agno (10th).

The study also revealed that the Philippines is the world's largest plastic-emitting country, with 356,371 metric tons of mismanaged plastic waste carried by its rivers into the ocean.

"Nakakahiya. Wasak na ang ating mga ilog, ang ating source of life. Para lang magkaroon tayo ng ideya kung gaano kalala ito-kung ang isang sako ng bigas ay 25 kilo, ang 356,371 toneladang plastik ay katumbas ng 14,254,840 sako ng bigas. Ganyan karaming plastik ang nagmula sa ating mga ilog papunta sa ating mga karagatan," Legarda said. "Hindi lang ito responsibilidad ng isang ahensiya ng gobyerno o ng isang local government unit, kailangan ang whole-of-society approach. Kailangan ng convergence, makipagcoordinate with the private sector at civil society organizations para makagawa ng detalyadong rehabilitation plan para bumalik ang sigla ng ating mga ilog at tributaries," Legarda added.

Legarda said that the country's plastic addiction has been unresolved for decades now. She noted that back when she was a broadcast journalist in

1988, she produced a documentary about the Pasig River and also covered stories about the Tullahan River and Laguna Lake. As legislator, she supported and sponsored the budget allocation for the Pasig River Rehabilitation Commission, filed the Laguna Lake Development Authority Act, and sought the adoption of the Integrated River System Management Approach.

The Deputy Speaker also said that the Ecological Solid Waste Management Act, which she authored, lays the foundation for proper waste segregation, recycling, and disposal that could have prevented this problem from happening. She also noted that the House Bill 9147 or the Single-Use Plastic Products Regulation Act recently approved on second reading, which she co-authored, intends to regulate unnecessary plastics to avoid more plastic waste, supports the development of more sustainable products and approaches, and promotes a circular economy and mindful consumption and production. "This is a harsh reminder

for us and our country that's been blessed with nature's bounty. We may have some of the best laws and policies in place to protect our environment, but if we will not correct our unsustainable behavior and practices, then our ecosystems and biodiversity will continue to degrade and even collapse," Legarda said.

"It's been said that there could be more plastic than fish in the sea by 2050 if we continue dumping plastic waste. For our country that heavily relies on fish for food and protein, do we really want that for our children and the generations to come? While we are in this pandemic that also gave rise to online shopping and delivery, all the more that we need to be more mindful of our consumption and to find ways to take out plastic waste in the picture," Legarda concluded. PR
