DENR EXECUTIVE OFFICERS, **CAVITE LOCAL CHIEF EXECUTIVES FULL SUPPORT FOR THE MANILA BAY** REHABILITATION PROGRAM

Calamba City, Laguna - The Department of Environment and Natural Resources (DENR) Honorable Secretary Roy A. Cimatu chaired the Manila Bay Rehabilitation Program Special Meeting, together with Undersecretary for Solid Waste Management and Local Government Unit Concerns Benny D. Antiporda, Undersecretary for Policy, Planning, and International Affairs Jonas R. Leones, Undersecretary for Enforcement Benito T. De Leon, DENR CALA-BARZON Regional Executive Director Nilo B. Tamoria, Provincial Environment and Natural Resources Officer (PENRO) of Cavite Ronita A. Unlayao, Cavite Governor Juanito Victor Remulla, and the Local Chief Executives on Thursday, June 25, 2021, at the Tanza Oasis Hotel and Resort, Tanza, Cavite.

According to Secretary Cimatu, two (2) main problems in the province are the Solid Waste Management (SWM) and the water quality of the rivers.

'The number one problem of the province when it comes to the environment is solid waste", Governor Juanito Victor Remulla emphasized. He disclosed that 21 out of 23 Local Government Units (LGUs) in Cavite do not have the capacity to put up their own solid waste facilities because of limitations of land area in the Province. Governor Remulla pleaded to the DENR to put a national imposition for Provinces to establish their own sanitary and better managed landfill in the province. "50% of our solid waste, which is approximately 2,000 tons a day, goes to the rivers," added Governor Remulla.

DENR Usec Antiporda shared that they aim to implement a total solid waste management sowhere sanitary landfills, composting and recycling facilities, and residual diversion shall be

established. With proper segregation we can effectively reduce our generated waste. He added that about 70% of our total wastes generated are biodegradable, while the other 20% are recyclables. USec Antiporda also shared their Strategic Mitigation Plan for downstream and upstream rivers in Cavite. They are targeting to install 30-meters victory trash traps to be installed in downstream rivers, while PET bottles with wire mesh trash traps will be installed for the upstream rivers.

"I am now appealing to all the concerned LGUs to strictly implement and enforce the RA 9003 (Ecological Solid Waste Management Act of 2000). Likewise, to also address the water quality issues of the bay, we encourage the LGUs to check environmental compliances of industries within your respective area of responsibilities." Antiporda is also the Head of the Cavite Cluster Taskforce and Manila Bay Anti-Pollution Taskforce.

In relation to the water quality of the rivers in Cavite, DENR CALABARZON Regional Executive Director Nilo B. Tamoria disclosed that multiple sampling stations were established in Cavite to closely monitor its water quality. "Kinukumpleto po natin ang Geographic Information System ng buong cavite para makita ang mga kasalukuyang sitwasyon ng bawat river system para sa kaukulang estratehiya na pagtutulungan ng pambansa at lokal na pamahalaan", he added.

Mayor of Mendez, Atty. Fredderick A. Vida emphasized that the business sector should ensure sustainable packaging so as to minimize their contribution to wastes from single use plastics. The DENR has already proposed the Extended Producers Responsibility (EPR) to the legislative body. According to USec Antiporda, with the EPR, manufacturers shall

'Deaths from unchecked illnesses, mental health now a concern' – RHU Tanza

Trece Martires, Cavite thru the help of a strong (PIA) - The Local Government of Tanza thru the Rural Health Unit (RHU) is highly concerned with the increase in the number of deaths from unchecked illnesses, as well as the mental health of the residents amid the ongoing health crisis.

According to RHU Officer Dr. Ruth Punzalan, residents who do not feel well are hesitant to go to a medical facility to be checked by a doctor for fear of being labeled as a CoViD-19 case especially if their symptoms are very much that of the CoViD-19 disease.

This fear and anxiety is observed to be the main cause for the increase in deaths in the locality which is not secondary to CoViD but to other illnesses added Punzalan.

RHU officials strongly encourage everybody to go to a doctor and have themselves checked especially when they feel ill.

"Early diagnosis, early treatment can save your life," said Punzalan.

Meanwhile, many people are experiencing depression and anxiety due to prolonged confinement and lack of activity due to lockdowns and from misfortunes brought by this global pandemic.

The RHU reminded to focus on mental health awareness since this illness is not selective of age or gender nor level in society.

Instances of suicide are alarmingly increasing because some people could not handle this kind of crisis situation.

39K Imus residents fully vaccinated against CoViD-19

TRECE MARTIRES CITY. Cavite (PIA) - More than 39,000 Imus City residents have been fully inoculated against COVID-19, according to a city health official.

Dr. Cherrie Lyn Tumilba-Boque, medical officer of the Ospital ng Imus said, as of June 19, a total of 39,654 individuals have already received their first and second dose out of the 66,750 residents who had registered in the city's vaccination program.

"Our vaccination usage is at 115%... this is because there are vaccines with one vial that is equivalent to 11 or 12 doses which is allowed by the IATF. We make our best efforts to maximize the use of these vaccines and be able to immunize more people," Dr. Boque explained.

She said that the city government is expecting additional 16,000 doses of COVID-19 vaccines from the national government to be delivered on Monday, June 21.

The additional COVID-19 vaccines are intended for the inoculation of residents belonging to A2 and A3 priority groups which include senior citizens and persons with comorbidity.

While the city government is working to complete the vaccination of A2 and A3 beneficiaries, it has also started rolling out the registration for residents belonging to the A4 priority aroup.

"Even before the opening for the online registration for A4 priority group, we had already started gathering data for the masterlist which we will submit to the Department of Health (DOH)," Dr. Boque said.

Dr. Boque added that around 6,000 individuals under the A4 category have signed up for the vaccination program.

She added that the city government prioritizes to complete the vaccination of the A1 to A3 priority groups but will gradually inoculate members of the A4.

Mayor Emmanuel Maliksi clarified that the COVID-19 vaccination program strictly follows the order of priority as per directive of the Inter Agency Task Force on COVID-19.

He also said that the vaccines provided by the national government are intended for the priority groups as per instruction of the DOH.

Maliksi further said that the bulk of the supply of the vaccines received by the national government are given to the National Capital Region having the highest number of active confirmed cases.

Mayor Maliksi assures that the 16,000 additional vaccines which will arrive Monday will be fully distributed to the recipients. (Ruel Francisco/PIA Cavite)

Lagundi helps in Covid patients recovery, study shows

MANILA - Department of Science and Technology (DOST) Secretary Fortunato de la Peña on Secretary Wednesday said that based on clinical trial, lagundi has contributed to the recovery of patients with mild symptoms of coronavirus disease 2019 (Covid-19).

The DOST-supported clinical trial involved 278 patients from seven quarantine facilities. Half of them received lagundi as an adjuvant therapy.

'All of them have recovered. But those who received lagundi gained back their sense of smell faster. he said in a public briefing. The clinical trial aims to determine if lagundi can decrease the number of patients who progress from mild to moderate or severe case. Loss of smell is among the apparent symptoms of Covid-19.

De la Peña believes that because of lagundi's pharmacologic properties, it

could be a suitable choice for the symptomatic treatment of Covid-19 patients. While those who were given lagundi became free from the symptoms faster, de la Peña acknowledged that both groups had an average of eight days to recover.

There is no significant difference in time to recovery between those who took lagundi and the other group. In terms of safety, no serious adverse events were reported," he said. De la Peña earlier said

that no participant has progressed to moderate or severe Covid-19.

Meanwhile, he said researchers will be finalizing if lagundi have reduced the viral load in the participants' blood.

If they get good results, he said they are expecting that the same clinical trial can be pursued among patients with moderate symptoms. (PNA)

SSS IMPROVES MOBILE APP FOR EASIER USE

MANILA - The Social Security System (SSS) launched Wednesday an improved version of its mobile application to allow its users to access information about their membership and contributions as well as for members to apply for salary loans and submit maternity notification via this app's easy-to-navigate features.

"For the mobile app, the SSS introduced enhanced features to allow for easy navigation and effortless information presentation for its users," SSS president and chief executive officer Aurora Ignacio said in a statement.

Ignacio said the improved SSS mobile app provides SSS members with, among others, updates on their membership contributions, application and status of salary loans, information on benefit claims, and online contribution payment services.

For employers, the app provides them with information about their contributions and loan payments, and reimbursement claims, among other services.

The SSS mobile app was introduced to the public on April 23, 2018 and was initially available in the Google Play Store for Android phones and the App Store for iPhones and other iOS devices.

It became available in the Huawei AppGallery on October 7, 2019.

In the year the app was launched, it was downloaded 824,006 times. This number continuously increased since then, with the total volume of downloads hitting 2,296,967 and 7,378,627, respectively, in 2019 and 2020.

"The total cumulative number of downloads of the SSS Mobile App as of 31 May 2021 has already reached 15,359,070," Ignacio said.

The new, enhanced version was made available in the Huawei AppGallery last May 30, and in Google Play the following day, she said.

Ignacio said the SSS is now in talks with Apple to make the app available for iOS devices "in the near future"

Earlier, Ignacio reported that the online filing and

registration of new employees as SSS members, along with the submission of most forms and benefit claims have been made mandatory as of July 15 last year.

The release of loans and benefits to members, except for unbanked pensioners, have also been made "cheque-less" or online through the use of PesoNet and other electronic payment systems beginning July last year.

Ignacio said that since July 15, 2020, the submission of the maternity notification form for pregnant female SSS members and the sickness notification form were required by the SSS to be done online, along with the retirement benefit claim of members who are at least 65 years old and land-based overseas Filipino workers (OFWs) and voluntary members who are at least 60 years old and the application for unemployment insurance henefit (UIB).

The online filing of the applications for the calamity loan and salary loan were made mandatory by the SSS on June 15 last year, while the filing of the sickness benefit reimbursement claim of employers was required to be done online as of July 1, 2020.

The online enrollment of bank accounts in the My.SSS or SSS online portal has become mandatory for member-employees since June 2020 and for their employers starting July 2020.

This online enrollment of disbursement accounts has enabled the SSS to automatically deposit benefits to the enrolled bank accounts of worker-members and their employers.

and their employers. The SSS has also made the mandatory online filing of applications for the Covid-19 Calamity Loan Assistance Package (CLAP) since the program was launched on June 15 last year.

Online filing of funeral benefit claims for SSS member-claimants was made available starting July 2020 and was made mandatory by August 2020, Ignacio said.

The online filing of the retirement benefit claim of employed members who are 60 to 64 years old has

More laws needed to address teen pregnancies

MANILA – President Rodrigo Duterte's signing of Executive Order (EO) 141, which aims to address the root causes of the rising number of adolescent pregnancies, will hopefully spur the creation of relevant laws that will address the situation that has been labelled an "urgent priority."

The Commission on Population and Development (PopCom) chief Juan Antonio Perez III told reporters on Thursday they hope significant legislation will come out after EO 141.

"Complementing the action of President Duterte, his signing of EO 141 will hopefully draw a positive response from Congress and the Senate to address gaps in family planning and reproductive health services among minors who have become parents, or are pregnant," he said.

Perez said they are thankful for the EO as it manifests the national government's deep concern for the most vulnerable during this pandemic.

this pandemic. "They include minors who had unplanned or unintended pregnancies, which lead to the most vulnerable single-parent families amid the pandemic," he said.

A 2018 report by the United Nations Children's Fund (UNICEF) showed that while adolescent birth rates have declined globally, they have remained generally stagnant or even increased in Southeast

likewise been made mandatory starting August last vear.

Department of Finance (DOF) Secretary Carlos Dominguez III, who is concurrent ex-officio Chairman of the Social Security Commission (SSC), has, even before the outbreak of the coronavirus disease 2019 (Covid-19) pandemic, called on the SSS to use digital tools to make it easier for its members and pensioners to access its services without the need for face-to-face transactions.

Dominguez said the digitalization of the SSS' system will also help cut overhead costs for the pension fund. He said the SSS needs to continue to be prudent in managing its expenses given that its task involves taking care of the hard-earned savings of Filipino workers in the private sector. (PR)

The average adolescent birth rate in the region was 47 births per 1,000 females aged 15 to 19, higher than the average of 35 in South Asia and close to the global average of 50, according to the UNICEF report.

The UN agency responsible for providing humanitarian and developmental aid to children worldwide also shared that highest adolescent birth rates at the country level were seen in Lao (94), Cambodia (57), Thailand (50), Indonesia (48), and the Philippines (47). "A striking number of young

girls become pregnant without having planned to or without having had control of their pregnancy. When an adolescent girl becomes pregnant, her life changes forever. Her schooling often gets disrupted, or ends altogether, her prospects of a job dim, the health hazards due to complications from pregnancy and childbirth are huge and often Wivina Belmonte, UNICEF deputy regional director for East Asia and UNICEF the Pacific said. "The issues are complex and to address. challenging Good solutions come from collaboration, co-creation, adolescent-centered approaches.

In 2019, the Philippines recorded 180,916 live births in the 10 to 19 age group, or about 495 live births per day, according to the Civil Registration and Vital Statistics System of the Philippine Statistics Authority. The PopCom Board of

The PopCom Board of Commissioners, led by National Economic and Development Authority Secretary Karl Kendrick Chua, said the issue of teenage pregnancies is an urgent priority.

"The action of the President effectively focuses the attention of the government on the issue of pregnancies among adolescents in the Philippines," Perez also said in a statement.

PopCom, as one of the EO implementers, is directed "to continue to educate leaders, parents, and other community members about evidence-based strategies to reduce, if not eliminate, adolescent pregnancy, and improve adolescent reproductive health".

"The PopCom shall consolidate a Comprehensive Action Plan Towards the Prevention of Adolescent Pregnancies the different initiatives of all government agencies and institutions," the EO read. (PNA)

Ex-Samar exec guilty of graft over 'ghost' employees

MANILA – The Sandiganbayan has found a former Samar provincial administrator guilty of misappropriating PHP76,000 to wages of "ghost" job order employees in 2005.

In its 64-page decision written by Associate Justice Kevin Narce B. Vivero dated June 25 and recently published online, the antigraft court's Sixth Division sentenced Romeo Chan Reales to six to 10 years in jail for violation of Republic Act 3019 or the Anti-Graft and Corrupt Practices Act and another two to eight years for the crime of malversation of public documents.

tion of public documents. He was also required to pay the provincial government of Samar PHP75,000 plus interest in civil liability. The court noted that investigation showed that 25 job order workers listed on the

time book and payroll of the provincial government were nothing but "ghost names".

The court noted that the "poorly controlled environment at Samar's provincial capitol enabled OIC-Provincial Administrator Reales to add fictitious persons to the payroll, put them forward for payment each period and stash away their wages."

"Taking advantage of the situation required less creativity and more devilry," the court said.

Reales, the court concluded, acted with criminal intent and wrote entries in each of the summary pf payrolls and time book and payroll public documents which affected its integrity and changed the effects which it would otherwise produce". (PNA)

Demand for residential property picking up

MANILA – The demand for residential property has continued to pick up since last year's dip as more investors take advantage of promotional payment terms in anticipation of market recovery from the pandemic, a property expert said.

During the virtual The ViCon event Thursday, Leechiu Property Consultants (LPC) chief executive officer David Leechiu said the demand rebounded for the second quarter this year in a row, with overseas Filipino workers (OFW) remittances showing "great influence" in the movement of the residential real estate price index (RREPI).

"Capital values were modestly affected, thanks to developers who were quick to pivot and maintain market velocity," he said.

Leechiu said the pandemic has affected residential condominium sales in Metro Manila last year, prompting developers to delay launches till the second half of 2020 and offering unprecedented payment terms.

Unit sales are up by 5.7 percent in the first quarter of 2021 from the fourth quarter last year.

"Recovery in the upper-

middle to luxury segment is strong with the rest of the segments expected to follow suit," he added.

Leechiu said the softening of rental rates is seen as temporary and is expected to stabilize once quarantine restrictions ease, vaccine rollout speeds up, and office operations return.

Meanwhile, the Villar Group kicked off the two-day The ViCon, the country's first and biggest virtual property exposition that would showcase its complete real property offerings from various price points.

It has partnered with banks and an institution in providing affordable home financing to Filipino families, such as AllBank, Banco de Oro, Rizal Commercial Banking Corp. (RCBC), UnionBank, and PAG-IBIG Fund that are taking part in The Vi-Con.

"We felt the need to open a digital window so that we can continue reaching and serving our clients since the pandemic seemed to shut the physical doors for us. The ViCon is just one of the many digital initiatives that we will be unfolding in the future," chairman Manuel Villar Jr. said in a statement. (PNA)

BOC-MICP Seizes Php 10 Million Worth of Smuggled Onions

AS part of the Bureau of Customs' (BOC) drive to curb smuggling, the Manila International Container Port (MICP), through the Port's Customs Intelligence and Investigation Service (CIIS), X-ray Inspection Project (XIP) and Enforcement and Security Service (ESS) on June 28, 2021 seized smuggled onions.

Through the issuance of a Pre-lodgment Control Order (PLCO), the two shipments consigned to Austero Merchandising which originated from China and declared as ice cream were subjected to non-Intrusive and 100% examination.

The examination conducted by examiners of Section 1A of MICP's Formal Entry Division and witnessed by MICP District Collector Romeo Allan R. Rosales together with the Port's Customs Intelligence and Investigation Service (CIIS), X-ray Inspection Project (XIP) and Enforcement and Security Service (ESS) revealed the presence of red onions which were concealed in Ice

Cream Containers.

The seized items were estimated to have a market value of Php 10 million. A Warrant of Seizure and Detention (WSD) was issued against the shipment for violation of Section 1113 in relation to Section 1400 of Republic Act (RA) 10863 also known as the Customs Modernization and Tariff Act (CMTA).

In his statement, MICP District Collector Romeo Allan R. Rosales reiterated the Port's commitment to prevent the entry of all illegal goods including Agricultural products which are meant for human consumption and do not have the necessary permits to ensure the safety of such items.

As the importation of food items remains a priority to ensure food security in the country, MICP remains committed to curb smuggling of unsafe food items under the direction of BOC Commissioner Rey Leonardo B. Guerrero. PR

SC clears columnist of libel raps

MANILA - The Supreme Court (SC) acquitted newsman Raffy Tulfo of libel charges in connection with his 1999 column in a tabloid where he bared the alleged illegal activities of a Bureau of Customs (BOC) lawyer.

In the decision announced Tuesday, the SC said "the constitutionality of criminalizing libel is doubtful".

"The libel cases that have reached this Court in recent years generally involve notable personalities for parties, highlighting a propensity for the powerful and influential to use the advantages of criminal libel to silence their critics,' the SC said.

It added that "alternative legal remedies exist to address unwarranted attacks on a private person's reputation and credibility".

"Civil actions for defamation are more consistent with our democratic values since they do not threaten the constitutional right to free speech, and avoid the unnecessary chilling effect on criticisms toward public officials," the Court said.

tribunal reminded The media practitioners of the standards expected of them as provided for under the Journalist Code of Eth-

"We regard the vital role that the media plays in ensuring that the government and its officials remain true to their oath in carrying out their mandates in a manner prescribed by law. Nevertheless, the constitutionally protected freedoms enjoyed by the press cannot be used as a shield to advance the malicious propagation of false information carried out by unscrupulous entities to injure another's reputation,' the Court said.

Tulfo and the tabloid owners were sued over a series of articles on alleged shady dealings in the BOC, particularly on the reported extortion activities against brokers and shippers, as well as a supposed illicit affair, involving lawyer Carlos

The Court's Third Division ruled that "the prosecution failed to prove that petitioner Tulfo acted with malice, or with reckless disregard in determining the truth or falsity of the imputations".

The Court held that the allegations all referred to acts related to So's official functions at the BOC.

It further held that reading the articles as a whole, the statements indicated So's alleged use of connections to stay in position and conceal his misconduct. They were written to end his purported abuse of public position.

From these, it can be deduced that the impugned articles fall within the purview of qualified privileged communications. columns relate to Atty. So's exercise of his official functions. His alleged actuations refer to matters of public interest which the citizenry ought to know," the Court said.

Tulfo and publishers Allen A. Macasaet and Nicolas V. Quijano were sued by So before a Pasay City Regional Trial Court, which convicted them for 14 counts of libel and imposed on them the penalty of imprisonment and finé.

The Court of Appeals affirmed the conviction on July 31, 2006 but after a motion for reconsideration, eight counts of libel were quashed and the remaining ones were sustained. (PNA)

DepEd wants proper support, protection for teachers in 2022 polls

MANILA - In preparation for the upcoming 2022 national and local elections, the Department of Education (DepEd) is seeking to facilitate the bulk application of more than 900,000 of its employees to obtain their Philippine National Public Key Infrastructure (PNPKI) digital signatures.

We aré continuously cooperating with our lead agencies to have a secure and peaceful elections, and part of our commitment is to ensure that our teachers are protected and given the proper support, Education Secretary Leonor Magtolis Briones said in a news release on Monday.

The PNPKI digital signature is a new requirement of the Commission of Flortions Commission of Elections (Comelec) for all public school teachers who will serve as Electoral Board Members. It is a virtual 'kev' that subscribers use to secure files sent over an otherwise unsecured 'public' network like the Internet.

In a letter from DepEd to the Department of Information and Communications Technology (DICT), the Department requested to streamline the application process by waiving the requirement for individual application forms, including physically filling out the forms. including In previous discussions with the DICT, the requirements for individual interviews and sup-

porting IDs have been waived. The DepEd, however, is further requesting the waiving of the requirement for individual application forms as this may be cumbersome to check individually for errors.

This rigorous process for teachers will entail the downloading of these forms, physically filling them out, and uploading the same wherein checking for accuracy is an altogether different tedious task. "This proposal will guarantee that our teachers will not be burdened by rigorous steps and requirements anymore. Undersecretary for Administration Alain Del B. Pascua pointed out in the letter.

DepEd also proposed the use of available secure and reliable technologies and the submission of documents for bulk processing in place of the PNPKI application forms.

Documents proposed to be submitted to DICT include a spreadsheet file containing DepEd employees' verified data certified by Human Resources and an institutional application from DepEd in place of individual applications.

In addition, the Department will facilitate the online registration of its employees through its DepEd Mobile App and DepEd Commons to expedite the application process. (PR)



SC ORDERS BPO TO PAY FORMER EMPLOYEE BACK WAGES

MANILA – The Supreme Court (SC) has ordered a business process outsourcing company to pay back wages to a former employee who filed a complaint against it for illegal dismissal.

The SC's 2nd Division upheld the petition of Vincent Michael Banta Moll against Convergys Philippines, Inc., which was ordered to pay back wages from March 25, 2018, separation pay and other unpaid benefits, and salaries, as well as attorney's fees.

The labor arbiter who first handled the case in 2018 had awarded Moll PHP264,329 that year after finding that Convergys abused its discretion when it transferred the employee without justifying the trans-

fer.

The high court said it is "not convinced" there was an actual transfer, saying the firm "failed to adduce any office document, be it in the form of a memorandum, notice, letter, email, or any form of communication pertaining to petitioner's supposed transfer to the Glorietta Office."

"It also failed to prove the inclusion of petitioner's name in the payroll account of U-verse Program in Glorietta Office if indeed there was transfer as Convergys would have this Court believe," the tribunal said.

There was considerable distance between Moll's residence and the Eton Centris Office in Quezon City compared to the company's Glorietta office in

Makati City.

The agent was hired as a sales associate in 2015 and was assigned regular accounts as part of schedule of activity and responsibility. However, beginning March 25, 2018, he no longer received any schedule. He went to the Eton Centris Office and confirmed that he was no longer given any new assignment. He attempted to report the matter to the company's human resources department for clarification but was refused entry to the office.

Moll filed a complaint before the National Labor Relations Commission and during the mediation proceedings, the company ordered him to report back to work. This return-to-work order, the court noted, "was clearly a mere afterthought, made only after the case had already been filed."

On March 24, 2018, the company decided to transfer excess manpower from the Eton Centris Office, including Moll, to its Glorietta office.

The transfer did not require a different set of skills nor a diminution of salary.

Moll transferred and attended the first day of the training on March 26, 2018, but eventually did not report to work.

The company argued that it merely exercised its management prerogative to transfer employees as stated in the employment contract. (PNA)

Malacañang still confident of 'better' Christmas

MANILA – Malacañang expressed confidence on Thursday that Filipinos will still experience a "better" Christmas this year despite the presence of a more infectious Delta coronavirus disease 2019 (Covid-19) variant.

"Confident pa rin tayo for a better Christmas," Presidential Spokesperson Harry Roque said in an online press briefing.

Roque issued the statement, as he noted over 10 million individuals have received vaccines against Covid-19 nationwide.

"We have exceeded the 10 million mark for vaccination," he said. "And we're confident that with more supplies of the vaccine coming in, mas maraming mabibigyan ng proteksyon (many more will be given protection) and we can move towards containment and a better Christmas this year."

Around 7,538,128 of the 10,065,414 individuals have received the first dose of Covid-19 vaccine, while the remaining 2,527,286 have been fully vaccinated as of June 27.

Despite the discovery of

new Covid-19 variants, Roque said the government was able to manage the recent surge of coronavirus infections in the National Capital Region (NCR) Plus 8 by prioritizing them in the vaccine deployment. The NCR Plus 8 is com-

The NCR Plus 8 is composed of Metro Manila, Bulacan, Cavite, Laguna, Rizal, Metro Cebu, Metro Davao, Batangas, and Pampanga.

"We have managed the Covid cases in Metro Manila Plus 8 na naging kuta talaga ng Covid-19 (with high Covid-19 cases)," Roque said.

The Philippines has so far received a total of 17,455,470 Covid-19 vaccines.

The country is also expected to receive over 13 million vials of Covid-19 vaccine in July.

National Task Force Against Covid-19 chief implementer and vaccine czar Secretary Carlito Galvez Jr. ensured Wednesday that coronavirus vaccine portfolio went through a "rigorous" review and scrutiny by the vaccine expert panel. (PNA)

BOC Files Criminal Raps vs Importers over P87M worth of Smuggled Goods

THE Bureau of Customs recently filed three (3) criminal complaints before the Department of Justice (DOJ) involving P87 million worth of misdeclared smuggled goods.

The first case is against JANTHEARA TRADING INTERNATIONAL for the alleged misdeclaration of an estimated 2,500 bags of imported onions amounting to P3,315,350.96 last May 17, 2021 at the Port of Davao.

The second case is against DENIAN DRY GOODS TRADING for its alleged misdeclaration of 343 cartons of Union cigarettes, 588 cartons of Astro American Blend cigarettes, and 32 cartons of laptop table worth P50,770,685.44 on September 18, 2020 at the Port of Cagayan de Oro.

The third case is against

MICASTAR CONSUMER GOODSTRADINGinvolved in the alleged misdeclaration of P33,191,648.77 worth of copy paper, insulators, chairs, bricks, and cigarettes on May 2, 2021 at the Port of Manila.

The licensed customs brokers who processed the importations of the three (3) importers are facing similar complaints.

Both the importers and the customs brokers purportedly violated several provisions of the Customs Modernization and Tariff Act (CMTA) and other applicable laws.

The cases filed were through the initiatives of the Bureau's Action Team against Smugglers, Port of Davao, Port of Cagayan de Oro, and Port of Manila. *PR*

DFA brings home 1.9K distressed OFWs from UAE

MANILA – Around 1,920 distressed Filipinos were flown home from the United Arab Emirates amid existing restrictions last month, the Department of Foreign Affairs (DFA) reported Thursday.

The recent batch was a group of 347 overseas Filipino workers (OFWs) who left Dubai on June 30 and arrived July 1 via Philippine Airlines (PAL).

It was the third chartered flight in June alone especially mounted by the DFA for UAE-based Filipinos.

All passengers of DFA repatriation flights are required to undergo reverse transcription polymerase chain reaction test 48 hours before the flight.

"The Duterte government continues to help our kababayan (countrymen) who are stranded or distressed in the UAE. We have and we will continue mounting chartered flights until we have successfully repatriated those in need," DFA Undersecretary for Migrant

Workers' Affairs Sarah Lou Arriola said in a news release.

On June 2, a Cebu Pacific flight brought home 364 land-based Filipino workers, while PAL transported 322 on June 17.

The DFA also thanked local manning agencies in helping organize the repatriation of sea-based workers. Three flights arranged by the agencies arrived from the UAE also last month with a total of 886 seafarers.

Two more flights arranged by a local manning agency and the Overseas Workers Welfare Administration will land on July 5 and 10 while an estimated 350 OFWs are expected to arrive on July 17.

"We are not only firming up plans but executing these plans swiftly to bring them home at the soonest possible time, in accordance with the instructions of the President," Arriola added. (PR)

Bacoor LCE gave updates on LGU's CoViD-19 response

Trece Martires, Cavite (PIA) – Bacoor City Mayor Lani Mercado-Revilla revealed that the city has 100% utilization rate for ICU units that are equipped with mechanical ventilators as she gave an update on the LGU's CoViD-19 response.

The local chief executive disclosed this during her interview with broadcaster Alex Santos of Radyo Pilipinas last Monday, June 21.

Revilla said that compared to last year, the ICU hospitals have somehow improved like the Southern Tagalog Regional Hospital having 8 ICU units. The city has four level 2 hospitals with about 2 to 3 ICU units and are usually reserved for non-CoViD patients.

"Kulang talaga. Kaya in cases na talagang kailangan, nagre-request ang LGU sa General Emilio Aguinaldo Memorial Hospital (GEAMH) sa Trece Martires o nire-refer sa One Command Hospital with the Philippine General Hospital (PGH) nearest to the city," said Mayor Lani

Bacoor remains the highest among the cities in terms of the number of CoViD-19 cases which the Mayor said is basically due to the city's proximity to NCR with most of the residents working there.

Transmission happens within the families and the LGU has no choice but to keep them together and pull out only those with critical symptoms.

While the LGU thru the City Health Office continue to remind the residents to notify the Barangay Health Emergency Response Team (BHERT) during the onset of CoViD-19 symptoms, home isolation is still prevalent among families due to hesitancy on quarantining in isolation facilities.

As of June, the rate of CoViD-19 related deaths

is 1 per day while positivity rate averages 29 cases per day, and recovery rate is 39 patients per day.

"Ang recovery rate is quite good, at ang mga Isolation Facilities namin ay hindi na gaanong napupuno," shared Revilla.

The Mayor also disclosed during her interview that about 13K doses of Sinovac will arrive during the week and they are among the few LGUs to administer PfizerBionTech vaccines which are intended to be distributed immediately among the registered residents.

The LGU will commence with the immunization of the A4 priority groups or the Economic Frontliners with the completion of the vaccination of Seafarers & OFWs as well as the members of the A2 (Senior Citizens) and A3 (Persons with Comorbidity) according to the Mayor.

"Kahit nandito na ang vaccines, hindi pa rin ibig sabihin na Kalayaan na. Nandyan pa rin po ang virus...maging pasensyoso po tayo sa vaccine rollout natin. We're trying our best to open more vaccine hubs para po maging accessible po ang ating rollout sa karamihan," Revilla said.

(Even though the vaccines are here, it still doesn't mean Freedom. The virus is still around... let's be patient with our vaccine roll-out. We're trying our best to open more vaccine hubs so that our roll out can be accessible to the majority.)

The local chief executive encouraged everyone to register in the online registration site since walk-ins are not accepted during the vaccination activity. Procedures for said online registration are posted on the city government's FB page. (Ruel Francisco with reports from City Government of Bacoor FB page)
