SILANG MAYOR FORMS TASK FORCE DISPLINA, WARNS 4Ps BENEFICIARIES

SILANG, Cavite (PIA) – Silang Mayor Kevin Anarna recently signed Executive Order 010-2022 creating a Disciplinary Task Force to monitor members of the Pantawid Pamilyang Pilipino Program (4Ps) in the municipality.

In his official Facebook Page this July 21, Mayor Anarna said that "4Ps Beneficiaries who are caught gambling, drinking alcohol, and pawning ATMs will be reported to the DSWD Regional Office." Mayor Anarna added that "If any 4Ps beneficiary is caught or photographed gambling, drinking, or pawning their ATM card, it will be revalidated and may be removed from the list." House calls for special polls to fill Cavite's 7th district seat

MANILA – The House of Representatives on Wednesday night adopted a resolution calling on the Commission on Elections (Comelec) to hold a special election to fill the vacancy for the position of representative for Cavite's 7th district.

The chamber adopted House Resolution (HR) 100, certifying the existence of a vacancy for the legislative post, after its representative, Jesus Crispin Remulla, joined President Ferdinand "Bongbong" Marcos Jr.'s Cabinet as Justice Secretary. Speaker Martin Romualdez, who has been designated as caretaker of the 7th district of Cavite, authored the resolution along with Majority Leader Manuel Jose Dalipe, and Minority Leader Marcelino Libanan. "The vacancy has left the constituency of the aforementioned legislative district without representation in the House of Representatives," the lawmakers said in the

resolution. They cited Republic Act No. 6645, which provides that in case a vacancy arises in the House of Representatives at least 1 year before the next regular election for members of Congress, the Comelec, upon receipt of a resolution certifying the existence of such vacancy, shall hold a special election to fill such vacancy.

Meanwhile, Republic Act No. 7166 provides that the Comelec should call and hold a special election not earlier than 60 days nor longer than 90 days after the occurrence of the vacancy. **(PNA)**

Free circumcision in Buna Lejos, Indang

On July 21, 2022, the Provincial Government of Cavite thru the Office of the Governor-Extension rendered free circumcision to 17 young males in Brgy. Buna Lejos, Indang, Cavite through the Operation Tuli program.

Beneficiaries aged 10-14 years old, stepped up and surpassed the procedure and pain of circumcision after undergoing screening and antigen swab testing performed by the team from the Provincial Epidemiology

and Surveillance Unit. The operation was rendered by medical professionals from the Provincial Health Office led by Dr. Kevin Roderno as the lead surgeon together with the staff from the OPG – Extension. They were assisted by the barangay health workers of Buna Lejos alongside Barangay Captain Elmer Torres who expressed their gratitude to the PGC for the successful operation.

To raise awareness on skin diseases and promote skin health, the Provincial Health Office cooperated with the General Trias City Health Office in conducting free skin consultation in Brgy. San Francisco on July 22, 2022 through its Kilatis Kutis program.

Trece Martires City, Cavite (PIA) – The Cavite Provincial Health Office (PHO) successfully conducted a three-day training on clinical management for STI, HIV, and AIDS for the medical team of the Bureau of Jail Management and Penology (BJMP).

The training held June 27 to 29 at the Quest Hotel in Tagaytay City was in partnership with the Pilipinas Shell Foundation, Inc. through Mr. Russell Q. Tabisula, Deputy Program Manager for Field Operations, in order to equip the participants with the principles and strategies on the holistic management of Person deprived of liberty (PDL) patients with HIV and AIDS.

The 3-day training was filled with relevant and sufficient

Chairman Eduardo Umali and Kagawad Ryan Santos who expressed their appreciation for visiting their community and extending the health services to their constituents.

He also briefly explained that U=U which means Undetectable is equal to Untransmittable wherein HIV medication can decrease the level of virus in a person's blood that may result in being undetectable, which in turn, prevents HIV disease from progressing and allows people to live long and healthy lives.

The event was also graced by Ms. Basha Rivera, Case Manager for the HIV Program of Shell Pilipinas Foundation, Inc. and a confessed PLHIV who shared her story of challenges, how she surpassed them, and how she can live like any normal person.

Queries and issues that need to be answered were addressed in an open forum at the end of every presentation of the respective speakers.

In closing, Dr. Edna T. Leonor, Chief Health Division-BJMP Calabarzon expressed appreciation to the Provincial Health Office for facilitating the training for their personnel which will be very helpful in performing their duties. CTA voids P341-M tax assessment vs. local Ferrari dealer

MANILA – The Court of Tax Appeals (CTA) struck down a tax deficiency assessment against a local dealer specializing in the sale of an Italian luxury car brand, citing the lack of proper documents by tax investigators.

In its July 21 decision which was recently uploaded online, the CTA en banc affirmed the July 10, 2020 ruling of its First Division in favor of Autostrada Motore, Inc., the local exclusive distributor of Ferrari cars in the Philippines, over an assessment for deficiencies in excise tax, value added tax and administrative

penalties amounting to over PHP341.3 million.

"The court did not err in declaring the assessments void for lack of authority of the tax agents who conducted the audit," the CTA en banc said, noting the absence of a letter of authority (LOA) from the investigating officers.

"The purpose of a mission order is different from an LOA. A mission order is issued to authorize the surveillance, not the audit and assessment of the taxpayer," it added.

The Bureau of Internal Revenue (BIR) issued a mission order dated Oct.

Pag-IBIG Fund finances 8,471 homes for low-wage earners in H1 2022

CAGAYAN DE ORO CITY (PIA)--Pag-IBIG Fund financed 8,471 socialized homes for minimum-wage and low-income members amounting to P3.67 billion in the first half of 2022.

Socialized home loans make up 19% of the total number of housing loans financed by the agency from January to June this year. The amount, meanwhile, represents 7% of the total housing loans released by the agency for the said period. Pag-IBIG Fund posted record highs of 47,184 in housing units financed and P51.96 billion in home loans released during the first half of the year.

"We at Pag-IBIG Fund remain committed in pursuing our mandate to provide a home for every Filipino worker. With our Affordable Housing Program, achieving the dream of homeownership is made possible especially for minimum-wage workers. The program's lowest rates and longest payment term allow our members from the low-income sector to buy or build a home of their own," said Pag-IBIG Fund Chief Executive Officer Acmad Rizaldy P. Moti.

Pag-IBIG Fund's Affordable Housing Program (AHP) is a special home financing program specifically designed for minimum-wage and low-income members from the National Capital Region (NCR) who earn up to P15,000 a month, and from outside the NCR who earn up to P12,000 per month. Under the AHP, eligible borrowers enjoy a special subsidized rate of only 3% per annum for home loans of up to P580,000 for socialized subdivision projects.

Pag-IBIG Fund Deputy Chief Executive Officer for Home Lending Operations Marilene C. Acosta said the AHP's 3% rate translates to a monthly amortization of as low as P2,445.30 for a socialized home loan amounting to P580,000, making homeownership within reach of low-income earners.

Acosta added that they first offered the AHP's subsidized 3% rate in May 2017 to help more members, particularly those from the minimum-wage sector, realize their dreams of owning a home. With their very low rates,

Pag-IBIG Fund members are able to enjoy a monthly amortization on their home loans that is lower than the cost of rent. And, since qualified borrowers do not need to put out cash for equity under the program, payments are even more within the budget of low-income members. "Makakaasa ang aming mga miyembro na patuloy nila kaming katuwang sa pag-abot ng kanilang pangarap na magkaroon ng sariling tahanan (We assure our members that we will always be with them in reaching their dream to have their own home)," Acosta added. DAR ready to work with Congress on condonation of farmers' loans

MANILA -- Agrarian Reform Secretary Conrado Estrella III said his department is ready to work with Congress on the condonation of loans and imposition of a one-year moratorium on payments of amortization and interest of about 650,000 agrarian reform beneficiaries in the country.

In an interview on Tuesday, Estrella expressed agreement with the pronouncements of President Ferdinand Marcos Jr. during his first State of the Nation Address (SONA) that the government does not stop from distribution of lands but looks after the welfare of farmers as well. "After two years of the pandemic, just like us, our ARBs have been experiencing financial difficulties too. These plans of the President will be a very big help to them," Estrella said.

During SONA, Marcos said that by condoning farmers' loans, they would be able to concentrate on farm productivity, thus ensuring the success of the government's food security program.

Marcos said this moratorium will further unburden farmers of their dues and "channel their resources in developing their farms, maximizing their capacity to produce and propel the growth of our economy."

As promised by Marcos, Estrella said a draft of the executive order on imposing a one-year moratorium on the payment of land amortization and interest payments is now being prepared by the

SC remands Antique university property row back to RTC

MANILA -- The Supreme Court (SC) has granted a petition by government lawyers and remanded back to the lower courts the proceedings in connection with a property ownership dispute at the University of Antique. The High Court granted the petition filed by the Office of the Solicitor General (OSG) and reversed the Court of Appeals, which in 2017 ruled that the OSG could no longer raise the issue of ownership of the property as it had been settled when the parties entered into a compromise agreement approved by the San Jose, Antique Regional Trial Court Branch 10 in 2014.

The OSG claimed that the compromise agreement was void because its deputized counsel in the RTC proceedings had no authority to enter into such a deal between the parties.

The university was originally known as the Antique School of Arts and Trades in Sibalom town, created in 1953 under Republic Act No. 851. The municipality then expropriated several parcels of land, including that owned by the Pechuanco family, to become a site for the school. In 1954, the court upheld the appropriation and Jose Pechuanco signed a deed of sale, transferring 8,670 square meters to the municipality, which then transferred the lot to the school.

Pechuanco's heirs later filed a suit for the recovery of the property occupied by the school.

In 2002, the OSG authorized the provincial prosecutor to appear on its behalf.

A proposed amicable settlement was raised by the heirs in 2012 and the OSG instructed its representative to inform the Board of Trustees of the University of Antique for their consideration.

The compromise agreement was submitted to the RTC in 2013 without the OSG as a signatory in the deal where the school, among other things, agreed to pay PHP12 million. The SC said in its decision published online on July 22 that the "deputized counsel merely assists the OSG and is under its control and supervision."

The appearance of a deputized counsel such as a provincial prosecutor does not divest the OSG of control over the case, the SC ruled.

"Accordingly, despite the deputation, the OSG must still be in control of all substantial matters of the case and as a general rule, a compromise agreement without the consent of the solicitor general is not binding," the SC said. (*PNA*)

and landless retirees of the Armed Forces of the Philippines (AFP) and the Philippine National Police (PNP)," Estrella said.

Prior to SONA, Estrella said they submitted a report to Marcos stating that in accordance with Section 40 (Special Areas of Concern) of RA 6657, there are 52,000 hectares of unused government agricultural lands that are up for distribution under Executive Order 75.

Executive Order No. 75, series of 2019, directs all government agencies, bureaus, departments, and instrumentalities to turn over agricultural lands owned by the government for distribution to qualified agrarian reform beneficiaries.

"According to Section 40 of RA 6657, agricultural lands can also be distributed to landless war veterans, landless surviving spouses and orphans of war veterans. (*PNA*)

DHSUD one with Marcos admin in boosting disaster response ops

MANILA – The Department of Human Settlements and Urban Development (DHSUD) on Tuesday said it will continue to improve the government's Emergency Shelter Assistance Program (ESAP) for calamity victims. As per President Ferdinand Marcos Jr.'s directives, the DHSUD said will strengthen emergency response operations and provide immediate assistance to victims of disasters.

In his first State of the Nation Address (SONA) on Monday, Marcos said the provision of ESAP for calamity victims should be implemented with "better coordination" between the DHSUD and the Department of Social Welfare and Development (DSWD). The government's ESAP provides calamity-affected families with emergency cash assistance or construction materials they can use to repair their damaged houses. Beneficiaries are usually those who do not want to transfer to resettlement sites following a disaster.

Assistant Secretary Melissa Aradanas, DHSUD Officer-in-Charge, said the department is determined to push Marcos' directives as a "prime mover" for the ESAP implementation. "This is an enormous task as we are expected to make the delivery of emergency shelter assistance faster and better. However, I'm certain that we can improve our preparedness and responsiveness to

disasters once we have a harmonized plan, backed by data from research and previous experiences," she said in a statement.

Aradanas vowed that the ESAP will serve as the core program of the DLSUD-DSWD. "DHSUD will work closely with the DSWD for timely provision of ESAP," she said.

The DHSUD heads the shelter cluster of the National Disaster Risk Reduction and Management Council, responsible for the distribution of emergency shelter assistance.

The DSHUD also lauded Marcos' call for the inclusion of the National Land Use Act (NLUA) as one of the priority bills of the 19th Congress.

Marcos emphasized the need to push for rational and holistic management and development of the country's land and water resources while owners should be held accountable for "making these lands productive and sustainable."

The President said local government units must strengthen their management capacities "for ecological balance within their jurisdiction."

The NLUA is part of the DHSUD's 2040 national housing and urban development sector plan.

"On our part, we vow DHSUD's unwavering commitment to support PBBM's shelter programs to better what we have achieved in the last three years," Aradanas said. (PNA)

Bong Go pushes for housing measures to build more resilient and decent houses for the homeless

PASAY CITY -- Underscoring the need to address cases of homelessness in the country, Senator Christopher "Bong" Go has once again pushed for his priority bills which aim to provide more resilient, affordable and decent houses to disadvantaged Filipinos across the country.

Go has refiled Senate Bill No. 192 and reintroduced SBN 426, providing for the Rental Housing Subsidy Program, and the National Housing Development, Production and Financing (NHDPF) Program, respectively, as part of his efforts to ensure that the homeless have access to decent yet affordable shelters.

Because of its geographical location, the Philippines is prone to natural disasters, such as typhoons, floods and volcanic eruptions. Thus, Go reiterated the need for the government to step up measures in dealing with crisis situations.

SBN 192 aims to provide adequate, sustainable and habitable shelter for Filipinos affected by disasters and other crisis situations. Under the proposed measure, a housing and social protection program will also be developed to provide disaster victims better and more affordable access to the formal housing market through the provision of rental subsidies provided by the government.

The bill seeks to address the plight of displaced families caused by various disasters and calamities, whether natural or man-made, as well as those families who cannot afford or build their own homes.

"Kapag po tinatamaan ng bagyo ang bansa o kung ano pa pong klaseng sakuna, alam naman po natin kung gaano kahirap para sa kanila ang mawalan ng bahay. Kaya tayong mga lingkod-bayan, dapat po gawin natin ang lahat ng ating makakaya para mabigyan natin ng disenteng matutulugan ang mga naapektuhang pamilya," stressed Go.

"Ang iba po sa kanila ay mas takot pa pong mawalan ng bahay kesa po matamaan ng COVID-19. Naging isa po talaga ito sa layunin ni dating pangulong (Rodrigo) Duterte kaya naman po tiwala rin ako na isa rin po ito sa magiging prayoridad ni Pangulong Ferdinand "Bongbong" Marcos, Jr.," he expressed.

Meanwhile, the lawmaker also pushed for SBN 426 which seeks to increase housing production by forging partnerships among relevant stakeholders to address the

social housing demands of the Filipino families.

As proposed, the bill shall generate and mobilize funds to guarantee the development of a sustainable, accessible, and affordable housing financing system for the country's informal settlers. Meanwhile, the Department of Human Settlements and Urban Development and its attached key shelter agencies, shall intensify the implementation of the vital components of the NHDPF program.

The National Housing Authority shall be the sole national government agency tasked to implement and develop the housing programs intended for the bottom 30% of the income population. Furthermore, the Social Housing Finance Corporation is tasked to develop social housing programs that will cater to the formal and informal sectors in the low-income bracket and to take charge of developing and administering social housing programs, particularly the Community Mortgage Program and its different modalities.

"Sa aking pag-iikot sa bansa, talaga pong nakakalungkot makita na napakarami po talaga sa ating mamamayang Pilipino ang walang matirahan dahil sa kahirapan. Paano pa po kung tinatamaan ang ating bansa ng mga bagyo o pagputok ng bulkan? Mas lalo pong dumadami ang nawawalan ng matitiran," expressed Go.

"Para sa aking mga kapwa mambabatas, nakikiusap po ako sa inyo na ipagpatuloy niyo lang po ang inyong suporta sa dalawang panukalang ito na naglalayong magbigay ng disenteng pabahay sa ating mga kababayan," he added.

Apart from these measures, Go also refiled his bills establishing the Department of Disaster Resilience and mandatory evacuation centers in every city, municipality and province to further intensify and strengthen the country's resilience to disasters.

The senator was also the main proponent of the Balik Probinsya, Bagong Pag-asawa Program (BP2) which is a long-term plan of the government to decongest urban areas, boost countryside development, and improve the quality of life in all regions.

"Sikapin nating mabigyan ng maayos na tirahan ang mga nangangailangan. Wala dapat maging squatter sa sariling bayan. Magtulungan tayo para mabigyan ng mas komportableng buhay ang bawat Pilipino," Go asserted. (OSBG)

"Binibigyan namin sila ng show-cause order or demand letter para sa kanilang delinquency. Binibigyan sila ng 15 araw para makipag-ugnayan sa SSS at kapag hindi ay irerefer ito sa Legal Department. Maaari silang mag-avail ng installment hanggang Nobyembre 2022," ani Lescano.

Ayon kay Joseph Pedley Britannico, SSS Lipa Branch Head, ang bawat establisimyento ay may mga accounts officer na siyang nagmomonitor sa full compliance ng employers sa SSS Law.

"Out of more than 440,000 accounts, pagdating sa employers na may 7500 ang bilang ng aktibo, may 2,000 hanggang 3,000 ang ikinokonsidera na delinquent at dito nagmula ang mga nabisita ng Team," ani Britannico.
