CAVITE TAKES PART IN THE CELEBRATION OF 44th NDPR WEEK

In empowering the differently-abled, the Provincial Persons with Disability Affairs Office and the Federation of Persons with Disabilities – Cavite Inc. (FPCDI) conducted a two-day celebration of the 44th National Disability Prevention and Rehabilitation week with the theme "Working with the Government in Achieving Equal Access to Education, Employment, and Livelihood towards Empowerment of Persons with Disabilities" on July 26 and 28, 2022 at the Provincial Gymnasium, Trece Martires City. The celebration intends to raise awareness on persons with disabilities' rights, protection, and issues. Also, the differently-abled had the opportunity to showcase their talents in the singing and dance competition. A motorcade joined by the officers and members of Federations of Persons with Disabilities in Cavite signaled the start of the celebration on July 26. Atty. Danilo Emelo, FPDCI President, delivered a welcome remark followed by Ms. Sonia Mendoza, who shared a message on behalf of Vice Governor Athena Bryana Mendoza, assuring that the Office of the Vice Governor is always open to help those in need including PWDs. Then, Mr. Alvin Mojica, Provincial Administrator for Community Affairs, imparted that the provincial government institutionalized the PDAO – office, staff, and funds – to focus on the PWDs. Former Local PWD Presidents were subsequently awarded certificates of appreciation for their exceptional work and accomplishments during their term. On the last day of the

celebration, resource speakers were invited to share information and knowledge to the attendees.

Ms. Marie Shiela Antenor Haloc, Disability Affairs Officer IV of PDAO, gave an overview of the NDPR Celebration. This was followed by a talk on the importance of equal rights and accessibility in education, livelihood and employment by Architect Don G. De Vera, a disability-rights advocate.

Ms. Marinelle Juangco, ADA IV who discussed the DILG Memorandum Circular No. 2021-041 entitled "Strengthening the Functionality of Persons with Disability Affairs Office and Persons with Disabilities Focal Person" that emphasizes the importance of establishing and appointing PDAOs and focal person in the country for addressing the concerns and catering to the needs of PWDs.

Moreover, Ms. Rey Ann Avilla, LGOO II, discussed the SGLG Functionality focusing on the Assessment and Criteria under Social Protection and Sensitivity. In relation to the F.Y. 2021 Functionality Assessment, the Local Government Units were awarded with a certificate of Appreciation by Provincial Government of Cavite and the Department of the Interior and Local Government alongside LGU representatives. Then, the Top 3 FPDCI Leaders were given recognition with audio-visual presentation.

Highlights of the NDPR Week Celebration were the singing contest won by Mr. Percival Navarro from Trece Martires City and the "Pag Nagkakaisa" advocacy dance competition won by Indangefios Movers from the Municipality of Indang.

Calabarzon logs highest enrollment turnout: DepEd

MANILA – The Department of Education (DepEd) has so far logged the highest number of enrolled learners in Calabarzon (Region 4-A).

According to DepEd's latest data, 2,116,809 learners were registered in the region's provinces of Cavite, Laguna, Batangas, Rizal, and Quezon for the upcoming school year 2022-2023.

This accounted for over 10 percent of the national figure for enrollment hitting 14,284,778.

The National Capital Region (NCR) recorded the second highest count with more than 1.7 million enrollees, followed by Central Luzon with over 1.4 million.

Learners at the elementary level recorded the highest turnout with over 6.6 million,

followed by enrollees from Junior High School with more than 4.6 million, then over 2.1 million learners in Senior High School, and 946,611 learners in Kindergarten.

Earlier, Education spokesperson Michael Poa noted that this year's enrollment turnout was significantly higher than the previous school year, considering their approach to a gradual transitioning to in-person classes.

The DepEd assured the public that the majority of schools last year have shown preparedness for the face-to-face learning setup.

In a Viber message, the DepEd said 34,769 schools are participating in face-to-face classes.

Nutrition Forum culminates the 48th Nutrition Month celebration in Cavite

Nutrition stakeholders from the local government units in Cavite gathered in a Nutrition Forum to culminate the 48th Nutrition Month celebration with the theme, "New Normal sa nutrisyon, sama-samang gawan ng solusyon!" on July 27, 2022 at the Cavite Collaboration Center for Public Health in Trece Martires City. The forum with the tagline, Strengthened Action on Nutrition: A Collaborative Action of the BNC called on LGU nutrition forerunners composed of Liga ng mga Barangay Presidents from the cities and municipalities of Cavite, City/Municipal Nutrition Action Officers (C/MNAOs), Provincial Nutrition Committee members and other partner agencies to intensify and invest in nutrition programs in their respective communities in the midst of the pandemic.

Dr. Nonie John Dalisay, OIC-Provincial Health Office welcomed all the participants to the event which aims to raise awareness on the importance of investing in nutrition. Ms. Marinelle Juangco from the Department of the Interior and the Local Government-Cavite talked about Unifying the Direction in Nutrition and the different legal bases that mandate local government units specifically at the barangay level to pursue and implement nutrition programs.

City Councilor Jojit Desingano shared the best practices of Barangay San Jose, Tagaytay City during his term as Barangay Chairman. The innovations and firm resolve to implement nutrition programs targeting not only the health aspect but other concerns including the environment have won them various recognition from the city, the province and the region. Their barangay has also been chosen in many benchmarking activities of different LGUs and organizations.

Participants signed a commitment of support to nutrition programs and the advocacy to invest more for successful nutrition interventions.

In closing, Dr. Maria Victoria Salvatus-Torres enjoined all the nutrition stakeholders to promote nutrition not only during nutrition month celebration but all year round as an integral part of public health. **PICAD**

He obtained his bachelor's degree in Architecture from the Technological Institute of the Philippines in Manila.

Acuzar established the New San Jose Builders, Inc., now one of the country's largest developers.

"This success can undoubtedly be owed to the leadership and performance-based and hands-on management style of Secretary Acuzar," DHSUD said in a statement. "Rest assured, Secretary Jerry, that the One DHSUD Family will be all-out in supporting your leadership." (PNA)

SC halts flag-raising rites, imposes lockdowns to curb infections

MANILA — The Supreme Court on Monday adopted further measures to mitigate the continuing impact of the Covid-19 pandemic, including a temporary stop on the weekly flag-raising ceremony in Manila.

"It was put on hold as a precaution to the recent spike in Covid-19 infections," SC spokesperson Brian Keith Hosaka told the Philippine News Agency on Monday. Among the courts temporarily shut down were the Calamba City, Laguna Regional Trial Court (RTC) Branch 35 from July 28 to August 3; Imus, Cavite Metropolitan Trial Court in Cities (MTCCs) Office of the Clerk of Court and Branches 1 and 2 from July 26 to August 1; Municipal Circuit Trial Court Branch 5 of Don Carlos-Kitaotao-Dangcagan in Bukidnon from July 29 to August 2; Tarlac City RTC Branch 110 from July 29 to August 4; Lucena City RTC Branch

55 from July 28 to August 3; and Baguio City Family Court Branch 2 from July 29 to August 4.

The National Capital Region (NCR) remains under the most lenient Alert Level 1 classification but is classified as moderate risk for Covid-19, according to Undersecretary for Public Health Services Team Beverly Ho last week.

She said the NCR has the highest daily moving average with almost 1,100 cases per day.

The Department of Health (DOH) reported 4,127 new cases of Covid-19 on Friday that brought the total active infections to 32,637.

The DOH likewise recorded 890 additional cases of the Omicron BA.5 subvariant of Covid-19 on July 28, but 823 of them have recovered.

To date, the country has logged a total of 1,997 BA.5 cases, 71 BA.4 cases, and 154 BA.2.12.1 cases. (PNA)

Pag-IBIG Calamity Loan ready for members affected by North Luzon Quake

Top executives of Pag-IBIG Fund announced on Monday (August 01) that the agency has initially allocated P3 billion in calamity loan funds for members in calamity-stricken areas, including those affected by the strong earthquake that hit North Luzon.

"Pag-IBIG Fund has allocated calamity loan funds to help affected members in Ilocos Region, Cagayan Valley and the Cordillera Administrative Region (CAR) recover from the devastation caused by last week's earthquake. We are also working closely with our fellow government agencies, as directed by President Ferdinand Marcos, Jr., so that we can maximize our collective assets towards providing for the needs of our fellow Filipinos affected in these areas," said newly appointed Secretary Jose Rizalino Acuzar of the Department of Human Settlements and Urban Development and Chairperson of 11-member

Pag-IBIG Fund Board of Trustees.

Under the Pag-IBIG Calamity Loan, eligible members may borrow up to 80% of their total Pag-IBIG Savings, which consist of their monthly contributions, the counterpart employer's contributions, and accumulated dividends earned.

And in consideration of the plight of the members, the calamity loan is offered at a rate of 5.95% per annum which is the lowest rate in the market.

The loan is payable over a period of up to three years, with a grace period of two months so that initial payment is due only on the third month after the loan is released.

Qualified borrowers may apply for the calamity loan within 90 days from the date when an area has been declared under a state of calamity.

Meanwhile, Pag-IBIG Fund Chief Executive Officer Acmad Rizaldy Moti stated that the agency has deployed its mobile branch,

CA dismisses realty suit vs. state school in Isabela

MANILA — The Court of Appeals (CA) dismissed a lawsuit by private individuals against a state university in Cabagan, Isabela over a dispute involving over 2,000 square meters of property.

In a 12-page decision promulgated July 27 and published recently, the tribunal affirmed the decision of the Regional Agrarian Reform Adjudicator of Region II (RARAD) of Isabela, which had dropped the complaint filed by Juan Espiridon Cureg against the Isabela State University.

Cureg claimed the school, formerly the Cagayan Valley Institute of Technology, had encroached on a 2,000-square-meter portion of the family-owned agricultural land, measuring 65,070 square meters, when the university put up its perimeter fence.

The RARAD dismissed the suit in 2017, ruling that it has no jurisdiction over the case as the parties were not

contending who between them is the true tenant or farmer-beneficiary.

The ruling added that questions on ownership are best resolved before a regular court.

The parties then appealed the case before the Department of Agrarian Reform Adjudication Board (DARAB), which said RARAD, not the regular courts, has jurisdiction over the dispute.

In reversing the DARAB and affirming the earlier ruling of the RARAD, the CA said "justice would best be served by allowing the parties to thresh out their allegations and defenses in a full-blown hearing before the regular courts, which has jurisdiction over ejection cases."

"Certainly, a complete resolution of the case will benefit both parties as it will finally settle their respective rights over the subject landholding," the CA said. (PNA)

Dengue cases in CALABARZON up 53%

CALAMBA CITY, Laguna (PIA) — The Department of Health (DOH) Center for Health Development CALABARZON has recently released its data which indicates an increase in the reported dengue cases in the region.

According to the July 16 data of DOH IV-A, there are now 6,362 reported dengue cases in the region from January 1 to July 16, a 53% increase based on the same time frame in 2021 with only 4,151 total cases.

There are more male patients of dengue this year with 3,381, while there are 2,981 female patients. Laguna currently has the

In terms of cities and municipalities with the most cases, Antipolo City leads with 601 cases; followed by San Pablo City with 346; Calamba City at 313; Imus City at 215; and Candelaria at 181 cases.

Dengue is transmitted by the mosquitoes *Aedes aegypti* and *Aedes albopictus*, which commonly bite during the day, but may also bite at night. These mosquitoes lay eggs in clear and stagnant water (including water in flower vases, and clean rainwater collected in barrels, cans, or old rubber tires). Adult mosquitoes rest in dark places of the house. Mosquitoes can also become infected with the virus when they bite a person who has already been infected and can thus spread the infection to other people.

According to DOH Healthy Pilipinas, some of the symptoms of dengue include sudden onset of high fever which may last from 2 to 7 days; joint and muscle pain, pain behind the eyes, and/or headache; feeling weak, skin rashes, nausea, and vomiting, decreased appetite, bleeding during hemorrhagic fever, which can manifest as nosebleeding, gum bleeding, vomiting of coffee-colored matter, dark-colored stools, or even just abdominal pain (as a sign of internal bleeding).

The DOH continues to remind the public to follow the 4-S against Dengue or 1) Search and Destroy Mosquito Habitats (which include draining clear stagnant and accumulated water from tires and pails, and jars); 2) Self-Protect by wearing long pants and long-sleeved tops and by using mosquito repellants; 3) Seek Early Consultation by consulting a physician immediately if fever persists after 2 days or any other symptoms appearing, and 4) Say Yes to Fogging when there is an impending outbreak. — Christopher Hedreyda, PIA4A

DENR CALABARZON, LGU DOLORES, QUEZON PARTNER FOR THE IMPLEMENTATION OF RAPID LAND TENURE APPRAISAL

Calamba City, Laguna
- The Department of Environment and Natural Resources CALABARZON Region entered into a Memorandum of Partnership Agreement (MOPA) with the Local Government Unit of Dolores, Quezon for the implementation of the Rapid Land Tenure Appraisal (RLTA) in the said municipality on July 22, 2022.

RLTA is a process to obtain a clear picture of the land tenure situation on the ground before land titling operations are entered into the area, as defined by the Land Management Bureau (LMB) Technical Bulletin No. 1 series of 2018. Engr. Olivia G. Bejo, Chief of Licenses, Patents and Deeds Division of DENR CALABARZON shared that based on an assessment conducted in 2018, approximately 2 million parcels of Alienable and Disposable (A&D) lands in the country were mostly untitled. "Gumawa ng paraan ang ating pamahalaan sa pamamagitan ng LMB kung paano mailalapit ang programa na pagpapatitlo ng lupa sa publiko. "Ang RLTA ay bahagi ng accounting of natural resources dahil sinusukat natin kung ilan pa ang maaari pang matituluhang RED Tamoria added.

Aside from the benefits of the RLTA, Tamoria emphasized that through

the partnership, the LGU will be capacitated in terms of land governance, and effectively manage the land resources within their area of jurisdiction.

Plaza stays as PEZA Director General per MC No.3 of Malacañang

Pasay City-With the Malacañang extending the authority of government officials from 31 July to 31 December 2022 or until a replacement has been designated.

Brigadier General Charito Ching B. Plaza returns to the Philippine Economic Zone Authority (PEZA) as the Director General (DG). This comes after Executive Secretary Victor Rodriguez, under the authority of President Ferdinand Bongbong Marcos Jr., issued a supplement to Memorandum Circular (MC) No. 1. s. 2022, numbered MC No. 3 last 28 July 2022.

By extending the term of office of government officials and employees covered by MC no. 1, MC No.3 emphasizes the continued and effective delivery of government services. MC no. 3 also ensures that no new contract, project, or disbursement of extraordinary funds is made by government agencies, bureaus, and offices until an official appointment is declared by President Marcos Jr.

Under the latest MC, "All

agencies, bureau and office, non-career executive service (CES) officials occupying CES positions and contractual or casual employees covered herein shall continue to perform their duties and discharge their functions until 31 December 2022 or until a replacement has been appointed or designated, whichever comes first." Further, MC no. 3 states that "all officials and employees covered by this Memorandum Circular are mandated to lawfully perform their duties and functions, and submit bi-monthly performance reports to their respective heads of the department, agency, bureau, office, or instrumentality, otherwise, they will be held accountable."

Plaza as PEZA head
 Elated to be back, Ching Plaza said, "Under the MC Nos. 1 and 3 declaring certain positions vacant and provided for the rules to address the vacancies, does not apply to government owned or controlled operations (GOCCS), government instrumentalities with corporate powers, government corporate entities, and government financial institutions."

Plaza also added, "PEZA is a government instrumentality with corporate powers and since MC No. 1 does not apply to PEZA, the positions of the Director General is not declared vacant. The sitting DG will stay on a hold-over capacity until 31 December 2022 or until a replacement has been appointed whichever comes first."

With her stay as the PEZA Chief, Plaza highlighted that she will "continue the Agency's projects and initiatives that started during her term under former President Rodrigo Duterte's administration."

Among these programs Plaza has established are the PEZA Transformation Road Map (TRM), the Global Biz with PEZA, the creation of new types of economic zones, The Development Outreach for Labor, Livelihood, and Advancement of Resources (DOLLAR) Program, and

Non-performing consumer loans put more pressure on PH banks

MANILA - Non-performing loans (NPLs) that were extended to small companies are putting more pressure on Philippine banks compared to those extended to large companies, a report by the Fitch Ratings said.

In a report that assessed the impact of interest rate hikes in Asia Pacific banks, which was released on Tuesday, Fitch Ratings said net revenue impact of the rate hikes on domestic banks is "mildly favorable" and is "moderate" in terms of asset quality impact. It said domestic banks posted the biggest increase in NPLs among its counterparts in South East Asia in the last two years "driven by delinquencies in

consumer loans."

The report said pulling out of pandemic-related measures to buoy the banking system from the impact of the pandemic also played a role in the rise in NPLs.

"We believe there are lingering impairment risks among consumer and SME borrowers whose finances have yet to recover from 2020's severe shock," it said.

The report added acceleration of inflation rate both here and abroad contributed to the interest rate tightening, which also hurt the peso.

Inflation rate increased to 6.1 percent in June due in part to the highest oil prices in the international market.

Fitch Ratings forecasts inflation to average at a level higher than the government's 2 to 4 percent target band until 2023.

This, it said, is the reason why it forecasts the Bangko Sentral ng Pilipinas' (BSP) key policy rates to end 2023 at 4 percent, from the current 3.25 percent for the overnight reverse repurchase (RRP) rate.

With the domestic banking system backed mainly by rate-insensitive current account and savings account (CASA) deposits, the debt rater said the domestic banking sector has "a strong ability to manage deposit cost."

"Changes in the policy reverse repo (repurchase) rate have not historically been fully passed through to bank lending rates," it said.

To date, the BSP's policy rates have been hiked by a total of 125 basis points.

The report said "the conglomerate-dominated business landscape gives corporations considerable bargaining power, and competition for high-quality assets often means that banks are hesitant to raise rates quickly."

"Therefore, we expect lending spreads to widen only moderately," it added. (PNA)
