# SC: Digital 2022 Bar exams to push through this November

MANILA - The Supreme Court (SC) on Wednesday announced the schedule this year's Bar examinations which will be held in a digitalized form instead of the usual pen and paper examination.

In Bar Bulletin No. 6, the high court said the examinations will proceed on Nov. 9 (Wednesday), 13 (Sunday), 16 (Wednesday) and 20 (Sunday), but said rescheduling is possible if unforeseen events occur.

"The Supreme Court will continue to use Examplify, secure examination delivery program, for the 2022 bar examinations, during which the examinees will use their own devices in their preferred venue," the court said.

The tribunal said the exams will be monitored by in-person proctors and closed-circuit television cameras in the exam rooms, just like what was done in last year's exams. The court has yet to

release an announcement on multiple exam venue options, which is similar to last year which was a departure from the usual single-site exam.

The testing software will be made available to bar examinations applicants who apply and are approved to take the exams.

The digital Bar exams were among the innovations adopted by the court amid the coronavirus pandemic. (PNA)

Followed a welcome remarks of Nelson Soriano. Provincial Health Officer I, urging everyone to keep coming up with innovative ideas that will help the delivery of TB services in the province. Aside from that, he reminded everyone that during orientations. seminars or trainings provided by the PHO and DOH, send assign and someone who is more qualified and knowledgeable to convey the programs given to them properly.

Provincial Health The Team Leader, Dr. Orlando Padilla, then gave an inspirational message during which he mentioned the correlation between our environment and lungs. He imparted that if we want to have healthy lungs, we must have a pollution-free environment for it equates to prolonging our life and preventing us in acquiring diseases. Hence, we must always take good care of our lungs.

Dr. Maria Elena Castillo-Gonzales extended her profound and sincere gratitude to all medical personnel and local chief executives for their hard work, support and dedication in order to lessen the burden of tuberculosis in the community. She also let everyone know that the region had previously expressed its intention to accept the challenge and implement iDOTS Phase II across CALABARZON. Dr. Castillo-Gonzalez then concluded her message by saying "Together, Let us all end Tuberculosis."

Afterwards, the ceremonial launching of iDOTS Phase II was kicked off. With this, a road map that represents the commitment in moving towards iDOTS Phase was launched and the medical professionals united in lighting the path by placing their lamp post stickers on the track as a sign of their support and commitment to the said program. Then, they simultaneously remarked "Sama-sama, tulong-tulong sugpuin ang TB sa lalawigan ng Cavite."

In closing, Dr. Armand Dotollo explained that TB is a multifactorial illness that affects people whether or not they have symptoms and whether they are infectious. He added that we are still experiencing the pandemic and other infectious diseases that may hamper the delivery of health care services, but despite this, healthcare workers are still very eager and motivated to provide the best patient-centered care in the area. He, then, imparted that "Failure is not the opposite of success, but it is part of success."

Dotollo concluded his remark by leaving the message "life is like a bicycle, to keep your balance, you must keep moving.

Highlights of the event were the awarding and recognition of top performing Local Government Unit, and the intermission number of some medical practitioners.

# **DHSUD seeks LGU participation** in housing projects

MANILA - The Department secured the commitment of Human Settlements and Urban Development (DHSUD) will actively involve private developers, financial institutions, and local government units (LGUs) to immediately provide housing to more Filipinos.

Secretary Jose Acuzar said Monday that he plans to meet with local chief executives across the country to tackle DHSUD's projects to benefit informal settler families (ISFs) and those living within danger zones.

"The housing sector in the country needs aggressive efforts. Therefore, have to involve every stakeholder that can take part in this advocacy of the new administration. That is, to provide shelter to millions of Filipinos," he said in a statement.

Acuzar said the DHSUD has

"I do hope that more governors, mayors, and lawmakers will support DHSUD's vision for the Filipino people," he added. So far, the DHSUD chief has presented strategies to Pasig City Mayor Vico Sotto and Representative Roman Romulo; Malabon Jeannie Mayor Sandoval and Vice Mayor Ninong Dela Cruz; and Caloocan City Mayor Dale Malapitan to maximize the use of government land for public housing purposes.

"We see the role of LGUs as one of the key components to gradually address or even put an end to the challenges we are facing in the housing sector. They are our allies in development," Acuzar said. (PNA)

# SC acquits 2 on drug charges due to lapses in evidence-handling

MANILA - The Supreme Court (SC) has acquitted two men convicted of illegal drug charges by the Quezon City Regional Trial Court (RTC) in 2019 after finding lapses in the custody of evidence.

In its ruling published online on August 17, the SC reversed the RTC which convicted Jimmy Saavedra and Ohmar Li.

"Absent any evidence or stipulation on how the seized drugs were handled while the specimens were in the evidence room, the chain of custody could not be deemed established to a moral certainty," the SC ruled.

"If the chain of custody procedure has not been complied with, or no justifiable reason exists for its noncompliance, it is the Court's duty to overturn the verdict of conviction," it added.

The police reported the were caught redhanded during a buy-bust operation on May 7, 2019 at Saavedra's residence in Barangay Unang Sigaw, following a tip from a confidential informant.

Undercover police said they were able to purchase PHP200 worth of shabu from Saavedra and Li.

The defense said the two were arrested separately -- Saavedra at Balintawak and Li on his way home.

The two said they were taken to a house where there were other suspects for detention and brought to the Quezon City Police District Station 3 in Novaliches the following day.

The SC said there were no safekeepingmeasuresafter the confiscated contraband was turned over.

The prosecution likewise failed to present testimony from the evidence custodian on measures undertaken to maintain the integrity of the seized items. (PNA)

# SC affirms reinstatement of 5 Meralco subsidiary workers

MANILA - The Supreme Court (SC) has turned down a petition filed by a whollyowned subsidiary of the Manila Electric Company (Meralco) in a labor case filed by five of its workers who claimed to have been illegally dismissed in 2014. In its resolution published online on Aug. 9, the high court's first division denied the petition . Meralco filed by the Engineering Industrial Services Corp. (Miescor), Meralco's engineering and construction arm.

The ruling ordered that the workers -- heavy equipment mechanics Angelito de Leon, Reyfraim G. Palma, Stephen G. Palma, Jesus G. Garcia, and vehicle painter Felimen A. Milan -- "be reinstated to their former or similar positions, without loss of seniority rights and other privileges".

In its petition filed before the high court, Miescor questioned the Dec. 17, 2018 decision of the Court of Appeals which reversed

the Dec. 8, 2015 decision of the National Labor Relations Commission (NLRC) and instead reinstated the original Dec. 29, 2014 decision of the labor arbiter in the case which ruled that the workers are regular employees of the subsidiary who were without just dismissed cause.

The workers who were hired at various times from 2008 to 2013 claimed that under the employment agreements they were made to sign, they were hired only for a specific project in Valenzuela City and that when the project is not finished on schedule, the company made them subsequent sets employment project contracts.

However, they claimed that they were never assigned to the Valenzuela project and were instead assigned to Miescor's Motor Pool Department Preventive Division in Marikina City.

Special Non-Working days are more flexible or their days can be changed.

But apart from the fact that they still need to be enacted by Congress, the President can also declare them based on discretion.

# Site-specific fertilizer recommendations eyed for less rice production cost

The QUEZON CITY --**DA-Philippine** Rice Research Institute (DA-PhilRice) through the Competitiveness Rice Enhancement Fund (RCEF) Seed and Extension Programs currently developing location-specific fertilizer recommendations to help local farmers maximize their resources amid high fertilizer costs.

resources "Farmers" have now become more limited because of high fertilizer costs. Meanwhile, current practices that if farmers continue to apply fertilizers that are not appropriate to crop needs, their resources are wasted, and yields can be sacrificed. We want to help them address that," Flordeliza Bordey, DA-PhilRice RCEF Program Management Office head, explained.

Studies show that mineral nutrients are vital in boosting rice growth and development. However, some mineral nutrients have limited availability in the soil and must be supplemented with fertilizer application.

Experts said that too little application will lead to suboptimal yield while excessive application is costly and can lead to soil and water pollution. Thus, they emphasized the need to determine the amount of mineral nutrients available and lacking in the soil.

With this, the Institute started conducting massive soil analysis of farmers' fields representing major

soil types in RCEF target areas through the use of the Minus-One Element Technique (MOET) kit. The project started in the 2021 wet season and is expected to complete generating specific recommendations for 512 municipalities by the end of 2023.

"We have processed the recommendations from the first batch of the MOET setups and are getting ready to cascade these to the target areas. We are collaborating with our partner-local government units (LGUs) to ensure that the recommendations reach the farmers, which they would hopefully adopt," Bordey noted.

MOET is a diagnostic tool used to identify deficient macronutrients like nitrogen, phosphorus, potassium micronutrients including sulfur, zinc, and copper in field conditions. Part of its results show the right element, amount, and timing of fertilizer application needed by the crop for better yields.

"Crops require both macro and micronutrients for better growth and development. Some of it can be sourced from the environment. The rest are deficiencies that can be supplemented by fertilizers," Ailon Oliver V. Capistrano, DA-PhilRice nutrient management expert, said.

He further said that the common method assessing the needs of the rice crop is to observe its physical appearance. When crops turn yellowish, some farmers would usually apply urea to solve it. However, Capistrano said the practice may not always address the soil or the crop's specific needs.

"Common fertilizer grades that farmers use like urea and 14-14-14 provide the macronutrients needed by the crop. These include nitrogen (N), phosphorus (P), and potassium (K). While NPKs are generally important for crop growth, therearealsomicronutrients such as copper, zinc, and sulfur that are necessary because it affects the soil and the plant's capacity

# Walk-in applicants not accepted in educational aid payout: DSWD

MANILA - To conduct a more orderly payout of the educational assistance for indigent students, the Department of Social Welfare and Development (DSWD) and Department of the Interior and Local Government (DILG) have agreed to release aid only to those with online registration or QR Code.

"That is the difference now, we will only cater to those (who) have already registered online or have acquired QR code. We will no longer accept walk-ins to avoid what happened on the first day of roll-out," DSWD Secretary Erwin Tulfo said on Wednesday during the ceremonial signing of the memorandum of agreement (MOA) with the DILG held at the DSWD Central Office in Quezon City.

The agency will create virtual system for registration. While it is yet to announce the online

"We would also like to encourage our partner-LGUs to help us not only in helping disseminate the fertilizer recommendations to farmers, but also to implement programs complement that advocacy on proper nutrient management such as providing the required fertilizers," Bordey said.

The RCEF-Seed Program component is a Republic Act 11203 or Rice Tariffication Law, which allots P10 billion funds every year for the rice farmers from the rice tariff earnings of the country. The program is a six-year government initiative to help farmers improve their competitiveness.

The local government units and lawmakers assist its implementation. Mandated to help ensure a rice-secure Philippines, DA-PhilRice leads RCEF-Seed Program. It is also the government's lead agency on rice research and development. (DA-PhilRice)


